NEW BUSINESS

- A. Updates from Administrative Director, Jenny
 - a. Starting to work on Q2 newsletter, please let us know if you have any additions for this. Starting to build this mid-June to be finalized end of June. As things happen Jenny starts working on the newsletter, please don't wait until the end the due date. Teresa is helping Jenny with interviews for the newsletter with staff employees. Teresa would like to start interviewing the board members as well. Tracey and Robin will be the Q2 highlights.
 - b. Portraits for pets originals are coming in to the shelter. If we can let donors know they should come during open hours Wed-Sunday. We have animals everywhere

- here, so Jenny is going to make a spot in the fundraiser shed to keep them safe. Junanne said she and Suzanne will be distributing the art at the end of the event.
- c. Ballots will be coming in soon for the board member voting, Jenny has a lockbox at her desk. The sealed envelope will be going in to this lock box which has no key. Tracey felt since Mac was gone, that two people not listed on the ballet should tally these votes. Jaime feels this is a great idea and would help count. Robin and Jaime will count votes in May.
- d. Linda Jaurigue a longtime supporter passed away last year and her husband and longtime friend is coming down next week to put up a memorial for her which will be a sitting area for meet and greets.
- e. Cole is moving to the east coast. He has been an amazing asset to the team. His last day is May 7 and we are all invited at 3:30. We have several good candidate applications set for interview tomorrow April 20.

B. Electrical update and quote, Tracey & John King

- a. Work needed completed permitted requiring PGE and county approval looking at 16 weeks plus non permitted
- b. Permitted work will be a new main panel with 400 amp, mounted on the wall. Looking at solar and generator ready. Replace existing subpanel.
 - i. Busch came in at \$19,500
 - ii. Wheeler at \$13,900 with a discount
 - Both are young guys, Busch are 3rd generation electrician.
 Wheeler is just getting business going, trying to build up his
 business base. John likes Wheeler as he went through all our
 buildings to gain an understanding of what is happening here.
 John told him this could lead to future business. Wheeler will use
 the best materials out there. Has extensive experience in solar
 installation.
- c. Once PGE is gone, non permitted items are replacing the breaker by the office, replacing the outside panel in dog kennel, trench conduit or bring power to dog intake building.
 - i. Cesar Toxqui is willing to complete the nonpermitted work for \$60/hour plus materials with a suggested budgeting \$6K
- d. We are looking at about \$20K, we budgeted about \$35K and looking at doing fundraising to help cover the costs.
- e. Junanne makes a motion to approve, Jaime firsts approved, Holley seconds

C. Wags & Wines, Teresa

- a. April 2 was at Thatcher Hotel, had a good show of employees and volutneers, the hotel donated a gift basket and waived tasting fee with a \$20 donation. Made about \$300 on donations and \$200 with raffle. Kelsey from Rivino booked up an event as well.
- b. April 9 Hopland Doggy Days at Hopland Tap. Had raffle donation, we got about \$280 with donations and 3 puppy adoptions.
- c. This Saturday is at Barra. They have Slam Dunk coming. Waiving tasting fee with \$20 donation. Also have the Tree seedlings for Earth Day. Looking for

- suggestions on how to present them. With a \$20 donation, you get free tasting and a redbud tree.
- d. Following Saturday will be the event at Rivino. They have a private chef coming with 20% of his proceeds going to the shelter, Rivino is waiving the tasting fee and will have the dog charcutier board. Kelsey has also gone out and gotten donations for the raffle event.
- e. May 21 will be at Toxqui winery, this is the same day as the Jeep event.

D. Fundraising Committee updates, Robin

- a. Portrait for pets update 64 donors Raising \$3,365 after deductions. We are projecting about \$5,300.
