#### **STAFFING**

- ★ 9 Employees (6 FT, 3 PT)
- ★ Every Saturday, each animal department meets for a check in starting with a one minute "pause"
- ★ Every Friday, Leadership meets
- ★ Q4 Staff Training
- ★ GoodPup, which has provided dog behavior support to HSIMC for the past 3 years, is merging with Rover who has decided they will not be continuing their shelter program. Adding more work to our staff/behavior team

#### **MEDICAL**

- Spay & Neuter Surgeries through East Hill Vet: Dogs 12 Cats 27
- Awnie currently under medical and behavioral evaluation for QOL in a medical foster home, xrays and exam done at East Hill
- Roxy had post spay procedure complications, Suzanne had the opportunity to observe successful emergency resuscitation (CPR)

Betty Boop has her third eyelid gland

- removed during spay

  \* Molly receives emergency dental and has 32 teeth removed!
- ★ Senior dog Titan receives a sedate and groom + senior blood panel + finds a foster to adopt home the next day!
  - Senior blind dog Ollie comes in with unmanaged diabetes, emergency care provided by EHV and a plan to stabilize or euthanize if not able to manage his medical needs. Medical foster found!

# Shelter Operations Wins/Challenges

#### <u>CHALLENGES</u>

★ Community members not being honest about stray animals, owned animals being turned in as straysTitan a senior dog from HSIMC ends up at MCACS after being turned away from HSIMC, don't worry we got him back!

- ★ Spay and neuter for our dogs in care is currently booked out into March
- ★ Large volume of calls for behavior support
- ★ Decreased cat adoptions = less ability to take in cats in need
- ★ Many stray animals do not have a safe place to go in our county and we are seeing an increase in animal abandonment
- ★ Senior cat and two underage kittens abandoned at gate

#### <u>WINS</u>

- ★ Senior dog Titan finds a foster home!
   12 year old dogs do not belong in the shelter
  - FeLV Cottage Seniors, Shade and Magick, were adopted!

Senior dogs Titan and Ollie find

- immediate foster placement where they can get the love and care they deserve during their golden years
- ★ Staff receives sugar rush from all the Halloween candy! Go zoom, zoom!
- ★ Large donation of warm cozy blankets sent by Pam in Petaluma!
- ★ Loose dog seen on Uva Drive and running on the 101 finds safety in our field thanks to the quick thinking of Rosa leaving our top gate open!

## Leadership Updates

#### 2026 Budget Development

Work is underway on the 2026 budget. It has been challenging to find uninterrupted time to focus on this process due to competing operational demands, but progress continues. The goal remains to present a balanced budget that reflects realistic program capacity and anticipated revenue trends by the November board meeting.

#### Wellness Clinic - Spring/Summer 2026

HSIMC is preparing to host an employee and volunteer Wellness Clinic in 2026. Calls for assistance continue to increase in both frequency and emotional intensity, reflecting growing desperation in the community and limited available resources. Staff are exploring ways to manage the emotional impact of these interactions, as they often involve individuals in crisis beyond our professional training.

#### **Behavior Support Program Transition**

GoodPup, our post-adoption behavior support partner, has merged with Rover and will no longer provide services to HSIMC adopters. We are actively exploring alternative solutions to ensure continued access to behavior support for adopted animals and the broader community. Existing scholarships will be refunded.

#### Partnership with MCACS – Animal Balance Project

HSIMC is collaborating with Mendocino County Animal Care Services on the upcoming Animal Balance project, with appointments currently scheduled for March, May, and July. Hoping to be able to schedule two more clinics - funding sources needed. This initiative will increase access to high volume/low cost spay/neuter.

#### Pet Pantry Program Expansion

The Pet Pantry has now supported over 600 families this year, underscoring the critical community need for this program. With the expiration of SNAP benefits for some families, we are already receiving calls for additional assistance. Expansion options are being explored to meet this increasing demand.

#### Regional Collaboration - Clearlake Animal Association

HSIMC provided a letter of support to Clearlake Animal Association in their bid to assume management of the Clearlake Animal Services contract. This effort represents our ongoing commitment to strengthening cross-county collaboration and resource-sharing among animal welfare organizations.

#### **Facility and Infrastructure Needs**

Outdoor dog kennels are requiring more frequent repairs due to wear and weather exposure. We are evaluating long-term solutions to "build back better," focusing on durable, animal-safe, and efficient designs that meet ASV Guidelines for animals housing. Additionally, we are seeking a construction-savvy volunteer to assist with the installation of ventilation fans in the Pet Pantry storage container to improve airflow and working conditions.
