Medical Neglect and Abandonment

(1)

On Jun 4th Mr. Reeves slammed brakes in the sheriff van while we were being transported from court to the jail. We were not seatbelted. I was thrown forward and over and slammed my face on a metal bench, twisted my back, crushed my hand, and pured my stomach with the metal shackles.

(2)

My right hand is healing deformed with pieces of my knuckles or bone floating under the skin.

(3)

I busted a little hole in my belly button and leaked fluid for a month. I still have abdominal pain and slight bladder leakage. I'm afraid I have more internal damage.

(4)

I can barely walk without feeling like I may fall and I'm in massive pain. In a sitting position I have massive pressure and pain in my lower area.

(5)

My jaw pops loudly when I eat due to bones shifting in my jaw where I bit my face.

(6)

I was told by staff here and at the hospital that I needed further and more intense X-Rays and testing and possible procedures, that I will not receive at this facility.

(7)

I already had previous injuries that happened due to negligence while being here working in the kitchen.

(8) I was teased by inmates that knew Jones harassed me for months so bad to the point I had nightmares.

(9) Lance Lincoln reported the stripsearches became sexual to Mr. Peterson of Atamack.

(10) Jones took my trustee status and fired me cause i called him a faggot in front of officer McGinn and the whole pod. Never in my life had I spoken disrespectfully to any authority figure. He was removed from the kitchen and reassigned elsewhere in the jail due to harassment of an Atamack employee. I was returned to the pod a week later. (No explanation)

(11) Me and several inmates gave statements to deputies months ago. Me and Thomas Howland told the truth. All the other guys were scared of hurting their criminal cases. They said they didn't say anything. No action was taken.

(12) Mr. Joe Bodilidit stated via video zoom conference that he received a call from the Public Defender's office informing him of sexual harassment with Me, other inmates and McInnes prior to me telling him and he took no action.

(13) There are several inmates and staff aware of incidents before and after mine with McInnes. Some have agreed to give statements if necessary. Thank You

- (9) I lay in bed eighteen or twenty hours a day tossing and turning one side to another due to the massive pain I'm in. I'm afraid to walk more than two or three steps from the wheel chair.
- (10) I feel like L.C.S.O. or this out-of-state incarceration should have been responsible and have taken more action to assure my safety, well-being and proper rehabilitation. I've been abandoned in this cell and neglected and am starting to suffer from fear and depression.


