#### 1) HOW VIOLATION OCCURRED:

Violation of Condition (30) of the Order of Probation, by accessing the Internet or other computer services until a qualified practitioner in the offender's sex offender treatment program, after a risk assessment is completed, approves and implements a safety plan for the offender's accessing or using the Internet or other computer services, and as grounds for belief that the offender violated his probation, Officer Rodriguez states that on 05/22/2021 the offender was found to be accessing the Internet or other computer services, to wit: Netflix, as evidenced by the tv in the offenders bedroom on and displaying Netflix previews on 05/22/2021.

CIRCUMSTANCE: On 05/22/2021 this officer along with Officers Henry Abarca and Temara Cook conducted a routine search of the offender's residence. Upon entering the offender's bedroom, the tv was on and displaying Netflix previews. A review of the offenders tv showed that a Netflix account was signed onto the tv in the offender's bedroom. The offender was the only person home and the only person occupying his bedroom where the tv was at. The offender states his adult son purchased internet service for himself for the times when he comes to the offender's home to do school work and watch tv. This officer instructed the offender not to have access to the internet. On 05/24/2021, this officer followed up and went back to the offender's home and after a review of the tv connection the internet was still connected to the tv allowing the offender to have access to the tv by way of the internet. This officer instructed the offender if he wants to watch tv he needs to get a basic tv service that does not require internet to watch.

Note that according to the court records the offender is not to have any access to the internet or other computer services until its approved by a qualified sexual offender treatment provider and may access the internet for work purposes only.

#### 2) OFFENDER STATEMENT:

The offender stated his adult son has purchased the internet in his name for the when he is at the home doing his school work and his son set it up on the tv.

This officer reviewed the most recent Criminal Punishment Code Scoresheet which indicates 22.80 lowest permissible prison sentence in months and 20 maximum sentence in years.
