Logline and Synopsis

LOGLINE: In 2001, Will, now a survivor in his thirties, is determined to break the silence, confront the truth, and seek justice after he and many other young black boys were molested in 1981 by a white Red Sox clubhouse manager at Florida's Chain of Lakes Ballpark, where the team held spring training and the boys worked as Clubbies.

SYNOPSIS: "Predator in the Clubhouse: The Boston Red Sox Child Molestation Story," a 119-page screenplay, is based on a true, untold story in the vein of "The Boys of St. Vincent" (1992). The events took place in Winter Haven, Florida, where the Boston Red Sox held spring training at the Chain of Lakes Ballpark. A white man named Donald Fitzpatrick, who worked as the organization's clubhouse manager, was known as Fitzy. From 1971 to 1991, Fitzy is believed to have molested more than a dozen black boys who worked as clubbies under him at the facility. He pled guilty in 2002 but never served time. He received a ten-year suspended sentence and fifteen years of probation. Fitzy died in 2005, but the victims' stories have never been told... Until now. Predator in the Clubhouse: The Boston Red Sox Child Molestation Story is one of the most eye-opening and compelling untold stories of child sexual abuse within a sports organization in history.

This screenplay is now award-winning, with four film festival selections, three of which earned awards (Best Drama screenplay at the 2026 Los Angeles Movie & Music Video Awards, a selection at the 2025 LA Film & Documentary Awards, Best Drama Screenplay at the 2025 New York Film & Cinematography Awards, and a Genre Winner at the 2025 Your Script Produced! 4th Edition International Screenplay Competition, which is represented by United Talent Agency). Gary's 183-page book version, with a slightly different title, is available on Amazon. The book is called "Predator on the Diamond: The Boston Red Sox Youth Molestation Story."

Lead Character Descriptions

- Teen Will: (black Male, age 15) Lead role- Will as one of the teenagers who was sexually abused by Fitzy. Quirky, naïve, and a basketball star at his ethnically diverse high school.
- Fitzy: (white Male, 57) Lead role – Predator who sexually abuses Will and the other Clubbies.
- Shirley: (black female, 35-40) Supporting role – Will's very strict mother, who is very strong.
- Oldest Will: (black male, 35) Supporting role – Teen Will, now grown, tells his story of sexual abuse to a psychiatrist.
- Mr. Roberts: (white male, 40) Supporting role – The principal of Teen Will's High School. He is somewhat of a racist and does not like the blacks at the school, including Will, to associate with the white students. He becomes a thorn in Teen Will's side and does find a good reason to expel him.
- Coach: (black male, 35) Supporting role – Young Will's basketball coach at the high school. He truly believes in Will and sees his potential.
