2. If the deceased person has been in long term residential care out-with the boundaries of Argyll and Bute Council but was previously a resident of Argyll and Bute and was moved to such residential care at the behest of this, or a previous Local Authority
3. Any resident or former resident of Argyll and Bute who has died in the service of their country
4. Permission for erection of memorial to be paid at same time as purchase of lair.
