Re: Letter of Support for the Triangle Community Road Planning & Environmental Linkage (PEL) Study

Dear Mayor Patkotak, Commissioner Anderson, and Commissioner Crowther:

On behalf of the **Utqiaġvik Trilateral Leadership — Ukpeaġvik Iñupiat Corporation (UIC), the Native Village of Barrow (NVB), and the City of Utqiaġvik** — we are writing to express our unified support for the **Triangle Community Road Planning and Environmental Linkage (PEL) Study**, advanced through the Arctic Strategic Transportation and Resources (ASTAR) partnership.

The proposed road connecting **Utqiaġvik, Atqasuk, and Wainwright** has long been recognized by our regional leaders and community members as a project with the potential to significantly strengthen our region's quality of life. A PEL Study is an important next step in evaluating this opportunity, allowing North Slope communities to meaningfully guide the planning process, identify a clear purpose and need, and assess route options and potential impacts before entering a formal Environmental Impact Statement (EIS).

Like the benefits outlined in earlier regional ASTAR support letters, the Trilateral notes that year-round overland access between our communities would provide:

- Increased social and cultural connectivity,

- Lower costs of goods and services,
- Improved access to subsistence areas and support for traditional activities,
- Enhanced emergency response capability,
- Expanded educational and workforce development opportunities, and
- More stable transportation options that reduce isolation and improve long-term community sustainability.

These benefits closely align with the community-selected ASTAR Criteria, which emphasize subsistence protection, connectivity, cost reduction, safety, education, and workforce opportunities.

We appreciate that the PEL process — funded by ADOT&PF and supported by DNR and the North Slope Borough — is specifically designed to incorporate local and regional leadership throughout. Ensuring that Utqiaġvik residents, subsistence users, landowners, tribes, and city officials are included early and throughout the process is essential, and we value the ASTAR team’s commitment to transparent communication and meaningful engagement.

The Utqiaġvik Trilateral Leadership supports the advancement of the Triangle Community Road PEL Study, with the understanding that:

1. The study will help our region better understand environmental considerations, potential impacts, and benefits.
2. The study will identify feasible funding strategies and timelines; and
3. The results will provide North Slope leadership with the information needed to determine whether the project should advance into a full EIS.

As the PEL Study progresses, we look forward to continued coordination with the ASTAR partnership, the North Slope Borough, and the State of Alaska. Our organizations remain committed to working together to evaluate this opportunity in a manner that respects our lands, culture, and long-term community needs.
