



“ENDLESS SUMMER PROGRAM AMBASSADOR”

**NZ RESIDENT BABY-BOOMER – WORKING INVESTMENT APPOINTMENT.
INGOING USD120,000, TWO YEAR CONTRACT, RETAINER, FEE OVERRIDE INCOME.**

A cadre of NZ resident businesspersons, including a Baby-Boomer to act as “Ambassador” with **financial, accounting, capital markets experience** for whom “**The Endless Summer**” investment product marketing theme resonates. The cadre will play a role in attracting Foreign Direct Investment (FDI) into NZ from High Net Worth (HNW) American Baby-Boomers seeking to recreate an intergenerational “**Endless Summer**” sanctuary investment in NZ as an adjunct to their US portfolio. HNWI’s the cadres will mentor on their NZ-US journey. The role delivers:

- (1) A 56% shareholding in “NZ Showcase USA Inc” on issue. (*Dilution will follow*).
- (2) A directorship in the Showcase Corp, guiding the NZ Listing Sponsor take-on program.
- (3) An “Ambassadorial” (mentoring) role, interacting with American HNWI’s.
- (4) An advisory role in developing an “Open Source” US investor introductory platform.
- (5) An override income of 1% on closing value of Showcase listed investment contracts.

(1) THE INVESTMENT

To subscribe for 200,000 shares in NZ Showcase USA Inc, (“NZUS”) priced at USD0.60c each for a total of USD120,000. This investment will:

- (i) Soft-launch the “Invest in NZ” Showcase with NZ investment products.
- (ii) Deliver a 56% interest in NZUS, the Showcase owner/operator Corp.
- (iii) Deliver a retainer based directorship in NZUS under a two year, outsourced service Provider agreement for the group appointed “Ambassador”.

(2) THE DIRECTORSHIP ROLE

As a NZ resident director of NZUS, this role will be undertaken by the “Ambassador” who will mentor the NZ Listing Sponsor take-on program. This requiring interaction with the various NZ organisations approved as “Listing Sponsors” to the “Invest in NZ” Showcase. A two year, Value Added Managed Services (VAMS) service Provider agreement will provide for payment of a fixed retainer of USD5,000 per month paid from the US to the nominated banking account of the Ambassadors VAMS entity.

(3) THE “AMBASSADOR” ROLE

As a NZ resident director of NZUS, the cadre appointed Ambassador will:

- (i) Be lead mentor / “*kaitiaki*” in NZ for US HNWI’s who express an interest in commencing a DD exercise on a Showcase listed investment opportunity.
- (ii) Play a leading role in guiding the proposed “Sister City” program between the Showcase’s hometown of Ft Lauderdale with a NZ regional port city that has an active, vibrant yachting/boating community and expresses an interest in partnering with the “world’s yachting capital”. The Showcase hometown of Ft Lauderdale.

(4) OPEN SOURCE INVESTOR-INTRO PLATFORM

As compliance with US Federal and State securities laws is a legal requirement of this planned Peer to Peer investor “Open Source” introductory service, the site will be developed in the US, built off a US sourced white-label app/solution. As this will be a unique, algorithmically driven, customizable software package it is proposed to develop this solution through a US incorporated affiliate of NZUS to facilitate a US based “seed round” to fund its launch. The NZ resident director/ambassador will play a role in this development, contributing to its functionalities from a NZ Listing Sponsors data input perspective to effectively present a Listed Emerging Growth Company’s (EGC) “Pitch Pack” to HNW American investors.

(5) OVERRIDE INCOME

The outsourced VAMS agreement will provide for a 1% override mentoring fee payable in USD’s on closing, calculated on the gross closing value of a Showcase Listed investment. USD90M is the two year FDI target, delivering USD900k in override fees.
