## Yours to Keep

Last week one of my confirmation students asked me, "why do we call this season leading up to Easter, Lent?" Before I could answer the question, one of the other students answered it for me. He said, "It's called Lent because now is the time to remember that God 'lent' us His Son." I honestly could not have answered that question any better than that. It is during this Lenten Season that we are to become more intentionally focused and appreciative of the fact that Jesus has come to us and that God loved us enough to "lend" us His Son in order for us to be reconciled to Him.

In the Book of Isaiah 55:8-9, God's Word tells us;

"For My thoughts are not your thoughts, Nor are your ways My ways," says the LORD.

9 "For as the heavens are higher than the earth, So are My ways higher than your ways, And My thoughts than your thoughts.

I don't know about you, but I for one, am grateful that God's thoughts and His ways are higher than my thoughts and actions. If I lend someone something, I expect to get it back at some point. And the same is true if I were to borrow something from you. If you were to lend me something, I'd be sure to return it to you. If I took a loan out at a bank, I guarantee you they'd expect me to make regular payments on that loan. The only exception that I can think of is chewing gum. If you were to ask me to lend you a piece of gum, trust me ... I wouldn't want it back after you chewed it. Of course, that would never happen because I hate chewing gum and never have any to lend. Anyway, the point is; loans are meant to be paid back. God's way is higher than our way because God doesn't want us to simply experience Jesus, perhaps only to "use" Him when we're in trouble or in desperate need of Divine intervention, etc. and then simply say, "thanks Lord, I appreciate all of Your help, now go back to where You came from." Unfortunately, that's the kind of relationship that a lot of people have with Christ. They simply want to borrow Him for a little while and then give Him back, so to speak.

Jesus has come to us and as we once again prepare ourselves to honor His ultimate sacrifice of love for us during Holy Week, and as we make plans to celebrate His glorious resurrection on Easter Sunday ... let us always remember that although He has ascended to back to the Father in Heaven, He is also right here with us today. His Spirit is among us. Jesus is here and He will never leave us. He lives in our hearts and in our soul, and His presence can still be felt each time we call upon Him ... and even when we don't.

God did not simply lend us His Son, He is ours to keep, now and forever. And so long as we honor Him and serve Him and commit ourselves to being His followers ... He will keep us as well.

The Lord is your keeper; the Lord is your shade at your right hand. The sun shall not strike you by day, nor the moon by night. The Lord shall preserve you from all evil. He shall preserve your soul. Psalm 121:5-7.

Stay close to the Lord and He will stay close to you.

God bless you and have a blessed Holy Week and Resurrection Sunday!

### From Liz Nash

I share with you the sad news for those who do not know that Douglas Anders, our former Conference Minister, died on Monday, March 22nd at his home in Bel-Nor (in St. Louis), Missouri. He fought a courageous battle with cancer for several years, always expressing in his email updates his faith in God no matter what the outcome. For me, Douglas was a trusted and valued colleague and friend. I had a close understanding of how hard he worked, of how engaged he was in the stewardship of our Conference's resources, of his dedicated work with leadership and committees, and of his care for the South Central Conference and all of our churches. Many people experienced his kindness and also his engagement and help when a church or a minister was in need. After he retired and moved home to St. Louis, he gave his time and gifts, even over the years of his illness, in many, many ways: as an Interim Conference Minister, as an interim and supply minister in churches, as a volunteer doing substantial work for the Missouri Mid-South Conference, and as an elected Alderperson for the City of Bel-Nor. As a measure of who he was, the city of Bel-Nor posted this on its website: "We lost a good friend, neighbor, and colleague with Douglas's death. He was a consummate gentleman who fought a courageous battle with illness but worked hard for the city and other causes as long as he was able. He will be sorely missed." Douglas will be missed indeed. Let us commend him to God and give thanks for his life with us, with those he served, and now for his life surrounded by God's love without measure.


Pastor Darrin and wife Kim enjoyed cake after the installation on Palm Sunday. They were installed by Council President Dean Fuchs.

#### St. John's United Church of Christ Council Meeting January 19, 2021

The meeting was called to order by President Dean Fuchs at 6:00 p.m. and prayer was given by Pastor Darrin Holub.

#### **Interim Council Member:**

After recognizing our late Carol Montgomery's faithful service as Council member, Dean Fuchs asked for the attending Council members to accept Blake Emmett as an interim Council member, replacing Carol for her one remaining year term. All unanimously agreed.

#### **Individuals Present:**

**Council Members** –Dean Fuchs, Clyde Engelbrecht, Tracy Matthies, Nikki Harmel, Blake Emmett, Jodell Hodde, James Press, Jeff Krolczyk and Bill Comiskey

Individuals – Pastor Darrin Holub and Larry Winkelmann

#### **Minutes from Previous Meeting:**

James Press asked for any concerns with the December, 2020 minutes previously distributed for review. A few minor comments via email prior to the meeting were incorporated. Bill Comiskey made a motion to accept the minutes as presented. The motion was seconded by Clyde Engelbrecht; the motion passed unanimously.

#### **Treasurers' Reports**

#### Treasurer's Report (Operational):

Ann Pape had provided the report previously via email. Bill Comiskey noted that we finished the year \$748.52 surplus over budget—a commendable achievement for this trying year. All financial reports will be approved together at the bottom of the Investment Report.

#### Treasurer's Report (Non-Operational):

Larry Winkelmann provided a copy of the September investment report to all council members. As of December 31st, 2020, the Investments report shows the current CD balance is \$117,400.17, unchanged from last month's report. The Savings balance is \$133,643.43 and the additional church funds remain at \$18,041.78. The Charity Reserve fund remains \$15,648.40 as reported last month. A motion was made by Jeff Krolczyk to approve all the above financials as submitted; the motion was seconded by Tracy Matthies. The motion was approved unanimously.

#### **Reports Previously Submitted:**

Charity Reserve — Clyde Engelbrecht: The stock market continued to do well this period, so our Moderate Balanced Funds' market value has increased from \$1.11M to \$1.15M. Our Fixed Income Fund increased from \$355.5k to \$356.7k. We have an account balance in Burton State Bank of \$40.95k. The Charity Reserve Committee moved that the Church Council approve withdrawing \$75k from the Moderate Balanced Fund and deposit same into a new Burton State Bank CD to assure that funds are available to our 2021 charity distributions. The motion was seconded by Nikki Harmel; the motion was unanimously approved.

**Christian Education** – Christy Moran submitted her report to all council members prior to the meeting: There were no questions or comments to her report; therefore, no action was required by Church Council.

**Pastor** – Darrin Holub: We will have our customary Lenten and Easter services with one exception—will have our Ash Wednesday service, but we will forgo the putting on of the ashes this year to avoid the personal touching and proximity.

Committee on Ministry—Pastor Darrin has volunteered to serve three more years on the Committee on Ministry, an oversight committee for all our churches in our association. This exposure will give our pastor insight into happenings and procedures in the wider Church. Internet Service—We will be replacing our Rise Broadband wifi internet access with Zoch Net—a free service which only requires us to purchase two wireless routers and installation fee totaling \$183. We will have a baptismal service on February 14<sup>th</sup>.

**Worship Attendence**—All are encouraged to work on improving our worship attendance as we progress toward "normalcy" from the pandemic.

**Break Bread**—The Council decided to reinstate Break Bread on 5<sup>th</sup> Sundays beginning Sunday, January 31<sup>st</sup>.

**Congregation Annual Meeting**—The congregational Annual Meeting will be held just after the 10:00 AM worship service on January 24, 2021

#### **Old Business:**

**Church Insurance**—Dean Fuchs has initiated a new insurance policy for the church through Wellmann Insurance, per last month's Council approval. The cost is about the same as our past Church Mutual policy, with some additions in coverages included.

**Financial Audit**—Our financial books were audited, with no discrepancies noted.

#### **New Business:**

Scholarship Committee—The Glen and Dottie Schoeneberg Scholarship Committee has worked extremely hard to develop revised and improved mission statement, guidelines and scholarship application form. These documents define in much more detail and clarity what this Scholarship program is, its objective, how it is funded and why it was so important to Glen and Dottie. This program is something this church can be proud to sponsor.

**Texas Sanitizing Pro's**—This business does free sanitizing service for churches and schools. They have volunteered to service our church. Dean will look into the details of their services.

Memorial Tree Planting—Along with Bootsie Huebner's substantial gift to the church, he had a request to plant a pecan tree on the church property. The Council would like to replace the large redbud tree in Bootsie's honor. This redbud tree recently collapsed and had to be removed. Dean will see if this redbud tree would be an acceptable substitution for Bootsie's pecan tree request.

Ongoing Church Activities—As we gradually recover from the pandemic, a few church activities may be appropriate to re-start in the near future, e.g., September Homecoming fundraiser and Family Day in May. Discussions were started to get committees organized in the very near future.

**Church Council Annual Meal**—This year's meal will be held at JW's Steakhouse on February 9<sup>th</sup> at 6:00 PM.

#### **Spiritual Time:**

Pastor Darrin—Philippians 4:4-7. These verses tell us to look for simple answers to everyday problems. Life can be a very complex journey unless you share your burden with the Lord. With His help the simple answers can become clear to us.

#### Next Council Meeting: Tuesday, February 16, 2021.

A motion to adjourn was made by Bill Comiskey and seconded by Tracy Matthies; the motion passed unanimously. The meeting closed by reciting The Lord's Prayer.
