St. John's Council Meeting
May 12, 2021

The meeting was opened by President Dean Fuchs at 6:00 p.m. with a prayer by Pastor Holub.

Individuals Present:

Council Members – Dean Fuchs, Jodell Hodde, Mark Klaus, Sam Hodde, Mike Clyde, Nikki Harmel, Blake Emmett

Individuals – Pastor Darrin Holub, Larry Winkelmann

Call to Order and Opening Prayer – The meeting was called to order by President Dean Fuchs at 6:00 p.m. and a prayer was given by Pastor Darrin Holub.

Minutes from Previous Meeting – The minutes were discussed from the April 14, 2021 regular Council meeting. A motion was made by Mike Clyde to approve the minutes as submitted, with a second by Mark Klaus. The motion was approved unanimously.

Treasurer's Report (April 2021) – The treasurer's report was reviewed and discussed. Nikki Harmel commented that the contributions to date from this same period in 2019 (skipping over the Covid influenced 2020 year) was quite close to our current contributions for this year. Dean Fuchs commented that the budget for the Audio/Video/Web Hosting was running high, and that he would do some investigation on that matter. There were no other substantial comments.

Investment Report – The investment report had been previously submitted for Council review. Larry Winkelmann commented that several of the CD investments had paid interest. He discussed with the Council in which accounts the various interest payments had been deposited. Mr. Winkelmann further reported that the Memorials Committee had convened and had made contact with the various families who had memorial contributions in excess of \$500, the policy of the Church and committee being that such memorial contributions could be dedicated to specific projects at the request of the family. Mr. Winkelmann then reported that the Scholarship Committee for the "Glen and Dottie Schoeneberg Scholarship" had met, reviewed 15 applications, and had decided to award \$1,500 to ten of the applicants. The names of the applicants, and their future plans, are to be noted in an upcoming Church newsletter. As a final note, Mr. Winkelmann then informed the Council that Steve Miller had retired from being in charge of the kitchen fund, and had returned all the associated information and various credit cards. Pastor Holub said that he would continue with the ordering of supplies for the kitchen fund.

At this time, Nikki Harmel made a motion to approve both the Treasurer's report and the Investment report. The motion was seconded by Jodell Hodde, and was approved unanimously.

Review of Reports Previously Submitted – Information previously submitted was supplemented with the following.

Worship Committee – Pastor Holub stated that the Worship Committee would be meeting May 23.

Christian Education Report – Through a previously submitted email, Tracy Matthies stated that there would be a Vacation Bible School kick-off swim party at the Blue Bell Aquatic Center on July 25.

Pastor's Report/Maintenance Report – Pastor Holub stated that the Church welcomed Samantha Gandy as a new member on the preceding Sunday. He further stated that there have been several new visitors coming to Sunday service. He then stated that confirmation was nearing completion with 8 students, and that he was extremely proud of this year's class. There was then a brief discussion on the procedure for accepting contributions at the Sunday service regarding passing the plate or leaving the plate at a specific location. At this time, it was agreed to leave the plates at the back of the Church rather than returning to passing the plate.

Regarding maintenance, Pastor Holub reported that maintenance was needed on the AC unit serving the office, and was further informed by the repair personnel that this unit was in poor condition. He further reported that the water heater had gone out at the parsonage, and he requested a procedure from the Council as to how to properly proceed with the repair.

Old Business

Break Bread Recommendation – Mike Clyde stated that there has been much discussion on returning to break bread lunches. The current plan is to start again in June. People have volunteered to help for June, July, and August. There is still a need for future helpers to keep the event going.

New Business

Credit Cards associated with the Kitchen Fund – Dean Fuchs stated that he would either change the names on the credit cards (due to Steve Miller's retirement), or cancel the cards.

Name Removal from bank account – As a result of Steve Miller's retirement from the Kitchen Fund, his name needs to be removed from the bank account, and replaced with Pastor Holub. A motion to this affect was made by Nikki Harmel, seconded by Jodell Hodde, and passed unanimously.

Tables for the FLC/Turkey Dinner – Dean Fuchs reported that he had received a request from the Turkey Dinner committee chairman for four 4 foot tables to be used in preparation of the annual turkey dinner. A motion to purchase said tables was made by Blake Emmett, seconded by Mike Clyde, and passed unanimously.

Church Secretary Position – Dean Fuchs reported that the committee for hiring a new Church secretary had met with a promising candidate, held an interview, and said candidate, Linda Conley, had accepted the position. A motion was made by Nikki Harmel to hire Linda Conley as new Church secretary, effective May 25, at the present salary structure. The motion was seconded by Jodell Hodde, and passed unanimously.

Spiritual Reflection - Pastor Darrin discussed how at both Christmas and Easter, he always looks forward to a simple gift (actually a nice ball point pen) that he receives each year. He discussed how this gift is freely given each year. Relating this to God comes through Lamentations 22 and 23, which discusses how God gives us a gift every day. He is always with us and beside us. For that we are truly blessed.

Adjournment/Lord's Prayer:

A motion to adjourn was made by Nikki Harmel, with a second by Jodell Hodde. The motion was approved unanimously. The meeting was adjourned at 6:59 with the Lord's Prayer.

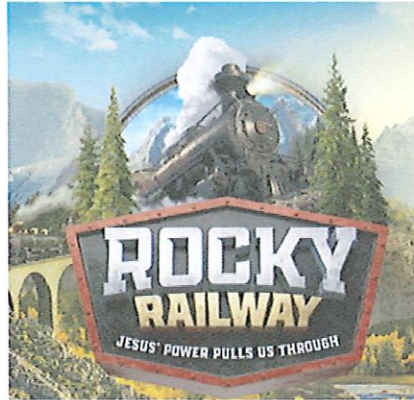

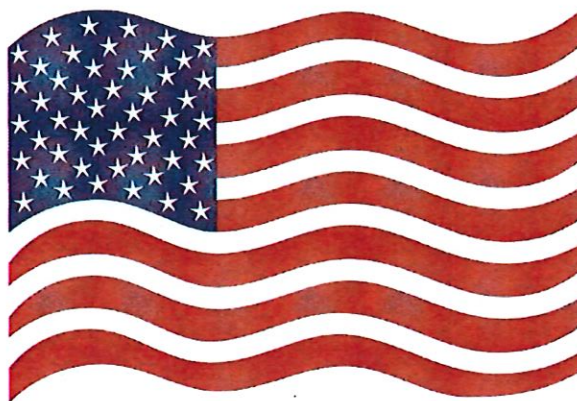

Subject: Burton Bridge Ministry announces COVID-19 vaccine event

The highly transmissible Delta variant of the coronavirus, first identified in India, has become the dominant strain in the United Kingdom and has been reported in Houston. The Washington County SubHUB closed in May 2021 but only half of eligible Texans have been fully vaccinated. For those still wishing to get vaccinated, Bridge Ministry of Burton Texas has arranged for the Brazos County Health District to bring its Brazos Valley Mobile Action Team (BVMAT) to administer a vaccine clinic on Friday, July 16, 2021.

“The date coincides with our senior meal program, where those who are 55+ gather for fellowship, games and a hot meal in the Family Life Center at St. John’s United Church of Christ,” says Susie Tommaney, Burton Bridge Ministry’s executive director. “It’s also the same day we see clients from all over Washington County who will be visiting for our monthly mobile food pantry.”

Reservations are requested but not required for the two-dose Pfizer-BioNTech COVID-19 vaccine. The second shot will be administered on Thursday, August 5. Identification is not required.

As of Wednesday, May 12, 2021, everyone 12 years old and older is now eligible to receive a COVID-19 vaccine in Texas. Minors wishing to be vaccinated will need to be accompanied by a parent or guardian.

The Pfizer-BioNTech COVID-19 vaccine is administered as a two-dose series, three weeks apart, into the muscle. Brazos Valley Health is offering the Pfizer-BioNTech COVID-19 Vaccine to prevent Coronavirus Disease 2019 (COVID-19) caused by SARS-CoV-2.

The Brazos County Health District is not affiliated with the Washington County EMS or its SubHub.

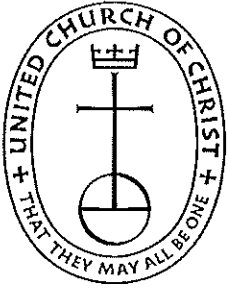
