## **Village of Wayne** Regular Council Meeting JANUARY 20<sup>TH</sup>, 2021

The meeting was brought to order by Mayor Everett and the pledge of allegiance was said. Roll call was read: Bechstein present, Zeigler present, Gross present, Morlock present, Lee present, and Wildman present. Gross moved and Lee second to approve the minutes as read. All yeah, M/C. Lee moved and Zeigler second to turn all bills over to finance and to pay all those found favorable. All yeah, M/C.

Police Chief Matt Herrig reported that will be resigning as chief as of Feb. 28, 2021. Mr. Herrig has accepted the Chief's position at Genoa and unable to do both jobs. The air pacs, face shields, etc. for the FEMA grant have been ordered however looking at March/April before delivered. Mayor reported has not contact Mrs. Silverwood about joining Park Board and apologizes. Mayor reported for Joe St Clair that the trench is complete by the walking trail and able to tie into drain tile, speed limit sign is fixed, and Terry created a component for the back of the gator to drive along trial, etc. the lay stone.

Gross reported that spoke with Pastor Ron Merritt and Pastor replied will be getting in touch with church lawyer to contact Village solicitor to get things moving. Fiscal Officer reported the grills and rockers from Park Grant have been ordered.

Council approved the board members for the 2021 Ohio Fire Fighter's Dependent Fund. Fiscal Officer will contact everyone from 2020 to make sure would like to serve on the board again this year.
