## Village of Wayne

Regular Council Meeting JUNE 16<sup>TH</sup>, 2021

The meeting was brought to order by Mayor Everett and the pledge of allegiance was said. Roll call was read: Bechstein present, Gross absent, Morlock absent, Lee present, Vandersall present, and Wildman present. Lee moved and Bechstein second to approve the minutes as read. All yeah, M/C. Lee moved and Vandersall second to turn all bills over to finance and to pay all those found favorable. All yeah, M/C.

A couple of village residents can to council to look at the map for the detention pond.

Wayne Welcoming Society is trying to get food trucks to come to the park on Fridays. Mayor reports Joe and Terry have the southside of the park cleaned up, the juveniles that broke into concession stand will be doing their community service project this weekend, and the ball diamonds lights are working again. Council discussed about the semi-trucks being routed through town are becoming a safety hazard and more police presence is needed.

Lee moved and Bechstein second to approve Ordinance 6-21-736: Street Lighting Assessment for 2022 \$14,000. Council tabled the 2022 Estimated Revenues until next meeting. Mayor reported that Mr. Hammer and Mr. Speweick are working to complete the detention pond property transaction. Mayor also reported waiting to hear back from the county to see who should maintain the ditch bank.

B. Hillz street sweeping is currently not available. Vandersall will investigate other street sweeping companies. Vandersall suggested cleaning quarterly and council discussed switching from ice control to salt to reduce gravel on the streets and plugging storm drains. Building a salt shed is an option or purchasing a used street sweeper. Mayor is researching electric rates for the town properties.

Lee moved and Bechstein second to waive the third reading rule. All yeah, M/C. Lee moved and Vandersall second to approve Emergency Resolution 6-21-712: Increasing appropriations for Tax Refunds (increase of \$2500) in General Fund and Water Loan Fund (increase of \$0.50). All yeah, M/C. Mayor and council discussed and agreed to the Schoolhouse property surveyed and surveyors are being investigated for price. Vandersall moved and Lee second to approve having Schoolhouse property surveyed. All yeah, M/C.

1<sup>st</sup> reading Ordinance 7-21-737: Authorizing Lot Combination. 1<sup>st</sup> reading Resolution 7-21-713: Authorizing the Mayor to enter into a Memorandum of understanding with New hope Christian Church. Wildman reported Gross got quotes about surveillance equipment for the park, village building, and fire hall. The total for all the quotes is \$21,500. Park restroom and concession stand will be the main focus due to recent vandalism. The walking trail has weeds coming through it and Mayor will contact Morlock Asphalt.
