

Village of Wayne
Regular Council Meeting
JUNE 2ND, 2021

The meeting was brought to order by Mayor Everett and the pledge of allegiance was said. Roll call was read: Bechstein present, Gross present, Morlock absent, Lee present, Vandersall present, and Wildman present. Lee moved and Wildman second to approve the minutes as read. All yeah, M/C. Lee moved and Bechstein second to turn all bills over to finance and to pay all those found favorable. All yeah, M/C.

Chief Todd Mocniak reported that old cruiser has been picked up, the 2 new body cameras are in and working, and code enforcement going fairly well. Chief and council discussed concession stand break in and community service for the juveniles. Chief will contact the parents with the dates agreed on June 19, 2021 from 1pm to 5pm with rain date June 26, 2021.

Mayor reported for Joe and Terry. Joe and Terry have been repainting the parking lines uptown and tree trimmed around the street signs before the detour comes thru. The street grates are all cleaned, still waiting on use of street sweeper, and 2/3 of the mulberry trees, etc. in the park are taken care off. Terry has also been working on the park benches and bathrooms. Wildman mentioned the canon garden will need some attention as well.

Fiscal Officer reported that the SCBA's for the FEMA grant have been paid. The bill came under the original bid so, Fire Chief looking into individual carrying bags for each member for their masks, other equipment, etc. to finish up the FEMA grant.

Lee moved and Wildman second to pass Ordinance 5-21-735: Income deadline amend to May 17, 2021 for 2020. All yeah, M/C. Had 2nd reading Ordinance 6-21-736: Street Lighting Assessment for 2022 \$14,000. Fiscal Officer talked about the OBM webinar update for the American Rescue Act. There is 151 pages out on what the money can be used for, there are some area that are still grey (not much detail), focuses on internet, broadband, water, sewer, etc. Fiscal Officer has not had a chance to go thru the 151 pages, not sure when the money will be released to village, however should be coming thru the county like the Cares Act did, and no specifics on what amount the village is actually receiving. The village does have until December 31, 2024 to spend the American Rescue Act money so have time to go thru all the details and come up with various ways to spend the money wisely.

Mayor reported that Memorial Day Ceremony went very well. Channel 11 News taped the Memorial Service and is up on the Village Facebook page. Gross asked about a drainage update. The properties are now in the churches name however, have not heard from solicitor on current updates. Gross also discussed about looking at video camera system for the park due to the recent incident to monitor break in problems, vandalism, etc. Gross has a contact and will be getting pricing, etc. for the camera system.

Vandersall moved and Bechstein moved to accept the financial statement for May 31, 2021. All yeah, M/C. Fiscal Officer sent out the Estimated Revenues for 2022 to give time for council to review them. Bechstein reported Little League having some electrical issues with the lights/scoreboard.

No further business, Gross moved and Vandersall second to adjourn. All yeah, M/C.
