Morlock and Lee second to pass Emergency Resolution 8-20-705: Amending the 2020 Appropriation for COVID Fund, FEMA Fund, etc. All yeah, M/C. Lee moved and Wildman second to pass Emergency Ordinance 8-20-733: Adopt & Enact the 2020 replacement pages to the codified ordinances. All yeah, M/C.

Mayor brought up about an online class: Reimaging Streets as Places. It is a 3-week online class, costs \$500 with scholarship available for \$450. Lee asked about trimming a few branches of a tree on E. Main blocking a stop sign and Halloween. Wayne Welcoming Society is waiting on guidance from the Governor office on Halloween, etc.
