Regular Council Meeting  
SEPTEMBER 2<sup>ND</sup>, 2020

The meeting was brought to order by Mayor Everett and the pledge of allegiance was said. Roll call was read: Bechstein present, Zeigler absent, Gross present, Morlock absent, Lee present, and Wildman present. Bechstein moved and Lee second to approve the minutes as read. All yeah, M/C. Lee moved and Gross second to turn all bills over to finance and to pay all those found favorable. All yeah, M/C.

Wildman moved and Bechstein second to approve Mayor to sign grant once final is completed and submit to the Wood County. All yeah, M/C. Zoning letters will be mailed out Thursday latest Friday. Mayor discussed the letter drawn up by solicitor about a property owner on Railroad St. dumping dirt/building up property. The letter was a cease and desist and property owner had to remove the dirt that was dumped. Wayne police officer delivered the letter, no one home so left in mail box, and will be sending another copy certified mail this week.

Bechstein moved and Lee second to approve the financial report for Aug. 31, 2020. All yeah, M/C. Mayor and Fiscal Officer received notice from Wood County about a round 2 of COVID money and looking around \$8,394.00 (half of the original amount). Council discussed and Fiscal Officer will email the auditor in the morning to accept the second round of COVID money.

Wildman asked on behalf of her brother about planting a Memorial tree or placing a bench around the walking trail in memory of Stephanie Ach. Gross moved and Lee second to accept the donation and including Wildman, Joe, and Mayor on tree selection, placement, etc. All yeah, M/C. Fiscal Officer will get with Joe on adding a reflective strip to the stop sign on St. Rt. 281/W. Main and trimming tree limbs back as well.

No further business, Lee moved and Wildman second to adjourn. All yeah, M/C.
