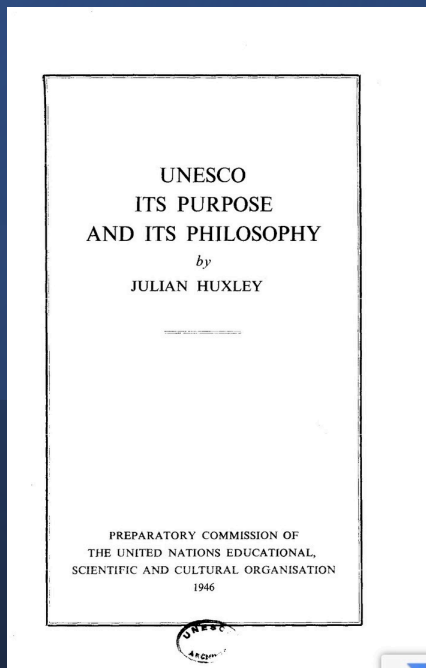

What is the governing ideology? UNESCO 1946 Julian Huxley



So much for what Unesco cannot or should not adopt in the way of philosophies or guiding principle. Now for the positive side. Its main concern is with peace and security and with human welfare, in so far as they can be subserved by the educational and scientific and cultural relations of the peoples of the world. Accordingly its outlook must, it seems, be based on some form of humanism. Further, that humanism must clearly be a world humanism, both in the sense of seeking to bring in all the peoples of the world, and of treating all peoples and all individuals within each people as equals in terms of human dignity, mutual respect, and educational opportunity. It must also be a scientific humanism, in the sense that

Two obvious corollaries follow. First, that the more united man's tradition becomes, the more rapid will be the possibility of progress: several separate or competing or even mutually hostile pools of tradition cannot possibly be so efficient as a single pool common to all mankind. And secondly, that the best and only certain way of securing this will be through political unification. As history shows, unifying ideas *can* exert an effect across national boundaries. But, as history makes equally evident, that effect is a partial one and never wholly offsets the opportunities for conflict provided by the existence of separate sovereign political units.

deal towards promoting peace and security. Specifically, in its educational programme it can stress the ultimate need for world political unity and familiarise all peoples with the implications of the transfer of full sovereignty from separate nations to a world organi-

Unesco also can and should promote the growth of international contacts, international organisations, and actual international achievements, which will offer increasing resistance to the forces making for division and conflict. In particular, it can both on its own account and in close relation with other U.N. agencies such as the F.A.O. and the World Health Organisation, promote the international application of science to human welfare. As the benefits of such world-scale collaboration become plain (which will speedily be the case in relation to the food and health of mankind) it will become increasingly more difficult for any nation to destroy them by resorting to isolationism or to war.

The U.N.'s War Against The West

The United Nations is actively supporting armed warfare and revolution by directly funding three Soviet-backed "national liberation movements" and one guerrilla group sponsored by the People's Republic of China (PRC). These are, respectively, the Palestine Liberation Organization (PLO) in the Middle East; the African National Congress (ANC), the South West African People's Organization (SWAPO) and the Pan Africanist Congress (PAC). The latter three groups are staging guerrilla and terrorist warfare in southern Africa. In Central America, Honduran refugee camps are also being used to aid Marxist guerrillas attacking the government of El Salvador.

This is not a new policy for the U.N. The Marxist governments of Angola, Mozambique and the new Socialist regime of Robert Mugabe in Zimbabwe were all aided by the United Nations when they were guerrilla revolutionary movements fighting in the bush. Since 1975, the United Nations has given at least \$133 million in direct aid to armed revolutionary movements, most of them Marxist.

While cash and services are helpful, it is only part of the U.N. largess. The PLO, for example, not only controlled the United Nations Relief Works Agency (UNRWA) refugee camps in Lebanon but turned them into "military bastions." That is the phrase used by the Lebanese ambassador to the U.N., Edward Ghorra, in his letter to U.N. Secretary General Kurt Waldheim in 1976.

Ghorra attached an additional letter

UNRWA has an annual budget of \$200 million for Palestinian refugee camps located throughout the Middle East. The budget for these camps in Lebanon is \$20 million a year.

"international staff" of UNRWA's 17,000 worldwide employees are Palestinians. This situation was described by John Miles of UNRWA's New York office to this reporter in an interview. Since Palestinians nearly dominate UNRWA, U.N. monitoring of military activity in the UNRWA refugee camps becomes almost impossible.

U.N. funding of national liberation movements has paid for food, housing, basic education, professional training, health services and medicines, legal fees, radio broadcasting, agricultural projects, communal farms and refugee relief.

The Israeli invasion of Lebanon in 1982 proved that U.N. facilities like the Sibilin Training Center near Beirut were used for PLO military recruits. PLO documents captured by the Israelis after the invasion also confirmed that the PLO used intelligence reports of the U.N. International Force in Lebanon (UNIFIL), the U.N. peace-keeping contingent, to monitor Israeli troop movements. The documents were dated May 26, 1981.

Another fringe benefit for the PLO from the U.N. is that all but 120

Let Unesco have a clear mind on this subject. Quantity is of importance—but as a means, a foundation for quality. It is true that one could not carry on a high modern civilisation in a population the size of a bushman tribe, any more than life could evolve the mental powers of a higher mammal in an organism the size of an amoeba. There is, however, an optimum range of size

that eugenics should be brought entirely within the borders of science, for, as already indicated, in the not very remote future the problem of improving the average quality of human beings is likely to become urgent ; and this can only be accomplished by applying the findings of a truly scientific eugenics.

application of medical science may increase the number of human beings in a given area but lower their quality or their opportunities for enjoyment of life : and if so, in the light of our basic criterion of evolutionary direction, it is wrong. We are brought by a new route to realise once more the need for a Unesco policy balanced between many fields—in this instance, Unesco policy would have to include, besides the application of medical science, studies on agricultural productivity (soil erosion, mechanisation, etc.) and on social welfare, and also the provision of birth-control facilities.

8 steps to communism

- Many of the SDGs align with the 8 steps to transform a nation through socialism into communism.

Goal 1: End Poverty in All It's Forms



They say“ By 2030, ensure that all men and women, in particular the poor and the vulnerable, have equal rights to economic resources, as well as access to basic services, ownership and control over land and other forms of property, inheritance, natural resources, appropriate new technology and financial services, including microfinance”

Conservatives realize that poverty is apart of the human condition. There is no way to eliminate it. Only lessen it. You can't force people to work and have a sharing economy without full elimination of freedom and private property rights.

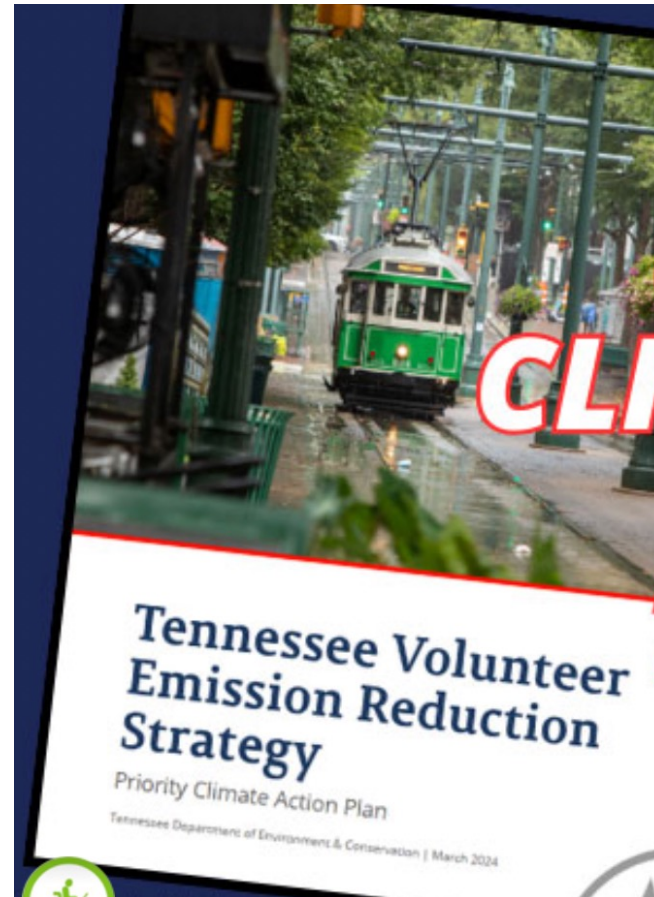
In CA this meant reparations from people who were never slave owners to people who were never slaves.

Executive Summary

On August 16, 2022, President Biden signed the Inflation Reduction Act into law, marking the most significant action Congress has taken on clean energy and climate change in the nation's history. With the stroke of his pen, the President redefined American leadership in confronting the existential threat of the climate crisis and set forth a new era of American innovation and ingenuity to lower consumer costs and drive the global clean energy economy forward.

The Inflation Reduction Act is aimed squarely at building a better America and delivering on President Biden's vision to make sure the United States—powered by American workers—remains the global leader in clean energy technology, manufacturing, and innovation. The Inflation Reduction Act's \$370 billion in investments will lower energy costs for families and small businesses, accelerate private investment in clean energy solutions in every sector of the economy and every corner of the country, strengthen supply chains for everything from critical minerals to efficient electric appliances, and create good-paying jobs and new economic opportunities for workers.

In keeping with the Biden-Harris Administration's commitment to working families, equity, and environmental justice, the Inflation Reduction Act prioritizes creating shared prosperity, making the nation more resilient to growing threats to health and well-being, and driving critical economic investments to historically underserved communities, particularly those living with legacy pollution. For several of the clean energy tax incentives, for example, the law offers bonus credits for projects that are located in economically distressed communities or traditional energy communities and for projects that meet requirements to pay the prevailing wage and hire qualified registered apprentices. The law also will advance the President's Justice40 Initiative, which commits to delivering 40 percent of the overall benefits of climate, clean energy, and related federal investments to communities that are marginalized, overburdened by pollution, and underserved by infrastructure and other basic services. Further, through an all-of-government effort, the Administration will work to ensure that investments under the Inflation Reduction Act facilitate state and local contracting opportunities for underserved small businesses.

The Inflation Reduction Act builds on the foundational climate and clean energy actions taken by the Biden-Harris Administration and investments that President Biden secured in his Bipartisan Infrastructure Law (or Infrastructure Investment and Jobs Act), signed in November of 2021. Historic in its own right, the Bipartisan Infrastructure Law provided billions of dollars to modernize the electricity grid, build a nationwide network of electric vehicle chargers, strengthen the battery supply chain, expand public transit and passenger rail, invest in new clean energy and emissions reduction technologies, improve resilience in physical and natural systems, and clean up legacy pollution in communities across the country—all while creating new, high-quality jobs, including union jobs, with good benefits and supportive services that build pathways for all to the middle class.

The Biden-Harris Administration is showing that American spirit and enterprise can alter the course of history and make people's lives better in pursuit of ambitious goals. In his first days on the job, President Biden set forth a bold climate agenda and has since vigorously advanced

THE INFLATION REDUCTION ACT WILL HELP THE U.S. MEET PARIS AGREEMENT TARGETS

MG: You mentioned that the climate provisions included in the Inflation Reduction Act could reduce emissions from the United States by 40% by 2030. How does that compare with the climate pledges the U.S. has made under the Paris Agreement?

CK: The Biden Administration has made a commitment under its NDC — or nationally determined contribution, which is a country's commitment to lower its emissions in line with Paris Agreement targets — to reduce U.S. emissions by 50-52% from 2005 levels by 2030.

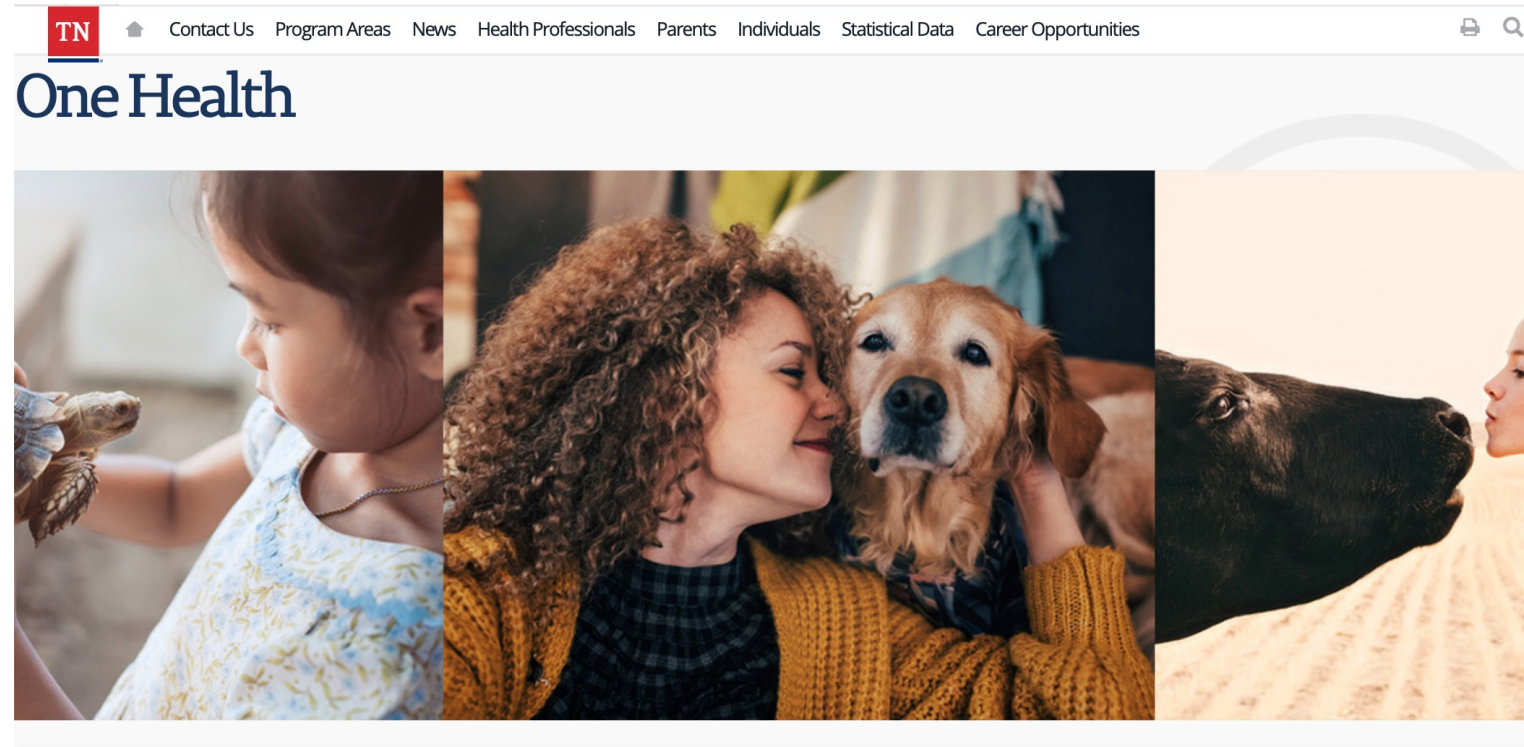

- What the UN Says “global response to global health risks, prevent deaths from air pollution, vaccines and medicine access for everyone, universal healthcare, reduce car accidents, prevention and treatment, mental health

Proponents of legislation that make public education funds available for use in the private education sector have incredible marketing slogans. "Fund students not systems" they say. The accompanying mantra that parents should be able to "take the money that belongs to them" and "choose what education is best for their child" offers hope to droves of desperate parents looking for an easy exit to an incompetent system that seems hell-bent on indoctrinating their kids. Unfortunately, those same proponents who are very vocal when it comes to the supposed benefits of ESAs and vouchers are eerily silent when it comes to being honest about the strings attached to public money and how it could be used to bring regulation into private and homeschools.

One entity who is very transparent about the strings attached to government money is UNESCO, the United Nations Educational Scientific and Cultural Organization, who's been charged with seeing the U.N.'s [Sustainable Development Goal \(SDG\) 4 \(Quality and Inclusive Education for All\)](#) through to completion by 2030.¹² This subject was addressed in a [background paper](#)¹³ commissioned for their Global Education Monitoring (GEM) Report that was highlighted in the article [The Strings of School Choice](#).¹⁴ In it, the authors lay out how public money funding private schools through school choice (and the public regulation that comes with it) can be utilized "as the main policy option to tackle education inequalities resulting from private actors' involvement in the provision of education." The paper states that the regulation of evaluation

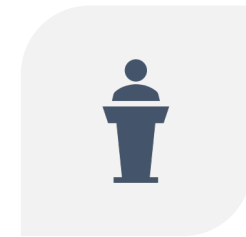

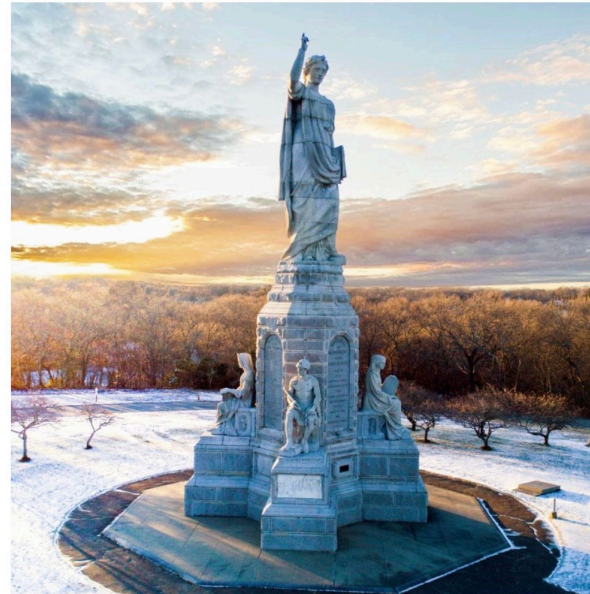

Thought to be the largest solid granite monument in the United States, this 81-foot-tall granite statue was built to honor the passengers of the [Mayflower](#). Boston sculptor Hammatt Billings designed the monument which features allegorical figures depicting the virtues of Faith, Morality, Education, Law, and Liberty. On the main pedestal stands the heroic figure of “Faith” with her right hand pointing toward heaven and her left hand clutching the Bible. A dedication on the monument reads, “National Monument to the Forefathers.”

Erected by a grateful people in remembrance of their labors, sacrifices and sufferings for the cause of civil and religious liberty.” The original design called for the monument to be nearly twice as tall at 150 feet (just under the Statue of Liberty’s height of 151 feet).

Energy in Tennessee

In 2021, the Tennessee General Assembly approved an \$884 million dollar investment in Ford's electric car megasite promising jobs.

Michigan bet billions on EV jobs and is now facing lay-offs and delays and scaling back their Ford mega-site as buyer momentum fades.

Forbes ran an article on May 9th which read "**EV Stocks Slide as Demand Slows for Tesla, Rivian and Nio.**"

The article points to;

"Tesla stock is down 30% through May 8, 2024 due to lower shipments, high vehicle prices, lack of new products, and fresh legal problems related to its self-driving software.

Rivian stock is down 51% after reporting a huge negative gross margin as the company tries to scale enough to lower its per unit

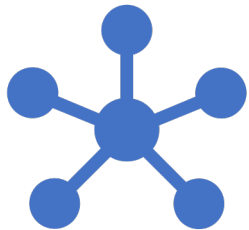

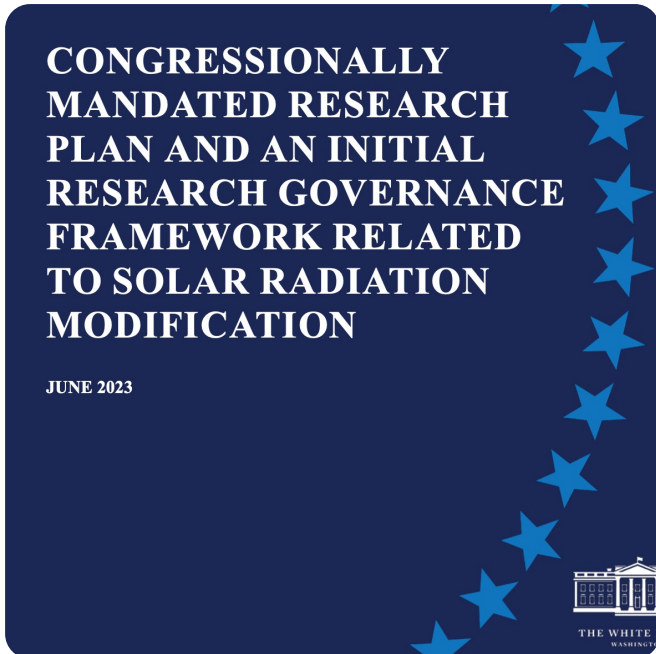
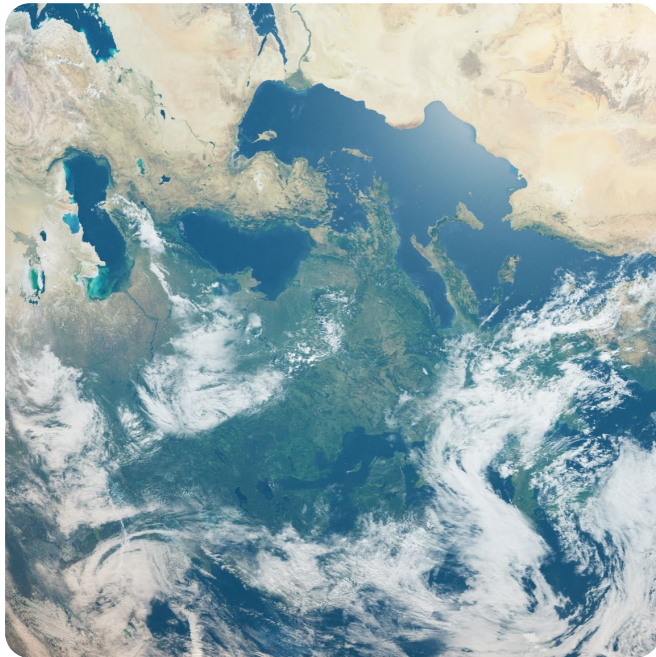

This is a good step forward in building the World Weather System to which I replighted American cooperation last June at Holy Cross College.

ia was one of 3 USA states to ban weather modification cloud seeding in 1967.

It was also in Pennsylvania that one of the first laws was passed with the intent of curbing possible harm to nature by changing the weather. In discussing the bill which became the 1967 Pennsylvania law, one of its sponsors in the House of Representatives stated: "Cloud seeding involves silver iodide, and silver iodide, Mr. Speaker, is highly poisonous. AgI used in seeding falls everywhere, on trees, on vegetation, roofs, people, and in its synergistic action joins with motor exhaust to become lead iodide. Uncontrolled automatic cloud seeding then takes place, and the area for hundreds of miles suffers inversions and drastically modified weather conditions, not to mention total pollution and toxic effects upon all fauna and flora. Pine trees, for example, are especially susceptible; they store these poisons in cold weather and release them into the atmosphere in warm weather. Dry ice, CO₂, also used in seeding, is equally dangerous, disrupting the entire ecology of the planet."

The other USA states to ban weather modification cloud seeding were Maryland and West Virginia.

CHAPTER 192 (Senate Bill 348)

AN ACT to add new Section 110A to Article 66C of the Annotated Code of Maryland (1957 Edition), title "Natural Resources", sub-title "Agriculture", to follow immediately after Section 110 thereof and to be under the new sub-heading "Cloud Seeding", to prohibit persons in the State from engaging in weather modification by means of cloud seeding or otherwise, to prohibit the use of ground generators for weather modification, both for a limited period of time and to provide for the automatic expiration of this Act.

WHEREAS, for a number of recent years farmers in parts of the State have suffered through drought conditions, which have been most severe during the last three growing seasons; and

WHEREAS, drought conditions have caused serious and irreparable financial losses to the farming community of the State; and

WHEREAS, it is the considered opinion of many persons that man-created modification of the weather is a contributing factor to recent drought conditions; and

WHEREAS, the orchardist supports weather modification by means of cloud seeding (the dropping of silver iodide particles into a cloud) and the use of ground generators in order to prevent the fall of hail, while the farmer opposes change in natural weather conditions by the above means, and the conflict between the two interests cannot be reconciled; and

WHEREAS, there is a public need for dispassionate review of cloud seeding problems so that there will be no repetition of the unfortunate incidents of violence which have occurred recently; and

WHEREAS, since responsible people have taken opposite views on this question, some action must be taken to prove or disprove one or the other of the opposing sides of cloud seeding; and

WHEREAS, a number of studies of weather control are being undertaken by the United States Congress, by other public groups and by private groups, and it is desirable to prevent further conflict until solutions can be found; now therefore,

SECTION 1. Be it enacted by the General Assembly of Maryland, That new Section 110A be and it is hereby added to Article 66C of the Annotated Code of Maryland (1957 Edition), title "Natural Resources", sub-title "Agriculture", to follow immediately after Section 110 thereof, to be under the new sub-heading "Cloud Seeding", and to read as follows:

ACT To amend Tennessee Code Annotated, Title 7, Chapter 86 and Title 58, Chapter relative to the Tennessee Emergency Management Agency and the emergency management system.

IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Title 58, Chapter 2, is amended by deleting sections 1, 5 and 6 in their entirety, and by substituting instead the following language:

PART 1

58-2-101 Definitions.

As used in this chapter, unless the context otherwise requires:

- (1) "Agency" means the Tennessee Emergency Management Agency.
- (2) "CLEO" means chief local elected official.
- (3) "Compacts" means the emergency management compacts included in Parts 4 and 7 of this chapter.
- (4) "Disaster" means any natural, technological, or civil emergency that causes damage of sufficient severity and magnitude to result in a declaration of state emergency by a county, the Governor, or the President of the United States. Disaster shall be identified by the severity of resulting damage, and follows:

(A) "Catastrophic disaster" means a disaster that will require massive state and federal assistance, including immediate military involvement.

The U.N.'s War Against The West

By THOMAS G. GULICK

The United Nations is actively supporting armed warfare and revolution by directly funding three Soviet-backed "national liberation movements" and one guerrilla group sponsored by the People's Republic of China (PRC). These are, respectively, the Palestine Liberation Organization (PLO) in the Middle East; the African National Congress (ANC), the South West African People's Organization (SWAPO) and the Pan-Africanist Congress (PAC). The latter three groups are staging guerrilla and terrorist warfare in southern Africa. In Central America, Honduran refugee camps are also being used to aid Marxist guerrillas attacking the government of El Salvador.

This is not a new policy for the U.N. The Marxist governments of Angola, Mozambique and the new Socialist regime of Robert Mugabe in Zimbabwe were all aided by the United Nations when they were guerrilla revolutionary movements fighting in the bush. Since 1975, the United Nations has given at least \$13 billion in direct aid to armed revolutionary movements, most of them Marxist.

While cash and services are helpful, it is only part of the U.N. largess. The PLO, for example, not only controlled the United Nations Relief Works Agency (UNRWA) refugee camps in Lebanon but turned them into "military bastions." That is the phrase used by the Lebanese ambassador to the U.N., Edward Ghorra, in his letter to U.N. Secretary General Kurt Waldheim in 1976.

Ghorra attached an additional letter from Lebanon's deputy prime minister in this communication to Waldheim. It documented PLO installation of "heavy weapons" in the UNRWA camps of Lebanon as early as 1969. The same letter noted that the PLO had even "occupied the UNRWA offices in the camps." Waldheim did nothing.

UNRWA has an annual budget of \$200 million for Palestinian refugee camps located throughout the Middle East. The budget for these camps in Lebanon is \$20 million a year.

"International staff" of UNRWA's 17,000 worldwide employees are Palestinians. This situation was described by John Miles of UNRWA's New York office to this reporter in an interview. Since Palestinians nearly dominate UNRWA, U.N. monitoring of military activity in the UNRWA refugee camps becomes almost impossible.

U.N. funding of national liberation movements has paid for food, housing, basic education, professional training, health services and medicines, legal fees, radio broadcasting, agricultural projects, communal farms and refugee relief.

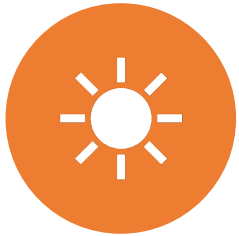
The Israeli invasion of Lebanon in 1982 proved that U.N. facilities like the Shiba Training Center near Beirut were used for PLO military recruits. PLO documents captured by the Israelis after the invasion also confirmed that the PLO used intelligence reports of the U.N. International Force in Lebanon (UNIFIL), the U.N. peace-keeping contingent, to monitor Israeli troop movements. The documents were dated May 26, 1981.

Another fringe benefit for the PLO from the U.N. is that all but 120

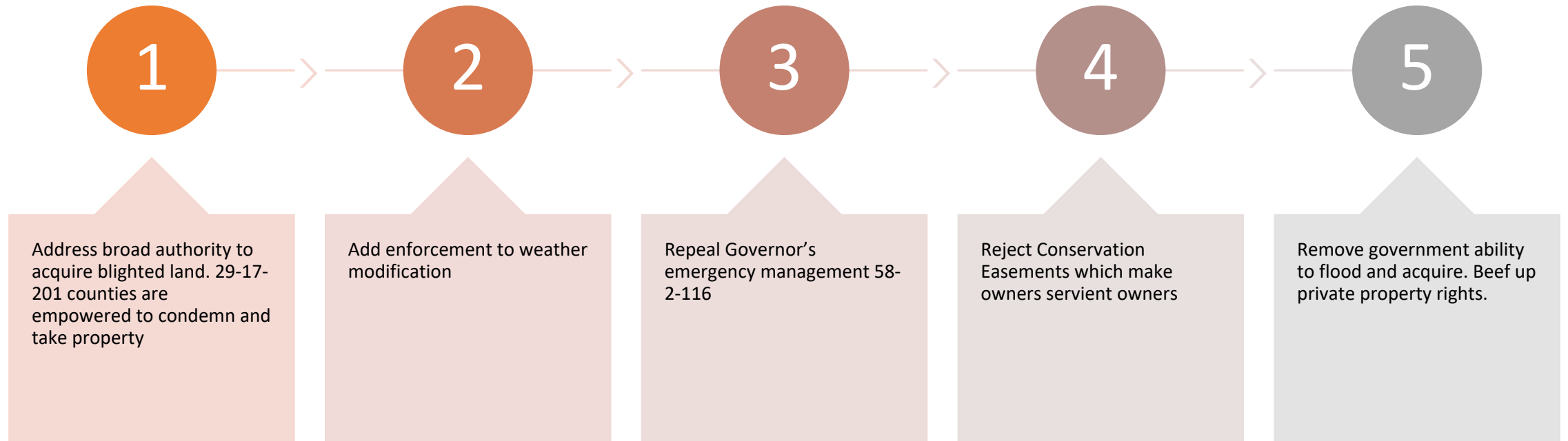

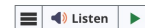

This bill authorizes the Natural Resources Conservation Service to accept contributions of nonfederal funds to support a broader range of conservation programs.

Current law authorizes the service to accept nonfederal contributions of funds to support certain programs, such as the Environmental Quality Incentives Program and the Conservation Stewardship Program. This bill expands the authority to include other conservation programs, including those that address climate change, carbon sequestration, wildlife habitat improvement, and protection of drinking water sources.

The bill also makes other changes to the administration of contributed funds, such as by allowing the service to match contributions and permitting contributors to designate funds for use in a specific program or geographic area.

USDA is using all available tools to support climate-smart practices and working lands conservation. The SUSTAINS Act, also signed into law as part of the Consolidated Appropriations Act of 2023, grants USDA the authority to accept contributions of private funds to conservation programs. USDA has taken steps to begin implementing the law. Over the next several months, USDA will seek feedback by engaging stakeholders on the best way to leverage the SUSTAINS Act through new conservation-oriented public-private partnerships.

Tennessee General Assembly Recognizes Liberty Threats

Tennessee Outlaws the UN Agenda

- **PUBLIC CHAPTER NO. 479 SENATE BILL NO. 1147**
- This state and its political subdivisions shall not adopt or implement policy recommendations that deliberately or inadvertently infringe or restrict private property rights without due process, as may be required by policy recommendations originating in, or traceable to, the United Nations or a subsidiary entity of the United Nations, including, but not limited to:
 - (1) "Agenda 21," adopted by the United Nations in 1992 at its Conference on Environment and Development;
 - (2) The 2030 Agenda for Sustainable Development, introduced at a United Nations Summit in 2015;
 - (3) The United Nations' proposal to reach net zero emissions by 2050; or
 - (4) Another international law or ancillary plan of action that contravenes the constitution of the United States or the constitution of this state.

(c) Since the United Nations has accredited and enlisted numerous non-governmental and intergovernmental organizations to assist in the implementation of its policies relative to Agenda 21, The 2030 Agenda for Sustainable Development, net zero goals for 2050, and its related plans and initiatives, this state and its political subdivisions shall not enter into an agreement, expend any sum of money, or provide financial aid to those non-governmental and intergovernmental organizations as described in or promoted by such plans and initiatives.
