The WHO and The UN

 "Where the WHO (World Health Organization) Agreement is an NGO, an unelected unaccountable non-governmental organization trying to steal authority top down through the Federal government the UN purports to steal authority bottom up through local government. Tennessee General Assembly Recognizes Liberty Threats

- The Tennessee General Assembly Recognized the UN Agenda was a threat to liberty and our form of government
- From one of the UN documents, "Governance and institutional settings. Complex governance arrangements and institutional structural rigidity can impede synergistic action and integration due to factors like overlapping authority, lack of mandate..."
- The "rigidity" of our constitution is a hindrance to their ability to accomplish mandates and wield the authority to accomplish these goals.
- The Tennessee General Assembly realized that in order to institute the UNs collectivist goals, where the end goal is a sharing economy, we couldn't have a Constitutional Republic, it would have to be socialist or communist, without individual liberty or private property rights
- Seeing as they are tasked with upholding the Constitution and these foundational principles like individual liberty and private property they put in protections against the implementation of these goals in our state in the form of law
- The UN has said that this is a global plan being enacted locally, and we have seen these SDGs sneak into city plans under the guise of the UN key words "sustainable" "equitable" "sharing economy" "green" "electric"
- We must ensure local education on this law and inform how to recognize the 17 SDGS to stop them from sneaking into our localities

Tennessee Outlaws the UN Agenda

PUBLIC CHAPTER NO. 479 SENATE BILL NO. 1147

- This state and its political subdivisions shall not adopt or implement policy recommendations that deliberately or inadvertently infringe or restrict private property rights without due process, as may be required by policy recommendations originating in, or traceable to, the United Nations or a subsidiary entity of the United Nations, including, but not limited to:
 - (1) "Agenda 21," adopted by the United Nations in 1992 at its Conference on Environment and Development;
 - (2) The 2030 Agenda for Sustainable Development, introduced at a United Nations Summit in 2015;
 - (3) The United Nations' proposal to reach net zero emissions by 2050; or
 - (4) Another international law or ancillary plan of action that contravenes the constitution of the United States or the constitution of this state.
 - (c) Since the United Nations has accredited and enlisted numerous non- governmental and intergovernmental organizations to assist in the implementation of its policies relative to Agenda 21, The 2030 Agenda for Sustainable Development, net zero goals for 2050, and its related plans and initiatives, this state and its political subdivisions shall not enter into an agreement, expend any sum of money, or provide financial aid to those non-governmental and intergovernmental organizations as described in or promoted by such plans and initiatives.

8 steps to communism

- Many of the SDGs align with the 8 steps to transform a nation through socialism into communism.
- 1. Healthcare control healthcare and you control the people.
- 2. Poverty Increase the poverty level as high as possible, poor people are easier to control and will not fight back if you provide everything for them to live.
- 3. Debt Increase the debt level to an unsustainable level. That way you are able to increase taxes and this will produce more poverty.
- 4. Gun control Remove the ability to defend themselves from government. That way you are able to create a police state.
- 5. Welfare Take control of every aspect (food, housing, income) of their lives because that will make them fully dependent on the government.
- 6. Education Take control of what people read and listen to and take control or what children learn in school.
- 7. Religion Remove belief in God from the government and schools because the people need to believe in only the government knowing what is best for the people.
- 8. Class warfare Divide the people into the wealthy and the poor. Eliminate the middle class.

- Goal 1. End poverty in all its forms everywhere. They say" By 2030, ensure that all men and women, in particular the poor and the vulnerable, have equal rights to economic resources, as well as access to basic services, ownership and control over land and other forms of property, inheritance, natural resources, appropriate new technology and financial services, including microfinance"
- Conservatives realize that poverty is apart of the human condition. There is no way to eliminate it. Only lessen it. You can't force people to work and have a sharing economy without full elimination of freedom and private property rights.
- The true goal is to reduce everyone to poverty level, step 2 in the steps to communism. Put everyone on welfare, food stamps to ration food, housing subsidies, make everyone dependent and easy to control. It is easier to lower standards than to raise them. When everyone lives at poverty level they are all "equal." Creating a welfare state is step 5 of the 8 steps to communism.
- When the UN says equal ownership and control over the land and forms of property historically that has meant wealth
 redistribution. North Korea did landowner campaigns claiming greedy landowners were the problem. It resulted in the
 murder of landowners and the distribution of their land. To this day in North Korea landowners and ancestors of them are
 punished while communists are revered.
- In CA this meant reparations from people who were never slave owners to people who were never slaves.
- What is claimed to be sustainable is not a sustainable system as it takes away the incentive for hard work by giving others what they have not worked to own. This eliminates private property rights as it steals what one worked for.
- This is a global plan not a national one so it doesn't seek just to redistribute wealth nationally but also globally. The UN calls it "global welfare" And they use climate change as the excuse for it. "Inclusive climate policies in the form of international aid, bioenergy taxes, or domestic revenue reallocation can avert the overall cost of addressing climate change in terms of global welfare (a 3.7% loss) and rather result in a 0.1% gain, at the expense of 0.5% decrease in GDP"
- What GAVI says this goal means "HEALTHY CHILDREN & FAMILIES = INCREASED PROSPERITY Immunisation provides a platform for delivering nutrition interventions and work hand in hand with good nutrition to help reduce child mortality. Vaccine-preventable diseases could tip children into a malnourished state as they impair the absorption of essential nutrients. Malnourished children are more likely to die from infectious diseases such as diarrhoea, measles and pneumonia, many of which can be prevented by vaccines."
- However, it was clean water and sanitation that helped first world countries fight such diseases. Just look at CA homeless who
 brought back Typhus. Vaccines are not the savior they claim and this looks to mandate liability free high ROI products without
 choice. See end for comment on vaccine issues.

- Goal 2. End hunger, achieve food security and improved nutrition and promote sustainable agriculture What the UN Says "promote access to and fair and equitable sharing of benefits arising from the utilization of genetic resources and associated traditional knowledge, as internationally agreed 2.a Increase investment, including through enhanced international cooperation, in rural infrastructure, agricultural research and extension services, technology development and plant and livestock gene banks in order to enhance agricultural productive capacity in developing countries, in particular least developed countries"
- What is hunger? Is it two meals a day? 1? It is important to define.
- Again when saying shared they mean "redistribution and control" In the Soviet Union under collectivization the peasantry were forced to give up their individual farms and join large collective farms. This led to millions starving to death.
- Free-market and our form of capitalist government work through decentralized controls and answering consumer concern and demand. Collectivization obliterates competition, regulates to death, and centralizes controls, resulting in shortages.
- When they say technology, genetic resources and sustainable they mean genetically modified, printed, lab-made, human-engineered food instead of natural organic God-made food. Somehow they claim lab-made is more green than a pasture. And neglect the implications of removing cows from an ecosystem, claiming their flatulence ruins the ozone despite it being part of the ecosystem.
- Genetically modified food, just like genetically modified anything, comes with negative implications. Not as nutritious. Pesticides used. MRNA vaccinated with no testing for mutagenic effects. Some meats are being grown off of tumor cells because they easily replicate. But what about the cancer implications.
- What GAVI says "IMMUNISATION + NUTRITION = HEALTHIER FAMILIES Immunisation and good nutrition go hand in hand. Vaccine-preventable diseases often tip marginally nourished children into a malnourished state. Malnourished children are more likely to die from infectious diseases such as diarrhoea, measles and pneumonia, many of which can be prevented by vaccines."
- Again sanitation and clean water are the big heroes of the 21st century. Not liability free products that produce a 20:1 ROI



- Goal 3. Ensure healthy lives and promote well-being for all at all ages What the UN Says "global response to global health risks, prevent deaths from air pollution, vaccines and medicine access for everyone, universal healthcare, reduce car accidents, prevention and treatment, mental health
- During COVID UN and WHO rather than discussing addressing metabolic disorders like obesity which
 led to worse health outcomes, the answer to health was lockdowns, don't see your loved ones, wear a
 mask to the table then take it off to eat, mandated vaccines and masks, compliance or job loss,
 punishing Doctors who disagreed with the narrative, punished Doctors for early treatment, resulting in
 increases of drug use, suicide and depression
- It meant infringements on rights to move about freely, to your ability to work to provide for your family, it eroded God-given rights as government branches worked outside of their delegated authority
- When they say universal healthcare it is socialism and control. Their One Health initiative equates humans to the same value of plants and animals. Disposable. It is a humanist worldview rather than a Biblical one where man is made in God's image.
- What they mean by vaccine and medicine access is Pharma's access to you via mandates and forced compliance. What they mean by prevention is vaccination. Push 100+ on children and heavily medicate them. What they mean by mental health is profiling and control. What they mean by global response is ignoring state and individual sovereignty What they mean by prevent deaths from air pollution is net zero agenda and carbon credits
- Ultimately people have the right to govern themselves, if they want to eat bacon they can eat bacon, when an NGO is saying they will make you healthy, you no longer have freedom
 - What GAVI says IMMUNISATION = HEALTHY LIVES & WELL-BEING "Immunisation is one of the most costeffective ways to save lives and promote good health and well-being. Every year, vaccines save 2-3 million lives, and millions more are protected from disease and disability. It routinely reaches more households than any other health service and brings communities into regular contact with the health system. This provides an effective platform to deliver other primary health care services and upon which to build universal health coverage."
- UNICEF was found to put HCG sterilizing hormones in their third world program vaccines. Why is this GAVIs
 focus on every SDG? The US has vaccines and has a deplorable infant mortality rate. Japan stopped making
 children before three have them and they have the best in the world. More on vaccines at end.



Goal 4. Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all

- What the UN Says "By 2030, ensure that all learners acquire the knowledge and skills needed to promote sustainable development, including, among others, through education for sustainable development and sustainable lifestyles, human rights, gender equality, promotion of a culture of peace and non-violence, global citizenship and appreciation of cultural diversity and of culture's contribution to sustainable development"
- What they mean is quality indoctrination into their Marxist/humanist ideology where man is the problem and the solution is fewer of us which is the opposite to a biblical worldview that says "be fruitful and multiply." They say there are many genders. Biblical worldview says there are men and women. They say people are the plague. God says we are made in His image. God says we are to have dominion over the Earth. They say we are the problem on Earth. When they say "sustainable lifestyles" they mean family planning, abortion, sterilizations, promoting trans gender surgeries that render children sterile, and promoting non-traditional lifestyles that won't be having children. What they mean by global citizenship is rejecting state sovereignty and decentralized government in favor of centralized global power.
- They look to teach a false history and dumb down the education system to provide "workers not thinkers" like Rockefeller wanted
- What GAVI says "VACCINES = IMPROVED LEARNING Immunisation increases educational attainment since
 vaccinated children learn more while they are able to go to school and perform better, positively impacting on
 cognitive development as well as long-term productivity. Moreover, schools are a platform for health promotion,
 delivery of vaccines and other health services. The benefits flow both ways: children of educated parents have a
 greater chance of being immunised and well-nourished and thus enjoy better health." California gives lots of
 vaccines and did away with exemptions yet they rank one of the last for education in the nation.

- "Education is thus a most power ally of humanism, and every public school is a school of humanism. What can the theistic Sunday school, meeting for an hour once a week, and teaching only a fraction of the children, do to stem the tide of a five-day program of humanistic teachings?"

Goal 5. Achieve gender equality and empower all women and girls

- The feminist movement was a way to destabilize the traditional family. Telling women that empowerment meant working out of the home meant they weren't raising their families with traditional values. They were allowing government schools to indoctrinate them. The women of the workplace movement also told women empowerment meant having multiple sexual partners which results in an increase in sexually transmitted diseases which can also lead to infertility. Or putting off marriage and potentially children.
- Now Gender Equality also means trans equality. And that also leads to sterility when young
 people choose to chop off their body parts and take chemical castration medications. It is
 profitable to Pharma as they are now dependent on hormones. It is profitable to Big Health as
 they now get top and bottom surgeries. And it contributes to population decreases to achieve
 "sustainable population goals"
- In here they also address redistribution based off of gender. It is Marxism and class redistribution was classically used. But now we have gender, race and sexuality being called the oppressed/oppressor. Where governments used the "oppressed" to overthrow the "oppressor" walking in non-repressive order, which is communism, everyone equally oppressed
- They mean to criminalize Christianity, marginalizing heterosexuality claiming it is discriminatory
- Feminize energy and demonize males as toxic so they won't fight back
- What GAVI says "IMMUNISATION = EMPOWERED WOMEN AND GIRLS "Immunisation is a gender-equal intervention. Globally, girls and boys are immunised at similar rates. However, there are variations at sub-national levels and in some countries because a range of different barriers inhibit women's ability to access healthcare for their children. Gavi supports countries to make focused efforts to identify and address gender-related barriers to immunisation services, such as through training female health workers, as empowering women is critical to improving child vaccination coverage." UNICEF who has the same SDGs as UN found to be sterilizing women through vaccination. Link on last page. How is that for empowerment?

6 CLEAN WATER AND SANITATION

- Goal 6. Ensure availability and sustainable management of water and sanitation for all
- What this means is control of resources. Allow corporations to control natural resources like water charging monopoly prices and driving an expensive and rationed new system
- Nestle was under-fire for taking water resources. That is a problem when you have monopolies all under the same owners Blackrock and Vanguard claiming natural resources
- What we have seen from governments is the Hegelian dialect of cause problem offer solution. Weaponize virus, release virus, mandate vaccines. In 2023 we had a number of hazardous chemicals released close to water sources. However, on a planet 70% water, water is hardly a scarce resource, desalination processes could be used, rain water collection should not be banned.
- A concern is that vaccines claim achievements that are really due to clean water and sanitation infrastructure, with vaccine hesitancy growing after COVID exposed safety concerns, harming clean water and sanitation could give rise to more communicable diseases which Pharma could take advantage of
- What GAVI says "WASH + VACCINES = LESS DISEASE "Vaccines, along with clean water, sanitation and hygiene (WASH), are proven interventions to prevent diarrhoeal diseases, a leading cause of child mortality in developing countries. Investments in oral cholera and rotavirus vaccines, WASH and health systems form an integrated approach to help eliminate diarrhoeal disease." Again vaccines are given the kudos deserved to water and sanitation." In 1999 the government removed a rotavirus vaccine due to safety risks to children. 5 live viruses were found in Rotateq leading to a study of infants with gastroenteritis. They found the vaccines were shedding and spreading what they purported to stop and came with other immune issues. Are a liability free product that provokes the immune system provoking immune disease leading to lasting profit streams? Are these vaccines trading self-limiting illness for chronic lasting illness that are profitable to the pharmaceutical industry? Looks that way. https://pubmed.ncbi.nlm.nih.gov/23249230/



Goal 7. Ensure access to affordable, reliable, sustainable and modern energy for all

- When they say "modern energy", "renewable energy", "clean energy", "sustainable energy" "green energy." They mean getting rid of gas and oil. Which is not realistic considering fossil fuels is what produces electricity, produces solar, and wind. They claim electric is cleaner than gas but the battery mining sites come at the expense of land and child labor
- Electric is however more conducive to one of their goals, control. As it can be remotely turned off and on. Whereas gas cannot. Liberal states in their attempt to "go green and electric" have infringed on property rights and rights to move about freely as they say you can't have a gas lawnmower or gas stove and then when the grid is taxed you can't charge your car. This comes with rolling blackouts and electricity rationing. A common theme with communist policies.
- Tennessee invested in a Ford electric car megasite taking millions of tax dollars promising green jobs. What was
 delivered was lay-offs because there is not demand for the product. You can't force a market unless you
 mandate it
- "Inclusive climate policies in the form of international aid, bioenergy taxes, or domestic revenue reallocation can avert the overall cost of addressing climate change in terms of global welfare (a 3.7% loss) and rather result in a 0.1% gain, at the expense of 0.5% decrease in GDP of high-income countries used to cover the financial expenses of providing international aid" found on page 33.
- What they mean is the US gets to fund climate efforts in other countries. They think that is sustainable. "Global welfare" "bio energy taxes" More stealing in the name of the "greater good." "Achieving universal electricity access across sub-Saharan Africa by 2030 would require an annual investment of USD 27 billion under existing climate policies, but would require an additional USD 6 billion without climate policies "
- They are looking to the US to fund electricity in Africa.
- What GAVI says "EFFICIENT EQUIPMENT = CLEANER ENVIRONMENT "Immunisation brings newer, cleaner and more sustainable technology to developing countries' health systems. For instance, Gavi's cold chain equipment optimisation platform gives countries access to solar and energy efficient refrigeration, which is not only more reliable and cost-effective but also more environmentally friendly. Our support includes vaccine monitoring devices that ensure optimum energy usage and reduce wastage." Vaccination tracking devices that are energy saving. Just what we want! More surveillance of people who are supposed to be free.



- Goal 8. Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all
- They claimed growth in green markets yet delivered lay offs
- When they say "inclusive" inclusive means "inclusive" of anyone on the LGBTQ flag, it means Marxism, using class, gender, race, sexuality divisions. It excludes the white male and anyone who upholds traditional values that don't align with their humanist values.
- What they look to eradicate is American values of equal opportunity in place with Communist values of equity. Everyone equally oppressed. If you work hard you achieve is the American dream. You have the opportunity due to the free market to offer a better service, product and win business. And they replace it with "math is racist," don't achieve, be dependent
- They did as Rockefeller wanted creating "workers not thinkers" by removing God as the highest authority which leads to higher purpose and making serving the state the highest purpose
- They look to regulate small business out of business so they can control people through monopolies like they did with mandates
- Destroy free market and push for centrally planned economy
- What GAVI says "HEALTHY POPULATION = MORE PRODUCTIVE WORKFORCE Investment in human capital can dramatically strengthen a country's competitiveness. Vaccinated, healthy children grow into a productive workforce and become strong contributors to the economy. In addition, healthy children free up parents' time so they are able to work. In Gavi-supported countries, every US\$ 1 spent on immunisation generates US\$ 54 in broader societal benefits of people living longer and healthier lives." There are studies that have come out showing unvaccinated children are healthier and have fewer immune diseases suggesting trading self limiting illness for chronic illness was a bad trade for health but a profitable trade for those who get a 20:1 ROI on vaccines. The workforce was severely inhibited when the Federal government issued mandates and orders through large corporations forcing people out of their jobs and to choose between employment or compliance to a rushed to market liability free product.



- Goal 9. Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation
- 9.c Significantly increase access to information and communications technology and strive to provide universal and affordable access to the Internet in least developed countries by 2020
- 9.4 By 2030, upgrade infrastructure and retrofit industries to make them sustainable, with increased resource-use efficiency and greater adoption of clean and environmentally sound technologies
- They say the green market is sustainable yet they regulate lighter cars which means less dense metal which means it is less sustainable
- They say they want to make planes and homes carbon free which means expensive retrofitting
- Put nations into debt with the World Bank
- What GAVI says "HEALTHY VACCINE MARKET = INNOVATION "Gavi makes vaccine markets work better by attracting more suppliers, dramatically reducing vaccine prices and ensuring more equitable and sustainable access to vaccines and other innovative products that meet developing countries" needs. Since our inception in 2000, we have contributed to a significant increase in new manufacturers supplying vaccines for Gavi and the majority of the vaccine doses we procure are manufactured in developing countries." Again was that the case during COVID? The profitable industry forced their products on people with a mandate halting innovation and driving people out. Also see Truth about UNICEF article to see the harms vaccine programs have done to third world countries. Besides in that article polio is now mostly vaccine induced polio. Keeping disease around that natural immunity would have done away with.

10 REDUCED INEQUALITIES

Goal 10. Reduce inequality within and among countries

- 10.2 By 2030, empower and promote the social, economic and political inclusion of all, irrespective of age, sex, disability, race, ethnicity, origin, religion or economic or other status
- What they mean no borders between countries, allowing anyone in
- Political inclusion is Marxism. It is advocating for non-repressive order which means everyone equally oppressed
- Again there is talk of global welfare here, transferring money between countries, wealth redistribution between countries
- Punish the rich, entrepreneurs confiscating all gains while screaming equality and delivering equal poverty
- What GAVI says BETTER HEALTH = INCREASED EQUALITY "Immunisation protects the health of communities, reduces the number of people forced into poverty, and gives children an equal chance of a healthier and more productive future. By focusing on the under-served communities and unimmunised ("zero dose") children in the poorest and most marginalised populations, especially the urban poor and those living in remote rural settings and conflict areas, Gavi brings immunisation and primary health care services to those furthest behind."
- That is a pretty big stretch, vaccines limit poverty? Yeah CEO poverty. Like we saw with COVID they took our tax dollars funded their product, cashed out when stocks were high then turned around to mandate it. Why haven't vaccines gotten kids out of American ghettos. Vaccines create long-term customers with their host of side effects, are free from liability and yield a high ROI. Dr. Peter Aaby former head of the third world vaccination program started a program called the Bandim Health Project to look at post vaccine health incomes of African children. What he found was alarming. He found that the Dtap vaccine was associated with a 10x higher mortality rate than children not receiving it. That it was preventing symptoms of these infections but made them more susceptible to other diseases and ultimately death. Dr. Christine Stabell Ben found similar results. Her study found that it was associated with a 5x higher mortality. That it was killing more children than it was saving. She considered this good news because the data was actionable and they could use it to modify the schedule to save 3000 children per day. 1.1 million per year. But they haven't.
- ICAN an organization fighting for informed consent took these studies and wrote to UNICEF advising them to discontinue this vaccine right away and listed several other studies all concluding the same thing. The Dtap is killing children. UNICEF replied with an older study called the SAGE study claiming there were no other side effects found from the vaccine but never responded to the new data proving otherwise.



• Goal 11. Make cities and human settlements inclusive, safe, resilient and sustainable

- Human settlements? What this means is getting everyone hooked to the same grid to increase surveillance and control. What it means in WEF Smart Cities like Chattanooga is prison cities, 15 minute cities. Where due to fiberoptic information travels very quickly and everything is controlled. There are already smart buildings being introduced where you have everything you need in the building. When everything including the light bulbs are smart, everything can be controlled and used for surveillance. It can all contribute to the social credit system that China has. A lot of cities are already putting smart cameras in like ours in Johnson City. Localities don't see the implications. China to see how 600 million closed circuit cameras one for every one and a half person, able to monitor them by facial recognition and able to limit them to do anything.
- If you say something wrong on social media much like we saw with the Canadian truckers, your bank account could be shut down, your power could be turned off
- Recently a video showed the potential implications of an Al driven, technology driven devoid of human oversight criminal justice system could look like. Easy to infringe on our rights without proper channels to exoneration
- Additionally, UNICEF Child Friendly Cities falls under SDG 11. Johnson City was chosen as a UNICEF CFC. We recently just pushed for rejection of this program. UNICEF has the same sustainable goals as the UN. And they say they are looking to "empower the voices of children" which we know to mean demoting the voices of children. UNICEF has a nefarious timeline discussed here https://all.org/guest-commentary/the-truth-about-unicef which includes vaccines with sterilization drugs, promoting gay lifestyles, abortions and family planning. Population control.
- Ban guns so people can't push back
- · Criminalize living outside the dense areas and instituting NACs, land off limits to humans
- What GAVI says "IMMUNISATION = HEALTHIER CITIES "By 2050, nearly 70% of the global population will be living in urban areas. The number of people living in slums or informal settlements has also grown to over 1 billion, many of whom lack access to basic health services. Strengthening urban immunisation programmes protects them against the increased risk of disease outbreaks and is an opportunity to bring integrated preventative services to urban and underserved communities"
- Why will we all be living in urban areas? See SDG climate action 13. Because they will be making land off use.



- Goal 12. Ensure sustainable consumption and production patterns
- 12.b Develop and implement tools to monitor sustainable development impacts for sustainable tourism that creates jobs and promotes local culture and products 12.c Rationalize inefficient fossil-fuel subsidies that encourage wasteful consumption by removing market distortions, in accordance with national circumstances, including by restructuring taxation and phasing out those harmful subsidies, where they exist, to reflect their environmental impacts, taking fully into account the specific needs and conditions of developing countries and minimizing the possible adverse impacts on their development in a manner that protects the poor and the affected communities"
- What this means is a planned economy can be defined as a type of economic system where financial decisions are made according to government plans. All decisions related to investments, production and other economic parameters are structured as per the decisions of a central authority.
- This means levying punitive taxes on fossil fuels and forcing people to live under worsening conditions and standards of living
- This agenda finds consumerism unsustainable. They prefer you "own nothing and be happy"
- Define providing for yourself, farming, fishing, as "ecocide" and then criminalize it as WEF discussed under the guise of it is bad for the planet. See Stalin and collectivizing farms
- "responsible consumption" mean those who want fossil fuels will be shamed and labeled irresponsible and punished using a social credit system using brown shirts like happened in history and in COVID neighbors turning on neighbors
- Where control is taken away from the people and surveillance measures monitor our compliance to their goals



Goal 13. Take urgent action to combat climate change and its impacts*

- What they say "13.1 Strengthen resilience and adaptive capacity to climate-related hazards and natural disasters in all countries 13.2 Integrate climate change measures into national policies, strategies and planning 13.3 Improve education, awareness-raising and human and institutional capacity on climate change mitigation, adaptation, impact reduction and early warning"
- "Strengthen resilience and adaptive capacity" means one world government similar to what was pushed for with the pandemic response
- "Climate change mitigation" means geoengineering efforts like the White House Solar Radiation Modification Mandate

- Where they are interfering in complex dynamic systems by blocking out the sun to help cool the earth, inconsiderate of the
 potential consequences blocking out the sun would create
- The Net Zero Carbon agenda falls under Climate Action. This is said to be a neo-feudal system where those who own land will have more carbon allotments. Ie. Elite's can fly their jets. You can't dive your car.
- Similar to how they experimented on viruses, said there would be a pandemic released a virus, blamed you for being a germ breather, and infringed on your rights. Now they are experimenting on weather, telling you there will be severe weather, as they blame you for being a carbon-emitter and infringe on your rights again.
- NAC (natural asset companies) claiming land off use to humans and as a NYSE investment falls under this
- · Saying you can't have a gas stove, gas car, infringing on your private property rights in the name of climate change
- This is a call for Global Welfare. Take money from the US to fund climate action world-wide
- What GAVI says "VACCINES = MITIGATION OF CLIMATE CHANGE IMPACT "The impact of climate change cuts across
 health and well-being, livelihood, and security of people, particularly for the poorest and most vulnerable communities, such
 as people on the move. Immunisation is critical to building people's and systems' resilience to and reducing the risk of
 outbreaks due to climate-sensitive diseases, such as yellow fever, cholera and Ebola, particularly in urban, fragile and postdisaster settings." Look at the yellow fever disaster, and the dengue fever disaster



Goal 14. Conserve and sustainably use the oceans, seas and marine resources for sustainable development

- This is to control water life resources. Limit ability to fish to provide for yourself. Create dependencies.
- Ban private fishing in trade for centralized government controlled
- Ban fossil fuels in the oceans, boats, and transport of goods that use "not clean and sustainable" forms of energy
- Ban human use of the oceans "for the greater good"



Goal 15. Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss

- What they say 15.6 Promote fair and equitable sharing of the benefits arising from the utilization of genetic resources and promote appropriate access to such resources, as internationally agreed
- That means making lab made meat and getting rid of CO2 emitting cows, ignoring the ecosystem implications removing cows and replacing pastures with labs would create
- This also overlaps with the NAC (Natural Asset Companies) and banning human use of land, getting us into consolidated, high density city areas that are east to control
- Criminalize private land ownership including ranches and agriculture tracks
- Control all agriculture through centralized government regualtion
- Take control of water resources

16 PEACE, JUSTICE AND STRONG INSTITUTIONS

Goal 16. Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels

- What they say "16.3 Promote the rule of law at the national and international levels and ensure equal access to justice for all"
- · What they mean, override decentralized, limited government in favor of centralized controls
- What they say "16.4 By 2030, significantly reduce illicit financial and arms flows"
- · What they mean, disarm the public so they can't reject centralized controls and removal of the Constitution
- What they say "16.9 By 2030, provide legal identity for all, including birth registration"
- What they mean make everyone trackable
- What they say "16.a Strengthen relevant national institutions, including through international cooperation, for building capacity at all levels, in particular in developing countries, to prevent violence and combat terrorism and crime"
- · What they mean make any one who doesn't obey the enemy and it punishable
- What they say 16.b Promote and enforce non-discriminatory laws and policies for sustainable development
- What they mean any traditional values and belief in God is discriminatory, you can't promote God so you can't have Godgiven rights
- Grant immunity to illegal aliens and "protected minority groups"
- Use ABC agencies to selectively target anyone who is not protected, those who uphold traditional values
- What GAVI says "STRONG HEALTH SYSTEMS = LONG-TERM STABILITY Effective, safe, and people-centred health
 systems are the backbone of social institutions in every country, and immunisation is often the first point of contact between
 these systems and the population. Through Gavi support, countries' efforts to improve equitable access to vaccines
 contributes to building public trust, stronger social cohesion, peaceful and inclusive societies."
- Public trust of vaccines and the organizations pushing them was lost during COVID as vaccines were rushed to market, many learned they were free from liability and they were coerced with bribes and holding jobs hostage in exchange for compliance. There is too much of an incestuous relationship between government and Pharma as well as NGOs who see humans as the problem and say there are too many of us. Why would we take life-saving solutions from NGOs who say there are too many lives and have often led to sterility and infertility.



- Goal 17. Strengthen the means of implementation and revitalize the global partnership for sustainable development
- What they say "17.4 Assist developing countries in attaining long-term debt sustainability through coordinated policies aimed at fostering debt financing, debt relief and debt restructuring, as appropriate, and address the external debt of highly indebted poor countries to reduce debt distress"
- What they mean global welfare, wealth redistribution between countries, everyone equally poor
- 17.5 Adopt and implement investment promotion regimes for least developed countries
- What they mean Blackrock and Vanguard are already investment regimes that enforce Marxist ESG and DEI to drive achievement of these global goals
- Enact global trade mandates that override national law, bypass nation lawmakers, nullify national and state laws and sovereignty and demand global obedience
- Gavi says "INNOVATIVE PARTNERSHIP = UNPRECEDENTED PROGRESS Leveraging the comparative advantage of each partner, the Vaccine Alliance's innovative public-private partnership model has transformed global progress by accelerating equitable and sustainable access to vaccines both at scale and pace. Since 2000, Gavi support has helped countries immunise more than 760 million children. This has helped to reduce deaths from vaccine-preventable diseases by more than 60 per cent and played a key role in halving the under-five mortality rate in those countries."
- Global cooperation means erasing state and nation boundaries to ensure world wide compliance and leveraging all these partnerships as enforcement mechanisms for full control

GAVI and UNICEF

- GAVI focused their SDGs around vaccines. We exposed the UNICEF child friendly city for what it really was. An abortion
 endorsing, sterilization endorsing organization that was found guilty of the following;
- In 1967 UNICEF categorically rejected any connection with contraceptives. In 1987, it joined its collaborators in endorsing a
 Resolution for Action that included not only contraceptive research, development, distribution and practice, but pressed for
 abortion regardless of the legal status as well as increased collaboration with agencies whose agendas included
 contraceptives, sterilizations and abortion often under political coercion.
- 1995: The Catholic Women's League of the Philippines won a restraining order against a two-year-old WHO and UNICEF anti-tetanus program. Two labs had found "B-hCG" sterilizing agent in the vaccine. The Filipino program had already "vaccinated" 3.4 million people all women, mainly between the ages of twelve and 45. The hormone-laced vaccine was also discovered in Mexico, Nicaragua, Tanzania, India and Nigeria. The anti-hCG hormone cause not only sterilizations but also incurable autoimmune disorders, miscarriages and birth defects.
- July 2002: Another UNICEF-funded sex education book distributed to Latin American countries was circulated at the UN Child Summit in New York. The book encouraged children to engage in sexual activities with other minors, with homosexuals and with animals. The Spanish language book, entitled "Theoretic Elements for Working with Mothers and Pregnant Teens" included a workshop book, also produced by UNICEF, which suggested that lesbian sex was an acceptable alternative for girls.
- UNICEF turned a blind eye to the research of BANDIM Peter Aaby and Dr. Christine Stabell Ben research showing the Dtap vaccine was associated with a 10x higher mortality rate than children not receiving it.
- Dr. Theresa Deisher wrote an open letter to legislators urging them to stop using aborted fetal cells as growth medium as
 the fragment DNA was found to merge with and alter DNA. It was ignored.
- COVID vaccines are having horrific side-effects yet are still being recommended to children
- When vaccines are being used by NGOs that push for population control and result in sterilizations and issues are pointed to
 yet never addressed, consumer concern is vilified yet never answered, people are right to be concerned about the
 recommendations of these organizations
- Vaccines are just one part of this picture. There are other mandates that are concerning surrounding the climate agenda.
- They experimented on viruses, told us there's going to be a pandemic, blamed us for being germ breathers, infringed on our rights to move about freely and our sovereignty. Now they are experimenting with weather, saying there's going to be severe weather, and are blaming us for being carbon emitters where they'll look to infringe on our rights again. What can we do?

- We need to educate our spheres of influence on this agenda and how it is being instituted locally
- We need to educate local leaders on the UN law and what these SDGs look like in policy so they know what is unlawful to institute
- We need to support the legislature in the efforts to establish and enforcement mechanism
