### **RESOLUTION 2022-5004**

#### **A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GRIZZLY LAKE COMMUNITY SERVICES DISTRICT IMPOSING AND INCREASING WATER AND SEWER CHARGES**

**WHEREAS** the Board of Directors of the Grizzly Lake Community Services District is committed to providing water and sewer service to customers as efficiently and inexpensively as possible; and

**WHEREAS** the Board of Directors has determined that in order to maintain the district's solvency and ensures that services can continue to be provided it is necessary to amend the district's schedule of water and sewer rates ("Rates") and

**WHEREAS** article 13D of the California Constitution adopted by the voters as part of proposition 218 requires that notice of any rate increase for water or sewer service be provided to customers affected by the rate increase, and requires that a hearing be held on the rate increase and provides that no rate increase may be implemented if a majority of a public agency customers object in writing to the proposed rate increase and

**WHEREAS** the district did mail notice of a hearing on the increased rates to affected customers in compliance with applicable law, did hold the hearing, and **DID/DID NOT** receive written protest from a majority of customers and

**WHEREAS** sections 13031 and 13074 of the California Public Resources Code and section 25215. 5 of the California Government Code authorized the district to impose and increase water and sewer rates through the adoption of an ordinance or resolution approved by the district's Board of Directors.

#### **The Board of Directors of the Grizzly Lake Community Services District does hereby resolve as follows:**

**Section 1. Incorporation of Recitals.** The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

**Section 2. Inconsistency with other Rates.** To the extent any Rates established by this Resolution are inconsistent with Rates previously adopted; it is the explicit intention of the Board of Directors that the Rates adopted in this Resolution shall prevail.

**Section 3. Rates.** The Board of Directors hereby adopts and imposes the Rates set forth in the attached Exhibit "A", incorporated by this reference.

**Section 4. Severability.** If any section, subsection, clause or phrase in this Resolution or the application thereof to any person or circumstances is for any reason held invalid, the validity of the remainder of this Resolution or the application of such provisions to other persons or circumstances shall not be affected thereby. The Board of Directors hereby declares that it would have passed this Resolution and each section, subsection, sentence, clause, or phrase thereof, irrespective of the fact that one or more sections, subsections, sentences, clauses or phrases or the application thereof to any person or circumstance be held invalid.

**Section 5. Effective Date of Resolution.** This Resolution shall take effect on the date of its passage and approval.



### PROPOSED MONTHLY RATE SCHEDULE

The water and sewer rate will be increased as set forth on the following table beginning on December 1, 2022, and will increase by 5% for four subsequent years. The final adjustment under this schedule will be implemented no later than **(December 1, 2027, 5 YEARS FROM THE TIME FIRST INCREASE WILL BE IMPLEMENTED)**. Any subsequent rate adjustments that increase rates will be subject to a Proposition 218 hearing.
