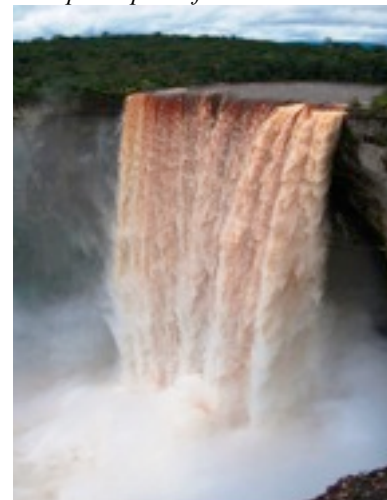

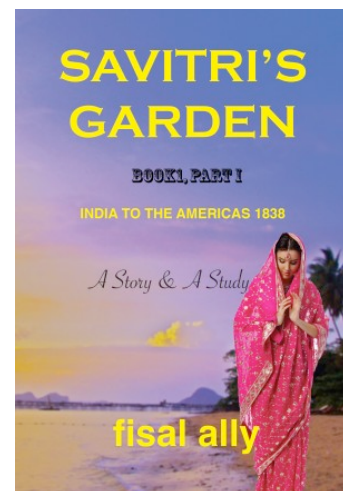

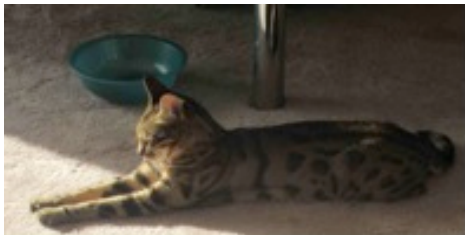

SAG-AFTRA, the actors union that has had 160,000 members on strike since last week, is afraid that artificial intelligence will lead to far fewer employed actors the future' (Ref55). The host (Ref 54) says, 'The fact is that AI can write scripts for movies now and even artificially create a whole movie by just using some one's face, using computer generated faces.' Computer-generated imagery, or

CGI, to create virtual actors and extras is somewhat old hat in Hollywood. But just as computers allowed replacing animation artists who used to draw 24 frames of artwork for each second of film, AI allows much easier, and cheaper use of CGI to generate performances by actors who aren't there. Thus SAG-AFTRA says the studios want to use AI to eliminate acting jobs' (Ref55). They are already doing it. Introduction

There are various types of scams and frauds taking place, where this article looks at various examples in being groomed, scams, fraud, and also a more in-depth look at the college admission scandal, which was once again in the spot light. Have you been scammed? Do you know someone that's been scammed? Do you know someone that's being groomed to steal someone's songs, books and other possessions? Almost everyone has come across someone trying to scam them over the phone by getting their credit card number. We often get email spams and have no clue why we're getting them even if we're just using an online email service where the emails do NOT get to our computer. However, sometimes we get emails and if download or open then we may end up with spyware being downloaded onto our computers, where someone is tracking our online whereabouts and may even try to hack us and scam us. By clicking on a link sent in an unknown spam email, it takes you to another website where the website could even have pornography, making it look like you are deliberately going to these websites when you are not. A person can easily become the victim of a scam, fraud, groomer or handler.

Update: as I was editing this section on July 18, 2023 at 11:10 I received a call from the phone number 416-800-1669 and when I answered, there were no sound or noise and nobody answered on the other end. I have NOT had one of these calls in a while. I looked up the number on Google and it says 'Robocaller Warning!' It also gives other description as to who is calling such as 'is a customer call' spam calls detected' location Toronto, 'left voicemail saying they

were from xxx (I decided not to put the company's name) and wanted to check in on my account. I haven't had a xxx account in several years so it's either spam from xxx or a scam caller with an old list of client phone numbers.' I find it odd that I'm editing this particular report and received such a call, as if someone is monitoring what I do (perhaps my 100 songs and 15 books have made them rich); I have not received such a call in a while, at least 2 weeks or more.

It's obvious that the ones that are masterminding the scams and frauds are getting something out of it, and could even get a good amount of money from scamming you or defrauding the system? Or else they wouldn't be doing it. In the college admission scandal, in the article called Rick Singer, mastermind of college admissions bribery scandal, gets 3.5 years in prison (ref 8) published on Jan 4, 2023, where Rick Singer was the mastermind of college admissions bribery scandal and ends up with 3.5 years in prison. In the end many do regret their involvement in these scams and frauds. **Loughlin said, "I made an awful decision. I went along will the plan to give my daughters an unfair advantage in the college admissions process."** She said, "In doing so, ignored my intuition and allowed myself to be swayed from my moral compass" (ref 11). **Singer 'said he unethically facilitated college admission for children in more than 750 families'** (ref 12).

Elizabeth Warren, United States Senator from Massachusetts (where all the criminal cases were led), told news media that **the scandal represented "just one more example of how the rich and powerful know how to take care of their own"** (ref 12), referring to the college admission scandal. The law sooner or later catches up with the ones involved.

Section I - Being groomed to steal someone's songs, books and other possessions?

We often hear of people being groomed, even children and very often it's for sexual favors. But others are also groomed on how to scam the work of others while collaborating with someone in these scams and not even being aware of it.

Like the US college admission scandal that took place a few years ago where many famous people were brought to justice, there were also scams and frauds where many musicians that were using other people's work were also brought to justice a few years ago. But still many have not been caught nor brought to justice. By the time some are brought to justice, they would have accomplished their agenda and enjoyed a lot of stolen money, and probably in a place where nobody can find them.

Pulled into a scam and being groomed

Are you being groomed by a handler or mastermind, or even a friend or a best friend to steal someone's songs, music, books and or other possessions? Have someone told you that you will be a star if you sing a song, or use a part of a song or modify a part of this song, but that song belongs to someone else? Are you being encouraged to modify the work or parts of the work, such as a song or music that belongs to someone else that will benefit yourself and the one(s) you are collaborating with? What if you are being pulled into a scam, where in the end you will regret it? What if the mastermind you are collaborating with is setting you up to take the blame? What if you are being framed for something? Did someone befriend you and is that person grooming you? Are they dragging you into a scheme, which you will regret? How do you know they didn't film you doing something and then will use it to blackmail you? This can happen to anybody. Always be safe and get a lawyer and witnesses to draw up a legal contract to ensure you are not being pulled into a scam.

We have heard of people stealing songs and breaking them into pieces, and suddenly those samples are showing up all over the world in many songs. The same thing happened to my songs and books, even though I've had many professional players on the recordings where my recordings are on a medium and handed out to the public. Also a number of people helped me to edit my books as proof of my work. Yet the people involved in these frauds do not care because all they care about is wealth and their paradise on earth from our hard work, and this is why the world is now a very bad place to live in. And if they get caught or by the time they get caught they would have accomplished their agenda and made lots of money, and hiding out in their paradise getaway.

In the way people used the side door in the college admission scam, don't you think the same thing is happening in music, where people are stealing our songs and going through the backdoor and the side door to scam the system and to make lots of money? It seems like it's mostly wealthy people that are involved in these frauds. We must wonder how they became rich in the first place.

No doubt it's many of the rich who are involved in the frauds and are collaborating with others because they have the means to do so, and also have the connections. Elizabeth Warren, United States Senator from Massachusetts (where all the criminal cases were led), told news media that the scandal represented **"just one more example of how the rich and powerful know how to take care of their own"** (ref 12), referring to the college admission scandal. Another article states, 'The punishment for Rick Singer, 62, is the longest sentence handed down in the sprawling scandal that embarrassed some of the nation's most prestigious universities **and put a spotlight on the secretive admissions system already seen as rigged in favor of the rich'** (ref 8).

Section II : Being groom by sexual predators

We often hear of children being taken advantage of by sexual predators, but people of various ages are also groomed by sexual predators for sexual favors. In the article, We heard about the actor 'Kevin Spacey trial - live: Actor called a 'predator' who was 'grooming' alleged victim' where 'Spacey denies 12 charges including sexual assault and indecent assault.' Grooming takes place much more than we hear about. Some are real and some are fabricated. An excerpt from the article says, 'Kevin Spacey's four-week trial is under way 'Spacey told alleged victim he would "introduce him to A-list stars", court hears.' Whether it's true or not, similar situations do take place where a groomer promises the victim(s) something important, such as becoming a star, getting a role in a movie, or making an album and playing in front of big audiences, all in return for something such as sexual favors and or riches. A groomer often have something to give, and at times others will go along with what the groomer wants so they can become famous, rich, get work contracts etc...

In an article called 'It is like he thought he could groom me' – Kevin Spacey's first alleged victim' by Josh Payne and Gwyn Wright, published on July 3, 2023, an excerpt states, 'An alleged victim of Oscar-winning actor Kevin Spacey told a police officer the Hollywood star's sexual advances were "like he thought he could groom me", a court has been told.'

There are many examples from over the years of someone with some kind of status grooming a person that wants a favor. At other times the groomer have nothing but promises the victim something the victim would like to have.

Section III : Scammed out of \$450K

Sometimes we hear that an elderly person was scammed out of their savings and or retirement savings. Other times we hear of a younger person pretending to like an older person that have wealth only to plot and scam the older person; there are many other kinds of cases. I person know someone that was scammed out of \$5,000 about two years ago, where the scammer called him saying that they were from CRA and that they were demanding \$5,000 in bit coin to pay up for tax owing, and the person believed the scammer and paid up that money.

Just recently, in an article called, 'I was in a trance': A tech executive was scammed out of \$450K as part of a cruel romance grift called 'pig butchering' — here's how it works and what to watch out for' published on July 2, 2023 explained how an executive was scammed out of a large sum of money. An excerpt from the article is, 'Shreya Datta had been swiping through dating apps for months before she met "Ancel Mali," a purported wine trader from France...' After they chatted online for a couple of months, exchanging flirty emojis and selfies, he ended up conning her out of \$450,000.' This goes to show how people are easily fooled, whether they are being fooled into stealing someone's song or parts of that song and using it, or conning someone out of their savings, and many other scams.

Section IV : Phone scams

I've had many phone calls claiming something to do with my Amazon account. First of all, I do not have an Amazon account. I rarely answer such calls because I don't have time to talk to solicitors. But sometimes, I think the call is from someone important and I end up answering the call. However, many people do answer those calls and tries to call back. A few times I called back the number thinking that those were calls that I was expecting. An example of this is in the CBC article, 'Tired of getting spam calls? Here's why you may never be rid of them (ref 4) by Sophia Harris · CBC News · Posted: Jun 03, 2023, 'There's no silver bullet' to the problem, CRTC official says. According to the cybersecurity expert Ritesh Kotak from the company in Toronto, he said that **"These scammers are financially motivated and driven." He said that the scammers spend time in 'research and development and figuring out ways to circumvent the system"** (Ref 4). 'He said scammers are able to bypass STIR/SHAKEN by purchasing and making calls from legitimate Canadian phone numbers — from anywhere in the world' (ref 4).

The article states, 'According to the Canadian Anti-Fraud Centre, 1,973 people lost a total of \$20.6 million to phone scams in the first three months of this year,' and that it's much more than that...' This article further went on to say that recently Selvaraj had 'recorded and posted a scam call on his YouTube channel. In the call, the fraudster tried to convince Selvaraj that a mysterious \$1,534 had been charged to his Amazon account. He called out the scammer who quickly hung up.

The amount of \$1,534 as mentioned in the example above is small compared to other scams, but for some this amount is a lot of money and is used for groceries and paying rent.

There are other kinds of fraud, such as scamming shareholders in a new construction building, and the scammer takes off with all of the money. In an article called 'Christian radio host Dave Ramsey faces \$150 million lawsuit from listeners who say they were defrauded by a timeshare

exit company he promoted. Why Sam Bankman-Fried is charged with perpetuating one of the biggest frauds in US history; Ryan Hogg post on Sat, June 3, 2023 (Ref 5) where the article states, ‘Christian radio host Dave Ramsey is facing a \$150 million lawsuit from 17 listeners who claim he played a role in defrauding them by promoting a timeshare exit company.’

In an article called ‘12 Dangerous Scam Phone Numbers and Area Codes To Avoid Written by Clark.com, Staff October 13th, 2022 (ref 7)’ says ‘When an unfamiliar number comes in, you’re better off waiting for a voicemail so you can determine if the call is legitimate before calling back. You can also Google the phone number itself. If the number is a scam, chances are good that others will have posted warnings about it.’ **So if you answer that call and it’s a long distance call then it could cost you a lot of money.** A few times I thought the calls were legitimate so I called back. It rings and no answer, you call back again and it says number does not exist. I was expressing concerns on March 20, 2023 as to why a number should not be given out on any social media and through email, and immediately after I sent the email I received a call from 1 587 570 8803 and when I answered the line went dead. I called back the number and it was a busy tone. The area code 587 which is from the province I live in. It's as if someone is listening in on my emails and did exactly what I didn't want anybody to do - I rarely ever get anonymous calls.

And this is exactly what the next example in the article (ref 7) says. **‘If you pick up, the robocaller just drops the line. But the bigger danger is if you miss the call. Like many people, you might think it’s an important call and dial that number right back. Bad move. Turns out the area codes are largely located in the Caribbean and could cost you \$15 to \$30 between international fees and per-minute charges!’**

Section V : The college admission scandal

The last edition of the Diverse City Magazine included a short write up on the college admission scandal. This report goes into more details. **The children of the parents involved are the victims. The ones who were robbed of their entrance are also victims.** In the same way that the person who wrote songs and books, which were stolen, is the victim, being ruined, destroyed and robbed of their future and wealth in songs, books, and royalties which someone else is collecting.

The college admission scandal was more than a scandal; it was fraud, scams and crimes that were mastermind. In the article called Rick Singer, mastermind of college admissions bribery scandal, gets 3.5 years in prison (ref 8)’ published on Jan 4, 2023, where **Rick Singer was the mastermind of college admissions bribery scandal** and ends up with 3.5 years in prison. It’s stated that ‘The mastermind of the nationwide college admissions bribery scheme that ensnared celebrities, prominent businesspeople and other parents **who used their wealth and privilege to buy their kids’ way into top-tier schools was sentenced** to 3 1/2 years in prison Wednesday’ (ref 8). ‘The punishment for Rick Singer, 62, is the longest sentence handed down in the sprawling scandal that embarrassed some of the nation’s most prestigious universities and put a spotlight on **the secretive admissions system already seen as rigged in favor of the rich**’ (ref 8). “It was a scheme that was breathtaking in its scale and its audacity. It has literally become the stuff of books and made-for-TV movies,” Assistant U.S. Attorney Stephen Frank told the judge Wednesday’ (ref 8).

There were many in the college admissions scandal. They wanted the best for their children when it comes to success. ‘Two wealthy mothers--sought-after interior designer Caroline and Bethany, owner of a successful financial-services firm--**share an obsession with getting their**

teenagers into the best possible college. (Ref 9)

It was a ‘brazen cheating scheme’ (ref 10) according to the New York Times as reported by Kate Taylor on October 8, 2021. For some it was one child, for some it was two and more, where their children are taking up spots that should have gone to others that worked hard for those spots. The ‘Former Pimco C.E.O. Gets 9 Months in Prison in College Admissions Case’ (ref 10). ‘Most parents were accused of crimes to get one child, maybe two, into an elite college. Douglas Hodge, the former chief of Pimco, paid bribes for at least four children, prosecutors say.

Some names are not known to most, but other names are known across nations. In the article ‘The Biggest Names Associated With the College Admissions Scandal: Where Are They Now? By Sarah Hearon from March 14, 2023 (Ref 11). ‘Lori Loughlin, Felicity Huffman and several college coaches and officials were indicted in the nationwide college admissions scandal on March 12, 2019 — and the fallout and prison sentences are still making headlines.’ **‘That’s the consequences one pay when involved in scams and fraud’** (ref11). ‘According to court documents, the Full House alum and her husband, Massimo Giannulli, allegedly “agreed to pay bribes totaling \$500,000 in exchange for having their two daughters designated as recruits to the USC crew team — despite the fact that they did not participate in crew — thereby facilitating their admission to USC” (ref 11). Loughlin and Giannulli are the parents of daughters Bella and Olivia Jade. By the parents aiding their two daughters to get on to this crew, would they have been capable or had the abilities to even prove their skills? Perhaps it’s a dream, but you still have to prove your skills else sooner or later their will be major conflicts, or perhaps one can pay their way with extra coaching to develop at a good pace.

Covid-19 had a put a twist on many things with all of the lockdowns and shutdowns, ‘Loughlin and Giannulli faced the judge in August 2020 via Zoom amid the coronavirus pandemic. During her statement, she got emotional’ (ref11). **“I made an awful decision. I went along will the plan to give my daughters an unfair advantage in the college admissions process,” she said. “In doing so, ignored my intuition and allowed myself to be swayed from my moral compass. I thought I was acting out of love for my children, but in reality, I had only undermined and diminished my daughters’ abilities and accomplishments.”**

Varsity Blues Scandal

Many are involved in the college admission scandal, and it’s a long list. An article called ‘Varsity Blues scandal’ located at https://en.wikipedia.org/wiki/Varsity_Blues_scandal (Ref 12) looks at some of the reactions when the news broke. ‘After the scandal broke, multiple American news sources including The Atlantic, Vox, Rolling Stone, and The New York Times characterized it as a symptom of a broken college admissions system. Alan Dershowitz, professor emeritus at Harvard Law School, said it was "the worst scandal involving elite universities in the history of the United States". Elizabeth Warren, United States Senator from Massachusetts (where all the criminal cases were led), **told news media that the scandal represented “just one more example of how the rich and powerful know how to take care of their own”** (ref 12).

How did the news get out? Things have a way of getting out and being tracked without others knowing about it. ‘In 2019, a scandal arose over a criminal conspiracy to influence undergraduate admissions decisions at several top American universities. The investigation into the conspiracy was code named **Operation Varsity Blues**. The investigation and related charges were made public on March 12, 2019, by United States federal prosecutors. At least 53 people

have been charged as part of the conspiracy, a number of whom pleaded guilty or agreed to plead guilty. **Thirty-three parents of college applicants were accused of paying more than \$25 million between 2011 and 2018 to William Rick Singer, organizer of the scheme, who used part of the money to fraudulently inflate entrance exam test scores and bribe college officials.** Of the 32 parents named in a Federal Bureau of Investigation affidavit led in U.S. District Court in Boston, more than half had apparently paid bribes to have their children enrolled at the University of Southern California (USC).’

The Varsity Blues scandal report states: ‘Singer controlled the two firms involved in the scheme, Key Worldwide Foundation and The Edge College & Career Network (also known as "The Key"). He pleaded guilty and cooperated with the Federal Bureau of Investigation (FBI) in gathering incriminating evidence against co-conspirators. **He said he unethically facilitated college admission for children in more than 750 families.** Singer faced up to 65 years in prison, and a fine of \$1.25 million. In January 2023, he was sentenced to three and a half years in prison plus forfeiture of over \$10 million.

The report states that ‘Singer primarily used two fraudulent techniques to help clients’ children gain admission to elite universities: **cheating on college entrance exams and fabrication of elite sports credentials.**’ And that ‘Singer arranged to allow clients’ children to cheat on the SAT or ACT college admission tests.’ **The report states that ‘Singer also bribed college athletics staff and coaches.’**

The report provides information on the universities and programs. In this article a lot of the information was removed to give a brief view of the universities, as follows.

Georgetown University - Men's and women's tennis Stanford University - Sailing

University of California, Los Angeles (UCLA) - Men's soccer

University of San Diego (USD) - Men's basketball

University of Southern California (USC) - Women's soccer; Men's and women's water polo

University of Texas at Austin (UT) - Men's tennis Wake Forest University - Volleyball

Yale University - Women's soccer

Conclusion

Sooner or later, the truth will surface and the collaborators and masterminds will be caught, at least we hope. In conclusion, the Varsity Blues scandal report states: ‘On March 12, 2019, William Singer, the CEO of Edge College & Career Network who masterminded the scandal, pleaded guilty to four criminal charges involving racketeering conspiracy, money laundering conspiracy, conspiracy to defraud the U.S. government and obstruction of justice. On January 4, 2023, William Singer was sentenced to 3.5 years in federal prison, 3 years of supervised release, and forfeiture of over \$10 million.’

Dave Anthony Martins of Guyana, From ‘The Tradewinds’ band - Now 88 years old, still playing and singing his songs

***From ‘The Latins’ to the ‘Debonairs’
and then the famous ‘Tradewinds’ band with hit after hit***

Dave Martins of Guyana formed a band in late 1966 while he had already immigrated and living in Toronto where there were already many people from Guyana and the Caribbean. He gave the new band the name ‘Tradewinds’ which became famous with hit after hit.

In the 1950s, Dave Martins sister ‘who had immigrated to Canada had suggested that he joined her in Toronto. He studied some music theory and made friends with a musician from the Bahamas and another from Toronto. The three friends started a group called The Debonairs’ (Ref 3). At the time they were just playing for fun and they were recognized as being good musicians. They auditioned and got some gigs. “...and before we knew it we were having enough work to play music full time,” Martins said (Ref 3). He said, “I formed the Tradewinds in late 1966, which was a kind of an oddity. We were living in Canada, and I had formed a band aimed at Caribbean people.”

Most would have thought that The Tradewinds was formed in Guyana or in the Caribbean, but although the music was geared towards Guyanese and people from the Caribbean, this was band was formed in Toronto, Canada in the late 1966. In the article ‘Guyanese icon Dave Martins is enjoying the simplicity of life’ by Cindy Parkinson, which was published on April 16, 2023, states that the legend is now 88 year old (ref 5). Thus the ‘Tradewinds’ would have began when Martins was already about age 31 or 32.

Dave Anthony Martins was born and grew up in West Coast, Guyana, South America in a place called Hague. ‘He attended the Sacred Heart Primary School and later St. Stanislaus College, travelling the long journey by bus and ferry’(ref 3). His ancestry goes back to Portugal, where his ancestors came from the Portuguese island of Madeira to work on the sugarcane plantations in the small South American country as indentured laborers, in the way the East Indians, Chinese and others had done.

Martins had three sisters, him being the forth child and then another sister after him; he does not have any brothers. From Hague, his family moved to Vreed-en-hoop where he attended St. Stanislaus High School. During this time, he became friends with the Henry brothers that lived

down the road from him. In an interview Martins said that the Henry brothers were Douglas, meaning they come from a mixed background of Indian (East Indian) and black (African). In Guyana, there's a lot of mixed heritage, and thus we often try to explain our mixed heritage to identify ourselves and our ancestry. He stated that they are still friends today..." (Ref 1). The two brothers were Joe and Jack Henry. Joe and Jack knew to play box guitars, and 'around the age of 14, Dave Martin was captivated by their playing that he became more interested in music, which would lead him on a long journey of music. "I started hearing these guys. They would go around the village playing music. I fell in love with the sound and that drew me to them." (Ref 3)

They formed an instrumental band; it was five of them. "We played a lot of Latin music, a few calypsos. We used to go to people's houses just for fun...(Ref 3)

While in Guyana, he 'worked at Atkinson Airport for four years' (Ref 4). In 1956 he arrived in Canada where 'he became exposed to Trinidadians that had a good record collection and the music wrapped him and held him in awe. Dave says that some of his early songs were influenced by that era' (Ref 4).

It was a long and gradual process - it didn't happen overnight

For Martins, 'it was a long gradual process' referring to music. He said, 'it didn't happen overnight.' Martins would have already been around age 21 or 22 when arrived in Toronto. And it wasn't until he was around age 31 or 32 when they started 'Tradewinds.' This means that Martins was patient and was willing to put in the time as a musician, instead of expecting to use other people's songs, it wasn't probably until he was around age 33 or 34 when Martins became popular. In Guyana Martins listened 'to all kinds of music, jazz, rock and roll, classical.' He said, "I became interested in classical music because I was drawn by the long structures..." While he was in Toronto, he started a little band. 'I named it the Latins - that was a business move. I knew from living in Guyana, Latin music, unlike now, Latin music was very popular in Guyana at that point ("Ref 1).

Guyana was home to Martins until he left for Toronto, but later Martins returned to live in Guyana, as Guyana is really home for many who leaves and then returns because of the love for the place. To understand how Martins' music evolved from playing Latin and then to a blend of music of Guyana and the Caribbean, one must understand the Guyanese culture.

Guyana is very diverse due to having six main races, which are the American Indians (Amerindians), Africans where many arrived during the days of slavery, but also during the days of indentureship from plantations that were closing down in the Caribbean. Then the Portuguese, East Indians and Chinese that arrived as indentured laborers to work in the sugarcane fields. The Germans were also field workers than began arriving in Guyana around 1834, when also the Portuguese began arriving. Indentured laborers from Germany and Malta also did hard strenuous field labor cutting sugarcane and working in the factories. The British, such as the English and Scottish were the plantation managers and field managers on horseback with whips in their hands, they were slave drivers.

Some plantation owners lived outside of Guyana, such as living in Britain. For example Gladstone who owned many slave plantations in Guyana and Jamaica had never seen his plantations in these places. He had never seen the torture, injuries and deaths taking place on his own plantations. Many slaves and indentured laborers succumbed to diseases such as the Maltese, Germans, Portuguese and Indians (East Indians). Thus India and Portugal had banned their people from going to British Guiana (Guyana) in South America when they learned about the brutality and deaths the laborers had faced from the Scottish and other planters. The bans had

taken place a few times due to the mal treatments and deaths. The Syrian/Lebanese arrival to Guyana began during the 1880s where they worked as merchants in Guyana, selling items such as cloths and thread; by that time, Guyana's indentured labor conditions were much better. The Syrian/Lebanese came mostly out of Lebanon according to research, where at that time, Lebanon was a part of Syria, and where many had left from ports like the Port of Beirut where they entered a small ship to France, and from France they entered a big steam ship that crossed the oceans to the Americas, where they ended up in different places such as New York, Argentina, Brazil, The three Guyanas, Trinidad and about everywhere in the Americas, where the Americas became the new home for many.

Before the British took control of the colonies of Demerara, Essequibo and Berbice, the French were also in Guyana and had begun the development of Georgetown. In the 1600s, the Dutch were the first to be granted an area for development from the Spaniards, where they had enslaved the Amerindians. Thus you will find names of places in Guyana called Georgetown, Richmond, Anna Regina, La Penitence, La Bon Intension, New Amsterdam, Vreed-en-stein etc... Guyana being in South America and having people of many backgrounds are in a Latin American region, although a big part of the population lives on the Atlantic Ocean coast and identifies more with a British Commonwealth Caribbean nation (or West Indian culture meaning the West Indies.) Not only does Guyana have many ethnicities, but also many dishes and music; in the 1800s Guyana was a very diverse country. In the 1950s, many Guyanese began moving abroad for one main reason and that was because of Guyana's political situation, where there were lots of looting and destruction to people's properties. That destruction continued for decades due to the corruption of politics and where the people were divided by race; we see the same card playing out worldwide destroying countries based on people's races and religions. There's Reggae, Calypso, Latin, Bollywood and others, and a blend of music also. Guyana is also spelled as Guayana, Guiana, Guiana. Guyana with the various spellings is actually a land in South America that spans an entire regions, from Venezuela, Brazil and the three Guyana (Br., Fr, and Dutch Guyana).

Martins formed a group called 'The Latins', and then formed the 'Debonairs' where they played less Latin music and more Caribbean style such as Calypso. 'He would play only on weekends but the music kept calling him...They began playing more, but 'the hectic schedule took its toll on Martins' life and he gave up the weekly gig in 1963 (Ref 4). In 1963, Martins would have been around age 28 or 29. Thus for Martins, it did not happen overnight. He was willing to work hard and to put in the time, whereas some would collaborate with others and steal people's songs/music to quickly get ahead.

Martin's life was about to take a big turn when he saw 'an advertisement in a Toronto newspaper from someone that wanted to start a Caribbean band' (Ref 4). After following up on the AD, a group of four musicians was born. The band sounded good and soon they began playing six nights a week in a club that accommodates about 200 people. He completely drifted from Latin music and more into a new style that reflected the culture and music of his home country, Guyana, and of the Caribbean style music.

Thus it was in 1966 when Martin formed an all-Caribbean band and called it 'Tradewinds.' Martin said that a metamorphosis occurred. "I discovered and appreciated Caribbean music by being away from it" (Ref 4). In other words, you don't know what you have, until it's gone, but he managed to later return to Guyana to live.

'He exposed the new band to the Caribbean and after writing four songs he decided to go to the Trinidad carnival. In three months, one of the songs topped the charts and by 1967 the

Tradewinds was a household name in the Caribbean. The band toured Guyana and played at the Astor cinema to sold out crowds' (Ref 4). The Tradewinds became a part of the Guyanese and Caribbeans, as this talented group continued to write song after song that brought them many hits.

He said that 'when stardom came, it arrived quickly. It came quickly, but by then Martins was already around age 32 or 33. Martins had certainly put in the work and time. The Tradewinds, which included two Trinidadians had decided to make a trip to the birthplace of calypso music. By then, Dave Martins had written and recorded four songs, including "Meet me in Port of Spain" and "Honeymooning Couple." "We...thought 'Meet me in Port of Spain' would be a big hit, but nobody paid any attention to it," Martins remembered with a laugh. "Then we went back to Canada, played a lot of free shows, and we thought that was that. But about two months later I started getting calls from Trinidad. "Honeymooning Couple" was a big hit; all the stations were playing it. "In the space of six months we went from being a nonentity to a chart-leading band in the Caribbean" (Ref 3). The group was on a roll followed by many hits: Mr. Rooster, You Can't Get, Copy Cats, Cricket in the Jungle. His songwriting continued. Some of his other famous songs are: Not a blade, Is we own, A long time ago in Guyana, Chanderpaul, Boyhood days. In an interview Martins explained how he came up with the hit song 'Not a blade of grass.' He said 'the idea came from Pat Cameron, a broadcaster at Radio Demerara. She suggested to Dave that he should write a song about the Guyana-Venezuela border dispute' (Ref 4). Thus, Dave Martins of Guyana had worked hard and put in the time - it didn't happen over night.

Back home Guyana is once again home for Martins

Dave Martins has relocated back in Guyana around 2008, and continues his songwriting journey along with live performances.

'Dave Martins and the Tradewinds have performed at venues such as Madison Square Garden and Vancouver's Queen Elizabeth Theatre. His country has shown its appreciation for his contributions by awarding Martins the Golden Arrowhead of Achievement. In 2002, the Guyana Folk festival Committee presented him with the Wordsworth Mc Andrew Award' (Ref 3).

A songwriter

Anyone can write a song, but it takes practice and dedication when it comes to writing song after song. And as we've seen, it was a long journey for Martins before the Tradewinds was formed. 'Martins said, 'To be a good songwriter, you have to have a lot of interest in a lot of things, you have to see in a song a lot of things most people will pass over not pay no attention to. Honeymooning Couple is a joke, my brother-in-law told me this joke...I ain't tell e notin but I tink to myself this is a song...the music is generally you, it's part of what the songwriter is, the song writer is a guy who is dissecting, opening up and looking...you probing and sometimes you probe and boy you think this is a hit and it turns out its not, and sometimes you're probing and you say this is no good - that's the hit - it's mysterious.' He's produced over 100 songs, several advertising jingles, and an award-wining play' (Ref 3).

A blend of African & East India music and more

In his interview with Freddie Kissoon (ref 2), he said on writing his songs that 'it sets it apart, nobody can copy it, you can try, its just a simple rhythm with a simple bass beat, and a simple drum beat, it's different from pop style, it has a Latin, American flavor to it, the African flavor to it, but other than that it's just music...other musicians come along and say I could do like dah (that)...you're building a body of music that comes from ONE SOURCE, LARGERLY

AFRICA, IT'S MOSTLY AFRICAN AND INDIAN. THERE'S ALOT OF INDIAN STUFF IN CARIBBEAN MUSIC YUH KNOW. I'M TALKING ABOUT INDIAN FROM INDIA, THERE'S ALOT OF IT BUT THE RHYTHMIC FLAVOR IS SO STRONG, IT TENDS TO DOMINATE..." Kisson said, "A Portuguese guy that put Guyana on the map of the Caribbean that's singing some fantastic calypso songs, how do you explain that?" Martins reply was 'You can't because its art -- *it's art that comes from SOME MISTERIOUS PLACE IN THE HUMAN PSYCHE.*" No doubt, the words of an honest hard working musician as it takes dedication and time to write songs. Where as some people would steal their songs/music from others, Martins wrote his own songs.

What I have noticed in beats, is what Martins stated about it's a blend of music which includes India, as the people that originated from India and entered Guyana (at that time British Guiana) back in 1838 and years to come, brought musical instruments and other items with them, where they played the tassa drums, a beat that became very popular across Guyana and the Caribbean. That same beat can be heard in other music across the Caribbean and South America. Even a few years back while walking through the mall in Edmonton, I would hear the Indian tassa beat in popular North American songs. But if only people knew that that beat came from India back in the 1800s to the Americas and wasn't recently invented in North America or Europe through popular music. I certainly recognized the beat as coming from India, which the Indian indentured laborers brought to Guyana and the Caribbean back in the 1800s, and which spread through the Americas, but only if people knew that.

The creative person

Martins said, "The creative person whether he is a painter, or a musician or a novelist, or a composer, whatever it is, he's a different head, he's a different soul, he is seeing stuff and being caught by stuff, that other people don't even notice, so its hard to say how it actually works ... you have to want to do that, that is something that is often missing, because you just can't force it, it comes to certain people... the vast majority said ah it's gone - once you become interested in it, once you see...you can't find a song about anything...nobody will say it the way you say it, or see it the way you see it..."

Martin - just me and my guitar

In an older interview, we learn more about Dave Martins. He had returned to Guyana to live, says that he's there to stay. He has no problem with playing at age 75? "I am active. I like to plant...I like to fix things." He has produced about 100 songs, and he's not short of ideas for writing new songs. He has taken some new directions. **He said, "but what I enjoy doing now is one-man shows** where I weave the comedy and the music about Caribbean life and all its forms, just me and my guitar."

Family life

The love of Dave Martins life is his wife, Annette Arjoon-Martins. According to one of his past interview, he said that he has five children. He said, "I never got interested in liquor, or drugs. I have seen very talented people in the Caribbean and North America who have been wrecked ...They are walking around practically begging, or they are dead" (Ref 3). He 'cares deeply about the welfare of young people. He said that their success is influenced by their upbringing and they must not forget their roots' (Ref 4)'. Martins enjoy doing lots of things. He 'makes furniture and plant trees in his spare time and he is a good handyman as well' (Ref 4). He said that 'the Caribbean should honor its artists and heroes in a big way.

‘Dave said that music will always be a part of his life. He credits his parents Zepherina and Joseph Francis for values they imparted in him as a child that have enabled him to treat people with respect and honesty and kindness’ (ref 4).

Section I - Caring is our responsibility

As a boy in Guyana, I saw how people took care of each other. Some had full time jobs and others didn't have jobs. Some faced illness. Some were elders with their own sufferings and need caring. Everyone in the household contributed to that caring. It was not a business. But normally always the person was cared for at home amongst family members. There are always exceptions; some do not have anyone to care for them or the illness may be very severe that other options has to be taken, but in general most are cared for at home amongst family members until they die. And no body got paid to carry out that caring, nor did they receive anything from the government.

It was often a shared responsibility. Not that family members though of it that way, but it was a normal process to provide the time to ensure the person was cared for. As far as I remember, nobody got paid to carry out caring. Its done out of love, and also it's a duty and a responsibility for family members. And today, I certainly do not get paid by anyone or by the government to care for my mom. I do it out of love. It's also our duty and our responsibility. I'm not here to judge anybody, as I understand that there are times when other options are taken. Everyone has to decide what they are capable of, and of course when the entire load falls on one person or on one couple, that breaks down the people involved in providing that care. So it should always be a shared responsibility amongst family members.

Section II - An innate love for our parents

I had watched a DVD called 'Why Man Should Recognize God' by Shaykh Khalid Yasin, who had converted from Christianity to Islam back in the 1990s. He stated, 'we have an innate love for our parents, from the time we were born to the time they depart from this world, and in the same way we also have an innate love for God when we were born.' That's a very important message from the Shaykh, as I have seen many showing that love to their parents and trying their

best.

Also an important message from the Holy Quran is:

“And our of tenderness, lower to them the wing of humility, and say: “O My Lord! Bestow Your Grace upon them as they had cherished and reared me when I was a child.” (Quran, 17:24)

Where does it say that it's the government responsibility or the responsibility of an institution? Where does it say that it's always a senior's home responsibility? It clearly states that it's the children's responsibility. Often there are others involved, such as spouses, or the child or children of their children etc...and this is often done at home in the family environment. It worked great in Guyana, but I cannot say the same thing for Canada because most people are too busy working and paying bills.

Comments on the verse above

(1) When the parent was strong and the child was helpless, parental affection was showered on the child: when the child grows up and is strong, and the parent is helpless, can he do less than bestow similar tender care on the parent? (2) But more: he must approach the matter with gentle humility; for does not parental love remind him of the love with which God cherished His creatures? There is something here more than simple human gratitude: it goes up into the highest spiritual region. Another excerpt from Ref 14 is: “**A strong sense of spirituality will help us face the challenges of living in today's modern world.** A strong spirituality is one that enables a believer to be confident in fulfilling their religious duties wisely and responsibly. A confidence that is based on spirituality will lead to a serene heart that will help one to face and overcome the stresses of life in today's modern world...” “*Let us not be among those who forget the obligation to be kind to others, especially to our parents and family members* simply because we are too tired from work or we are facing difficult problems. Be fair and do not take it out on our family members who are in need of our love, care and concern” (Ref 14)

Section III - None of us gets paid to provide care for our parent (s) that requires caring due to some illnesses; we do it out of love, else it's our duty

I do not carrying out care giving to be paid. I do it out of love and it's also a duty and a responsibility. I don't get paid to do this. The government does not pay me anything to do this. I do not get any kind of credits from the government or anybody to do this. I chose to do this. It's inborn in me; it's innate. Thus I have to make a sacrifice, regardless of any hardship I face doing this. I would rather face the hardship and have nothing than to ditch my responsibilities; it's much easier to go out and to work full time and do as you please and earn money and buy this and that and go traveling, but I know what my duties and responsibilities in life are. I still have to get out there and work, as I do have bills to pay. I chose to make a sacrifice as I know what my duties are, and what life is all about, but many do not understand this and they prefer to spend their time doing other things instead of taking on their responsibilities, and thus today all of that negligence and abandonment is leading us towards the destruction of the humanity, leaving a reckless future for children where the word 'parent' will not even be heard of, as there will be no parents in the future. Thus, this is a last opportunity to show love and to take care of your elders that needs help and for us to make a difference.

Caregivers are very important. Many are paid and many are unpaid. In Guyana, we didn't use terms like caregiver, because caring for an elderly or an ill family member was normally a part of the family's responsibility, and no body got paid, everyone took care of each other.

Very often the ones taking care of family members are unpaid and give their time because of love, as in myself being a caregiver along with other family members being involved in our mom's caring and program. I also assist others in taking them to the doctor, for physiotherapy, for an outing etc...And we don't call it caregiving, we call it love. It's our duty regardless. We're all unpaid as caregivers - we don't ask for anything in doing what we do - and I could say the same for about all families I know of that are originally from Guyana regardless of skin color, race or religion, and are living in places like Edmonton, Toronto, New York, Florida and other places. It's a way of life in Guyana, and many brought those ways with them to new lands, but the times are also changing.

Some are in positions where they cannot care for a family member at home because of situations. We may all end up in that situation, but as long as I'm alive I will do my part to my best ability. I'm not judging anyone by writing these articles. These articles are not being written to judge any of my relatives, friends or anybody. All I'm doing is sharing my experiences and our way of life with others.

We all learn from each other. For example when we were younger, we didn't understand what dementia is and the behaviors that came with it, but we do understand it now.

Section IV - Our home program and care

For my mom, she does certain activities every week. There are other things such as getting out and going for a drive and for coffee. For example during the week of June 1st, 2023, we went to the bank as my mom likes to do her own banking. Her math is still very good, as seen when other family members are doing math, questions and puzzles with her. After the bank, we drove into the university area, then Whyte Ave and then to a McDonalds on the Southside for coffee. My mom is old fashion and always just wants a plain bagel toasted with butter and a medium coffee with one cream. But I always get her one or two hash browns, and asks her if she wants anything thing else. While on the south side we almost always drive by the apartment buildings we used to live in when we first arrived in Canada, drive by the Junior High School I went to, the elementary school my brother went to, along with the other schools my family members and relatives attended. And we also always drive by some of the homes our relatives used to live. On the way back, as we drove down Jasper Avenue, I asked my mom if she'd like to visit one of her relatives and she said yes. I was surprise when she said yes, because normally she would not feel up to it. After visiting our relatives which also surprised them, we were then on our way home and we stopped at the cemetery to visit the graves of my dad, grandmother and uncle. How often would some one in an old folks home get to do these things?

And at home we have a cat, who my mom really adores. The cat always put a smile on my mom's face and she always call for him. These are all benefits to the person living at home with a family member (s) and the cat also gets a lot of attention, love and care. The following week I planned to take my mom and my aunt for a drive and coffee, but my aunt could not make it, but my mom and I went out for the drive and coffee.

Section V - Serve the creator - he told us what our responsibilities are

When we worship the creator, we are serving him, therefore in many instances worshipping is

the same as saying serving. Note how the word worship and serve are used interchangeable. When you take care of your parents, orphans, giving charity to the poor etc and you are following the guidance from God, you are worshipping him, in other words you are serving him with what he asked you to. It's easily to go astray and to forget our duties. Many of us strives in the remembrance of God through out the day, else the devil and his followers can easily throw us off the straight path and make us forget our responsibilities, as the shaitan (devil) and his followers are waiting for us on the straight path to lead us astray in the way Iblis (Satan) had done to Adam and his children.

Section VI - It's a great sin and crime to abuse a person that requires care

Recently, in the in the mainstream media there were some articles concerning the care of a person with illnesses or an elderly person where abuse were involved. Similar abuses also have happened in seniors home.

THERE'S A PLACE OF SANCTUARY IN EACH ONE OF US IT'S A SIMPLE MATTER OF UNDERSTANDING THAT THIS PLACE EXISTS AND THAT WE CAN GO TO THIS PLACE ANYTIME WE CHOOSE

IMAGINE the alarm clock beeping at 6 am and immediately your inner world gets filled with endless thoughts of roller coaster loops while your tired and restless body says five minutes more. You escape into our inner world of fantasies, wishful thinking, making revisions to the past and how the future must turn out. Another half-an-hour slips by before dragging your tired body out of bed. You crawl into the shower, grab a coffee and rush out the doors. While driving with the radio blaring, you become preoccupied with your inner world of thoughts and revisions of the past, so your past experiences turns out the way you think they should have turned out. Suddenly your subconscious senses the change in traffic lights, from green to orange and you spontaneously react by slamming on the brakes, bringing your conscious mind into focus and back into the present moment, spilling coffee on your clothes. Ouch! You bellow, becoming

anxious, uptight, tense and stressed as your blood pressure rises and your breathing becomes choppy.

In each one of us there's a place where everything's all right. In this place there's no need to keep escaping to your inner world of fantasies and to keep revising the past. This place exists in the present moment and can be accessed through present moment awareness. When you retreat to this place, you will find stillness, sanctuary, acceptance, peace and harmony. You will become more relaxed, less tense, less stressed and, as a result your health will improve.

Techniques to find this place of stillness sanctuary

Tools such as meditation, yoga, deep breathing, prayers and Tai Chi can be used to find stillness and sanctuary in the present moment where every's all right. For example meditation is a tool used to silence the over active mind from driving us mad. Once the mind become quieter, we start to get a glimpse of this place where everything's all right. Our body starts to heal as stress and tension disappear and we realize there's no need to dwell in the past or to constantly escaping to our inner world filled with revisions of how things should have been and how the future must turned out. You will find acceptance, peace, happiness, and relaxation.

Meditation through breathing techniques

From the few Yoga classes, which I have taken, one form of meditation is to lie on the floor, on your back, with your arms out and body relaxed. You inhale and exhale slowly paying attention to your breath. Remember that when you inhale, your diaphragm expands pushing out your stomach and as you exhale your stomach goes down. As you inhale, feel the air moving through your nostrils, your windpipe, lungs and back up through your windpipe and nostrils.

The mantra should slowly fade leaving your mind in complete silence, peace and harmony. Your breathing will improve and you will become more relaxed, peaceful and healthy.

Mediation through Prayers

A lot of people pray for money, fame, a big house or to be better than someone else. But little do they know the essence of prayers. Prayer is a form of meditation, which is extremely beneficial when done correctly. I personally believe that the more a person prays correctly, the more he or she will see the benefits, especially when it comes to health, something each and everyone of us seeks. I believe that during any prayer, the mind must be emptied of all distractions and unwanted thoughts, quieting the over active mind making the body more relaxed, peaceful and healthy. Preface

The Trilogy of Savitri's Garden by Fisal Ally is a love story based on the first batch of indentured laborers that left India in 1838, crossing the Indian Ocean and the Atlantic Ocean and arriving in British Guiana (Guyana) in South America on May 5th 1838, as slavery was recently abolished, yet these new laborers were treated as slaves, where many succumbed to diseases and deaths. During my research, when it comes to slavery in Guyana and the Caribbean, I keep coming across articles where the British - mainly English - were highly involved in the slave trade and were profiting from crimes against humanity. At least a decade later, I came across the article called 'How Scotland erased Guyana from its past' by Yvonne Singh. I was very surprised to hear of the abuses by the Scottish that had taken place in Guyana. Then I began hearing more of the crimes the Scottish had committed in Jamaica. Many in the Americas know about slavery, but do not know how involved the Scottish were in slavery.

The Indians from India arrived in Guyana at the tail end of slavery and thus many were treated as slaves where many were beaten, mistreated and worked to death. The Scottish Historian, Dr. David Alston have researched on the Scottish involvement in the slave trade bringing this information the public, which according to Yvonne Singh's article 'How Scotland erased Guyana from its past' shows that the Scottish had hidden their past from the public. Indranie Deolall's article 'A whisper behind the silence' provides information based on Dr. Alston's research on some of the crimes committed by the Scottish during the slavery British Guiana (Guyana) in South America.

In 'A whisper behind the silence by Indranie Deolall, October 8, 2021' states, "Scots were involved in every stage of the slave trade: from captaining slaving ships to auctioning captured Africans in the colonies and hunting down those who escaped from bondage. This book focuses on the Scottish Highlanders who engages in or benefitted from these crimes against humanity in the Caribbean Islands and Guyana, some reluctantly but many with enthusiasm and without remorse. Their voices are clearly heard in the archives, while in the same sources their victims' stories are silenced - reduced to numbers and listed as property" (Ref 1).

Section 1 - History & culture, The 1833 Slavery Abolition Act

Background

'In the 18th century, the West Indies (includes many of the islands in the Caribbean and British Guiana (Guyana) in South America had become a main trading center due to the enslavement of human beings, first the Amerindians (American Indians) and then the en-slaved Africans. Although the enslaved people fought for their rights and freedom, they could not defeat this evil, inhumane, terror and disgraceful act, which continued for hundreds of years for the accumulation of wealth' (Ref 7).

William Wilberforce

A British by the name of William Wilberforce, born in 1759, learned that the British public was not aware of the horrors of slavery, taking place thousands of miles across the oceans. Wilberforce was not blinded the way the mass was. He was brilliant and could see what others could not see. He fought against slavery and succeeded when slavery was abolished throughout the British Empire. In 1807, it became illegal for British ships to carry enslaved Africans torn from their homes and families, however, this did not prevent planters in the Americas (and in Britain) from demanding slaves as the evilness of slavery continued where the planters continued to accumulate wealth through the bondage of humans (Ref 7).

Wilberforce continued to work towards stopping this evil profit making business and in 1833, his perseverance and his good for humanity had finally paid off. The Abolition of Slavery Act was passed on August 24th 1833 by the British Parliament which became law on August 1st, 1834 where emancipation took place, meaning the act of slavery by the plantation owners against people who were enslaved was now abolished (Ref 7).

Section II - The Trilogy of Savitri's Garden, a historical fiction love story based on the first batched of Indians laborers to the Americas

After researching for about 15 years and writing and rewriting the novel 'Savitri's Garden' which was first published in 2002 and then updated over the next few years, this novel grew into a trilogy with a study guide, and included lots of facts to teach the history of indentured laborers to British Guiana (Guyana in South America). The first book was broken down into two parts, and thus there are four novels and a study guide, a total of 5 books.

Ex-slaves in the Trilogy of Savitri's Garden

During my research, I came across a lot of articles on slavery. In the Trilogy of Savitri's Garden, here were fictional characters that were ex-slaves named: Cooper (Coop) who was now a servant in the novel; Jamal Thomas; Joseph now an African driver; Lillian (Lilly), Kwesi who was a mulatto and now a driver.

From the glossary at the back of book I, Part I are some important definitions:

Abolishment of slavery - took place in 1838 in the British colonies, while slavery continued in other places such as America, Brazil and Cuba and was not abolished till after the 1860s (Ref 8).

Apprenticeship period - after slavery was abolished on August 1 1834, the Africans were placed on an apprenticeship program, where the agricultural workers would work for six years, and the non-agricultural workers would work for four years, but the work was harder and the hours were longer. During the apprentice period the Africans worked forty and a half hours a week with no pay, and they were given the option to work for wages for thirteen and a half hours or they could have used this time to work on their own provision ground. The apprentice periods had ended on July 31, 1838 for all apprentices (Source: The West on Trial by Cheddie Jagan) (See Ref 8)

Section III - Slavery in Scotland

The Scottish involvement in the slave trade where a Scottish historian, Dr. David Alston provides research, along with Yvonne Singh and Indranie Deolall

'For more than 20 years, the historian Dr. David Alston (a Scottish historian) has been on an often lonely road, carefully researching the extensive role of Highland Scots in the transatlantic African slave trade, and the profitable plantations of the Caribbean, but especially the prized jewel British Guiana (Guyana in South America), where they came to seek, make, keep and add to their fortunes' (Ref 1).

'Due for release this month as a scholarly book of the same name subtitled "Silenced histories of Scotland and the Caribbean," his 400 page publication by Edinburgh University Press, is an

important and courageous collection of evidence that seeks to help correct the national narrative including the myth that the Scots were more egalitarian than the English, and that they did not engage in the slave trade' (Ref 1).

“Scots were involved in every stage of the slave trade: from captaining slaving ships to auctioning captured Africans in the colonies and hunting down those who escaped from bondage. This book focuses on the Scottish Highlanders who engaged in or benefitted from these crimes against humanity in the Caribbean Islands and Guyana, some reluctantly but many with enthusiasm and without remorse. Their voices are clearly heard in the archives, while in the same sources their victims' stories are silenced - reduced to numbers and listed as property” (Ref 1)

He adds, “but these voices remain a whisper. And yet even that whisper is difficult for us to bear. We (The Scots) are indeed ‘well wadded with stupidity’ and are inclined too readily to wrap ourselves in comfortable narratives of Scottish and Highland victimhood...” (Ref 1)

In 1833, Britain's Parliament finally abolished slavery.

How Scotland erased Guyana from its past - Yvonne Singh

‘It's hard to process that a network of Scotsmen from here and the surrounding area used Guyana as a “get-rich-quick-scheme”, exploiting for profit the trafficked humans (both slaves and indentured labourers) who were my ancestors. A “gold rush” with no thought of the tragic human consequence. Says Singh’ (Ref 2)

‘As I wade through research and testimonials of the fate of slaves in Guyana. it's difficult to suppress the anger I feel: up until 1826 (nearly two decades after the abolition of the slave trade in 1807), “the 11 o'clock flog” was administered in Berbice's searing heat to men and women who flagged in their tasks; sexual abuse was so endemic in the same district that, in 1819, one in 50 of the enslaved population was the child or grandchild of a white European’ (Ref 2)

‘She then recalls a troubling story. “Granny said that he Indian women would be working out in the rice fields and it was then that most of the rapes would take place. No one would hear them scream...it was only nine months later that they had to deal with the consequences’ (Ref 2).

‘Today, steps are being made to acknowledge Scotland's slaving past’ (Ref 2)

Slavery and bondage in Scottish collieries

‘For nearly two hundred years in the history of coal mining in Scotland, miners were bonded to their “masters” by 1606 Act “Anent Coaliers and Salters”. The Colliers and Salters (Scotland) Act 1775 stated that “many colliers and salters are in a state of slavery and bondage” and announced emancipation, those starting work after 1 July 1775 would not become slaves, while those already in a state of slavery could, after 7 or 10 years depending on their age, apply for a decrees of Sheriff Court granting their freedom. Few could afford this, until a further law in 1799 established their freedom and made this slavery and bondage illegal’ (Ref 6).

‘Significantly, Scotland and the Scottish people benefitted from the wealth and opportunities that slavery generated. This legacy is still present in our Georgian buildings, statues and street names. Scottish men and women played a strong part in the development of this trade, as well as its abolition’ (Ref 6).

Enslavement markets and auctions

‘Following the union of parliaments in 1707, Scotland gained formal access to the transatlantic slave trade. Scottish merchants became increasingly involved in the trade and Scottish planters (especially sugar and tobacco) began to settle in the colonies, generating much of their wealth enslaved labour’ (Ref 5).

Section IV - Slavery in Britain

‘In 1772, Somerset v Stewart held that slavery had no basis in English law and was thus a violation of habeas corpus. This built on the earlier Cartwright case from the reign of Elizabeth I which has similarly held the concept of slavery was not recognized in English law. This case was generally taken at the time to have decided that the condition of slavery did not exist under English law. Legally (“de jure”) slave owners could not win in court, and abolitionists provided legal help for enslaved black people. However actual (“de facto”) slavery continued in Britain with ten to fourteen thousand slaves in England and Wales, who were mostly domestic servants. When slaves were brought in from the colonies they had to sign waivers that made them indentured servants while in Britain. **Most modern historians generally agree that slavery continued in Britain into the late 18th century, finally disappearing around 1800.**’

‘Before 1066

From before Roman times, slavery was prevalent in Britain, with indigenous Britons being routinely exported. Following the Roman conquest of Britain, slavery was expanded and industrialised.’

‘By the mid-18th century London had the largest African population in Britain. The number of black people living in Britain by that point has been estimated by historians to be roughly 10,000 though contemporary reports put that number as high as 20,000. Some Africans living in Britain would run away from their masters, many of whom responded by placing advertisements in newspapers offering rewards for the returns.’

‘Some of these people fled their slavery in an attempt to create a new life for themselves in the streets of London...’

‘Whilst slavery had no legal basis in England, the law was often misinterpreted. **Black people previously enslaved in the colonies overseas and then brought to England by their owners, were often still treated as slaves.**’

Andrew Holness tells it like it is as Jamaica evolves into a digital society, like what we've been hearing about over the past few years. The speech by the Jamaican Prime Minister is on what’s coming and what’s unfolding before our eyes. The LINE is a part of the NEOM project in Saudi Arabia. To many, this futuristic city project is impossible and is just a fantasy or fiction seen in a movie. But construction of this project has already begun in the province of Tabuk in north-western Saudi Arabia, which starts from the Red sea and runs 170 kilometers east going across the desert, mountains and valleys. It's planned to be 200 meters wide and 500 meters high. And the cost is predicted to be \$725 billion dollars and is expected to be completed in 2025. Another video called HERO DOC WAS INTENTIONALLY POISONED WITH 200X THE DOSE FINAL TESTIMONY (Reference 22), First published at 03:03 UTC on May 21st, 2023.

Another video is: HOW THEY WILL CONTROL THE ANGER OF THE VAXTERMINATED (Reference 23) First published at 13:21 UTC on August 9th, 2022. 'Dr. Buttar says that everyone who has had the Vaccine has a Ticking Time Bomb inside them.' The other word he used in his video is a 'payload.' Many believe that the news he was coming out with to warn the world about what has been placed inside many people's bodies and how it will affect us had caused him his life, to silence him, as a big conference was about to be held where he was one of the main speakers. He never made it to the conference, but we're sure he made it to a good place in

Dr. Michael Yeadon, Pfizer past Vice President

Supreme Court Master Grant Taylor of violating, among other things, his "right of protection and preservation of the vessels of my bloodline [and]... the vessels of the souls of my children." "It accuses Taylor and the court of exposing Nagase's children to "future consequences untold and not yet realized of myocarditis, thrombosis, cancer and sterility." **His children received 'what he describes as "a prima facie MEDICAL EXPERIMENT commonly known as COVID-19 vaccination."**'

Nagase is asking \$33.3 million in damages. 'Nagase, who has resigned his license to practice in B.C., is accused of violating professional standards by "making public addresses regarding the COVID-19 pandemic and related issues that included his making misleading, incorrect, or inflammatory statements about vaccinations, treatments and measures for COVID-19," the public notice says.

The VAERS records have proved that there were many deaths and injuries after people have taken the covid-19 jabs. There were also many stillbirths. Even during the Pfizer trials there were injuries. For the longest time we’ve heard of the Internet being censored in places like China, Iran and Saudi Arabia. Recently a female who criticized the NEOM project in Saudi Arabia on social media was imprisoned. Also, lately the public has become preoccupied and distracted with mainstream news on the titanic and on the riots in France after a French policeman shot a 17 year old. In a video posted on June 25, 2023 (Ref 9) a headline was from **CBCNN live states: ‘Facebook and Instagram to end all news availability for Canadians users following passage of Bill C-18’**. Breaking news: Meta axing news availability in Canada. **The host of the video says, ‘All independent news outlets have been silenced.’**

Google search states: ‘Bill C-18 has become law and remains unworkable. The Government has not given us reason to believe that the regulatory process will be able to resolve structural issues with legislation’, June 29, 2023 (ref 43).

Google search states: many countries have banned or temporarily limited access to Facebook. Use of the website has also been restricted in various ways in other countries. As of July 2022, the only countries to continually ban access to the social networking site are China, Iran, North Korea, Myanmar, Russia, Turkmenistan and Uganda; retrieved on July 14, 2023; 12:10am Edmonton time (Ref44).

Discussions to censor social media during the riots in France

Days following bill C-18 in Canada, on June 28 it was reported on BBC that ‘Anger in Paris after police kill teen in traffic stop’ (Ref 52). According to the news ‘Protests and unrest erupted

in the Paris region overnight after police shot dead a 17-year-old who failed to stop when ordered to by traffic police.’ On Reuter’s news (Ref 40) states ‘France riots: Minister deploys 45,000 police amid riots by Layli Foroudi and Charlotte Van Campenhout, June 30, 2023. The news states, ‘France’s interior minister said on Friday the coming hours would be decisive as he sent 45,000 police onto the streets following three nights of riots since an officer shot dead a teenager at a traffic stop in a working class suburb of Paris.’

During these riots, Social media was being blamed for the riots. According to the article ‘Why social media is being blamed for fueling riots in France’ (Ref 53) published on June 30, states ‘social media companies are once again under scrutiny, this time in France as the country’s president blames TikTok, Snapchat and other platforms for helping fuel widespread riots over the fatal police shooting of a 17-year-old-driver.’ The article states ‘During his speech on Friday, Macron did not specify what type of content he viewed as “sensitive,” but he said he expected “a spirit of responsibility” from the social media platforms.’ In Euronews.com/2023/07/05/violent-protests-prompt-french-president-to-consider-suspending-social-media-tools; **Macron threatens to cut off social media during protests**, after unrest by Una Hajdari; updated 06/07/2023 (Ref41) states: ‘French president Emmanuel Macron claims that protesters are using Snapchat, TikTok, and Telegram to film violent events and organize illegal gatherings.’ ‘French President Emmanuel macron discussed the possibility of banning access to certain social media features, in a meeting with local mayors in the cities that have seen violent protests.’

It’s seems as if Canada and France are moving in lockstep censoring social media. Will other nations soon follow Canada and France also censoring their News? In the past, very often-social media platforms were already censoring alternative news on covid-19. According to the National Post (Ref 42) published on June 22, ‘Meta says it’s blocking news on Facebook, Instagram after government passes online news bill.’ **‘With Bill C-18 on the verge of becoming law, Canadians could soon see news removed form their Facebook pages and Google searches by Anja Karadeglija, published Jun 22, 2023 (Ref42). And excerpt is: “Today, we are confirming that news availability will be ended on Facebook and Instagram for all users in Canada prior to the Online News Act (Bill C-18) taking effect,”** Facebook said in a blog post on Thursday afternoon.’

He did a heavy metal cleaning. He did a d-dimer test, which looks at the clotting of your blood, clotting of the arteries. He did it twice in 6 months period. He said he was so shocked and the doctor said you need to do it if you want to survive after taking these shots. When she (referring to the nurse) took out the blood there was some white thing in

there...his friend told him they found this in athletes and that is the reason they die, they have this white blood clots, tons of them in their blood, they have them everywhere. He went to a doctor and this time they didn't see the white stuff, they saw black particles and he said this is heavy metal you have in your blood.

He said when he think about it that it was some kind of a flu and that what it is, and people over reacted maybe, and people maybe saw opportunities for - the host said 'making money' . He said, ultimately, I think there was a kind of over reaction to this.

At time 30:55, Bill Gates who is on the TED show says, ‘Now malaria from the bite of mosquitoes - I brought some here.’ He opens the cover of a clear container and then says, “We will let those roam around the auditorium (the audience laughing)” he continues “there is no reason only poor people should have the experience.” He’s smiling and laughing as people clap. He then said, “those mosquitoes are not affected.” The headline says, “How do you stop a deadly disease that’s spread by mosquitoes - so we come up with a few new things (there may be some errors in this part of the transcript due to not making out some of his speech). At time 31:50 of Ref 8, the headlines

states 'Bill Gates announce \$168 million dollars to develop next-generation malaria vaccine.' The host of the video says referring to Bill Gates that he's 'here to save us from the GMO mutant mosquitoes he developed in the first place.'

In the article called 'Bill Gates-Funded Firm Releases 150,000 Genetically Modified Mosquitoes In The Wild by Monit Khanna; May 5, 2021 (Ref 46); indiatimes.com/technology/news/bill-gates-funded-firm-genetically-modified-mosquitoes-539802.html states: 'A biotech firm funded by Bill Gates has released 150,000 genetically modified mosquitoes in the US to curb mosquito breeding and gain control over the spreading of diseases like dengue and malaria.'

'How do these mosquitoes work?'

'According to the study, researchers have bioengineered male *Aedes aegypti* mosquitoes to mate with the wild female population (females are known to bite their prey and cause dengue/malaria). The genetically engineered males carry a gene that passes to their offspring and kills female progeny in early larval stages. The male child won't die they'll continue to possess the gene that will pass on to future generations. The article states: This factory breeds 30 million mosquitoes per week. Here's why. 'These mosquitoes are allies in the fight against dengue and other deadly viruses, by Bill Gates; April 15, 2022

'Inside a two-story brick building in Medellin, Columbia, scientists work long hours in muggy labs breeding millions and millions of mosquitoes. In the podcast, at time 1:13:55 into the video, Sophia Dhal Tweets (May 13, 2023): Bill Gates-funded lab breeds 30 million mosquitoes a week for release in 11 countries.;

(Fact check) -Currently Rated Helpful tweeted (May 13) - 'These mosquitoes are not genetically modified. They merely carry bacteria called Wolbachia that blocks them from transmitting dengue and other viruses such as Zika, chikungunya and yellow fever, to humans. They will spread this to wild mosquitoes

Time 1:18:41, the video states: 'CCHF is on the World Health Organization's list of 'priority' diseases, and its found in eastern Europe and now France. Other diseases the UK has been warned to look out for include deadly Rift Valley fever, Zika, and 'breakbone' fever.

Spraying, GMO's and the decline of bee population (Ref 8)

In the article, 'gmoanswers.com/are-gmos-causing-decline-bees, Are GMOs Causing a Decline in Bees? (Ref 48) states: 'The sudden and widespread disappearances of adult bees from hives, termed Colony Collapse Disorder (CCD), became a national concern more than 10 years ago. Claims circulated that certain GMO crops harm bees. These assertions have been refuted by the mainstream scientific community.'

At time 9:20 in the podcast of Ref 8 states, 'Bee species are threatened by multiple factors including harmful pesticides that kill bee populations and habitat loss. Harmful chemicals can paralyze or even kill bees. But the main threat to bee populations? Climate change.' at time 9:35 states: '**Robotic bees** - A Solution to the declining population?' by 180 Degrees Consulting Hansraj; Sep 3, 2021.' At 10:05 states, 'These GMO crops were made to self pollinate.' The host says that Monsanto knows that the bees throws a wrench into their plans, as bees naturally creates food.' '**When a bee attempts to pollinate a GMO plant or flower its poisoned and dies.**' 'The bee colony collapse has been going on and has been recognized since.' He says Monsanto bought out the largest bee studying plant that's studying the bee collapse. 'Now they turn around and blame you for the decline of insects and animals population, saying your daily intake of carbon are contributing to the sixths mass extinction.'

In the article, Santosorganics.com.au/blogs/planet-based-living/genetically-modified-crops-threaten-bees (Ref 49), Genetically modified crops threaten bees states: '**The world's food supply could be under serious threat.** Antibiotic resistant genes from genetically modified crops are suspected of decimating the North American bee population.' 'The US is importing millions of dollars worth of Australian bees to pollinate its food crops. US bees are dying from antibiotic-resistant strains of bacteria, likely to be the result of widespread genetically modified (GM) crops. At the same time, the Australian Federal government is pushing for the adoption of GM crops here, and is reducing support for Australian beekeepers.'

'Friends of the Earth in the UK' 'Reports "Concerns have been expressed by English Nature, the Government's own wildlife advisor, as well as the Royal Society for the Protection of Birds and the Wildlife Trusts that the widespread use of GM herbicide-tolerant crops is likely to threaten wild bee populations."

Section VIII - Forever chemicals in our food consumption

We continue to learn more about how plastic and chemical gets into our food and water supply. It should be obvious that when you heat up plastic containers in a microwave that the container heats up and that some of the components from the plastic can leak into your food. In a report called video called ‘FOOD & TAP WATER POISONED! - Government Makes HUGE Admission In Study! - 98% Of Population At RISK! World Alternative Media (Ref 34), the headline from the Daily Mail.com says '**Nearly Half of tap water in US is laced with hormone-warping 'forever chemicals;** linked to cancer and infertility, major government study finds - with worst-hit areas in Cali Eastern Seaboard, Great Lakes, and Great Plains.'

In the podcast at (Ref 34), the host said chemicals caused frogs to become gay, having sex with same sex frogs. The host said, 'We already know they are putting hormones in the cattle causing girls to hit puberty younger and boys to have issues getting testosterone and also causing severe psychological issues.' Its evil what they are doing to us; it's a part of transhumanism.' 'they are doing this unpurpose.'

- Manage biological innovation
- Structure and manage production and supply chains

W-Fi radio frequency

In the video (Ref 10), at time 48:50 headline 'Wi-Fi, wireless radio frequency radiation can damage the blood brain barrier.' Studies done on rats prove this to be the case. Even cell phones gives off high power radio frequency radiation and over time when placed next to your eardrums and the sensitive tiny ear bones can cause cancer.

Some of the points listed are: 'Machine learning helps scientists predict which genes to target for editing'; **'the world's first babies to have their genome edited born in China'**; 'creating new organs and enhancing human functionality'; 'biohacking with implanted digital devices to enhance bodily functions'; 'implanted chips for a highly personal version of two-factor authentication.'

There are always a lot of good in technology, but the problem is the evil use of technology outweighs the good and has brought about the destruction of many societies through wars, and is now used for the destruction of humanity across the entire earth. The host states that it's all good that limbs can be made to better some one etc..., but the problem is 'the technology is being weaponized against humanity.'

WIDE EYED INNOCENT OUT OF CONTROL

I was a lead guitarist, but on many of my recordings I also played bass, rhythm guitar and keyboards. I played bass on all of my home recording. Actually I played all of the instruments on my recordings, except for one song where a friend from work, Rob Chizek, played saxophone on the instrumental version of Blue Caribbean Sea. In our band formed in high school, the player who was actually a guitar player said he would play bass; he was also a rhythm guitarist and lead guitarist. Our rhythm guitarist also played around with the bass a bit.

Playing the bass line for a recording on ‘A Kiss Goodnight’

When I was putting together a 4 song tape where some of the recordings were done in my home studio and also in a professional studio, I had gone down to Homestead studio to do a mix and to also get some tapes of the song. It's in these professional recording studios you always pick up some good tips on playing. Thus my recordings done at home and in the professional studios were all published back in the days where my songs were placed on medias such as tapes and CDs and were handed out to the public as independent productions.

While I was redoing some work on ‘A Kiss Goodnight’ at Homestead studios, Barry Allen gave me some tips on how to play a good bass line that's in sync with the bass drums. I already had a bass line for the song which was not always in sync with the bass drums because I played what I felt, and as I was redoing the bass line in Homestead studio, Barry told me to strike each bass note at the same time with the bass drums. So I did, and thus the bass line was now in sync with the bass drum, and it's this bass line, which is used in all the other recordings, where also I added my original bass runs.

How I came up with the bass line for Wide Eyed Innocent

In the 1990s while I was doing some home recordings with a drummer whom a friend had introduced me to, I played a different bass line on Wide Eyed Innocent in those days. As I practiced this song after those initial recordings, I was beginning to touch on something more so I had to follow through with it. My chord progression changed where this song became a heavy guitar playing song. It was a different bass line I was coming up with and I would say that this is one of my best bass patterns. It took a while to change the rhythm guitar to a more heavy metal rhythm guitar, and thus I came up with this new bass line. When I was doing some recordings at Power Sound, I was going to play bass on all of my recordings since I already had a bass and bass lines, but the owner of the studio, Phil Anderson, who was a professional bass player and had played in a very popular band in Edmonton back in the days with a hit song on the radio said that he could play bass for me on the songs, and I agreed to it, and of course I paid him to play as

I did with other players. As stated before, I entered professional studios when I had some extra money and I always paid for studio time and paid the other musicians - who were always professional musicians to play on my songs. Phil had played the exact same bass line, which I had created with basically no modifications, except on the in the chorus he played it different which was awesome. Unfortunately, a few years ago, I heard my exact bass line for Wide Eyed Innocent being played somewhere, obviously stolen as these reckless musicians have done to many of my songs just contributing to the destruction of music, and apparently we're seeing the destruction of the art, as AI is taking over music, thanks to the thieves that stole and destroy our music, and of course they are all collecting royalties from the songs which I have written.

Phil Anderson at Power Sound Studios came up with an amazing bass line for Keep Mae Fire Burning

Initially, I had played a bass line for Keep Mae Fire Burning in my home studio, but at Power Sound, it was Phil Anderson who came up with an amazing reggae bass line for the song. That shows how amazing of a bass player Phil Anderson is.

Bass line for Out of Control

Out of Control was all done at home where I played all of the instruments and for drums I mainly used a drum machine on all of my home recordings, so I came up with a bass line for Out of Control. Once again, unfortunately, a few years ago, I was walking downtown and I heard a group playing my song (in other words stole my song) Out of Control or the song may have been coming over PA system.

Bass line for the instrumental Say No

The instrumental called Say No was done at home, and I came up with the bass line. Once again unfortunately, I was walking through the mall a few years ago, and I heard another group playing my song, in other words they stole my song and they are all collecting my wealth. Who would ever believe that some musicians in Edmonton, Alberta, Canada or in other places are so nasty and wicked? These thefts have led to the destruction of music, as AI is taking over music.

Bass line for Missing you going crazy

I came up with the bass line for this song, and I had done the recording at Big Records where Dennis Shehan was the engineer and Tim Lent played drums. Later, while doing some recordings at Power Sound, we had problems recording this song, and thus there is only one main recording of this song, which was done at Big Records; this recording is on www.allymedia.ca under the music tab, and scrolling way down.

Bass line for SoCrazy4u

Initially, I came up with the bass line for this song. While recording this song at Beta Studio, the producer's bass player was playing bass. He played basically the same bass line, but because he is such an amazing bass player, he revved it up - that's the best way for me to explain how he played the bass line, which sounded great.

Bass line for True Love, and Lisa

I came up with all of the bass lines. At Beta Recorders owned by Gary Koliger in Edmonton, while I was recording Lisa, their bass player basically played the same bass line, but when you are a professional bass player and played for decades like their bass player, they sure add good stuff to the bass line, and it was the same bass player that played bass on SoCrazy4u at Beta Recorders - no doubt a very talented bass player. The intro for Lisa is also played two ways. The original way is where I started of with a part of a chord progression used in True Love, as Lisa is an offshoot from True Love, but during a JAM SESSION in the 1990s (The 1990s Independent

scene) with about 8 of us and with live drumming, a bass player of Portuguese background, who was a good friend of a person I know and who was also at the jam session, had played the bass line with a different pattern, and I still use that same bass pattern today on that version of Lisa, and that's the great thing about having independent music and different versions of a song.

THE SCAMS TAKING PLACE THAT HAVE LED TO THE DESTRUCTION OF MUSIC

Music is a big business. But for someone like myself, I enjoy singing my songs along with cover tunes while just simply playing my guitar. And over the past years I've probably made about 100 videos playing and singing some of my songs and many cover tunes.

The journey continues. I do not need anybody to tell me what to do with my songs and books. I'm an independent artist and I make those decisions.

Go on your own music journey based on your own credentials

Don't let a friend talk you into something you will regret later and that will stain your life forever. Don't steal people's songs. Write your own songs, or get songs from others and not stolen songs.

How did I come up with the song The Birds Won't Come My Way

I was in Ft. McMurray working and I went with a roommate to a junkyard to assist him in getting an engine for his car. He basically did all the work, using some tools to remove an engine from a vehicle, so while he did that, I was taken up with the birds flying around in the junkyard and in the near distance, which to me seemed to be polluted. This song is about pollution. And today we see everything is true in this song. Look at the recent sky over NY and its orange reddish color and a lot of gray skies...

When it comes to the art of music, I go on my own journey, doing it for myself

I don't write songs for riches or fame. I write songs for myself. Anyone can do it. Anyone can write a song. But you have to do it yourself and you have to put in the time than to expect others to do it for you. Songwriting is easy, but some songs can take a long time to complete. The more you write the better you become and the more different kind of songs you will come up with. But you have to do it yourself than to expect someone else to do it for you. If you love what you do, you will continue to do it, regardless of what others think about your songs or voice. As a teenager, we also state that we will write songs the way we choose to write our songs and not to do it because others say we must write a certain way. I remember us saying that we would not go commercial. By the time I was age 21, I had written about 75 songs.

With songwriting you have to put in the time

I had written about 75 songs by the time I was age 21. I didn't sit on my butt and expect the songs to appear. You also grow as a songwriter and musician. I heard about some musicians stealing people's songs and thus I had written a book called 'The copyright scam.'

After what had taken place over the pass 13 years, I will not give anybody permission to use any of my songs

Based on everything I've witnessed, **I will not give any of my relatives and any of my friends, nor anyone permission to use any of my songs where others may pull them into scams.** Thus I could only try to keep my relatives and friends and myself out of trouble by not allowing others to pull us into their scams. If people wants to rob us and destroy us then that's their choice, but I'm sure they will pay one day - if not in this world, then for sure in the next, but little do they understand or realize it.

Video taping my original songs

Over the years I would set up a small camera and videotape my own tunes and also cover tunes. I probably have about 100 videos. Recently, I would just pick up an old acoustic guitar, turn on the camera and start to sing some of my songs. It's all raw. I don't even comb my hair. And it's all for fun, and as you can see, my cat, Furrari, is keeping my company as I play and sing. When I look at the video, I'm surprise to see him in the videos, going in and out of the house and deck, and then hanging out next to me and listening to me sing.

Guyana making waves in its oil discoveries and production drawing countries around the world

Guyana is in pink

Guyana is a small Amazonian South American country that borders Venezuela, Brazil, Suriname (Dutch Guiana) and the Atlantic Ocean and has just under 800,000 people. In the past Guyana was developed by the Dutch, French and British, and thus you will see names such as Vreed-en-Hoop, Vreed-en-Stein, New Amsterdam, La Penitence, La Bonn Intension, Essequibo, Georgetown, Richmond. Many cultures came to Guyana, from the Africans, Portuguese, Indians (from India), Chinese, other Europeans such as the Germans, and the original people are the Amerindians (American Indians). Today there are many Venezuelans and Brazilians living and born in Guyana.

Guyana making waves in oil

This South American country is once again on the map with its oil discoveries. Guyana's oil production continues to increase and is now 383,000 bpd (barrels per day) and it is predicted that by 2027 that Guyana will be producing 1.2 million bpd. Even rumors have surfaced 'about Guyana being invited to join the Organization of Petroleum Exporting Countries (OPEC), only to be swiftly denied by the producers' group.' (Ref 6)

'A change of mammoth proportions is happening in Guyana and it has sent oil market commentators scrambling to revise their medium-term global market outlook. That's because this micro-state in Latin America - with a population of less than a million people - is in the midst of a full-blown oil production boom, and is now one of the industry's most promising investment frontiers' (ref 6).

Guyana's auction delayed once more

Once again, Guyana has moved its auction date from July to mid-August. But the new date is not set as yet. 'The government will evaluate comments and suggestions and seek parliamentary approval of the Petroleum Act before the action, Jagdeo said' (Ref7). 'The South American nation has three times before delayed the offer of 14 blocks intended to recruit new explorers and lessen the grip over its oil output by a group led by Exxon Mobil Corp9.' (Ref 7)

'Terms are yet to be made public, but the new PSA could have a 10% royalty clause (Ref 6)' from the 2% royalty when Guyana made its original contract with ExxonMobil, however even with royalties at 10%, 'it would still be at the lower end of the royalty scale in Latin America' (ref 6).

India and many others has eyes set on this South American nation

The small South American country of only 800,000 people, as there are more Guyanese living outside of Guyana than inside of Guyana, is now known amongst the other leading oil producing countries. India is also eyeing Guyana, as Guyana's oil explorations continue with new discoveries. Guyana oil is drawing people from the surroundings. Although in the Guyana gold mining industry drew many Brazilians to Guyana, now there workers coming from places like Columbia, Venezuela and Cuba.

There are some set backs, where Guyana is in the top ten countries in the world for crimes and thus many Guyanese are still hesitant about going back to live or to even visit Guyana, knowing that one of the main reasons many had left Guyana was because of the high crime rate. Also the government had rushed in its oil commitment with ExxonMobil and thus from the very beginning, there have been concerns on what would happen if there's an oil spill in the ocean who would cover the cost. It's well know in the Latin America / Caribbean region that there was an explosion in 2010 that caused a massive oil and gas spill flowing throughout the Gulf of Mexico that cost BP \$69 billion. Now, that's a lot of money that any company would want to dodge. And thus Exxon was successful at dodging all costs due to its crooked oil deal with the Guyana government who were desperate at the time to get the oil deal going which would benefit the country and its people. But the discussions on an oil spill in the Atlantic ocean which would not only destroy ocean lives but may wash up on many of the Caribbean countries including

Guyana and other South American countries was always at the forefront of discussions and continued to haunt the government and its leaders.

Guyana oil is contributing to an oil boom in the Americas

In the article ‘Oil Market’s Latest Drag Is a Flood of Crude From the Americas’ published on May 4, 2023, states ‘For the first time in at least two years, the Americas will be the world’s biggest driver of oil production growth’ (Ref 1) and Guyana’s oil production is a big part of that. In another article called ‘Large Production Increases Will Come From the Americas’ (Ref 2), where the internet link states ‘Americas not OPEC will lead oil production growth’. This growth also includes countries in North America, and states ‘Annual oil production, millions of barrels per day for the following countries: US, Canada, Brazil, Mexico, Argentina, Guyana

The article (Ref 2) states, “The Western Hemisphere is the secure supply source the world needs in the medium term to keep oil prices from shooting through the roof,” said Schreiner Parker, the head of Latin America for Rystad Energy. “Brazil, Mexico, Guyana, Argentina and even Venezuela will see production increases this year that will help shore up supply in the face of continued OPEC cuts.” (Ref 2)

Guyana is not only known for its gold mining operations, but its oil exploration and discoveries continues to grow attracting big players from around the world as ‘ExxonMobil Confirms Fifth Oil-Production Project in Guyana (Ref 3) stating ‘The Uaru development is expected to pump 250,000 barrels of oil at peak.’

‘ExxonMobil is preparing to approve its fifth oil-production project in Guyana and may take additional exploration acreage, Alistair Routledge, head of the company’s Guyana operations, told Reuters’ (Ref 3). While India is eye Guyana, Japan has already made its move for Guyana. ‘ExxonMobil has submitted a development plan for the field, and an initial construction contract was awarded last fall to Japan’s MODEC. Routledge said the consortium could sanction spending on the project by April if the plan is approved by Guyana’s government’ (ref3).

A review of Guyana oil auction and upcoming oil expansion

In the last edition of the Diverse City Magazine, the article on Guyana’s upcoming oil expansion states: ‘A look at Latin America & Caribbean countries pursuing new oil & gas bid rounds by Shikema Dey, published April 20, 2023 states ‘Countries in Latin America and the Caribbean, like their counterparts around the world, are forging ahead with plans to accelerate the development of their oil and gas resources. This has seen countries such as Guyana and Suriname (both countries in South America) rolling out bid rounds as reported by OilNOW in recent months.

Guyana keeps changing its date for countries submitting its bid for Guyana’s oil auction. ‘The operator will consider submitting bids when Guyana holds its first competitive auction for new exploration areas...’(ref 3).

Guyana has hope. In the article ‘How Exxon captured a country without firing a shot’ Guyana is poised to become Exxon’s top global oil producer. Where the company ends and the government begin is increasingly unclear. (ref 3)

Guyana's historical ruling in High Court

There have been a lot of talks about if an oil spill were to occur in the ocean, who would cover the costs. In the original agreement Guyana was left with covering all costs, which many around the world thought that was unfair along with the low royalties being given to Guyana.

'Guyana's High Court handed down a historic ruling in May against both the country's Environmental Protection Agency and Exxon Mobil's subsidiary in the region' (ref3). It's said that 'The case was brought on behalf of two Guyanese citizens, Frederick Collins and Godfrey Whyte. They accused the EPA of failing to enforce the requirements of its own permits by never securing a guarantee from Exxon or its subsidiary, Esso Exploration and Production Guyana Limited, that the company would cover all costs related to a possible oil spill' (ref 3). When it comes to big corp there are always excuses to cut costs. 'That's because Exxon's drilling project in Guyana is the riskiest kind: deep-water offshore drilling, which involves intense pressure bearing down on complex equipment. The conditions are similar to those that preceded the Deepwater Horizon explosion in 2010, which spewed oil and gas throughout the Gulf of Mexico, costing BP \$69 billion. Janki said the ruling should send a message to people on the ground that they have the power to oppose projects like these. "Justice Kissoon put the rule of law above the interests of Exxon Mobil, and that's massive," Janki said.

Oil bonanza - India is looking for a 'slice in the pie'

In the article, Guyana's oil discovery, a game changer, by P Elango and published on June 14, 2023 called 'The huge reserves in the South American nation provide a massive opportunity for Indian companies (Ref 5) says 'there are opportunity for India.' 'In just five years, Guyana will join the coveted club of 20 countries that produce more than one million barrels of crude oil per day and will emerge as a major exporter of oil. This journey will involve multi-billion dollar investments in oil and gas field developments and associated infrastructure.' 'Major oil companies around the world are looking for a slice in that pie. Guyana's Ministry of Natural Resources announced its first international bidding round. This boom in oil production will trigger all around economic development over the next decade. This is a great opportunity for Indian companies both in public and private sector to tap' (ref 5).

Guyana's future

Even with all of it's oil discoveries, Guyana is still one of the poorest countries in the world. And with the New World Order and the 'Great Reset' taking place, along with a cut back on carbon emission and gas vehicles bringing in electric cars, this will affect oil production all over the world, and this means that Guyana may remain one of the poorest nations in the world.

Add onions, garlic to pot and let it cook for approx. 2 to 3 minutes.</p> <p>Add shrimp to pot and let it cook for approx. 5 minutes and then stir and mix so the onions and garlic are not at the bottom getting burnt. Add to taste: salt, black pepper, paprika Let shrimp cook for approx. 20 minutes and then add approx. 2 cups of water and stir. Add tomatoes and boiled potatoes to the pot and let it cook for another 10 minutes with stove on medium</p>	<p>Fisal recipe for making dhal from lentil Preparation time 10 minutes Cooking time: approx. 10 minutes Ingredients: 3/4 cup lentil (you could add more depending on how much dhal you want to make), black pepper, salt, whole jeera, paprika Soak approx 3/4 cup of lentil in approx. 4 cups of water. Let it soften for about 5 to 10 minutes or you could have already have it soaking for an hour or more; the softer it is then the easier it is to mash. Take mashing took (see photo) and mash up. Place on stove. Set stove to Hi. Cook for approx. 10 minutes and as the lentil becomes soft continue to mash.</p> <p>Boil potatoes which will be added to the akra and also to the bolanje Boil approx. 8 potatoes peel and cut - don't boil too soft, boil to medium softness and then will add the potatoes later to the pots and cook for approximately 10 minutes with the other dishes....</p>

OUR 4 DIVERSE DISHES COOKOUT



Ingredients - tomatoes, shrimp, onions, garlic



Frozen akra



Onions and garlic in 3 different pots - Add approx. 3 Tbsp oil to each pot



Boil potatoes for approx. 10 minutes so it's half cooked - potatoes will be placed in pots about 10 minutes before each dish is completed



Curry powder is added to each pot



Add shrimp to one pot, add egg plant to the other pot, add frozen akra to the other pot and stir



Stir each pot



Neisha stirring the pot with akra
Add approx. 2 cup of water to the pot with shrimp



Neisha stirring pot with egg plant



Shrimp with aloo completed



This pot shows that the potatoes that was already boiled was added to the akra about 20 minutes before completing, the same was done to the bolanje

Dhal (lentil)

Dhal is often served with rice, roti and other dishes or served as a soup, or it can be drank also. Add spices such as geera, paprika, salt to taste, black pepper



Add approx. 3/4 cup lentil to pot



Add approx. 3 or 4 cups water. The more dhal you want to make then add more lentil and water



Cook on hi and mash. Add spices such as black pepper, paprika and whole jeera



Mash with mashing tool so it becomes like a soup

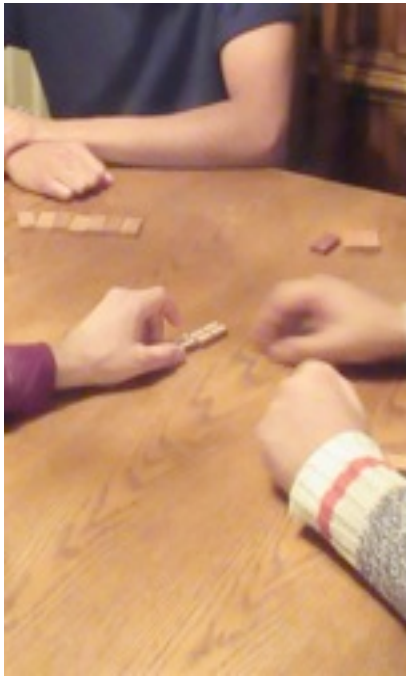
