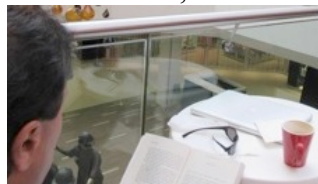

#### **Introduction**

On June 24, 2020, after researching on the immune system, the vaccines and the covid pandemic, I had published an article under The New World : Order Out of Chaos series of articles called (Part III) 'The Battle to Control Humanity's Bloodstream.' Another article I wrote is called: 'A glance at the covid pandemic: heard immunity, wearing a mask, social distancing, and the lockdown' published on October 27, 2020.

While many accept the narrative they are being told through the mainstream media and other mainstream sources about the covid-19 pandemic and the vaccine without a doubt nor carrying out any research and cross-referencing, many are researching and cross reference information and are finding out about other solutions from academics, experts and professionals on the covid-19 and its new strains, instead of accepting mandatory vaccination as the only option for all of humanity. Dan Erickson 'is an entrepreneur and have developed eight medical clinics to date through central and Southern California (Ref Z1).' Experts such as the Scientist, Dr. Shiva Ayyadurai, who had invented email in 1978 when he was only 14 years old, and Dr. Rashid Buttar who is a best selling author and a medical doctor and who does alternative treatment for patients that were vaccine injured and many other conditions, provides great knowledge when it comes to the covid pandemic, vaccinations, wearing the mask, social distancing and boosting the immune system. There are others whose lectures I have been reviewing. These people are heroes. They are brave for putting their lives and careers on the line to bring important information to the public. They are heroes for empowering us with knowledge in this darkest period of humanity's existence where many people are confused, depressed and have no clue what the future holds for us and all of humanity. There are many more like them. I did not have to wait many months after the covid pandemic to learn that the vaccine will be a reoccurring vaccination, not once, not twice, but many times, and that the RF-ID chip is also being planned for humanity. What you need you should decide in collaboration with your health care profession - the government should not be involved in it..." (Ref R). And he is speaking from a 'scientific perspective.' He says that "from a scientific perspective, the human body is extremely complex - to impose a child get 35 different vaccines, 70 doses, God only knows what the interactions are, is not only criminal-and to say we're going to figure out the safety, I'm sorry..." (Ref Q). Another doctor I listen to on vaccines is Dr. Rashid Buttar, whose



son was vaccine injured as a child and he had carried out alternative treatment to treat his son, and was successful at its. Today his son is around 21 or 22 years old and from what I remember I believe he is a martial arts champion. In those days it took many years to research, develop and test a vaccine, and yet there are claims about vaccine injuries. Now were dealing with vaccines with no long-term studies. I am concerned that these mRNA and DNA vaccines may cause some serious damages to people.

Since each person's body is different, then how can the same vaccine work for everyone? Could it cause different kinds of injuries for different people, such as face paralysis, problems with the heart or even death? ## Section 2 - The mRNA, DNA and other vaccines are being rolled out

The vaccines are being rolled out all over the world. When I hear the terms RNA and DNA, I know that has to do with our God given genetics and it's our genetics that makes us who we are, such as male, female, our height, eyes colors etc...,but also the environment and other factors play an important part in our lives and molding us. So I'm asking questions such as, will an mRNA or and DNA vaccine cause any kind of problems later on in life? The small 'm' in mRNA is for messenger.

During my research, I came across a YouTube video called **'Pfizer's coronavirus vaccine relies on a new, unproven technology.** A diagram shows how it differs from other candidates by Aria Bendix' (Ref T) posted on November 9, 2020. Note the words in the title 'unproven technology.' These vaccines are designed different from a flu vaccine and since the technology is new and unproven. I would certainly be concerned. The video states 'Pfizer's candidate is an mRNA vaccine, an unproven technology that uses a snippet of the coronavirus' genome to encourage antibody production. Moderna's use the same approach, **though no mRNA vaccine has ever been approved before.**' Note the words 'no no mRNA vaccine has ever been approved before.' Those statements do not give me any confidence in these vaccines, so why should I beg for this vaccine and say 'Bring it on' or 'I'm taking the vaccine as soon as it gets here' when I know that most people that are diagnosed with covid recovers from it. Does it mean that taking a vaccine will have no side effects? Of course not! I'm looking for the best solution.

There were no long-term studies done on these vaccines, since they were developed in less than a year. What if in a few months later or even a year or 5 years later I end up with all kinds of side effects or even an early death? We must ask questions. I have already researched and wrote an article about people being vaccine injured and mercury being in the vaccine preservatives and where a child's body may not be able to eject the mercury causing major health problems and or a disability such as autism. I'm already aware that vaccines have preservatives. My question is, what are the preservatives and other chemicals in these new vaccines, and how will it affect others and me? I'm not hearing anything about the preservatives.

There's an article called 'Moderna's groundbreaking coronavirus vaccine was designed in just 2 days' by Susie Neilson, Andrew Dunn, Aria Bendix on December 19, 2020 (Ref P). The title alone makes my stomach turn. A vaccine designed in only two days? What about all of the quality checks, tests, and stages of design the vaccine should go through? Just two days? This makes me very worried about every single person being vaccinated and humanity's future.

I came across an article called 'Inovio COVID-19 Vaccine Uses Electricity to Drive DNA Into Body Cells (1)' by Barbara Loe Fisher and Kate Raines; Published April 18, 2020 References: (Ref Z2). The title of this article is chilling and is telling us that electricity will be used to 'drive DNA into body cells?' Where in the world is that electricity coming from? Does it have anything to do with 5G? An excerpt from the article states: DNA vaccines like Inovio's experimental COVID-19 vaccine (INO-4800) inject a small piece of circular DNA called a plasmid that carries genes encoding proteins from the pathogen to provoke the cells into producing antibodies....The key challenge for DNA/RNA vaccines is getting patients' cells to accept the introduced genetic material. The report states: The U.S. biotech firm has already produced enough of the vaccine to support Phase 1 (immune system reactivity and safety) and Phase 2 (efficacy) testing and plans to have one million doses ready for distribution by the end of 2020. The report states: 'The experimental vaccine requires a special device that uses electricity to drive DNA into cells of the body.' What if the patients' body rejects the genetic material? Then what happens after that? Will it cause a hormone imbalance? What if the electricity causes some damages to the cells and to our DNA? For me these are all valid questions to ask. I will be doing lots more research in these areas.

There's a YouTube video called 'Coronavirus vaccine: Johnson & Johnson vaccine trials put on hold after participant becomes ill' published on Oct 13, 2020 discussed by Dr. Anand Parekh (Ref U). Everything seems rushed with vaccines coming out and being forced on people. What are the chances that two destructive viruses devastated humanity exactly 100 years apart? What are the chances that one person name Bill Gates is trying to solve computer viruses and now trying to solve biological viruses? For me nothing is adding up about this covid-pandemic and mandatory vaccination. We are told that we can't work if we don't take the vaccine, and this is what force vaccination is all about. We are left with no choice. Then the elderly in the long-term care facilities must also take it, and therefore shouldn't the death rate of the elderly in the long-term care facilities decrease tremendously, starting months ago especially with the lockdowns and masks? But that's not the case. If many elderly in the long term care facilities and in places like China, India and other places take the vaccine then they should all live long and healthy lives.

A YouTube channel highlight says: Nearly 70% of Indians unwilling to take COVID-19 vaccine Study' (Ref Y). Why are so many Indians unwilling to take the vaccine if the vaccine will work to stop the virus? It's not only India, but people from who all over the world are skeptic about the vaccines and many are reluctant to take the vaccine. The following two points made next in this paper are not my claims, nor have I done any research on this to have discussions on it. However, it's important that I mention them here because this may explain why 70% or even more in India are reluctant to be vaccinated. Point one is, there are claims

being made all over the Internet that the Bill and Melinda Gates Foundation had tested polio vaccine in India between 2000 and 2017 which resulted 496,000 children being paralyzed and also lawsuits (Ref Z3). Point two is, there are also claims of sterilization that took place in Africa using the vaccines. However, there are claims that this never happened and it's all a hoax. Obviously many in India and Africa know about these claims, whether they are true or false and have suspicions about being vaccinated and whether there are agendas to decrease the population through sterilization or to even bring about shorter life spans. Talks of population reductions are nothing new, and which countries have major population problems? Of course it's India with about 1.4 billion people and China with over 1.4 billion. Decades ago, population control was planned in China where most Chinese families were only allowed to have one child, and now there are millions of elderly with nobody to care for them because their one child had to leave their aging parents behind to work in the big cities. So what becomes of the parents who have nobody to care for them? We know that they are getting the vaccine first with frontline health care workers. Are different people and different nations getting a different kind of vaccine? There are so many being created but yet not unique for each individual.

There's a YouTube video called 'Kill or cure? | Pfizer stocks lose 2% after trial-death news and allergy warnings' published on Dec 10, 2020 by RT News with the highlight at 18 seconds into the video: **'Any person with a history of a significant allergic reaction to a vaccine, medicine or food should not receive the Pfizer/BioNtech vaccine' and in slightly smaller writings: 'UK warns people with history of allergies against using Pfizer jab.'** At time 27 seconds into the video there's a box that says The Wall Street Journal, Two in U.K. Suffer Allergic Reaction to Pfizer's Covid-19 Vaccine. At time 33 seconds into the video the box says Evening Standard, Warning after two NHS workers have allergic reaction to Pfizer/BioNTech Covid vaccine.' And at 37 seconds into the video the highlight says 'FDA: 6 died during Pfizer vaccine tests; paralysis side-effect risk Ref (Z4).

### **Section 3 - GMO, genetically modified organism**

We have all heard of GMO, genetic modified organism and today we are hearing that the vaccines are mRNA and DNA vaccines, whereas six months ago we just heard the word 'vaccines' and not mRNA vaccine or DNA vaccine. DNA and RNA have to do with our genes. I have also written an article called A New World: Order Out Of Chaos (Part II) The Vaccine and changes to Humanity's DNA which was published June 24, 2020 (Ref R). I'm aware that there are already genetic modifications on human beings taking place in this world, and not just on crops, such as parents selecting the color eyes for their new born baby. Does that mean that the baby is a GMO baby? Our genes are passed down through our DNA. Therefore, in the future can vaccines be used on humans to create mutations whether intentionally or accidentally, in the way our crops have been genetically modified or should I say mutated? Will man (the ones that runs the world from the top and I do not mean our government ) be playing God with these new mRNA and DNA vaccines and already have agendas planned for humanity? ## Section 5 - The RF-ID chip is here and waiting for us

In the YouTube video called 'Will They Put a CHIP in the Coronavirus Vaccine?' posted on May 30, 2020; CBN News. The CEO, Jay Walker, of 'Apijet, the company', was interviewed by Lorie Johnson discussing the RF-ID chip where Apijet provides syringes for the drug companies and does the packaging. In the video, Walker states, "...**each of these device that are injected have the capacity to also have a small chip.**" Why would a syringe have the capacity to carry a small chip if we're not getting chipped? Something is very fishy and smells real bad. He says that "...it have the unique serial number for each dose" and then went on to explain that there's no personal or patient information and that it's a 'bar code' to provide information on 'where and when that dose has been used.' The information assists 'public officials' of areas with outbreaks, meaning that in that area a certain number of people will then have to be vaccinated to control the virus. He stated that the technology is optional and that the 'US government haven't even decided if we are going to use it.' But the fact is, it's there and it's an option. It's there for a reason. It's there because it's coming. Don't be surprise that people if some people that are begging for the vaccine are also the first in line to be chipped because they want to make sure they get each and every vaccine. If people are chipped what comes after that?

If someone wants the vaccine then that's their choice, but don't force everyone else to take it, because from my view once you take this vaccine that's being pushed on the public, it will become a reoccurring vaccination and it could be for life. There was a recent article called, 'Only a Third of Employees at This Hospital Want the Vaccine' by Kaiser Health News, states that in the United States 'In late November, a hospital survey of 350 workers found 70% either did not want to take a COVID vaccine or did not want it as soon as it became available' (Ref S). There is that 70% again. This research paper earlier stated that 70% of the Indians are unwilling to take the vaccine. Is it a coincidence, or numbers just being made up? Obviously, many people are asking the same questions and are suspicious about the vaccines and motives behind having the whole world vaccinated. The articles later says: 'So, officials are not dismayed at the turnout so far, saying it shows their educational campaign is beginning to work.' No doubt, the campaign spoon-feeds people a little at a time, in the way now there are lockdowns and mandatory masks, sooner or later everyone will be chipped. An educational campaign is very important and should also include experts such as Dr. Ayyadurai, Dr. Buttar, Dr. Erickson and others so information can be shared and not censored by the mainstream media. But we know that's not going to happen, so it's up to everyone to get educated and start educating others. Knowledge empowers people to make better decisions.

## **Section 7 - Herd Immunity**

What is herd immunity and how does it work? In a YouTube video (Ref Z) Dr. Erickson said, 'Collateral damage is causing more damage than covid.' At the time 27:40 of video he says: 'Herd immunity is how every country will get rid of covid...He said, "Whether we have a vaccine or we don't as per epidemiologist...they said **we will reach herd immunity with or without a vaccine**...we didn't have a vaccine for sars, we don't have a vaccine for the common cold, a lot of viruses we don't have vaccines for and yet they move through our people every year and they burn themselves out through herd immunity..." Dr. Massihi says "**You have to protect the old, you have to protect the frail population, you have to protect those that have severe immune deficiencies and those that are likely to not do well, and you have to do this in a stepwise fashion...**" Erickson says, "...the virus is going to move through society whether you lock it down or not. The host of the video asked: **Do you think that the people in your community would submit to a mandatory vaccination regime or covid vaccination? Dr. Erickson replied, "I don't think so,** I think it's appropriate to give people the option for a vaccine like flu... the vaccination increases our peak towards herd immunity - it will happen regardless, it is helpful, there's no question about that - **I DON'T THINK WE SHOULD FORCE PEOPLE TO HAVE A VACCINE**...Dr. Erickson explains that people are frustrated, hurting, "people are afraid, they are in lock down, they are not working" ... "frustrations I'm hearing from a lot of Americans who are not allowed to carry on with their lives right now..."

**In a more recent video posted in October 24, 2020 (Ref z1) at 9 minutes into the video, Dr. Erickson said, there's a 99.6 survival rate.** He explained that when the virus hits, our 'skin is a barrier' and once the virus gets through 'your BNT cells take over creating antibodies to defend - they know what to do, they produce millions of antibodies and they defend you everyday. At 13:30 minutes into the video he said, **"The WHO this week (the video was posted on October 24, 2020) state the lockdowns are now an appropriate strategy**

**anymore, they want to go beyond that. Moreover, the large negative effects on public health for doctor Nebaro (not sure of spelling) of the WHO said the lockdowns are causing doubling the world's poverty and malnutrition by 2021, and its time to get rid of them.** If this is the case why aren't countries supporting the WHO? He further said "thousands of physicians are coming together to set the records straight and prominent scientists from Oxford, Stanford and Harvard came together to give rational sustainable conclusions. He provides the following points:

1) We need to protect the vulnerable when this type of pandemic hits...we didn't do that well.

2) Herd immunity is a fact of infectious diseases, it's not a strategy.

3) **There should not be suppression of scientific discussions; we should have free discussions on these topics.**

They want to get low risk people get back to life as normal.

These physicians believe that the above measures will help provide a more sustainable approach to pandemics in the future.

## **Section 8 - Boost Immunity, Eat Healthy, and Stay Fit**

**D**r. Ayyadurai is an expert in immunology. Along with leafy vegetables, garlic, turmeric and other spices as discussed in his lectures, he says to take vitamin A, D, C and other vitamins, which are explained in his lectures. He discusses which vitamins and spices to take and their functions. He also has a 'Truth, Health and Freedom' movement that provides a lot of good information for our health. With such a movement he has no choice but to give us the facts, and he obviously is since many around the world are tuning into his lectures.

## **Section 9 - People running out to take the flu shots**

**I** have spent many hours researching, cross-referencing and listening to lectures from experts in the medical and science fields. I have empowered myself with knowledge for moving forward. ## **New oil discoveries in Guyana continues during the covid pandemic**

With a looming second wave of covid that can lead to lockdowns across the world, this global pandemic will not spare the small South American country, Guyana, even with its new oil boom and many continuous oil discoveries, where oil production had commended in December 2019 in the Stabroek Liza Phase 1 block.

### **Guyana is expected to become one of the fastest growing economies in the world**

The article called 'Remarks at the Guyana Oil & Gas Summit' (Ref P) states: Guyana is expected to be the fastest growing economy in the world this year, despite the fact of the impact of these economic shocks. Even considering COVID, the IMF expects Guyana's GDP to grow more than 20 percent in 2020.' It also states: Guyana is poised to become one of the highest oil producing countries per capita, and even eclipsing many countries in the Middle East [inaudible] natural gas. We've seen a similar sea change with respect to U.S. gas production.

### **A bit on the Guyanese culture**

Guyana (formerly British Guiana, also spelled as Guiana, Guayana and Guinna) is the small South America country once ruled by the Dutch, French and British, where the Spanish had allowed the Dutch to begin it's Dutch colony. Many from around the world, Britain, Holland, France, Africa, Portugal, India, China, Syria / Lebanon came to Guyana to contribute to its development, along with the Amerindian (American Indians). Sometimes Guyana is even said to be an island in the Caribbean and even in the West Indies since Guyana cricket players plays on the West Indies (Caribbean countries are also said to be in the West Indies) cricket team. **Although Guyana is not in the Caribbean region, it has a similar culture to places in the Caribbean such as Trinidad and Tobago, Barbados, Jamaica, St. Lucia and other islands and is said to be in the Caribbean region.** What about the Latin American region?

### **Is Guyana a part of Latin America**

Latin America is defined differently depending on who is using the term. At one time not all Spanish-speaking countries in South America were considered to be in Latin America, because it was political and not culture. That would seem strange today. As it is, large areas in Latin America never spoke Spanish before such as the Amerindians (American Indians) and in some other places other languages are spoken, but they were still in Latin America. Latin America is not defined and many began to define it how they want to see it such as only the Spanish speaking countries are being in Latin America. Others include Brazil. Then others include all the French colonies such as French Guiana, Martinique and Guadeloupe even if these colonies have large populations that originated from India. So it's not about your race, religion, or one specific language. Then some say it's all of the countries that speak a romance language such as Spanish,

Portuguese and French. But in the United States usually Latinos / Latinas are only considered to be people from the Spanish speaking countries in the Americas, even if they are not Hispanic (meaning you're a descendant from Spain.) If the French speaking countries are considered to be in Latin America, such as Fr.Guiana in South America and Martinique in the Caribbean, you can be Latino / Latina and at the same time you can be of any race and religion, such as being a descendant of East Indians and being Hindu or Muslims. **Then what about Guyana since Guyana is in South America?** The reason I'm bringing this up is because very often I reference articles that state Guyana is in Latin America. Many will say that Guyana is not a part of Latin America because its main language today is English (locals speak Creole Patois) and also the culture is a Caribbean culture instead. Let's look at this carefully and share some knowledge, which many are not aware of. From my view Guyana has always been a part of Latin America and also a part of the Caribbean region, even though its not it the Caribbean. I believe that Guyanese have the best of both worlds, Latin America and the Caribbean. Let me explain. With Venezuela claims to most of Guyana, Venezuela would definitely consider Guyana to be in Latin America and not separate from Venezuela regardless of the language spoken, therefore Guyana has to be in Latin America. In fact only a few months ago, I met someone from Venezuela and she told me that Guyana belongs to Venezuela. Many people have no clue what's taking place in Guyana and Venezuela. They research on Guyana and say 'Oh they speak English, so they are not in Latin America.' Another reason is that in certain parts of Guyana, the people have more in common with the Brazilians and Venezuelan and nothing in common with the Caribbean. For example on the Easter Long weekend the Brazilians vaqueros (cowboys) enter Guyana to compete with the Guyanese cowboys and at that time the area is filled with Portuguese music, culture and dishes. In that area most of the people from Guyana have more in common with the Venezuelans and Brazilians and not with the Caribbean. From my view Guyana is in Latin America and also in the Caribbean region, and thus Guyanese have best of both worlds. There are many other reasons. For example, before the 1860s there were 30,000 Portuguese in Guyana, which was the second largest group in Guyana at that time and I believe much larger than the Indians from India at that time. Therefore if Portuguese-speaking people are included as being in Latin America, then why isn't the Portuguese in Guyana? And today there are many Portuguese and Spanish speaking people in Guyana. There are many Brazilians and Venezuelans that lives in Guyana. In Georgetown in Guyana you will find an area with Brazilians with their culture, music and dishes. So aren't they Latinos/Latinas? And in school even from back in the days, my uncles had to take Latin in school, and thus many take Spanish in school. In some articles and literature and encyclopedias Guyana is a part of Latin America. From my view, Guyana is also in the Latin American region and Caribbean region.

### **Exxon, Hess and CNOOC in Guyana**

In September 2020, oil continued to spiral downwards with great losses, and thus there are no exceptions for this small-impoverished South American country in the Caribbean region and the Latin America region in the Americas. But there's hope. According to the article Oil & Gas Stock Roundup: Hess' Guyana Oil Find, Equinor's Offshore Wind Deal & More, the writer states, '...the holiday-shortened week ended Aug 11, the crude sell-off deepened as U.S. oil stocks rose, breaking the six-week streak of declines.' Recently the oil giant ExxonMobil with its 45% stake and its partners, Hess at 30%, and CNOOC at 25% which the Chinese off drilling company, announced another discovery known as the Redtail-1 well in the Stabroek block, and with the Yellowtail-2 bringing Exxon's discovery to eighteen with an estimated 8 million barrels of oil.



The Stabroek Liza Phase 1 project commenced in December 2019, and the Liza Phase II project should begin in the middle of 2022 with 220,000 bpd. Exxon's third offshore project is the Payara oil field, which is expected to produce 220,000 bpd when its production begins in 2024. The covid pandemic has not spared anyone and continues to destroy economies, businesses and people's lives across the world, but with the new president of Guyana, Mohammed Irfaan Ali, that was recently sworn in on August 2020, the government and people of Guyana are eager to work hard during these dark times to continue the country's economic growth, bringing more jobs and social programs for the people. With all of the discoveries so far, it is expected that Exxon and its partners will produce approximately 750,000 bpd from the off shore waters of Guyana. According to the article Exxon Moves Ahead With Major Guyana Oil Field, the writer states, 'Such a rate of production would turn the tiny Latin American nation sandwiched between Venezuela and Suriname into quite a large player on the international oil market.'

We're at the crossroads of history, a turning point of no return as the covid pandemic plagues humanity with the oncoming forced and reoccurring vaccination for the masses across the entire world, and where the Pfizer vaccination is an mRNA vaccine. RNA has to do with our genetic code. Do we want a pharmaceutical corporation injecting something into our body that may even cause some kind of unforeseen harm or change in our genetics in the future, especially since there were no long-term tests done since the vaccine was created in under a year? I have always heard that a vaccine takes 10 to 15 years to research, test and roll out. He then went on to expose the 'weighted race feature' in the electronic voting machines, which can be used to change the number of votes cast. Others have also been exposing the voting machine as being used to manipulate the votes around the world and now also in the United States.

On November 3rd 2020, Election Day in the U.S, I turned on the television to watch the election. seems to be my original music and literature in the mainstream television and music, whereas I never did before. Why all of a sudden that something so strange began at that point in time and continues to the present? Then at around 9:52pm while watching 6 KREM, the highlight on screen was: 'BATTLE FOR CONTROL' and I believe I heard the person said 'BATTLE FOR CONTROL OF THE U.S SENATE' and soon there were many variations with similar words to 'The Battle to Control Humanity's Bloodstream.' America was always at war. But now Americans are at war and divided, a battle that's going to change everyone's lives and the world forever. Many want the vaccine, many do not want the vaccine. Many are saying that there was major fraud in the U.S 2020 election and many are saying that the election was honest and fair. This is not the America we knew of before the covid-19 pandemic began. THE BATTLE IS ON FOR OUR BLOODSTREAM AND FOR THE TRUE NUMBER OF VOTES CAST!

President Trump's team continues to make allegations of major electoral irregularities. His team has had hearings in different states and is being turned away, but they are persistent. Finally, in the Pennsylvania hearing, they were heard with their crushing and imperious facts and evidence, that legislature listened to them and blocked the certification for Pennsylvania. At the Arizona hearing Shiva Ayyadurai discussed the 'weighted race feature' in the voting machines, which can be used to change the outcome of the votes and thus the election. Why would equipment as such be allowed in an election? It makes no sense whatsoever! Shiva also stated that Twitter had suspended his account for 21 days, which is one of his main communication tools during the election, when he began tweeting about the 'weighted race feature.' The battle grew in America, and some of the United States Senators had inquiries where they confronted Twitter, Facebook and Google on interfering in the election. Many faithfully believe that all of these technologies and platforms are given to us only in our best interests, but there is not a doubt that these technologies are rapidly being created and rolled out for other reasons. We all know about revolutions, but when Shiva's voice echoed 'REVOLUTION' and I'm writing and reading about it after hearing him, even around that time, as I drove, I can see from a distance on the digital billboards in Edmonton, Alberta, Canada, where I live, the word REVOLUTION resonating to tens of thousands of people, as many around the world are also hearing his words for his Truth, Freedom and Health movement from his lectures videos and many other videos with him recorded by others.

As President Trump's team goes to the Supreme Court, voices echo, "One person, one vote," (Ref B) after Shiva's voice. Shiva is certainly is a voice for the people and has what it takes to be an American Senator. Like Shiva and his family, many people from around the world came to America and want to live in America because of freedom and democracy. If democracy

fails, America will be changed forever and so will the world. If democracy prevails, then there's hope.

## **Section 1 - MIT Scientist exposed the 'weighted race feature' in the voting machines that can be used to manipulate votes**

**D**r. Shiva Ayyadurai has been exposing the feature in the voting machines known as the 'weighted race feature' that can be used to manipulate votes. He is an MIT Phd, Scientist, Engineer, Mathematician, and United States Senate Candidate. He holds four degrees from MIT and two masters. His undergraduate is in Electrical Engineering Computer Science and his Phd is in Biology. He is also known as Dr. Shiva. In this research paper his names are used interchangeably.

His field of expertise is Pattern Recognition Analysis, which he has been doing for over 40 years. Back in 1978, at age 14, he invented the first complete email system with the inbox, outbox and other features while working as a fellow in a medical school where he had written about 50,000 lines of codes and also came up with the term 'email' because the language he was using at that time only allowed him to use five characters, and today the whole world uses the email 'email' and email software. He has a movement known as the 'Truth, Freedom and Health' movement. There are some confusions as to who invented the first complete email system with the inbox, outbox etc...which was the 14 year old Shiva Ayyadurai in 1978 in New Jersey, and who was the first to send an electronic message to more than one computer using an @ symbol which was Ray Tomlinson before 1978; these are two different technologies and this is explained in the 'Conclusion' section of this report.

Immediately after his own senate race in the Massachusetts Primary election on September 1, 2020, based on the election voting data, which he had requested and received, he knew that something was terribly wrong with the data. The numbers did not add up, which clearly revealed that there were more votes cast than voters that came in to vote. There were excess ballots. How was that even possible in a fair and honest election?

With strong support and a hard working campaign, Shiva was guaranteed a win in the U.S September 1, 2020 primary election. Months before the election, many like myself were listening to lectures by Dr. Ayyadurai on boosting the immune system, problems with wearing a mask and the lack of oxygen, social distancing and the problems the lockdown was causing to families and society. I learned about his campaign when he began talking about the primary election. He had lots of support with his 'Truth, Freedom and Health' movement and many of us learned about health and boosting our immune system. He had reminded his supporters that it was very important for him to win the September 1, 2020 primary election, meaning that they were about to put in a lot of work to make it happen. Many from around the world were tuning in to his lectures and people from different states were asking him to run in their state because they saw hope in him. They witnessed a genuine person that was preaching 'Truth, Freedom and Health' and that's what people are looking for. People are tired of the deceptions and fraud that are taking place right in front of their eyes and faces. Shiva is not only talking about 'Truth, Freedom and Health,' but his words are all action. Actions speak louder than words! He is also an excellent speaker. He has everything it takes to win the election. Many supported his campaign and people from different states were showing up to assist him because they wanted change and not lies and deceptions. They wanted "Truth, Freedom, and Health." He stood by his



words as can be seen in many of his video lectures and some of the books, which he had written. He always talks about how his grandmother back in India healed people and how truth and honesty prevails, and so far he has been setting an example as seen in his lectures and with many around the world listening to him.

After analyzing the data from his Massachusetts September 1, 2020 primary election, he concluded that fraud had taken place in the election. Fraud in America? Many would think that this could only happen in places with Saddam Hussein, Fidel Castro, Chavez and in any other 'Banana Republic', but not in America. He used the term 'Banana Republic' referring to Massachusetts. Has Massachusetts become another 'Banana Republic?' Is America now a 'Banana Republic?' Many are waking up to the facts.

With the amount of work Shiva and his team put in, a win was guaranteed. Dr. Ayyadurai and his campaign have no doubt that he has won in the September 1, 2020 U.S senate primary election for Massachusetts. They were always out there promoting, and cars would beep at them and some out shout, "Go Shiva!" While campaigning they said that they had never once seen their opponent out there campaigning, not even one lawn sign of him. They had made thousands of phone calls and did everything it takes to guarantee a win. According to this video (Ref 1), they put out 20,000 bumper stickers and distributed 1.5 million write in cards, made thousands of phone calls, and a lot more. In this day and age in America, you don't need a name like Kirkpatrick, McDonald, Smith, Johnson, Kennedy, Williams etc... to get ahead in the world and or to hold a high position in politics. Dr. Shiva Ayyadurai has everything it takes and much more to be a United States Senator, and with all of the work they were putting in. What happened? Was he and his supporters robbed out of their hard work? Were there others plotting and conspiring against them so they would lose and never win? The facts are presented later in this research paper. Something is wrong because with hard work and fair elections, people with Muslim names such as the mayor of Calgary in Canada, and the mayor of London in England had won their elections even with their Muslim names and dark complexion. Shiva stated that he should have won the September 1, 2020 primary by a 'landslide.' Based on the analysis of the September 1, 2020 Massachusetts voting data, he became very concerned about what would take place in the November 3, 2020 election and began a 'write in campaign.'

While the word 'fraud' echoed about the September primary election as people tuned into Shiva's videos, most in America and around the world at that time had no clue what would take place two months later in the November 3, 2020 federal United States Election.

Dr. Ayyadura became highly involved in mathematical analysis with the voting data presented to him and he began to expose a feature in electronic voting machines known as the 'weighted race feature', where votes are stored as a fraction or a decimal, and where votes can be multiplied by a fraction or a decimal changing the results and outcome of the election. He was very surprised that such a feature existed in the voting machine.

If fraud had taken place in the U.S 2020 primary election, then logically speaking, there is a strong possibility that fraud had taken place in the federal election between President Trump and Joe Biden. On December 14, 2020, as the words echoed from the 'steps of the Supreme court, "One person, one vote" many people from all across America and the world - even many Democrats supporters - are concerned that fraud had taken place in the United States 2020 federal election and that democracy is failing.

## **Section 2 - A look at the voting system and data irregularities in the September 1, 2020 primary election**

In explaining the data to his viewers on You Tube and other platforms, Dr. Ayyadurai provided a simple diagram with the voting data he had requested. He drew a diagram to explain how the voting system should work with the input labeled as Voters (P) which is the participating voters with an arrow going to a box labeled as ‘Voting System in your town.’ On the other side of the box is the output with an arrow labeled Votes (M), which is the number of votes cast.

To simply put it, the total of votes cast must equal the number of people that came and voted, but that’s not the case with the data Ayyadurai was presenting. He provided a table with the title ‘Massachusetts US Primary Senate Races September 1, 2020 with four columns: City/Town, Number of Participating Voters, Number of Votes Cast and Number of Excess Ballots. The numbers are not lying because the state provided the numbers.

He said, “...we issued public records request...we found out the seven of the cases where they actually gave us back the data - the others are violating laws by not giving it to us - what you notice here is the Participating voters in the second column. For example for Boston, according to their own records had 142,911 Participating Voters, but the Number of Ballots cast were 147, 025. The Excess Number of Ballots is 4,114. More votes than voters. “This is why we know fraud took place.” (Ref 2)

For Rockland the numbers are: 1,644; 3,931; 2,287. This shows more than twice votes were cast than the voters that came out to vote. Anybody can clearly see that there’s something seriously wrong with the numbers, and the records clearly shows that irregularities had taken place in the Massachusetts Primary Election on September 1, 2020.

After looking into what had taken place in the Massachusetts September 1, 2020 primary senate election, Shiva says America needs to go back to hand counting votes. It’s clearly seen from his Primary election data that the numbers are not adding up. If this happened in one area, what are the chances that it will happen in other areas? Ayyadurai says “... I have not ever conceded my Republican primary race... I have a lawsuit to stop the certification of the entire Massachusetts US senate race...” (Ref 2)

### **Section 3 - An analysis of Massachusetts and Michigan’s data**

Dr. Ayyadurai said, “...what we found consistently in the seven cities they gave us data there were more votes than voters...Phil Evans got involved and Phil looked at the data of our votes in Franklin county for example where we won, the only county where 70 to 80% of the votes were hand counted...” Shiva presented a graph with his votes (the red) and his opponent votes (the blue) and showed how the curves flattened. “and this is how the votes should look over number of votes, they flatten,” he said. “...When I saw what happened in our election system here, Phil and Bennie and I had built a very close working relationship...”

Shiva worked with Phil and Bennie analyzing the data and plotting graphs. Bennie already knew about the weighted feature in the electronic voting machine. Therefore, they were able to move fast and commenced their presentations as their graphs evolved. They will later come up with a different graph to present in the Arizona hearing. Their analysis were all being done within hours or days - or you can say in real time - providing explanations and theories. As the days went by, they came up with different graphs and presented them to the viewers. That certainly was one way to get feedback and have their work critique, and thus there were many critiques as they had most likely anticipated, while they race against time, since they did not have months and years to go away into a lab to analyze countless data and come up with graphs and theories and then deciding on the best graph to present to their viewers. As they came up with

something, they presented them to their viewers. "...In all the other counties where the votes were machined counted the votes do not converge, they have this parabolic effect. And this parabolic effect, Phil, is one of the big indicator of something going on, voter issues or election fraud," Shiva said. (Ref 3). He is looking at Pattern Analysis Recognition, a field he has been involved in for over 40 years of his life to point out voting fraud. Ayyadurai presented a table: 'Audit of Massachusetts Primary Election 2020 Reveals More Votes Than Voters - Election Fraud' and provides an update. Starting at four minutes and fifty seconds into the video (Ref 3), he said, "Bennie was one of the person that discovered our votes are stored as decimal fraction...Phil looked at the data of our votes in Franklin county for example where we won, the only county where 70 to 80% of the votes were hand counted..." He said in all the other counties the votes were machined counted..." That raises a red flag. The only county that was mainly hand counted they won, which reflect all of the work they had put it. And they lost all the other ones that used a voting machine, which seems very suspicious.

At time 4:31 in the video, Shiva stated, "the election has not been certified in Massachusetts, I'm still a US senate candidate in Massachusetts. He then continues with Michigan's data. (Ref 3)

Ayyadurai discussed the mathematical analysis of four major counties votes in Michigan for the Trump-Biden election. The counties presented in this video are Oakland County, Macomb County, Kent County and Wayne County. The analysis raises important questions on election integrity. He drew diagrams and provided explanations. Input should equal output, but that's also not the case. He discussed the Dominion voting machine, which has the 'weighted race feature', which can change the votes by a decimal or fraction.

In the chart with the title 'Executive Summary' a few points are 'In short, 69,000 votes from Trump were transferred to Biden in these three counties.' The last point state states, "transfer" was done by a computer algorithm that linearly transferred more votes from Trump to Biden as the precinct increased in its "Republicanism." (Ref 3)

He explained that in Massachusetts there is one type of vote, where as in Michigan there are two types of voting which are 1) the 'Individual Candidate voting' and 2) the 'Straight Party voting'. He says that votes being transferred are seen more in the Republican precincts and less in the non-republican precincts. (Ref 3)

#### **Section 4 - President Donald Trump's team hearings in different states on voting irregularities**

President Donald Trump's team lead by former mayor of New York, Rudy Giuliani, went to the different states presenting their case as witnesses in those states came forward and made allegations of voting irregularities. Most or all of the witnesses have signed affidavits and many have high status in society such as being in the military, owning their own firms etc... The witnesses are putting everything they have on the line, therefore they are not going to risk everything they have by telling lies and making up stories. They are presenting what they had observed and experienced, and even with facts and evidence to show that fraud had taken place in the United States 2020 election. The team had gone to Georgia, Pennsylvania, Michigan, Arizona and other places.

#### **Legislature blocked certification for Pennsylvania after hearing the evidence and facts**

A public hearing by the Pennsylvania Senate Majority Policy Committee was held to review the irregularities of the United States 2020 election. After hearing the testimonies, the legislature blocked certification for Pennsylvania. In the video (Ref E) at time 47:48, a retired army colonel who was an Operations Officer named Phil W provided information. His last name sounded like Walder, but I couldn't clearly make out his name due to the clarity of the video. In the army he was involved in information warfare and had 'conducted computer network operations.' Over the last two years, his team along with another team has been working on the 'voting machine manipulation.' He stated that the voting machines have "been used in elections around the world - in stolen elections around the world - in Venezuela, Italy, Argentina, Singapore, Bolivia...Philadelphia uses ESS, Pittsburg uses Dominion..." Around 51 minutes into the video, Phil said, "The voting systems in the US and in Pennsylvania were built to be manipulated." He said that the systems "are connected to the internet and servers outside of the U.S...there is no transparency as our previous witness mentioned as to how the voter information is processed, how and where its stored." In his words, "The voting record is able to be modified and or deleted by operators, administrators and outside...operators can assign votes for write in ballots, blank ballots or ... ballots in large numbers so that they can be directed towards one candidate or another at the operator or the supervisor discretion." (Ref E)

This all sounds familiar. Dr. Ayyadurai and his team members have made similar claims, so it's not only one person making a certain kind of allegation on the voting irregularities. Countless allegations are being made. Phil W said that the machines are easily hacked to manipulate votes. One of their hackers discovered 'a malware on the server that caches every login and every password.' He said, "on 30th of September, an election storage facility was robbed in your state - 30 USB devices were stolen and a laptop...it's been described by another person in another state we're working with, just like the lotto. Who ever organizes the lotto is always going to win, it's controlling the numbers..." He continues, "Our experts believe that 'up to 1.2 million Pennsylvania votes could have been altered or fraudulent...'" Different cases were presented. This is what you would find in a 'Banana Republic.' (All single quotes and double quotes in the two paragraphs above are from Reference E)

## **Section 5 - The Arizona Hearing on November 30, 2020**

Aside from the kind of irregularities mentioned earlier, in the Arizona hearing on November 30, 2020, discussions surrounded accusations made in an email by someone that did not provide an affidavit, making claims that '35,000 votes were embedded for each Democratic candidate in Pima County' (Ref 5), including for Biden where the votes were carefully moved around both at the local and federal level and depended on the voters turnout to avoid suspicion and to get the results required. There were dialogues surrounding the email as to whether it's possible to check the data to verify the allegations to see whether the claims are true or false. An email with such accusations and no affidavit does not help the hearing. However, many allegations were made.

About 37 minutes into the video, allegations made that data was being moved around and that 'the same amount went down and then went up for another. (5)'

## **The dark web and hackers**

At around 2hrs and 15 minutes into the video it's stated: the dark web, any hacker can get on there and make changes... machines are able to change the total...(Ref 5)

### **Dr. Shiva Ayyadurai discussed the 'weighted race feature' in the voting machine**

At the Arizona hearing, Dr. Shiva Ayyadurai who was also referred to as Dr. Shiva discussed the electronic voting machines and its software feature known as the 'weighted race feature', along with the data from his September 1, 2020 primary senate race in Massachusetts. Although this information on the 'weighted race feature' was previously presented to viewers tuning into Dr. Ayyadurai's lectures on You Tube, it was not until around December 7, 2020 that the news about the 'weighted race feature' in the voting machine began to echo across the nation. During the presentation, he presented a new graph, which was not previously seen on other You Tube videos. It was a new graph that they came up with within the last 24 hours before the hearing where massive tests were carried out using Pattern Recognition Analysis, an area which Shiva has been working in for over 40 years and thus an expert in this field.

At around 5 hours and 37 minutes into this video that's over 10 hours long (Ref 6), a female thanked the Chairman and made the statement, "Sidney Powell had mentioned some conflict of interest with Dominion and these systems. She had said, her words are governors and secretaries of states and other politicians have invested interest in the system." She continued on and asked, "does this lend to her claim that there might be some nefarious motive behind this system?" (Ref 6)

At round 5 hours and 38 minutes into the video, Dr. Ayyadurai addressed her question by first giving an account of his own experience while he ran for the US Senate in the Republican Primary Election in Massachusetts on September 1, 2020. He said, "I was deeply shocked when I found out that this weighted race feature existed." He went on to explain how he and his team had acquired important data to review and 'to validate whether the weighted race feature was on.' As in this hearing, in previous videos, he had explained the ballot images, the cast votes records and the list votes records. He explained the process of what takes place when you put a paper ballot into the voting machine that an image is created. The paper is not tabulated but the images are. To verify the result the ballot images are required. He had applied to get the ballot images for the Massachusetts primary election. He said, "...The Secretary of States of Massachusetts - and I believe this may be true in many Secretaries of States across the country - they responded back to me saying they deleted the ballot images, in fact they destroyed them that they don't have to save them by state law." ( Ref 6)

During the hearing, Dr. Ayyadurai said that it is disconcerting that the voting machine has this kind of software capability. He said, "do we have one person one vote or do we have one person not one vote." He said, "... I think the courts needs to step in and re-clarify one person one vote going back to the 1964 equal protection clause of the United States constitution." (Ref 6)

He stated USC20701 and 20702 "for Federal Elections those ballot images must be saved to validate the integrity of the election." Aside from this weighted race feature in the machine, he discussed how Twitter had interfered in his senate race.

### **Dr. Ayyadurai's Twitter account was suspended for 21 days during the election**

Twitter, Facebook and Google were created for people to use, but there were concerns raised as to whether these platforms were conspire with each other to influence the election. At around 5 hours and 39 minutes in the video, Dr. Ayyadurai stated that Twitter had suspended his account

for 21 days during the election when he began talking about the ‘weighted race feature’ that existed in the electronic voting machine, but when he was tweeting earlier about election fraud, Twitter did not shut him down. That’s another red flag. It’s okay to tweet about election fraud on Twitter, but it’s not okay to tweet about the ‘weighted race feature’ in the voting machine on Twitter.

Upon hearing Dr. Ayyadurai’s elaboration on the voting machine, one of the members at the meeting said, “These machines are suppose to tabulate, not calculate, they are suppose to count one for one. These machines were built to do so (calculate) (Ref 6).

The meeting continued and at the time 5:47:20, Mr. Rob DePitten (this may not be the correct spelling of his name, due to the clarity of the video) who had reviewed countless articles and clips and videos says, “I think this is the biggest fraud in the history of our constitution republic is taking place right before our eyes. The corrupt Mainstream media and tech oligarchs are colluding in an attempt to assassinate the American public true legal votes for our President Donald J Trump through corrupt Government officials across countless precincts and corrupt state officials and courts.” (Ref 6). He said that what he ‘identified is between 120,000 and 306,000 fake people.’ He went over the data where there are approximately 1500 precincts in Arizona. He also presented data on a computer.

## **Section 6 - CEO’s from Facebook, Twitter and Google confronted by US Senators on the interference in the 2020 election**

In a You Tube video (Ref 7) an American Republican Senator asked, “Does Twitter have the ability to influence the election?” There was a pause then he continued on by saying, “Mr. Dorsey, you still deny you don’t have the ability to interfere in our election?” The Senator pressed on, “Does Twitter have the ability to influence election and you said no. Do you still stand by that answer?”

The reply is, “Twitter as a company. No”

But the senator drilled him, “You don’t think you have the ability by moderation policies by censoring ... you don’t think that censorship withholding true information from the American public? You don’t think that interferes in the election?”

The reply is, “Not our current moderation polices. Our current policies are to protect the conversations and the integrity of the conversations around the elections.”

In another YouTube video (Ref 8) posted on November 17, 2020, an American Republic Senator, Josh Hawley, was asking a straightforward question to the CEO of Facebook, Mark Zuckerberg, and the CEO was not giving a clear answer. In the video, Hawley asked, “Do your Facebook content moderation team communicate with their counterparts at Twitter or Google?”

Zuckerberg answered, “Senator I am not aware of anything specific but I think it would be probably pretty normal for people to talk to their peers and colleges in the industry.”

The Senator replied, “It would be normal but you don’t do it?”

Zuckerberg answered, “I’m saying I’m not aware of any particular conversation but I would expect that some level of communications probably happens...”

The Senator asked, “How many items on the task platform reflect that Facebook, Twitter and Google are sharing information about websites or hashtags or platforms that they want to suppress?”

Zuckerberg replied, “Senator, I do not know.”

From the two videos which I just mentioned above, there are discussions taking place on Twitter, Facebook and Google on the suppression of information, and since Dr. Ayyadurai's Twitter account was suspended for 21 days when he began tweeting about the 'weighted race feature' in the voting machine that can be used to change the votes, his account was suspended. The actions taken against Dr. Ayyadurai certainly say something about these social media platforms and that they are collaborating with others to censor individuals? Action speaks louder than words.

**Section 7 - At the Arizona hearing Dr. Shiva Ayyadurai provided detailed on how Twitter suspended his account for 21 days and that the Secretary of State of Massachusetts and the National Association of State Election Directors NASED were involved in the scheme**

The information, which Dr. Ayyadurai presented, at the Arizona hearing about his Twitter account being suspended was also discussed in a number of videos before the Arizona hearing. Similar to what he had already stated in other videos, in the 10 hour video (Ref 6) during the Arizona hearing, he said "...when I started sharing this on TWITTER on September 25, the Secretary of State in Massachusetts contacted TWITTER and shut me down for 21 days left in my election...And what came out in testimony in Massachusetts with a FEDERAL JUDGE here was that the Secretary of State of Massachusetts has a SPECIAL PARTNERSHIP WITH TWITTER where they were able to brand what I was sharing had validated the images were destroyed as election misinformation and in addition they called the National Association of State Election Directors NASED which is the Association of all the state election directors and they too got involved in contacting TWITTER to SHUT DOWN my TWEETS while I was exposing the ballot images which were destroyed which means the evidence showing that the weighted vote feature was on." Shiva said that this was quite extraordinary.

Twitter did not shut him down when he was tweeting about election fraud, but as soon as he started to expose the voting machine that has a 'weighted race feature' that can be used to increase votes for a party and at the same time decrease votes for the other party by the same amount or a different amount, Twitter had suspended his account for 21 days. That would interfere with him getting the message out. If it happened to Dr. Ayyadurai chances are there were other interferences in the election, else why would U.S Senators have hearings and asking the CEO's of Twitter, Facebook and Google on collaboration and also on interfering in the election.

Ayyadurai pressed on by saying, "State of Massachusetts Secretary of State and the State Election Directors found threatening because what I was essentially stating was the State Election Directors and a number of these states are concealing the actual evidence which directly correlate which can be exposed whether the 'weighted race feature' was on, so yes, I do believe it's nefarious and if you go look at the National Association of State Election Directors," (Ref 6) answering the question where the word nefarious was used earlier in a question asked by a female during the hearing.

Dr. Ayyadurai said, "...the State Election Directors and the Secretary of States are the ones who certified electronic voting systems, which means are they certifying electronic voting systems knowingly with the weighted race feature? In my view I know in Massachusetts that's what was done....And knowingly telling the vendors to delete ballot images which are the evidence interconnect the weighted race feature being on and the ballot images, so Massachusetts, the factory settings of these electronics voting machines - the default factory

settings - is to save all ballot images. What we discovered in Massachusetts is a tell the vendors to set that to off, which means delete, destroy all ballot images and I believe that many of these Secretary of States are involved in this, so yes I believe it is nefarious. (In the video this quote ends at the time 4:42:46)

## **Section 8 - Dr. Shiva Ayyadurai's preparation for the Michigan hearing - Failure of the DOJ**

Dr. Ayyadurai had prepared for the hearing in Michigan held on December 2, 2020, following the Arizona hearing, where he would expose the 'Failure of the DOJ (Department of Justice)', but was not called to testify. Exposing the DOJ would have sure caught some attention.

The title of a slide is 'A Pattern Recognition Analysis of Michigan 2020 Trump-Biden.' At time 15:10 in the video (Ref 9), he used 'Pattern Recognition' to figure out the 'normal state of the system' and the 'abnormal state of the system.'

## **The Diebold Election Systems manual for voting machine and federal laws on voting In the manual, The Diebold Election Systems p. 2-126 (Ref 9) is mentioned in the video**

Ayyadurai spoke about the Diebold Election Systems weeks before the Arizona or Michigan hearing. For the Michigan hearing, he had prepared information on the voting system that's listed in the Diebold manual as seen in this video (Ref 9). The word 'Diebold' was used at the Pennsylvania hearing, but there were no mention of the 'weighted race feature.'

Although lots of important information were presented at the Arizona hearing, Dr. Ayyadurai did not discuss the Diebold manual as he does in this video; he may have ran out of time at the Arizona hearing. In the manual as per highlight in the video, he shows what's written in the manual: 'Weighted races are tallied by weights, assigned from the voter registration, and may be counted in Central Count vote centers only.' That's a major Red Flag. At time 14:15 in the video (Ref 9) he says, "The ballots images are being deleted which is a violation of Federal law." He gives the law number 52 USC 20701 and his report says: all Records Generated in Connection with a Federal Election MUST BE SAVED for 22 MONTHS. It also states: The Department of Justice is NOT investigating this violation, in spite of knowing about it.

This is a real problem for the whole country and every citizen if the Department of Justice turns a blind eye to this.

## **Section 9 - FBI investigation 2020 election fraud**

There are videos where Mark Zuckerberg had donated 300 million dollars to assist at the election, along with another company (Ref 10). On November 30, 2020, according to the media out of New York, NewsMax Stinchfield, during an interview with Phillip Kline, the FBI has already gotten involved with the investigations on election fraud (Ref 11). The Headline was FBI requests data on questionable ballots. Phillip Kline who is the Director of The Amistad Project and a former attorney general of the state of Kansas says, "...what our data shows is what we called the blood in the stream is, it's after the crime is committed." He says that they "have identified hundreds of thousands of ballots." In their process they review data provided by the



government and they contact voters to compare and see if what they are stating ‘reflected accurately in the voting process.’ (Ref 11)

In the process they came up ‘with tens of thousands of republican ballots that were not counted’ (Ref 11). Their collections shows ‘hundreds of thousands of republicans who say they never requested a ballot but they voted absentee by somebody else.’ ‘Identified people outside of the state who voted within the state’ (Ref 11). He stated that Mark Zuckerberg provided 400 million dollars into the 2020 election, while other video (s) mentioned the number 300 million (Ref 10).

## **Conclusion**

As the discussions around the election, forced vaccination, the lockdown and wearing a mask continues, President Trump is not backing down without a fight and nor is Dr. Shiva Ayyadurai where the 2020 United States elections are concerned. Many wants to know that they’ve had a fair election and not one based on voting anomalies, and that democracy has won.

As I carry out my research, one of my main sources continues to be Dr. Shiva Ayyadura because of his background in the immune system and he was the first to expose in voting irregularities in the U.S 2020 elections. It first happened to him and then to President Trump. The data proved that fraud had taken place in the September 1, 2020 primary election in Massachusetts. Many have signed affidavits, making allegations that fraud had taken place in the November 3rd, 2020 federal election, and are coming forward with their allegations by putting everything they have on the line. Ayyadurai have presented data that are not adding up for the September 1 and November 3, 2020 elections. Where do they go from here? Are the damages already done and cannot be reversed? It looks like the battle to reclaim democracy is still on and the fight is strong.

‘On the step of the Supreme Court’ (Ref A) Shiva leads a crowd with the words resonating ‘One person, one vote’ and ‘Truth, Health and Freedom.’ Shiva Ayyadurai had also created the first complete email system as a 14-year-old teenager in New Jersey or you can say he is the inventor of the first email (electronic mailing) system and shortened the name to ‘email’. On the Internet, another person name Ray Tomlinson is sometimes said to be the inventor of email. There are some confusions on this because Tomlinson did not create an electronic mailing system; he created a different technology and they are confusing his technology with the name ‘email’ which was created by the 14 year old, Shiva. We are looking at two different people that created two different technologies. In Section 1 of this research paper I already explained that Dr. Ayyadurai came up with the term ‘email.’ In Ray Tomlinson own words in a video, he said “The term (referring to email) wasn’t coined until several years later’ (Ref I), meaning that it was Shiva that came up with the term ‘email’ for his electronic mailing system which he created in 1978, and that Ray Tomlinson created a different technology before 1978 but it was not the electronic mailing system (email). Therefore why are people using the term ‘email’ when speaking of Tomlinson’s invention? Why all the confusion? It’s very simple to explain and to understand this. As stated in Section 1 of this report, Ayyadurai came up with the term ‘email’ in 1978, when he wrote a complete electronic mailing system and called it ‘email’ which mimics what a physical mailing system does which have addresses, dates, time, inbox, outbox etc... This is what Ayyadurai is claiming he did on the computer by writing about 50,000 lines of code to create the electronic mailing system. It was not Tomlinson that did this. Tomlinson did something very different. Tomlinson sent an electronic message from a computer to more than one computer by using an @ symbol. He could have used any symbol but he chose

the @ symbol. That's not an email system he created with the inbox, outbox etc...He sent an electronic message from one computer to more than one computer. Electronic messages were already used on computers, so Tomlinson did not even invent an electronic message which people are confusing it to be an electronic mailing system, nor did Tomlinson wrote 50,000 lines of code to create the email system with the inbox, outbox etc.... The whole world uses the term 'email' because Dr. Ayyadurai named his electronic mailing system 'email.' A You Tube video (Ref F) clearly says that 'Ray Tomlinson wrote a software program over the period of about a week that used file-transfer protocols and send-and-receive features.' He is sending a message, and the other computers are receiving that message. So that's understandable. That's not an electronic mailing (email) system based on what we know an email software does that mimics how a physical mailing system works. Since Shiva created the first email system, later on others would add to it as technology as time moves forward, and that only makes sense, but the fact is, the 14-year-old Shiva Ayyadurai was the one who created or invented the first email system and not Ray Tomlinson. Give credit were deserves.

It's very simple to understand the difference in what Dr. Shiva Ayyadurai created and what Ray Tomlinson created. It's two different technologies. It seems like there's a deliberate and planned movement created to blemish and flaw the success of a 14-year-old Indian teenager in the United States of America that invented the first email system. From the comments I'm reading on videos, its mainly people with British names that are trying to take away the credit from Shiva because he is Indian and are giving the credit to Tomlinson because he is 'white.' All they are trying to do is confuse the mass and lie to the sleeping masses. My opinion is, if Shiva Ayyadurai's name was Dickie, Volare, Smith, Johnson, Tomlinson, Harrison, McCarthy, McDonald, Tom, Dick and Kirkpatrick etc... and maybe if Shiva's skin tone were not of dark complexion, they would have no problems understanding who invented the first email system and who sent just an electronic message from one computer to more than one computers; two completely different technologies. But all they want to do is to create confusion and deceptions thinking that nobody would stand up to them, and today Dr. Ayyadurai is standing up and speaking up against the 2020 United States election fraud and the ones that's involved in the fraud and also having his Twitter account suspended for 21 days during the election which was very important to him with all of his hard work.

Dr. Ayyadurai said that Twitter had suspended his account for 21 days. Did Twitter interfere in his election? There have been meetings with Senators and the CEOs of Facebook, Twitter, and Google about influencing the election using their platforms and communicating with others. I created two pages on my Facebook account called 'True Love' and 'A Kiss Goodnight' after my original songs from the 1990s and which I have been writing about and promoting around the year 2017, and to discuss some similarities of recent songs '24 Karat Magic' by Bruno Mars to my song 'True Love', and Lady Antebellum (now called Lady A) song called Just A Kiss (Goodnight) which came out around 2011 around the same time I gave a copy of a tape to someone that claimed he knows everything about music and that he is a producer, and also similarities to my song 'A Kiss Goodnight' to the recent Disney project called A Kiss Goodnight. As soon as I went to update my Facebook page called 'A Kiss Goodnight' bang! I was knocked off my Facebook account and I was not allowed back in. I tried for a while with my user name and

password but my account was seized by Facebook. I had contact Facebook about four times and got no reply, and as I tried to get back into my Facebook account, I was not allowed. Due to this, I lost all of my contacts to relatives and friends made through Facebook of people I knew when I was a boy in Guyana and have not seen in decades, and I had also made some friends on Facebook and I lost connection to most because of what Facebook did. Like many people that signed affidavits and putting their lives and career on the line to tell the truth about the 2020 election, I have no reason to lie about any of this and I have proof that I have written all of my songs and books. But when others are scheming and plotting against you and censoring you, how do you stop their deceptions? My opinion is Facebook had interfered in me getting my message out about my original books and music being sampled and samples being used by world famous musicians, with no contract and no permission, and I had never ever made a penny from any of my songs and music. Based on my experience, social media platforms like Facebook has conspired against me, and if this can happen to me then it's happening to others, and what they did to me is unlawful. Dr. Ayyadurai said that Twitter had suspended his account and he came up with amazing proof and information to prove that platforms as such are conspiring against individuals and have interfered in the 2020 election. Also concerning the witnesses that came forward to speak up on the U.S 2020 election fraud, I do not see any reason why anybody would make up false claims about the 2020 election, then sign an affidavit to risk everything they gave, unless they are telling the truth to the whole world; many people have already come forward fighting for democracy and to stop the fraud and deceptions taking place.

## A Glance at Camp Pekiwin 2020

Driving down 109 Street heading north, passing the University of Alberta and the High Level bridge, to the right a steep hill takes you down to the one-way bridge called the Walterdale Bridge with three lanes and arches reaching up to 184 feet. Witnessing the white colored arches and the striking modern day design evokes memories on the many bridges, which I have driven across in New York City. The modern design of the bridge and a city with one of the biggest malls in the world, boasts the growth, development and riches over the past five decades. This bridge takes you across the North Saskatchewan River towards the heart of the city. The bridge was opened in September 29, 2017 replacing the old Walterdale Bridge which was built in 1913, where construction of the bridge had begun in early 2013 with millions of dollars, labor and years poured into this latest development in Edmonton, Alberta, Canada making the city more attractive where visitors from all across the world destines to spend days and weeks at West Edmonton Mall. As I drove across the bridge to the right is the Re/Max Field in the Rossdale area where baseball games are played. This year, the scenery has changed.



In the year 2020 life was turned upside down for many across the world as the covid-19 pandemic came to life, destroying many lives. But for some in Edmonton, life has been in shackles, from birth or for years, or even for generations.

Nestled between the lively Waltherdale Bridge and the RE/Max baseball field in the open landscape in the Rosedale area is a camp with over 170 tents with a big sign at the front that says THIS IS NATIVE LAND.



This camp is called 'Pekiwewin Camp, a solidarity and resource camp against police violence (1).' Inside the camp is a teepee for prayers. Driving by, from the outside, you can see people going about their business.





Camp Pekiwewin was set up before sunrise on July 24, 2020 for the homeless and by the end of the day a dozen tents were set up. Days to follow, the camp grew with more tents and more people passing through. The site of the camp reveals a protest to end homelessness and ‘calling on the City of Edmonton to permanently convert the space into a ceremonial and gathering place for Indigenous communities (3).’ At the camp, there were volunteers and groups such as Black Lives Matter assisting helping out and giving a voice to the homeless, which the government and society has neglected.

As I drove pass the tents a number of times and looking in from the outside, I have only seen indigenous people. There are many tents, shopping carts, a man down on his luck sitting on the sidewalk with his bicycle lying on the pavement. Who would have ever expected to see such conditions Alberta, Canada which is one of the richest provinces in Canada. It’s obviously more important to pour money and labor into the construction of a dazzling new bridge, view and redesign the city, but it’s evidently not important to pour enough money into programs and housing for the homeless and to end poverty in one of the richest place in the world. The sight paints a picture of how the government has failed to take care of some of its people; not only the government but also the rich people living in this city. The indigenous people are hoping to regain this area as for generations in our past history, this area was ‘a traditional gathering place, trading, burial and ceremonial grounds amongst many Indigenous families for generations.’ (1)

This area is only used for extra parking during the baseball games at Re/Max Field across the road from Pekiwewin. Perhaps Pekiwewin will one day be the new name for this spot bringing more development to the city, but this time for the original people of this land. About one to five minutes driving north and up the hill, depending on traffic, you will drive into the heart of the city, the downtown area of Edmonton which have grown over the past few decades with many office towers, construction and new developments. The downtown library was recently opened having undergone a complete redesign. It’s conceivable that one day that scenic area in Rossdale will be developed as being requested by the Indigenous people. We need change and we need change now! Everyone’s life must matter. And homelessness should not be allowed for any one. All lives matters! And we want to see progress!

### **Some of the conditions and demands for the homeless**

There are a large number of Indigenous people who are homeless in Edmonton and are often discriminated against. According to the Shima Robinson who is a contact at the camp, the updated demands are, ‘free transit, the establishment of an accessible emergency response fund for frontline workers, more transitional support services, a review of bylaws that target people in poverty and an end to tent slashing and property destruction.’ Defunding the Edmonton Police Service budget by \$39 million was removed from the demands. Robinson reminds us that there’s an ‘urgent need to address the lack of housing in the city (Ref 3). There are also complaints about police violence on the homeless communities such as the alleged slashed tents and pepper sprayed used.



## Homelessness and life at the camp

People at the camp and the ones passing through seeking shelter, meals and support have grown to about 400 a day. At night the tents provides a place for people to sleep. In the morning, coffee with snacks and in the afternoon a meal is provided. There are many volunteers and health care workers providing services at the camp.

There are daily problems at the camp and according to Kaela Siewert who is a former EMT says there are about five overdoses a week and ‘all successfully reversed.’ Other problems are faced such as a life-threatening injuries during an assault of a camp member. (4)



The Mayor of Edmonton, Don Iveson, had stressed how urgent it is in resolving homeless in Edmonton and have given a ‘10-week deadline for finding a solution before the weather turns cold (3)’ During the pandemic the government had announced 48 Million to assist the homeless. Iveson, emphasized the importance of having enough housing for the homeless before it gets cold.

Around the second or third time passing by the camp, I stopped at the traffic lights only about 10 years from the camp, my vehicle being the closest to the lights. There are two or more lanes coming down from the hill and four lanes going towards the hill and two of those lanes branch off to the right. As I looked straight ahead on the other side of the traffic lights, there was a young man walking in the middle of the road with cars coming from behind him and my car now approaching him as I left the lights. He was tall, slightly tanned and looked indigenous but of mixed heritage and looked about age 20. My thoughts were he was heading to Camp Pekiwewin. As he walked in the middle of traffic, I had slowed down and kept as far to the right so I don’t hit him. It was as if he just appeared out of nowhere, as a sign of the indigenous people with a message. And that message would be: look what you’ve done to our world, our people, change is coming! It was as if he was the enlightened one for the people, it was as if he was a brave warrior reminiscing of the past when they rode their horses on this same land and when they were free from this bondage that was put onto them.

*Snow already on the ground and the tents are still there. Temperature has already fallen very low for a number of days, reach around -18 degrees Celsius for the low.*



The last time I passed by Camp Pekiwin was November 12, 2020 and the tents were still up. Edmonton has already had overnight temperature to around -18 Celsius before November 12. On that day as I drove by, there was a police vehicle blocking the inside street. It looked like some people with their belongings were being taken to shelters for the homeless. I have heard of one building on the Southside being used for the homeless. Homelessness must end and all lives should matter and be treated with respect.

Half-ripe plantain baked with sweet potato by F. Ally



Prep time: 10 minutes

Baking time: 20 to 30 minutes

Serves 2 to 4

Ingredients: 1 half-ripe plantain, 1 sweet potato, olive oil, black pepper, paprika pepper

Peel, slice and wash plantain and sweet potato

For a spicy taste sprinkle spices (black pepper, paprika pepper) to taste

No salt used



**Instructions:**

Add one teaspoon olive oil to each pan and spread out using a tissue; this will help prevent sticking to pan

Set stove to 200 degrees Celsius



Bake on one side for approx. 8 minutes

Remove pan from oven. Use spatula to turn over plantain and sweet potato

Shrimp & Akra by F. Ally using Neisha's Recipe Book



Served with rice, roti or pita bread

F. Ally used Neisha's Recipe book, but used different spices

Ingredients: 1 bag shrimp, 1 pack frozen akra, 3/4 onion, 7 garlic cloves, 3tbl oil

Spices: Paprika, black pepper, oregano leaves

Prep time: 10 minutes

Cook time: 20 minutes

Set stove on Hi

Add oil to pot

Add onion and garlic

Fry onion and garlic for approximately one minute

Add shrimp to pot and fry for 2 to 4 minutes so one side becomes a little brown. Turn shrimp over with a spoon and cooking for 2 to 4 minutes so this side gets a little brown

Keep shrimp to one side of pot and continue cooking shrimp

Add akra to the other side of pot and cook for approx. 5 minutes without stirring

Use spoon to turn over akra and cook for approx. 5 minutes

Mix shrimp and akra together but make sure not to mash up akra





Add paprika, black pepper, oregano leaves to taste

Stir and cook for about 5 more minutes

Add 1/2 sliced tomato to one part of pan and cook for approx. two minutes

Mix everything together but do not mash up the akra and tomato



Cook for about another 5 minutes

Set stove to Medium and cook for about another 5 minutes

## VEGETABLES WITH CHICKEN

**Chicken stir-fry and a chicken wings side dish by F. Ally**



Prep time: 30 minutes

Cook time: 50 minutes

Bake time: 40 minutes

Ingredients: 1 bunch broccoli, 10 brussel sprouts, 1/4 cauli flower, 1/8 cabbage, 3 sticks celery, 1 sweet red pepper, 3 carrots, 1 onion, 8 cloves garlic, 1 chicken, 2 Tbs oil, barbecue sauce  
Spices: Paprika, black pepper, Oregona leaves

Slice up, wash and rinse

Set stove on Hi and add 2 Tbs oil

Add garlic and onion and fry for approximately 5 minutes, stir a few times

Add contents to pan and mix

After 5 minutes put cover on pan and continue cooking on Hi for 30 minutes

Bake chicken at 220 degrees Celsius for approx. 20 minutes, then turn oven to 240 degrees and continue baking for about another 20 minutes

Mix 3/4 of the chicken with the stir-fry and simmer on low for approx. 15 minutes or until stir-fry is completed

**Barbecue chicken side dish**

Continue baking the wings, legs in the oven at 240 degrees Celsius few about 15 minutes or until gets a bit brown

Add barbecue sauce and continue baking for approx. 15 minutes or until complete.

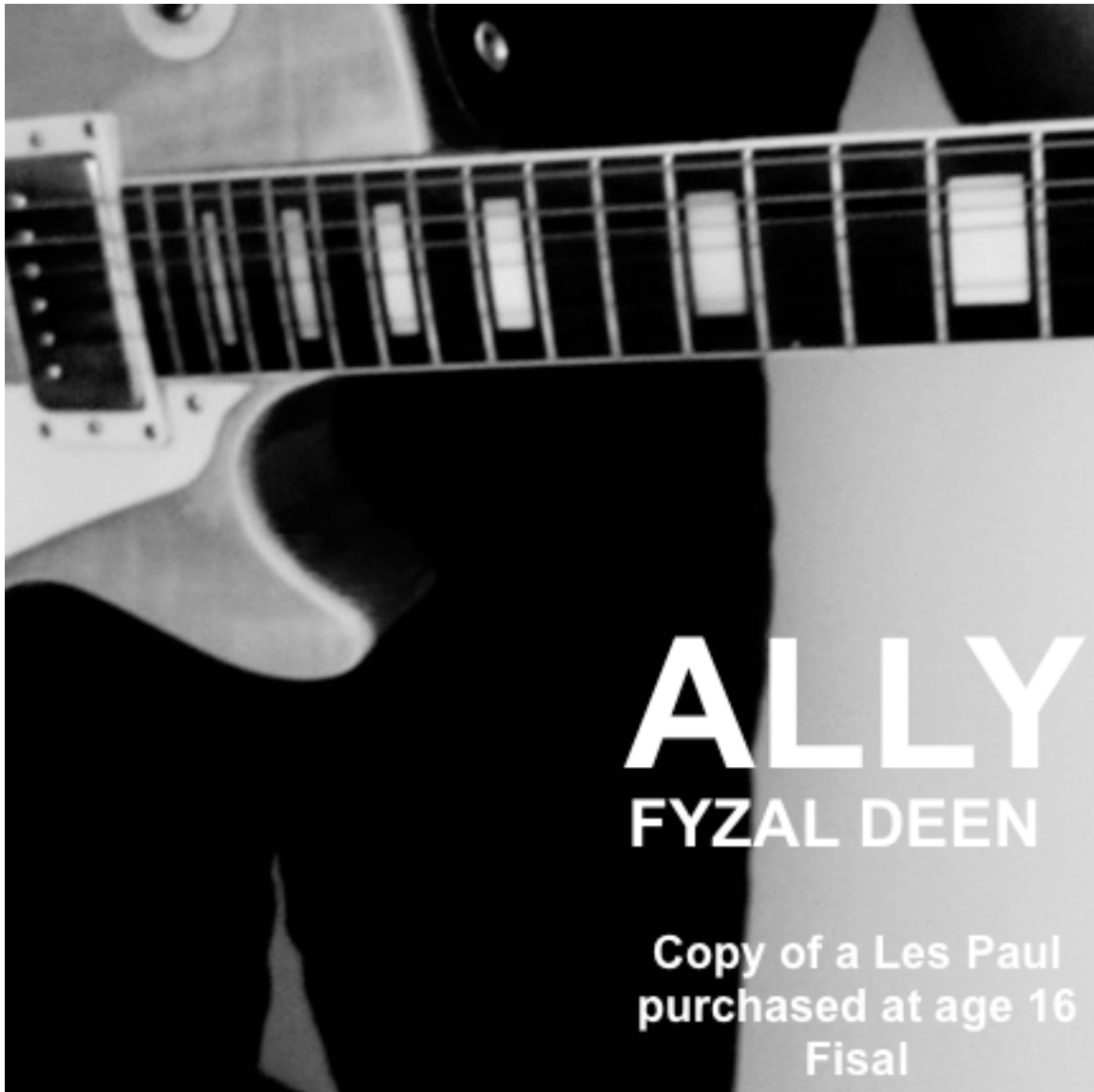

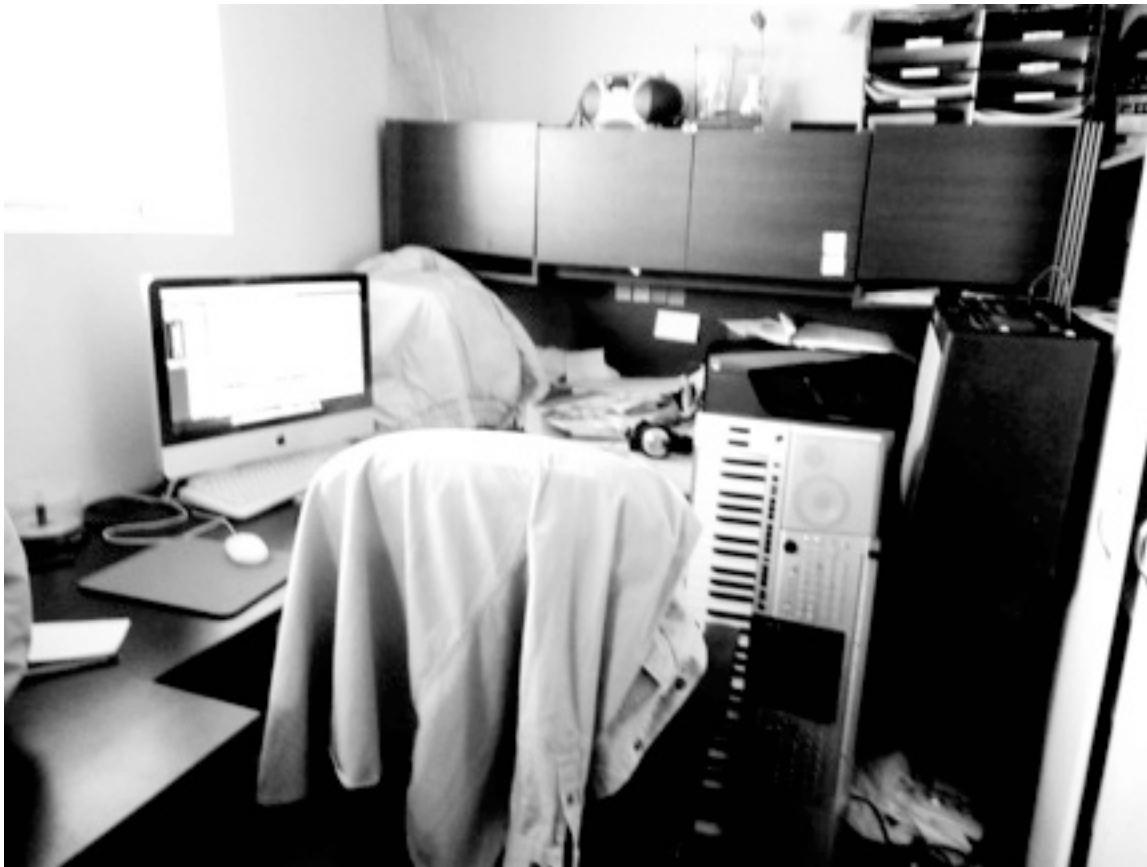

If you've worked on a song for weeks, months and every a year or years, you are going to recognize your work anywhere. And what makes me so certain about this is, the melodies are very similar to mine. Both the lyrics and melodies area almost identical, so there's no getting away for any of this. Not only in these two songs but many songs that came out around that time. And often enough when I post something relating to similarities, someone would send me a message trying to rebuke what I'm saying. Why should that person even care? Doesn't that sound fishy and suspicious? I've saved all of those messages. How would that person know when I post similarities, unless that person has something to hide and is guilty about something and therefore is tracking me on everything I do and to silence me, and it's no doubt that it seems to be the same person is doing it all the time...Fisal Ally

Someone's obviously trying to tell me some thing. I do not need to listen to the song again. What's below is what I wrote initially. I may add some notes, and it will be in brackets...Fisal Ally

### **Sit, Relax and Meditate**



#### **Steps for rejuvenation by F. Ally**

Letting go of these thoughts is important

But how do we let go? Some of us do it automatically through prayers and other methods. Learning to let go and let the silence buried from within us to surface can be accomplished through meditation. I had undergone this change many years ago, when I had taken a full three-day seminar from Dr. Deepak Chopra and his team.

Some of the benefits from meditating regularly are:

1) Relieving stress and anxiousness 2) Allows us to let go and wind down 3) Achieving stillness and silencing of the mind 4) Lowering blood pressure 5) Stop judging and blaming

Below is a technique I use in my meditation

I will refer to the mantra as a phrase. Here are four phrases; there are many which you will find on the Internet.

1) Om shanti shanti (*Mantra in Sanskrit*)2) Om Namah Shivaya (*Mantra in Sanskrit*)3) Maranatha (*phrase used in Christian meditation*)4) Subhannalah (*phrase used in Islam during zikr and prayers. Zikr is similar to meditation or some say it is a meditation, which is a part of the prayer*)

## **Meditation steps**

Sit comfortably with palms on lap. Close your eyes for a few minutes? What happens? All kinds of thoughts kept coming and going? Of course.

Close your eyes, sit and relax and begin saying your phrase over and over for a few minutes. Focus more on the phrase. By saying the phrase over and over, this phrase should replace the stories and blaming that goes on in your head. You now have a simple phrase now swirling through your head instead of rambling thoughts or blame? As a beginner, your thoughts and rambling stories will surface over and over. When this happens, the goal is to catch yourself and start repeating and focus on the phrase saying it over and over. Buried thoughts, hurts and anger will surface. Let them surface, deal with them and let them go, and then start repeating your phrase over and over.

As you repeat your phrase, slow it down. Now there will be gaps of silence in between the phrase. Continue to slow down the phrase and let the silence gaps between your phrase get bigger so you have more silence between your phrase. Let the phrase become slower and fade, and when the phrase fade remain in silence as long as you possibly can. The thoughts will come back. Repeat the process. Over time a person gets better at it. Trying doing this for 15 to 45 minutes every morning for a year and you will become a much calmer person.

The rejuvenating process begins with silence

When your mind is silent, this is when the rejuvenating begins. When your mind is silence, make a wish. For example, wish others peace and love or say a prayer and let the words radiate into the unseen.

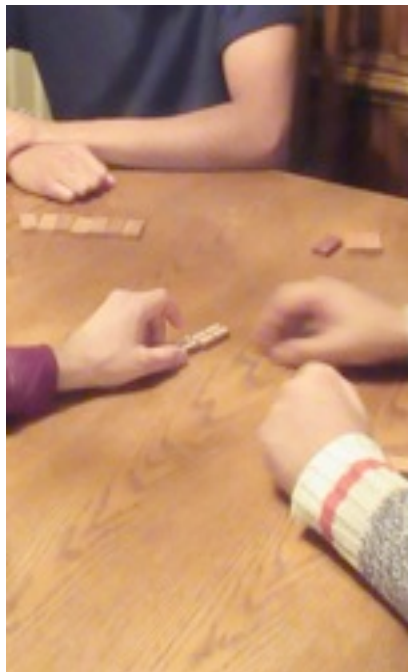
