United Nations Scientist admits vaccine deaths, says better explanations needed.

Gates: "First, we've got population. The world today has 6.8 billion people. That's headed up to about nine billion. Now, if we do a really great job on new vaccines, health care, reproductive health services, we could lower that by, perhaps, 10 or 15 percent ..."

Since the 1990s many have questioned vaccinations. Many refused being vaccinated. But with this lockdown the entire world is being told that everyone has to be vaccinated. And this will not be a one-time vaccination

On May 1, 2020, the House Resolution (H.R) 6666 was introduced in the United states, where methods will be used to quarantine people, and where many will have to take the vaccine even if they are against it. I have reviewed some doctors that are completely against this lockdown and also against mandatory vaccination. They do not believe that a healthy person should be lockdown, and that vaccination should not be forced on anybody. They believe that it should be the person's choice. Dr. Rashid Buttar is one of the doctors that have been speaking out against mandatory vaccination for different reasons.

Do vaccines cause autism - mercury in the body

Dr. Buttar says that he is not anti-vaccination, but he is anti-stupidity. If a vaccine is proven to be safe and solves illnesses and is not causing harm to the person, then I'm all for it because like Dr. Butter, I'm also anti-stupidity. If a person is ill and is low on certain minerals or have an infection, and a vaccine will help and not harm the person by create all kinds of side effects, more health problems and complications later in life then I believe that most people will not be against such a vaccine. However, some people has to make choices based on their conditions where they may accept a vaccination knowing that there are risks involved or where sooner or later that same vaccine may cause complications, in exchange for a partial cure or for a longer life. I believe that being

vaccine should be an individual choice and not a Big Pharma control over out bloodstream, especially since I own my body, at least I sure hope so.

But when I began hearing that mercury and other substances were being injected into people's body at one time and causes harm, that's a major concern. Many parents have these concerns for their children.

Dr. Buttar has used non-conventional medicine to help patients with autism and other illnesses and has been very successful. He has treated his own son at three years old. He says that his son was vaccine injured.

At the House Hearing, 108 Congress on Session, May 6, 2004, Hon. Dan Burton (chairman of the subcommittee) says that Dr. Rashid Ali Buttar is testifying before the subcommittee 'on his personal success and application of a groundbreaking treatment...another cutting-edge medical development currently being used and tested for the use in autistic patients is Hyperbaric Oxygen Therapy...' The chairman continues, "As I stated before, autism is an epidemic, and I sure hope our health agencies are paying attention, because it really is...I implore them to continue their fight against these devastating diseases and get mercury out of all vaccines for children and adults.

Mr. Burton introduced Dr. Rashid Buttar who is from Cornelius, NC, is the creator of a transdermal chelator. Dr. Buttar began, "I'd like to start off by first pointing out that the overwhelming evidence of mercury and chronic disease has been reviewed and yet still it's considered to be a controversy." He addressed Congressman Burton by thanking him and said, "we all appreciate your battles that you have fought on our behalf for years and years and years."

Dr. Buttar began to treat his son at age 3. At the House Hearing, 108 Congress on Session, May 6, 2004, he demonstrated with slides showing the tests of some of the people he had treated, where for example he had pointed out that there were no mercury showing up. The quoted in this section are from this hearing, a 64 page report; see references below. He explained that a study by Boyd Haley, "found was that children that had autism had no mercury in their hair, whereas children that were developing normally had very high levels of mercury. Why?" He says that the children (with autism) cannot get rid of the mercury. He stressed on this point again saying that 'children that are autistic cannot get rid of it.' After 6 tests were carried out, he shows his son's mercury level, where as before he showed 4 slides that showed no mercury level, meaning that the mercury was not showing up in his son. But after six tests, the mercury in his son was now showing up. His son's mercury level was '13 micrograms per gram creatinin, which is over four times the toxic level.' Dr. Buttar was demonstrating that even though at times no mercury was showing up in the tests, that he found mercury after dong more tests.

In the year 2020, Dr. Buttar states that in 1991, autism affected 1 in 10,000, and in 2020, it's 1 in 32 or 1 in 29 (depending in which Yout Tube video you are reviewing). And at

this hearing in 2004, it was 1 in 500 children. This indicates that autism increase rapidly in the 1990s and continues to increase where it's now about 1 in 32.

At the hearing back in 2004, the speaker says, "Dr. Buttar and a growing number of health and science professionals postulate that heavy metal toxicity is at the root of several disorders such as Alzheimer's and autism." The meeting continues and he says, "I am pleased to announce that the chairman and I have nominated Dr. Buttar to the National Institute of Health for consideration of the Director's Pioneer Award. The award provides a stipend for research in areas that are not funded by mainstream sources.

During the presentation Dr. Buttar demonstrated using slides. He said "We did a search under mercury and a number of different chronic diseases... although in the medical literature there's very little evidence of mercury associated with chronic diseases, the amount of references that I found with mercury and cardiovascular disease...amounts to 358 studies." He continued with slide No.3 showing that there were 643 references in the 'relationship between mercury and cancer.' He says "Then when you go to the neurodegenerative area, mercury in the brain, over 1,445 references regarding the relationship between mercury and neurodegeneration; and yet for some reason still it's considered to be a controversy. There is no controversy, as you know, Mr. Congressman."

Dr. Buttar explained that mercury comes from fossil fuels, the water we drink, the food we eat and other sources. He states, "We know about the Thimerosal issue with the Vaccines." He went over why he was at the meeting by saying, "I am here to discuss with you today that you have asked me to come and discuss is how do we get the stuff out," referring to mercury in the body.

He went over an example of a 44-year old female that has mercury in her body and the procedures taken to remove the mercury and showing her recovery. He says: <u>DMPS</u>, a chemical that is used selectively from mercury and arsenic; and you'll notice that woman's mercury level was 65 micrograms per gram creatinin. Normal is considered anything less than 3." He explains that during the treatment with tests that her mercury level decreases, and during the treatment when the mercury increases what causes the increase. He says that when they add glutathione the level of mercury increased to 41 because the substance helps to pull out more of the mercury.

Dr. Buttar explained that in the autistic population as well as in the Alzheimer's population, there's a phenomena called 'an impaired detoxification pathway' where the patients body cannot get rid of the mercury. He explained that when his team carry out the tests that the mercury does not show. It does not even show using their techniques such as 'the advanced techniques of using IV therapies to challenge the body.'

She shows slide No. 16 where a 34 year old female with substantial medical problems, 'including hormonal disruptions, cardiac disrhythmia. She had ataxia, she couldn't walk

straight, she had a problem speaking, she had milk coming out of her breasts, and she was 34 years old. She was suicidal.' *She had seen 16 doctors in 5 years before she came to see him and he told her it was mercury and she said that she was checked for mercury.* He tested her twice in two years and the tests did not show mercury. She asked him to treat her and during the treatment her mercury level was increasing but she was getting better during the treatment. The level continued to rise from 9.4 to now 19. She could not get rid of the mercury on her own. This is also what they see with autism.

On slide No. 19, he explained the mercury level going from 2.8 to 9.4 to 19 to 27 micrograms per gram creatinin of mercury. This patient 'at this point was completely normal. She was symptom free... They're sensitive. Their system cannot eliminate the toxicity that they have been exposed to.'

Dr. Buttar's son had lost his ability to speak at age 14 months, but still has his first word 'abu' meaning father in Arabic, along with another 10 word. At 15 months old, he lost his vocabulary. He began to treat his son at age 3. He shows some slides and points out that no mercury were showing up. He explained a study by Boyd Haley where Haley found 'that children that had autism had no mercury in their hair, whereas children that were developing normally had very high levels of mercury. Why?' He says that children cannot get rid of mercury. He stressed on this point again saying that 'children that are autistic cannot get rid of it.' After 6 tests were carried out, he now shows his son's mercury level, whereas before he showed 4 slides that showed no mercury level.

His son's mercury level was '13 micrograms per gram creatinin, which is over four times the toxic level.'

The doctor with his team then carried out a study with 31 Patients that were diagnosed with 'autism, autism-like spectrum, pervasive developmental delay.' 'They were all treated with the same format, transdermal <u>DMPS</u> with--it's conjugated with a number of different amino acids, and it's delivered in a highly specialized micro-encapsulated liposomal phospolipid transdermal base. All 31 patients were tested at baseline with urine metal screens, hair metal screens, blood metal screens, as well as fecal metal screens; and all children showed little or no mercury on initial testing. He showed slide 23 where a child was tested and nothing showed up at 'baseline, <u>but as treatments</u> continued these children started dumping mercury."

In the year 2020, Dr. Buttar have been speaking out against mandatory vaccination. He has many videos and below is are direct quotes. He has given permission to share his videos (at least some of the ones I have watched) to educate others.

Dr. Buttar says, "They say it's not in there, but yes it's still in there." He is referring to mercury. "It says thimerosal free....thimerosal is ethylmercury. When you add ethyl to mercury you make ethylmercury or thimerosal which is a preservative in vaccine and ethylmercury is a thousand times more destructive than inorganic mercury-and inorganic mercury according to the EPA is the second most toxic known to man. *Why are we*

putting the second most toxic substance known to man, adding an ethyl group to it to make it into a preservative know as thimerosal or ethylmercury which makes it a thousand times more destructive and putting that in vaccines for a child when we are trying to protect their immune system In the pretense of building an immune system. It gets worse than this. All kinds of foreign substances are in the vaccines from pigs, dogs, monkeys etc..." Buttar went on to give more examples. He says that every aspects of the modern day vaccination schedule defies human physiology. He says he's not antivaccine, but he's anti-stupidity. He sends a message to the viewers "if there are doctors, and is giving vaccine to know that you are giving something that's causing harm and you need to wake up, open your eyes, open your ears and do your own research and realize...that you are hurting people."
