#### Introduction

On Euronews Now, with the higlight 'VACCINE CAUTION

Norway adjusts advice for elderly and frail people after vaccine deaths'. On this news broadcast, the host asked "...how do they asses if somebody is too frail or too old, not well enough to take the vaccine. Is there any sort of standardize practice..." The doctor answered "it's very difficult to standardize this...this will be a decision made by the physician, the nurses, the relatives and the patients themselves. If you have patients that are very frail, very sick and have a short remaining life span you should do some extra evaluation of the appropriateness for vaccinating..." (Ref 2)

Some are asking, "Do I have to be vaccinated?" The host said, "The answer in the UK is NO. (Ref 2)

At 18:45 minutes into the video, the highlight says, "every time more vaccines are pushed upon us, there is a greater resistance to them" Francoise Salvadori, Co-author of Antivax, a history of the anti-vaccination movement in France (Ref2). At 19 minutes into the video a number of Pfizer recalls were also exposed.

The Jerusalem Post Staff, December 30, 2020 stated, '88-year-old dies hours after COVID vaccination in second such incident.' The small writings say 'In both cases medical professionals do not believe that the deaths were connected to the vaccines' (Ref 4). What's causing all of these deaths then? Something caused their death, since this person was alive before taking the vaccine and after the 88-year old was given the vaccine, she died. If it's not connected to the vaccine what are causing these deaths? Does it mean that if the 88-year old, like many others, did not take the vaccine, that they were going to die at the exact the time they died? If that's the case then why give them the vaccine? This 88-year old, like many, may be weak and frail, but so are many, where many lived for years after, the arrival of covid-19. People that are 90 years old and over 100 years old are frail and weak, but somehow they made it to those ages. Many of the elderly that are alive and lives for a very long time are on medication and programs that keeps them living for along time. Many have personalized medicine and or programs which they live by and are unique to them. If the vaccines have no blame in anything, then why did Pfizer announced their intent to recall a lot of approximately 90,000 bottles of the vaccine and were other Pfizer products announced to be recalled such as 150,000 bottles of Lyrica along with others? ## Section 2 - Miami Doctor who believed in the Vaccine and is an advocate for the vaccine died after taking the Pfizer vaccine

According to the Miami Herald, 'Healthcare workers receive the first dose of the Pfizer BioNTech Vaccine at Memorial Specialty Pharmacy in Miramar, Florida, on Monday, December 14, 2020. By Memorial Healthcare System' (Ref 7). There are people experiencing minor and major side effects, along with the death of a doctor.

Dr. Gregory Michael at Miami Beach who is an advocate for the vaccine had become ill and died a few weeks after taking the vaccine. In a video by Dr Rashid A Buttar posted

on January 4, 2021 called 'ALARM CALL TO THE WORLD' (Ref 4) at time 6:50 into the video he spoke about a post by Dr. Michael's wife Heidi Neckelmann that can be found on Facebook, Instagram, and at many sources, which Heidi wants to share with others to bring awareness of what happened to her husband after taking the vaccine. Dr. Rashid went over Heidi's message to the world where she wrote: 'The love of my life my husband, Gregory Michael MD, an obstetrician that had his office in Mount Sinai medical center in Miami Beach died the day before yesterday (sometime first week of January) Due to a strong reaction of the covid vaccine. He was a very healthy 56-year-old active and loved by everyone in the community, delivered hundreds of healthy babies and worked tirelessly through the pandemic. He was vaccinated with the Pfizer vaccine at MSMC ON DECEMBER 18, 2020. Days later, he saw a strong set of petechiae (which are little red dots, little spots of blood that appears underneath the skin as explained by Dr. Buttar) on his feet and hands which made him seek attention at the emergency room at the MSMC. The CVC was done at his arrival showed his platelets count was zero (Dr. Buttar explained that a normal platelet count ranges between 150,000 to 450,000. He had a platelets count of zero and platelets are the component that are responsible for helping the blood to clog.) He was admitted to the intensive care unit with the diagnosis with acute case of ITP (ITP stands for Immune thrombocytopenia) caused by a reaction to the covid vaccine. A team of expert doctors tried for two weeks to raise his platelets counts to no avail. Experts from all over the country were involved in his care, no matter what they did the platelets count refused to go up. He was conscious and energetic through the whole process. Two days before a last resort surgery, he got a hemorrhagic stroke caused by the lack of platelets that took his life in a matter of minutes. HE WAS A PRO-VACCINE ADVOCATE THAT'S WHY HE GOT IT HIMSELF. I believe people should be aware that SIDE EFFECTS CAN HAPPEN, THAT ITS NOT GOOD FOR EVERYONE AND IN THIS CASE DESTROYED A BEAUTIFUL LIFE A PERFECT FAMILY and had affected so many people in the community. Do not let his death be in vain, PLEASE SAVE MORE LIVES BY MAKING THIS **INFORMATION NEWS.** 

'Michael ran his own private practice at Mount Sinai Medical Center in Miami Beach for 12 years, according to his website. The Miami native also worked as a clinical instructor and faculty member for the physician assistant program at Barry University and Miami Dade College...The Pfizer spokesman said the company is "closely monitoring all adverse events in individuals receiving our vaccine."" (Ref7)

On January 27, 2021, it is reported by Amanda D'Ambrosio, Staff Writer, MedPage (Ref 8) for 2 weeks, 'Michael's care team tried to increase his platelets, but their attempts were unsuccessful', Neckelmann wrote. Doctors scheduled him for a last-resort splenectomy; then, two days before the procedure, Michael suffered a fatal hemorrhagic stroke, according to reports. He died in early January 16 days after he was first immunized. (Ref 8).

Immune thrombocytopenia is characterized by a decrease in platelets, caused by the immune system attacking its own thrombocytes (Ref 8). James Bussel, MD, a professor

emeritus of pediatrics at Weill Cornell Medicine in New York, said that there are also two other ITP diagnoses that physicians know of which occurred after vaccination for COVID-19, but those cases responded to treatment. (Ref 8)

### Section 3 - Many have turned down the Pfizer Vaccine

Reported on January 7, 2021, on a Yahoo article called 'Health; Patients rejected Pfizer vaccine to wait for 'English' jab, says doctor (Ref1), 'the Oxford vaccine was not available as yet, but on Twitter, Dr Williams who is a 'high-profile' doctor now an MP but continues to see patients said: "Some local patients have turned down an offer this weekend of getting a Covid vaccine when they found out it was the Pfizer one. 'I'll wait for the English one'. The doctor said, "Sometimes patients need a bit of time to make up their mind about these things, but time isn't on our side here!" 'At the beginning of December, the Pfizer/BioNTech vaccine was offered to patients where as the Oxford/AstraZeneca version was authorized on December 30.' (Ref1)

# Section 4 - Doctors and Nurses have filed law suits against the neccesity to be vaccinated

'There are thousands of people protesting against the vaccines. In Norway 87,000 health care providers, doctors and nurses have filed law suits against the neccesity to be vaccinated..." (Ref 4). It's reported that many doctors are refusing to give the vaccine to their families and patients. There are many seminars being held across the world with thousands of doctors coming together to denounce the vaccine.

# Section 5 - The CDC reported 5000 cases before Christmas, and severe side effects after taking the vaccine, and a look at a lack of Vitamin D

By now most people across the world is aware that there have been no long-term studies on the covid-19 vaccines since it's only been around for about a year now, and there many concerns concerning infertility, side effects, and other future problems from taking the vaccine (s). There have been severe reactions to the vaccine. The CDC has reported 5000 cases of side effects before Christmas. Dr. Rashid Buttar had stated in one of his videos that it's well over 5000 cases. That's before Christmas and as I work on this report it's now February 11, 2021, thus, how many more thousands cases are there? One of the early studies states that 63 out of 65 women have become sterile after taking the vaccine. On a YouTube video posted on December 3, 2020, with the title 'What Did Bill Gates Say About COVID Vaccine Side Effects?' (Ref 3) the host reviewed a part of mainstream news, where on CBS Washington, the host asked Bill Gates a question, "After a second dose at least 80% of the people experienced a systemic side effect ranging from severe chills to fevers. Are these vaccines safe?" Gates replied, "Well...the FDA not being pressured will look hard at that, the FDA is the gold standards of regulators...the side effects were not super severe it didn't case permanent health problems...Moderna did have to go with the fairly high dose, so to get the antibodies, some of the other vaccines are able to go with lower doses to get responses that are pretty high, including the JMJ and the Pfizer. (Ref 3 posted Dec 3, 2020)

We keep hearing that most of the deaths have nothing to do with the vaccine or that the side effects are not severe, and people are begging for the vaccine. But the fact remains that people are report severe reactions to the vaccine, and there have been many deaths after people have taken the vaccine. How many doses of the vaccine will we need? The vaccines now requires a person to take at two does or more, where as a year ago all we heard about is single dose and one covid-19, and today we're hearing about many variants of the virus. Gates says, concerning taking more than one dose, "We hope just two, although in the elderly sometimes it takes more and make sure we have lots of elderly people in the trial will give us that data" (Ref3). He wants lots of elderly in the trials, and this is where a lot of the deaths are coming from. Wouldn't it be better to take all of the elderly out of the long term care facilities, take them home, isolate them and let the family come together to help out with the assistance of help from the government also? And boosting the immune system and taking the right medication unique for a person should help.

The host of this video says in "one study 84% of the patients in the ICU had a deficient of vitamin D and only 4 % of the people have sufficient level of vitamin D."

# Experts in the medical field and immunology says to take vitamin D for boosting our immune system

In Dr. Rashid Buttar's video he often tell his viewers to take vitamin D as this is very important for building our immune system and fighting covid-19. He also often says to take vitamin C, zinc and selenium. However, he states that it's important to know the dosages. For example, you must take the right dosages of selenium, instead of wanting to take lots, because it can turn into a metal.

In Dr. Shiva Ayaddurai's video he often recommends Vitamin A and D, along with others vitamins. In one of his videos he discussed the benefits of taking different spices such as garlic and turmeric, and he encourages his viewers to follow a bottom's up movement and that each person should have personalized medicine.

For professional advice on building your immune system and fighting covid, it's important to view the YouTube videos by the doctors names just mentioned and to carry out your research.

Dr. Buttar says that there's a 99.9 % recovery rate from covid-19.

# Section 6 - The covid variants, more vaccine doses to come, and we must still social distance and double facemasks are suggested

In a CNN video (Ref 5) from February 3, 2021 questions were asked and answers were provided. 'You've received the second dose of a Covid-19 vaccine currently on the Western market -- Moderna, Pfizer-BioNTech or Oxford-AstraZeneca.' Now that people are vaccinated where many have had a second dose, then are there still any restrictions? There are more restrictions now that before such as doubling up on the masks and there are more variants of the virus. According to CNN, experts says 'There are still safety precautions you need to follow in order to keep you, your loved ones and everyone else safe and protected from the deadly coronavirus.'

In a previous interview, vaccine scientist Dr. Peter Hotez, professor and dean at the National School of Tropical Medicine at Baylor College of Medicine in Houston states, "In looking at the Phase 1, Phase 2 data, what I saw with a single dose is some people had high levels of virus-neutralizing antibody, others were nonresponders...So the major reason for the second dose is to get everybody to respond. If you just get a single dose, you don't really know where you stand." (Ref 5)

They are also saying that even after you get your second dose of the vaccine, it can take two to three weeks after before your immunity fully kicks in. Experts are also saying that the virus is mutating and are more contagious. 'Experts are already warning that antibodies from a prior case of Covid-19 won't protect against being reinfected with a variant from South Africa. (Ref 5)

## The variants

According CNN Medical Analyst Dr. Leana Wen, they do not know if you will still be a carrier of the corona virus even after you've taken the vaccine and the doses recommended (Ref 5). According to Wen, "Once vaccinated, an outdoor sporting event or concert is probably safe, if there is good social distancing between households and everyone is wearing masks." She further said, "Indoor, crowded gatherings are probably still best to avoid even if you're vaccinated." I do question Wen's conclusion since very often there's a bit of breeze outside, so if you cough the breeze or wind will spread the virus into the air and make contact with many. What happens if at an outdoor sporting event a strong wind moves in, isn't there a chance that the wind can spread the virus to a large area infecting lots of people or everyone?

A person that's vaccinated and fully immunized can still be asymptomatic and carrying covid-19 virus and spreading it to others. They are saying that they do not know if the booster doses will be required in months or years to come.

#### Section 7 - A doctor looks at taking the vaccine vs. not taking the vaccine

In the video which is over 1 hour and 21 minutes and titled 'Facts On Election Fraud, Pandemic, PCR Testing, Doctors, Censorship and Truth! - Dr. Rashid A Buttar; Jan 4, 2021; 'ALARM CALL TO THE WORLD' (Ref 4), Dr. Rashid A Buttar said, "These injuries range from inability to work, inability to ambulate to severe sickness, even to the point of having paralysis and in some cases death. This should be mainstream information but nobody is taking about it. They are not releasing this information, they are not discussing it. So here is my question, <u>if this vaccine is so safe then why would you need to mandate, to force, to deceive, to threaten those who question the narrative, of course the logical answer is that its not safe, it's not condusive to living a healthy and long life and that's the reason they are trying to shut down the narative as they have been throughout this entire pandemic. There are thousands of people protesting against the vaccines. In Norway 87,000 health care providers, doctors and nurses have filed law suits against the neccesity to be vaccinated..." (Ref 4)</u>

A number of points Dr. Buttar made in this video (Ref 4):

Headline 'Get the COVID Vaccine, But remember the following (meaning that you have taken the covid vaccine but):

- 1. You can STILL spread the virus
- 2. You can STILL get COVID again
- 3. 10-15% chance of adverse effects
- 4. Anaphylaxis & Bell's Palsy side effects
- 5. Increased risk of HIV!!!(WT...???)
- 6. Becoming sterile almost a certainty
- 7. ZERO vaccine manufacturer liability
- 8. Directed by WHO, GAVI (got it wrong)
- 9. You MUST STILL wear a mask!
- 10. You MUST STILL socially distance!
- 11. You get only 2 months of immunity...before you have to do it again!

In smaller writings it states: Congratulations! You're immunized...against a virus you had a 99.9% chance of surviving! FYI, you have a 2,473% greater chance of dying in a car accident!

The above points made by Dr. Buttar describe what Bill Gates and others are saying about the vaccine. Therefore, why take the vaccine, if you are still a carrier of the virus, have to wear double the mask now, and that there are many variants meaning that the vaccines may not even work for the variants? As it is, many people do not take the flu shot and many gets over the flu. Scientists and doctors have spoken about herd immunity, and according to Dr. Rashid Buttar, there's a 99.9 percent recovery rate from the virus. Therefore, why not allow herd immunity to take place. As it is, most people knows many people that have the flu, yet when it comes to covid-19 many people heard or knows of only a few people that has or had the covid-19 virus, and many also do not personally knows of anyone that has had covid-19.

## Section 8 - According to animal studies, transduction permanently puts the virus into your DNA and transforms your cells

At time 50.30 into the video (Ref 4), Dr. Sherri Tenpenny who is a Medical Doctor from the USA says, "Know that when they develop this (referring to covid-19 vaccine) under the umbrella of the 2005 prep act, they have complete liability protection, you can't sue them and you have no recourse that this vaccine harms you." She said that since the year 2002 that they have been working on developing a corona virus vaccine when we had SARS. She says, "And every animal studies that they have done, particularly the ferret studies where the ferret immune system mostly mimics the human adult immune system. Ferret studies, rabbits and rat studies all the animals ended up with a paradoxical immune response in which the antibody levels that were very high actually accelerated the infection made it worse and allow the pieces of the virus to go inside the cell and be incorporated into the DNA of the recipient of that vaccine by a process call transduction. Transduction irreversibly puts that virus into your DNA and transforms your cells."

The flu vaccine is very different from the mRNA vaccine. In one of Dr. Shiva Ayyadurai's video he explained that when the mRNA vaccine is injected, not all of it goes where it's intended to go and that some of the vaccine remains outside.

# Section 9 - The mRNA vaccine will change our DNA and humanity will never be the same

Dr. Buttar stated (Ref 4), "This is the first RNA vaccine that have been commercially utilized which actually goes in and changes our genomic code, remember that RNA **REPAIRS AND REWRITES DNA**, so whatever this vaccine is, when it's introduced into our system, it will start to rewrite and repair, supposedly repair, rewrite our DNA to the point that it will morphologically change us and within a generation or two, we're not even going to be what makes us human, and all this under the pretense of urgency to take the vaccine to prevent the spread...for a condition that the diagnosis is going up up up but the death rate is flat...." And with all of the variants coming up, what if the vaccine interacts in a way that will damage a person very badly, and we're talking about the person's DNA that makes up that person. What happens to people who are pregnant? What happens to the child later in life?

## Section 10 - Medical doctors are saying the vaccine is not proven, nor safe, and there's no need for the vaccine

Many do not want the vaccine because they do not believe the vaccine is safe and also nobody should be changing the whole world's genetics. At time 28:40 into the video (Ref 4), Medical Doctor & Forensic Psychiatrist from the USA, Dr. Andrew Kaufman says that this "pandemic is not a real medical pandemic. The covid-19 vaccine is not proven safe or effective because there has not been enough time and in addition there is not a clear definition of any new disease for which it can be tested against. There has not been a virus that has been purified or shown to be the cause of an illness thus there is no target for a vaccine, however, the bottom line is, since there is no additional deaths have occurred in relation to a new disease there is simply no need for a new vaccine." Many doctors are speaking up and here are a few from the video.

At time 29:14 in the video, Dr. Hilde De Smet, Medical Doctor from Belgium says that "a new covid-19 vaccine is not safe and that there is no global medical pandemic..."

At time 30:18 : Dr. Nils R Fosse, Medical Doctor from Norway says "the covid-19 vaccine has not been proven safe...the death rate in Norway is not higher than an average year."

At time 30:30 - Dr. Elizabeth Evans, Medical Doctor from the UK says, "the covid-19 vaccines are not proven to be safe or effective…"

At time 32:40 - Dr. Vernon Coleman, General Practitioner from the UK says the Covid-19 scam is the greatest hoax in history

At time 34:00 - Dr. R Zac Cox, Holist Dentist and Homeopath from the UK says "....they are experimenting on us which is against the Nuremberg code. I will not be taking the vaccine..."

Other doctors on this video are making similar claims stating that the vaccine is not proven safe and that there is no emergency. This vaccine will no doubt change humanity's DNA.

At time 1 hour and 12 minutes into the video states: In 1956, Communist Soviet Premier, Nikita Khrushchev said: 'We will take America without firing a shot. We do not have to invade the U.S. We will destroy you from within.

#### Section 11 - Problems with wearing masks

According to CNN on January 28, 2021 (Ref6), Double masking for Covid-19 protection: A trend with a purpose By Sandee LaMotte, 'Public health officials are

suggesting double masking as a way to increase the level of protection from the coronavirus and its multiple, more contagious variants.' There are different masks. The single-layer mask is less effective than the two and three layer home made mask, which is less protective than the surgical mask, and the surgical mask gives less protection than the N95 mask. According to the report from CNN it states: 'But the CDC isn't currently recommending N95 masks for the general public, partly due to a shortage of the masks for health care workers, and also due to concerns that people will tolerate the masks, which can hinder breathing.'

It's important to remember that each person's body is unique, and some or even many have breathing and or problems with the lungs, and thus wearing a mask and cutting off air and oxygen to our heart and brain can result in more health problems. So the stronger the mask is, the less oxygen a person is sending to the heart, brain and body.

CNN reports (Ref 6) "I worry that if we suggest or require that people wear N95's they won't wear them all the time," Dr. Rochelle Walensky, the new head of the CDC told CNN's Anderson Cooper and Chief Medical Correspondent Dr. Sanjay Gupta in a town hall Wednesday. "They're very hard to breathe in when you wear them properly," Walensky said. "They're very hard to tolerate when you wear them for long periods of time." (Ref 6).
