INTRODUCTION

This article looks at some of the cases where people are dying after taking the vaccine and where many also ends up with adverse side effects. We are told that the vaccine is protects us, but people are still dying and getting injured after receiving the vaccine (s). Many are aware of what’s taking place and as a result are refusing to take the vaccine or have decided to longer to see how the experimental vaccines will affect people in a few years. Many are also being pressured by doctors, family members and friends to take the vaccine even if they do not want it.

People being forced or pressured to take the vaccine

At minute two in the Youtbue video called ‘Mandatory vaccination debate’ published on July 13, 2021 says that **you ‘can’t take a person’s blood pressure unless they allow it’** (Ref 1). This statement clearly says that people **MUST** have choices, when it comes to their own bodies. This same video has a highlight that says ‘Germany’s Merkel against mandatory vaccines.’ Therefore, if you cannot take a person’s blood pressure unless that person allows it, then how can a government force a person to inject something in their bodies if they do not want it? If people want the vaccine they will go to the places that provides the vaccines. In many countries, they are going door to door to vaccinate people, and to convince people that they should take the vaccine.

A doctor's view on people being given a choice or taking or not taking the vaccine

Dr. Erickson at the time 27:40 of a video that was taken down, he says: "Whether we have a vaccine or we don't as per epidemiologist...they said we will reach herd immunity with or without a vaccine...we didn't have a vaccine for sars, we don't have a vaccine for the common cold, a lot of viruses we don't have vaccines for and yet they move through our people every year and they burn themselves out through herd immunity..." Dr. Massihi says "You have to protect the old, you have to protect the frail population, you have to protect those **that have severe immune deficiencies and those that are likely to not do well, and you have to do this in a stepwise fashion...**" Erickson says, "...the virus is going to move through society whether you lock it down or not. The host of the video asked: **Do you think that the people in your community would submit to a mandatory vaccination regime or covid vaccination?** Dr. Erickson replied, "I don't think so, I think it's appropriate to give people the option for a vaccine like flu... the vaccination increases our peak towards herd immunity -it will happen regardless, it is helpful, there's no question about that **-I don't think we should force people to have the vaccine...**" (Ref 2)

Boosting the immune system

During the covid pandemic, Dr. Shiva Ayyadurai the inventor of the first complete email software which he named email and who is an expert in immunology says one treatment will not work for everyone, thus one vaccine will not work for everyone. He says that we must go back to the basics. He explains that each person's body is unique and how each person should be treated different. "Your body and my body are unique. What you need you should decide in collaboration with your health care profession -the government should not be involved in it..." In his Youtube lectures he discusses vitamins, minerals, leafy vegetables, garlic, turmeric and other spices that help to boost immunity. He also says to take vitamin A, D, C and other vitamins to boost immunity.

On aluminum in the vaccine

In the video, Public Health Committee Public Hearing On proposed legislation concerning Immunisations' published on Dec 1, 2020, Dr. Larry Palevsky, Pediatrician, Northport Wellness Center states 'The kind of aluminum we put into vaccines is a different kind of aluminum that we see environmentally...we have not evaluated the safety of the aluminum nanoparticles and its injection and where it goes when it gets into the body...we continue to say unequivocally that the vaccines have been studied effectively and that's just not true" (Ref 3). Some are concerned about the long-term effects of the vaccines, and that a person may experience death or adverse effects months or years later. If some have died right away, then what's in the vaccine that's causing the deaths and injuries? Later in this paper, Dr. Larry Palevsky delves into animal studies and the vaccine.

With widespread fear being instilled into people through the media, by doctors and other professionals, some are beginning to believe they do not have a choice in this matter if they believe that there is a chance that they can end up dead or injured for life. If you are left with illnesses for life, then what kind of a life is that? Many believe that they should look for other means instead of taking the vaccine.

Vaccinated people blaming the unvaccinated

The vaccinated people are blaming the unvaccinated people for spreading the virus and causing illnesses and deaths. But the fact remains is even people who are vaccinated are catching the virus and thus spreading it.

In the video at the link, <https://www.bitchute.com/video/LNZhH4ajGs0N/> the host on Gravitass says, “Vaccines were supposed to be the silver bullet to ending this pandemic. Now new variants and rare adverse events have put them back under the scanner. Experts fear the new Delta plus variants could escape the immunity given by vaccines” (Ref 4)

If the variants can escape the immunity of the vaccines, this means that the vaccinated people can get the virus and spread it to others, and not just the unvaccinated people.

People with underlying conditions

Very often when someone dies after taking the vaccine, we hear that they had an underlying problem even if they were healthy before taking the vaccine. We always hear that the deaths and injuries are extremely small as compared to the millions of people being vaccinated, and that the CDC is investigating the cause of death. What about that person’s life? The person that’s injured or died? Did that person not have a right to live, especially if that person was against being vaccinated? At one time it was said that the vaccine was available for those who wants it. Why are people being pressured into taking something they do not want for various reasons?

What if some one has underlying condition, such as heart palpitations, a very weak heart, strokes, a family history of heart disease and strokes and other problems, is it fair to force them to take a vaccine that may create more problems for them? If all vaccines works and were good for everyone, then why people be against the

vaccination. Why would anybody give up a good paying job and risking that they would never be able to work again in that profession? There has to be very good and valid reasons.

In the video **‘Why Pfizer And Moderna Can't Be Sued For Covid Vaccine Side Effects’ published on December 22, 2020**, at time 4:37 it states ‘...roughly **4 in 10 Americans said they would definitely or probably not get a vaccine**, while this was lower two months ago...’ (Ref 6). This statement shows that many do not want the vacci

Why would some qualified staff are refusing to take the vaccine and would rather give up their career? This section looks at some of the people that do not want the vaccine for different reasons.

The goal is to get the covid vaccine to every person in the US who wants one

In the video, **Why Pfizer And Moderna Can't Be Sued For Covid Vaccine Side Effects; published on December 22, 2020**, at time 18, it states that “...The goal is to get the covid vaccine to every person **in the US who wants one**. But survey data shows that nearly 40% of the US population doesn’t want it. Wide spread mistrust might have something to do with the fact that if anything goes wrong with the vaccine, the drug makers that produce them aren’t responsible...that means that company like Pfizer and Moderna have total immunity from lawsuits resulting from injuries from taking the covid vaccines (Ref 7).

At minute 1 in the video published on June 4, 2021 called ‘Nurse is willing to lose her job to avoid getting vaccine. Hear why,’ the nurse said “We’re seeing a lot of adverse reaction after Pfizer, Moderna and J & J ...” so it makes me a little leary so you don’t know until you take it you are going to get one of those reactions or not...at least we need a couple more years to see if any long term effects...” (Ref 8). At 2 minutes into the video, she states, “I know from my past of being treated for various illnesses, usually I have bad side effects from that intervention...for me that is my hesitancy...” (Ref 8)

Pressure from doctors, family members and friends to get the vaccine

Some people that do not want the vaccine or wants to wait longer, since the covid vaccines are experimental vaccines, are being pressured by their doctors, and family and friends into taking it.

When a person is filled with fear or is under pressure, that person can easily break. Lots of fear tactics are being used to pressure individuals into taking the vaccine, even if that person have valid reasons for not wanting the vaccine.

At minute 2:35 in this video, a man said, “ I’ve had a history of not being able to trust vaccine...” He implied that his doctor pushed him into getting the vaccine. He also stated that he travels a lot, and these were some of the reasons he decided to get the vaccine even though he’s against taking the vaccine. He says, **“we just don’t have enough data, right now we are just guinea pigs.”** You would think that once you’ve taken the first shot that you must take the second shot to make the vaccine effective, but he stated that he does not know if he will get a second shot...” (Ref 8).

At time 3:55 in the video, a female stated that she’s not taking the vaccine because she had covid in February so she has natural immunity... (Ref 8).

SECTION II - Some of the reasons why people do not support the vaccination

Religious reasons for not supporting the vaccination

Some people do not support the vaccine because of religious reasons, such as aborted fetus were used in the vaccine experiments.

At time 31:35, in a CNBC video dated May 23, 2021, the Heading states: ‘For Employers Covered Under Title VII of the Civil Rights ACT, it states, “Once an employer receives notice that an employee’s sincerely held religious belief, practice, or observance prevents him from taking the influenza vaccine, the employer must provide a reasonable accommodation unless it would pose and undue hardship.” With people being pressured to take the vaccine, at time 32: 25 in the video, the host says, “The people who do not trust the vaccine, may find that alone may not give them an exemption from the vaccine requirement at work...” (Ref 9). However, people do believe they have the right to decide what goes into their bodies.

The article, **Abortion opponents protest COVID-19 vaccines’ use of fetal cells; by Meredith Wadman** publish on June 5, 2020 states: “We urge your government to fund the development of vaccines that do not create an ethical dilemma for many Canadians,” wrote Archbishop of Winnipeg Richard Gagnon, president of the Canadian Conference of

Catholic Bishops, and 17 other antiabortion religious, medical, and politic groups and individuals in a 21 May letter to Prime Minister Justin Trudeau. “The ... manufacture of vaccines using such ethically-tainted human cell lines demonstrates profound disrespect for the dignity of the human person.” (Ref 9a)

Health Canada Warning

In the article published on June 29, 2021 by **The Canadian Press** called ‘**Health Canada adds warning of very rare, serious condition as potential side-effect**’ states, ‘Health Canada is updating the label for the Oxford-AstraZeneca and COVISHIELD COVID-19 vaccines to add capillary leak syndrome as a potential side-effect...**The agency is also including a warning for patients with a history of the ailment TO NOT GET THOSE VACCINES.**’ The article states: Capillary leak syndrome is a very rare, serious condition that causes fluid leakage from small blood vessels (capillaries), which can result in the swelling of the arms and legs, sudden weight gain, low blood pressure, thickening of the blood and low levels of the albumin blood protein. SECTION III - Myocarditis, inflammation of the heart muscle

In the video ‘UPDATE 1-U.S. FDA adds warning about rare heart inflammation to Pfizer, Moderna COVID vaccines’ by Reuters published on June 25, 2021 June 25, 2021, states ‘The U.S. drug regulator on Friday added a warning to the literature that accompanies Pfizer Inc /BioNTech and Moderna COVID vaccine shots to indicate the rare risk of heart inflammation after its use.’ The video states, ‘As of June 11, more than 1,200 cases of myocarditis or pericarditis have been reported to the U.S. The cases appear to be notably higher in males and in the week after the second vaccine dose. The CDC identified 309 hospitalizations from heart inflammation in persons under the age of 30, of which 295 have been discharged.’ (Ref 11)

In the report ‘Israel sees probable link between Pfizer vaccine and myocarditis cases’ by Reuters published on June 1, 2021 states, ‘Israel's Health Ministry said on Tuesday it had found the small number of heart inflammation cases observed mainly in young men who received Pfizer's COVID-19 vaccine in Israel were likely linked to their vaccination.’

The report states, ‘Pfizer said in a statement that it is aware of the Israeli observations of myocarditis and said no causal link to its vaccine has been established.’ (Ref 12)

A number of doctors in Indonesia died after taking the vaccine

In the video ‘Vaccinated doctors dead amid Indonesia COVID surge | DAILY PLANET NEWS’ published on Jun 25, 2021 it states (Ref i), ‘Nearly 1,000 Indonesian health workers have died from the virus since the pandemic started, with the country's medical association confirming on Friday that 401 doctors were among the victims - 14 of whom were fully vaccinated. (Ref 13)

In the video, ‘Vaccinated Indonesian health workers who got COVID19 had high exposure to virus- expert by TeleRadyo; ABS-CBN News published Jun 18, 2021 states, ‘Hundreds of medical workers in Indonesia may have caught COVID-19 despite being vaccinated because they have a higher risk of exposure to the disease due to their occupation, a health expert said.’ (Ref 14)

Youths with myocarditis ‘inflammation of the heart’

In the video ‘13 year old boy dies 3 days after COVID Vaccine’ published on June 29, 2021, reported that after a 13 year old boy in Michigan received the Pfizer Covid vaccine, he died 3 days later. The report also states: ‘The first reports of myocarditis after COVID-19 mRNA vaccination involved (US) military patients and patients from Israel.’ (Ref 15)

Myocarditis is ‘inflammation of the heart. And pericarditis, inflammation of the pericardial sac. Sometimes pericarditis can cause fluid to buildup within the sac, and this is called a pericardial effusion.’ (Ref 15).

Pfizer now has a label.... There’s now a label that says adverse effects such as myocarditis.

The video states: ‘The CDC has received 1,226 preliminary reports of myocarditis and pericarditis following about 300 million total doses of Pfizer and Moderna vaccines. Myocarditis is most common in between age 12 and 30, and more common in boys.’ (Ref 15)

Elderly deaths after being vaccinated

By now it’s known that there has been many deaths after people have been vaccinated and countless with side effects. One of the first news when the vaccine began to roll out back in January 2021 were the DEATHS OF MANY ELDERLY in Europe.

In the video ‘23 Deaths In Norway, 10 In Germany, Shortly After The COVID Vaccination, A Coincidence?’ which was streamed live on Jan 15, 2021 states: In both the countries the deaths occurred in elderly. In Norway the thought is that the deaths occurred due to the fever, nausea, and diarrhea caused by the vaccine that contributed to the fatal outcome in severely ill and frail individuals. In Germany, the 10 deaths occurred within four days after the administration of the vaccine. However, these all were due to the underlying illnesses in the older individuals instead of the vaccine. 23 deaths have occurred in Norway shortly after the administration of the first dose of the vaccine in very elderly and frail patients. (Ref 16)

Terminally ill patients or seriously ill patients who were not able to handle the side effects

In the video (Ref 16) at time 1:43, Dr. Mobeen says provided an explanation as why so many elderly people had died after taking the vaccine. He says, ‘**This happened in terminally ill patients or seriously ill patients who were NOT ABLE TO HANDLE THE SIDE EFFECTS that occurred for example fever or diarrhea and the underlying disease process when superimposed by these after effects caused them to die.** In other cases it was just a coincidence that the patients own underlying previously underlying disease brought them to a point of death, although in the meantime they had received the vaccination as well. These are the two basic categories you will see.’

Bell's palsy after COVID vaccine

The headline of City News says: Health Canada: 131 cases of bell’s palsy in 17.7 M Vaccines.’ The video, ‘**Toronto woman develops Bell's palsy after COVID vaccine**’ published on May 27, 2021, states: Jennifer Gibson says she knew there might be side effects after getting the COVID-19 vaccine, but wasn't prepared when two weeks later, she developed Bell's palsy. Xiaoli Li has more.” According to the news, “She wanted to get the vaccine because “she wanted to see life get back to normal in Canada” (Ref 17). As seen from the video one side of Gibson’s face drools and she struggles to speak.

The video states: “Health Canada tracks adverse reactions to covid vaccines and the most recent data shows 131 cases like Gibson.”

Doctor in Miami Dies After Getting COVID Vaccine

One of the first deaths of a doctor reported after taking the Covid Vaccine was Dr. Gregory Michael in Miami, Florida, who received the 1st dose of the Pfizer vaccine on Dec.18th 2020. ‘Shortly after receiving the Pfizer vaccine, he reportedly developed acute immune thrombocytopenia. Unfortunately, he died 16 days after getting the covid vaccine. Dr. Gregory Michael's cause of death is a result of a brain hemorrhage.’ ... ‘Dr. Gregory Michael was healthy. He did not smoke. Did not take any medications. Never had any reaction to any medication nor vaccines. Then, supposedly three days after he gets the 1st dose of the covid vaccines, he developed tiny reddish spots, or petechiae, caused by bleeding under the skin of his hands and feet.’ (Ref 18)

A 46-year-old Thai woman died last night, just hours after receiving the vaccine

The video, A 46-year-old Thai woman died last night (Tuesday), just hours after receiving an AstraZeneca vaccine shot, states, ‘According to the woman’s niece, who took her to the vaccination site at the Thai Business Administration Technological College in Bangkok, the woman had a headache and developed mild fatigue when she returned home. She then took two paracetamol tablets in the evening, followed by her migraine medication about four hours later.’ Then ‘15 minutes after, she had a seizure and lost consciousness. An ambulance was called, but she was found dead when it arrived.’ (Ref 19)

SECTION V - Senator, Ron Johnson holds a press conference on vaccine injuries

In the video ‘**Sen. Ron Johnson holds press conference on side effects from COVID-19 vaccine**’ published on June 28, 2021, three people that were vaccine injured presented their case. They were all healthy before taking the vaccine but now have to live with vaccine injuries. The United States, Sen. Johnson, has not taken the vaccine. (Ref 20) He said, “...**In his eyes the CDC and other Health Officials aren’t being fully transparent when it comes to the adverse reactions people can experience after getting the shot.**” Sen. Ron Johnson stated, “I think the American public should be able to have informed consent when deciding to take an experimental vaccine one way or another.” (Ref 20)

At the press conference, Candace Hayden said, after receiving the shot: “I was suffering from severe parathesia and was partially paralyzed from my chest down.” (Ref 20)

Tears slithered down from Brianne Dressen's face as she spoke. "I lost control of my legs and my bladder, along with my dignity." (Ref 20)

Sheryl Ruetters said, "On January 14th, I received the Moderna vaccine, the next morning, I woke up with severely swollen lymph nodes in my neck." (Ref 20)

Stephenie De Garay whose 12 year old daughter Mattie was at the conference and sitting in a wheel chair said that Mattie "participated in the Pfizer covid vaccine trial last year but has not been the same since." Stephanie said, "Over the past 5 months Mattie have been to the ER 9 times and have been hospitalized 3 times for a total of two months" (Ref 20). She expressed how her daughter was very well before taking the vaccine.

SECTION VI - Vaccine manufactures are protected from being sued

Many have died after receiving the vaccine and countless others are left with injuries. If you are injured you cannot sue a vaccine manufacture. The vaccine manufactures are protected from being sued and this is also a concern to many. The government takes on the case and if survives the vaccine injury, the victim that survives and family are left to suffer for a life time. If the vaccines are safe then shouldn't the vaccine companies be held accountable like other companies, instead of the government? Companies are supposed to stand behind their product's safety.

In the video Pfizer's abusive vaccine deals published on Feb 24, 2021 (Ref g), at time 3:40, the host of Gravitas states, "...if you receive a vaccine from Pfizer, you have adverse effects because of the jab, you can always go ahead and file a lawsuit against the company and if you win that lawsuit, instead of Pfizer, it will be the government that will be compensating you and this is a normal practice..." (Ref 21)

In the video 'Why Pfizer And Moderna Can't Be Sued For Covid Vaccine Side Effects' published on December 22, 2020 at time 10:20, it states, "...legal expert say if an employee is forced to get a vaccine and suffers a debilitating injury from it, claims would be routed through workers compensation programs and treated as an on the job injury." (Ref 22)

In the video 'Vaccines were supposed to be the silver bullet to ending this' Host Min (1:30) **And in America the Pfizer and Moderna shots will now come with a new label, a warning against heart inflammation.** (Ref 23)

SECTION VII - United States Senator, Rand Paul, speaks on the vaccination and natural immunity

In the video 'Delta rising: France mulls compulsory COVID vaccines for health workers | DW News, published on July 11, 2021 at time 3:25, it states, 'Israel is offering a booster shot to adults with WEAK IMMUNIE SYSTEMS.' (Ref 4)

Dr. Rand Paul have been speaking up where the vaccination is concerned. **In the video 'Rand Paul says he doesn't need to get vaccinated. Doctor says he's wrong'** published on May 25, 2021, Rand Paul says, "Until they show me evidence that people who have already had the infection are dying in large numbers or being hospitalized or getting very sick..." The senator said, "I'm not getting vaccinated." (Ref 24)

"...I just made my own personal decision that I'm not getting vaccinated because I've already had the disease and I have natural immunity now." He continued, **"You know in a free country you would think people would honor, you know, the idea that each individual would get to make their medical decisions."** (Ref 24)

In the video, 'Dr. Paul Speaks at HELP Hearing on Vaccine Hesitancy, published on June 22, 2021, Rand Paul says, "Over 65 it's at least a thousand times more dangerous. The death rate under 25 about one in a million.' He said, '...and if we say just go take your vaccine, don't think about this, that's not good medicine. We should think about this.' He said, '...if you get vaccinated, there's a 96% chance you won't be hospitalized. The numbers are very similar for natural immunity too. (Ref 25)

Boosting your immune system

Everyone is born different and therefore when it comes to medicine, one size does not fit all. Doctors and specialists discuss this with the parents and treatment involves. One treatment is not for everyone. According to Immunologist expert, Dr. ShivaAyyadurai, says, "One size does not fit all medicine...finding the right medicine for the right person at the right time..." He says that we must go back to the basics. He explains that each person's body is unique and how each person should be treated different. **"Your body and my body are unique. What you need you should decide in collaboration with your health care profession -the government should not be involved in it..."**

The kind of aluminum we put into vaccines is a different kind of aluminum that we see environmentally. This is called a nanoparticle and nanoparticles bind really tightly to the bacteria antigens, the virus antigens, the food protein antigens and any other contaminants that are in the vaccines that we may not know about and we know that the biochemical properties of the nanoparticles is that they are capable of entering the brain and so we have not evaluated the safety of the aluminum nanoparticles and its injection and where it goes when it gets into the body and whether it gets into the brain - do vaccine ingredients belong in the brain - no - do they get into the brain, no one has ever studied it, but animal studies using the same chemicals in vaccines we give to children directly demonstrates the vaccine ingredients do enter the brain.
