

Bullfrog Resort LLC ----- Pet Policy Waiver

(This agreement applies to ALL domesticated pets other than Service Animals)

In consideration for the resort (Bullfrog Resort LLC) permitting me to keep my pet in the cabin assigned to me, I hereby agree to the following:

1. My pet is a domesticated dog.
2. No more than two pets are permitted in the cabin.
3. I agree to pay a non-refundable fee per pet of \$40 plus tax. I understand that additional fees may apply in the event my pet causes any damage.
4. I agree to pay Bullfrog Resort LLC any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of the Resort. I hereby authorize my credit card on record to be charged for the cost of these additional services.
5. I must keep my pet restrained on a leash or in a pet carrier when my pet is outside my cabin.
6. When I leave my pet unattended in the cabin they will be in their kennel. I will not allow my pet to make long extended barking noises through the day and night.
7. I must properly remove and dispose of any waste associated with my pet on Resort premises.
8. I agree that should the Resort determine in its sole discretion that my pet is objectionable to other Resort guests, I must immediately make other arrangements to house the pet outside the Resort.
9. I release the Resort, from any and all liability for any injury and/or damage suffered by my pet.
10. I agree that I assume full responsibility for any injury or damage caused or alleged to be caused by my pet and incurred or alleged to be incurred by any guest, employee, or invitee of the Resort. I agree to indemnify, defend, and hold harmless the Resort Entities from and against any and all alleged or actual losses, claims, damages, liabilities, costs, and expenses (including attorneys' fees and court costs) suffered by the Resort Entities or asserted by any other Resort guest, invitee employee or person arising out of or in connection with my pet's stay at the Resort.
11. I understand and agree that the Resort retains the right to exclude my pet if, in the Resort's sole discretion, my pet is considered dangerous by reason of size, disposition or is likely to frighten or harm other guests of the Resort.
12. I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any communicable illnesses or diseases.
13. I agree that at all times while on resort property I will ensure my pet complies with all relevant laws and regulations of Wisconsin, including any laws or regulations relating to the muzzling of my pet.

If the Resort determines any failures to comply with any part of the above agreement, you may be asked to leave the Resort immediately and without reimbursement.
