The FBI Whistleblowers:

Apparently, the FBI is immune to the "Whistleblower Protection Laws" of this Country. *Btw what **IDIOT** thought that was a good idea???* By **ROYALLY SCREWING OVER THESE THREE UPSTANDING AMERICANS**, FBI Director **Christopher Wray** sent a very strong

According to Joe Biden’s September 1, 2022 “Independence Hall Speech” the biggest **threat to the Country was **Donald Trump** and his **supporters**. This was **PUBLIC RECONFIRMATION** of the Biden Administration’s **GREEN LIGHT** for the FBI’s **DEEP STATERS** to go after Trump, anybody who might support Trump, or anyone who might sympathize with those being targeted through this **ABUSE OF POWER** (e.g., Agent O’Boyle, Agent Friend, and Mr. Allen).*

The point is that Washington DC Juries are the farthest thing from **“Impartial”** as you can get, and it is **past time** that they are removed

from the process. Also, I like the idea that **U.S. TAXPAYER FUNDS** that would have been spent in DC **would instead be spent in Cincinnati** (*or some other non-hyper partisan location*).
