Public Sector Hubris: Another factor in Trump's victory was a growing disdain for what can be called "Public Sector Hubris." Public Sector Hubris (PSH) is an intangible sense of entitlement among some in government based on their belief that government officials (once commonly referred to as "*public servants*") are the "masters" rather than the "servants" of the American People. PSH really took hold during the Obama years. Obama was and is a proponent of **BIG GOVERNMENT**. His governing philosophy and his tendency to exude a certain **smugness** and **arrogance** were quickly adopted by his many fans and allies throughout the federal bureaucracy. "We in government know what's best for the American People" soon replaced "We in government serve the American People" as the mantra of countless D.C. federal government employees. Soon state and local government employees, particularly in states like New York, California, and Illinois, were taking their cues from Obama and the feds. I think I speak for a lot of us when I say that the brightest kids in my high school class (*although several of us did some form of military service*) **DID NOT** end up with careers in government.

Government workers, particularly at the federal level and in Democrat run states, are **HARD** to fire. A big reason for this is that the Democrat Party is beholden to the government employee unions. Even U.S. President *(and Progressive icon)* **Franklin Delano Roosevelt** knew that a government employee union was a **BAD IDEA** (see page 103). Obama's \$800 billion stimulus ensured that government workers at the federal, state, and local levels had **JOB SECURITY** during the economic downturn of 2008-2009. This further enhanced their sense of **invulnerability**. On the other hand, their private sector counterparts **lost jobs** in every town and every industry. Needless to say, those of us in the private sector took notice of this **DISCREPANCY**. We also noticed that whereas we in the private sector are held to very **high standards of conduct and performance**, our public sector counterparts **ARE NOT**. Civilian public sector employees are **very hard to discipline** no matter how **egregious** their conduct or **incompetent** they may be. IRS Agent **Lois Lerner**, who targeted conservative groups and individuals for enhanced IRS scrutiny, and Trump targeting FBI Agent **Peter Strzok** are high-profile examples of this. *Interestingly enough, it seems the only way federal government employees can get suspended or fired is if they show ANY sympathy for Trump or his supporters (see page 164).* Whether at the federal, state, or local level, public "servants" who abuse their authority to persecute their political opponents are the **epitome of corruption and tyranny**. Private sector employees, on the other hand, are largely employed "at will." Private sector employees who are not good at their jobs, or simply irk the boss, get

fired. Entrepreneurs who are not competent enough or are simply unlucky tend to run out of cash. **Donald Trump's victory was IN LARGE PART a backlash to Public Sector Hubris.**

PSH does not apply to the soldiers, sailors, or airmen (*99% of O-6 and below*) in our military. Also, there are millions of fine police, firemen, border patrol, and other true Public Servants out there. They need to remain vigilant though. PSH is pernicious and contagious. Many of us in the private sector have had enough of it.

The Deep State: Public Sector Hubris taking hold in the deepest layers of the federal bureaucracy has resulted in what has become known as the **Deep State** (or as some call it the “administrative state”). Deep Staters are entrenched, **unelected**, and often **insufferably pompous/ smug** bureaucrats who believe (*too often correctly*) that **they are the ones who actually call the shots in government**. Elections and elected representatives of the People come and go, but the Deep Staters only grow more entrenched as time goes by. As long as the President and Congress do not “**rock the boat**” too much, the Deep Staters are content to “stay in their own lanes” and rule over their personal power fiefdoms, be it the IRS, the State Department, the DOJ, or wherever.
