Seller's Representations: Our puppies leave here healthy to the best of our knowledge. The puppy will be health checked by our veterinarian at 6 weeks of age and be vaccinated at 8 weeks of age on _____ Date. We guarantee their parents are free from testable genetic diseases, every puppy leaves here up-to-date on all age appropriate vaccines, evaluated by our licensed veterinarian and has had multiple wormings. The buyer has five days from the time of purchase to have the puppy examined by their veterinarian and to personally inspect the puppy. Failure to have the puppy examined within five days from the time of purchase null and voids this health warranty. **Having this puppy vaccinated for lepto null and voids this health warranty.** Any request to return the puppy to the seller must be accompanied by a written statement from a veterinarian describing any problems found. Puppies are not sold on a trial basis. Please be committed for the life of this dog (10 - 15 years). Money will only be refunded within the first five days from the time of purchase. **(Deposits are non-refundable)** Your puppy is guaranteed against life threatening Genetic Defects **until two years of age.** As a breeder I do my best by selecting dogs with tests or tested lines to help reduce genetic problems. Unfortunately we can not predict all conditions. Qualifying genetic defects for a replacement dog are those related to breed specific testing. I do not guarantee hips, elbows. Research shows clearly that genetics plays a 35% role in hip, elbow issues. I can not predict how you raise and care for your puppy or how bones develop based on your environment. Therefore I cannot guarantee something I have no control over. Please understand our responsibility as a breeder is providing you with a healthy puppy on the day of sale. I cannot possibly predict heart, lung, cancer issues of any puppy. We have done our part in health screening our dogs and only breeding those that pass breed specific testing. Replacement for genetic defects will be made as soon as one is available and only when a second opinion from a qualified veterinarian is provided. In a rare case of death the dog will be replaced free of charge if under **two years of age** A necropsy report completed by a qualified veterinarian must show the cause of death was caused by a genetic issue. **At no time do I consent to pay any veterinary bills.** Shipping fees are at the buyers expense. **No money will be refunded.** The final determination as to a replacement puppy will be at the sole discretion of the breeder. Warranties shall apply only to the original purchaser. Transfer of dog ownership shall void this agreement. Buyer understands that breeders prediction of coat, color, size and temperament at adulthood are estimates only and are based on breeders goal to match puppies with families appropriately. **This puppy is being sold As a pet and must be spayed/neutered by one year of age. Proof of spay/neuter surgery must be received within (14) days after completion of the surgery. This notice can be in the form of an invoice form the veterinarian showing the procedure has been completed. Failure to do so will null and void this health warranty, If this puppy is bred purposely or**

accidentally the purchaser agrees to pay Big Bang Poodles the difference for breeding rights. Up to \$5,000

This warranty does not include (viral illnesses, infections, improper bites, retained teeth or hernias of any kind) The breeder guarantees the puppy against fatal viruses for 72 hours, this includes Distemper, Parvo and Corona. Not covered are coccidiosis and Giardia because they are commonly found in puppies and may or may not cause symptoms. Puppies are very susceptible to many types of viruses and diseases so you should give a lot of thought to the places that you take your puppy until they complete the immunization program. We cannot guarantee your puppy against diseases, viruses or parasites once they leave my property. This should be considered a reasonable expectation and the buyer's financial responsibility. The breeder has done everything possible to avoid and clear parasites. This agreement does not include any illness due to ingestion of foreign objects, food, chemicals, physical injury or issues whose cause is unknown or may have an environmental link. Upon execution of this contract all veterinary care and its associated costs are the sole and exclusive responsibility of the buyer.

Consideration

This puppy identified above is being sold for the sum of \$ _____

Maintenance: Buyer agrees to maintain this dog in good health and provide preventative health care including but not limited to internal parasites and where indicated heartworm preventative medication. It is agreed that this dog will be housed indoors and fed quality food. **Boarding this dog at Acme Creek Kennels in Traverse City Mi null and voids this health warranty.** Breeder recommends the buyer take the puppy to obedience classes for training and socialization. It is also agreed that you will maintain the dog at a healthy weight. Buyer agrees to postpone strenuous repetitive exercise (such as agility training or running miles a day) until a minimum of one year of age. Buyer agrees to never place this dog in a shelter, pound or similar facility. Buyer agrees to let the breeder know if at any time the buyer can no longer care for the dog.

Full and final agreement: The parties agree that this writing represents the entire agreement between them and that no other representations either oral or written have been made regarding the dog described above. Buyer agrees that he/she understands this contract fully and that this contract is under the jurisdiction of the state of Michigan in the county of Kalkaska.
