- Admin Updates (15 minutes)
  - Google Groups & Members
    - Member list created and being cleaned up. Some have had trouble getting into Google groups. Raichle suggested we use Slack instead of Google Groups. Members agreed on this change.
  - WRPC Memorandum of Understanding
    - Raichle working on this.
    - Mission and Vision adopted.
    - Surveys are being processed to capture core values, etc.
  - WRPC Website (Tracy and Raichle are working on this)
  - Draft Work Plan

  - Community of Focus Brief
    - Documents being created for tracking
- WRPC Logo drafts (15 minute)
  - Noah and Raichle have been working on logo. Raichle presented Powerpoint with five optional designs. Members will be asked to vote before the next meeting.
- Funding Streams and CoF
  - Tracy re/funding streams (5 minutes)
    - Tracy was not in attendance
  - Liz framing WRPC work with ATCOI funding (5 minutes)
    - Shawn presented this item and described history since Fall 2021 including agreement SIU/ATCOI merger and agreement to emphasize Communities of Focus
  - Diane re/ SnapEd funding (7 minutes)
    - Diane talked about uses of SNAP/ED funding, which are now focusing on food justice and Active transportation including creating opportunities and places for active living. Work on SNAP/ED started before WRPC, but is being rolled into WRPC effort now. The Eastside Coalition is actively involved. Outreach and organizing with groups is happening in Springbrook and other parts of Lakewood. The effort will Inform update of

Lakewood active transportation plan, starting with soliciting Springbrook's interest in the effort.

- Marcy re/CoF (10 minutes)
  - CoF are part of place based factors 11 factors that King County used were initially utilized and community readiness was gauaged. Two years into COF focus, COVID hit and the focus turned to that response. Measures are being revisited. A Vulnerabilty Analysis has been pursued. There are some community concerns with this approach, so this is being reimagined.
  - Priorities of Focus are being identified in each area Marcy showed chart of each community and these priorities.
  - Springbrook has readiness to act on priorities including the work of Springbrook connections.
  - Parkland and South Tacoma residents are being heard and surveyed, but priorities have not been agreed upon. There is a team of people meeting to discuss priorities. Parkland will likely decide on priorities within a few months. South Tacoma will take longer due to the number of interested parties and initiatives.
  - Census Tract and zip code level data is being used to identify community characteristics
  - Blue Zones effort in Parkland is still being negotiated. Costs for initiative are higher than expected.
