

How to Claim Your Battery Rebate for Central Coast Community Energy (3CE)

An example of the application as well as the steps listed to receive the money have been attached below.

*Note 2 Conditions must be met to qualify for the baseline \$300 per kWh rebate:

- 1. Be a 3CE Customer
 - a. You may switch from PG&E to 3CE and still qualify for the rebate as long as your system was installed after January 1st, 2024.
- 2. Receive Permission to Operate from the Utility company
 - a. typically received 3-8 weeks after installation in the mail

*Note at least 1 Condition must be met to qualify for the bonus \$500 per kWh rebate:

- 1. Be a CARE customer
 - a. low income or medical baseline customer for PG&E.
- 2. Be an existing NEM1 or NEM2 solar customer who is willing to enroll into NEM3
 - a. Solar contract signed before 4/15/2023
 - b. Additional storage added after 1/1/2024 would be eligible for this Rebate.

Residential customers not currently enrolled in NEM 1.0 or 2.0		
Current Solar Billing Plan customers	\$300 per kWh	
Net Energy Metering-to-Solar Billing Plan early adopters*		
CARE, FERA, and Medical Baseline	\$500 per kWh	
* 3CE customers who move from a legacy Net Energy Metering 1.0 or 2.0 tariff to the new Solar Billing Plan at least one full billing cycle prior to the expiration of their "grandfathering" period will receive the higher \$500 per kWh rebate.		




Steps

- Review your most recent energy bill to confirm that "3CE Electric Generation Charges" are included in the statement this verifies you are a 3CE customer
- Purchase your eligible residential battery system and set up to discharge at least 50% daily between 4pm and 9pm
- Gather relevant information and the following supporting documentation for your application:
 - Battery make and model
 - Battery capacity (kWh)
 - Permission to Operate Letter or Email (this was sent to you from PG&E or SCE)
 - Invoice from contactor with proof of payment
 - Any additional rebates you are applying for (these may be included in the invoice from your contractor)
 - If applicable, a copy of your 1040 tax form to prove income qualification (this may be required if you are applying for the income-qualified adder)
- 4 Submit online application
- Enroll in load-shift tracking software with 3CE partner Texture
 - After application is submitted, 3CE will email customer with link to complete battery registration with Texture
- 3CE processes your application and will notify you of your application status
- Receive your rebate check in the mail!
