

- Community survey
 - 48 surveys sent
 - 14 responded
 - Top concerns of those who responded
 - Rentals & Safety
 - Oak Lane stairs
 - Boat storage: split between if they be there or not, when yes; only between 10/1 5/31 and a size limit of under 25'
 - Lack of caring for certain homes
 - Lack of detailed financial information being shared with community
 - Lack of civility within the community
