





## **General Information**

Expel<sub>2</sub>0 is designed to improve water movement in soil to promote drier surfaces. Expel<sub>2</sub>0 will not change or affect soil properties but enhances drainage speed by reducing the surface tension of irrigation or rainwater.

## **Directions for Use**

Expel<sub>2</sub>0 can be applied with most conventional sprayers. Applications should begin in advance of seasonal onset of wet soil conditions, Expel<sub>2</sub>0 may be applied as a spot treatment for low-lying and high moisture holding areas. Expel<sub>2</sub>0 may also be applied on a scheduled spray program to maintain drier soil conditions. For best results, we suggest immediate watering in to help move the product from the leaf surface, followed by a normal irrigation cycle to move Expel<sub>2</sub>0 into the soil.

Compatibility	Expel <sub>2</sub> 0 can be mixed with most chemicals used in turf management, however, it is recommended that field-testing be done on a small area before spraying to assure safety concerns are met.
