



Dear I-130 Petitioner,

You may share the sample affidavit on the following page with friends or family that want to write a letter of support to be submitted with your Form I-130 petition.

An affidavit is basically a sworn letter; the person who writes an affidavit is an affiant. The affiant swears to its truth and may be required to testify before an immigration officer in rare cases. It is recommended that you submit 2-4 affidavits to support the primary evidence that your marriage was entered in “good faith.” Select friends who know you well as a married couple. The affidavit letter must include the following information:

- Person's full name, address, date and place of birth
- Relationship to the couple (i.e. friend)
- How the person came to know the couple
- When and for how long he/she has known the couple
- Frequency that the person sees the couple (i.e. monthly)
- Date and signature

The affidavit does not need to be notarized. However, it is important to include a statement that swears to the letter’s validity, “I swear, under penalty of perjury, that the foregoing is true and correct to the best of my knowledge.”

The following page includes a sample affidavit to be used as an example. Do not submit the affidavit on the following page without updating it to fit your specific situation.

Please refer to your personalized filing instructions from CitizenPath for the USCIS mailing address, filing fee and more examples of documents that you can use as evidence of bona fide marriage.


