~No one may ride in any class or schooling arena without a hard hat. When mounted, all riders must wear protective headgear in accordance with current USEF rules.

~In divisions, horse (hunter) and/or rider (equitation) must be entered and on the judge's card for AT LEAST one over fences class in that division.

~First through sixth place ribbons given in each class. Champion and Reserve awarded in each division.

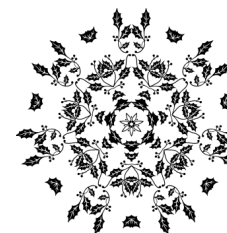

RELEASE FORM

I AGREE in consideration for my participation in the KREWE OF HORSE SPORTS SPRING IS BLOOMING HORSE SHOW (the Competition) to the following:

I AGREE that the "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm").

I AGREE to hold harmless and release the Competition and Hitch Stables from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition or Hitch Stables.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the USEF rules about protective equipment, including GR801 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the USEF strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

BY SIGNING THE ENTRY FORM, I AGREE to be bound by all applicable Competition Rules and all terms and provisions of this entry form and all terms and provisions of this Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.
