Privacy Policy of AJ Nationwide Consulting

- Introduction. This Privacy Policy discloses the policies of AJ Nationwide Consulting at
 ajnationwide.com and its operator AJ Nationwide Consulting LLC, a New York LLC located at 1413
 ave j, brooklyn, New York 11230 (collectively "we" or "us") regarding the collection, use and
 disclosure of information that you (a "User") submit to us or that is collected through your use of AJ
 Nationwide Consulting.
- 2. Location. AJ Nationwide Consulting is located in United States and is subject to United States's laws. If you are outside of United States, your use of the website constitutes consent to the transmission of personal information to United States. If your use of AJ Nationwide Consulting is against the laws of your jurisdiction, it is your responsibility to refrain from the use of AJ Nationwide Consulting.
- 3. **Types of Personal Information Collected.** "Personal information" is data that identifies, relates to, describes, can be used to contact, or could reasonably be linked directly or indirectly to a User. For purposes of this Policy, there is no meaningful distinction between the terms "personal information" and "personal data."

- 4. Collection of Personal Information.
 - a. **Submission from User**. Certain items of personal information we rely on you to submit to us. When a user completes our funding application, we collect information relating to the person(s) and the business including: SSN, business name, personal name, EIN number, address, type of services provided, etc...
- 5. Cookies and Other Tracking Technologies.
 - a. **Third Party Cookies**. We work with third parties that place cookies on our Website to provide:
 - Data Providers. We use third-party data provider cookies in connection with AJ Nationwide Consulting. The following third parties utilize data provider cookies on AJ Nationwide Consulting: Godaddy.com. Godaddy discretion
 - b. **Third Party Cookies Control.** To the extent AJ Nationwide Consulting exercises any control over the cookies created by Third Parties, it will be done in compliance with this Privacy policy. Other companies' use of their cookies is subject to their own privacy policies and not ours.
 - c. Opting Out of Cookies and Other Tracking Technologies.

- 6. **Use of Personal Information.** In general, we use your personal information to:

- 7. **Electronic Communications.** Consistent with this Privacy Policy and as is permitted by applicable law, we may communicate with you via electronic messages, including email.
- 8. **Disclosure of Personal Information to Third-Parties.** We disclose the personal information we collect (or otherwise generate or obtain) for the following purposes:
 - a. **Our Affiliates.** We disclose your personal information to affiliates of AJ Nationwide Consulting LLC for the following purpose: to assist in obtaining a merchant cash advance
 - b. **In the event of a corporate transaction.** We may disclose or transfer your information to a third party if we sell, transfer, divest, or disclose all or a portion of our business or assets to another company in connection with or during negotiation of any merger, financing, acquisition, bankruptcy, dissolution, transaction, or proceeding.
 - c. <u>Use to protect against, investigate and deter fraudulent activity</u>. When necessary, your personal information may be disclosed to third parties for the purpose of protecting against, investigating and deterring fraudulent, as well as unauthorized or illegal, activity.
 - d. **Defend our legal rights**. To protect and defend the legal rights of AJ Nationwide Consulting, and AJ Nationwide Consulting's employees, we may disclose your personal information. We may also require your personal information to defend against legal claims, or to establish our legal rights.
 - e. **To comply with and as required by law**. We may disclose your personal information to government authorities or other relevant third parties in order to comply with applicable legal requirements, judicial proceedings, court orders, subpoenas, legal process, or lawful requests from governmental authorities.
 - f. **At your request.** We also share your information as directed or requested by you, or subject to your consent. In some circumstances, you may have the right to opt-out or object to our sharing of your information with certain third parties.
