On the last day of 2024, Sullivan Law Firm represented an anonymous copyright case. The court recently denied the case's request for anonymity, leading to the revelation of details. The plaintiff was identified as KTM Enterprises, LLC, and 40 stores were implicated in the case. The product in question was KTM Enterprises' popular Happy Bee hive inspection stand. Maijia Support found that the stand was available on all major cross-border e-commerce platforms. While a temporary restraining order (TRO) has not yet been issued, a risk warning has been sounded! To avoid potential legal disputes, Maijia Support urges the relevant sellers to take immediate action and promptly investigate and remove the product.

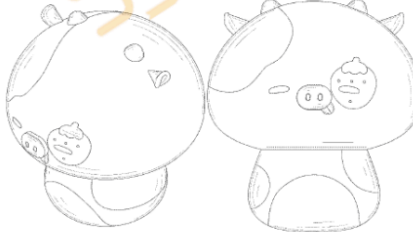

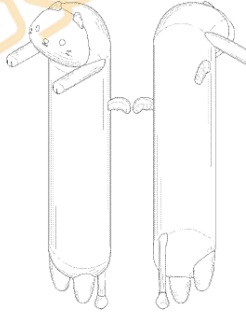

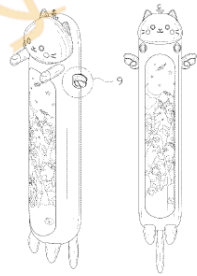

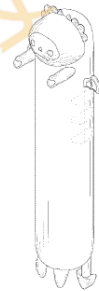

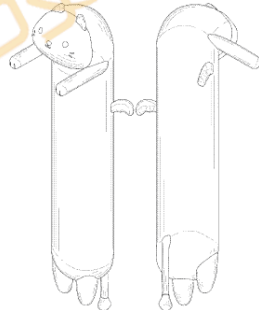

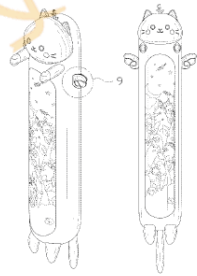

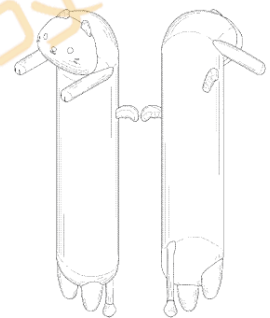

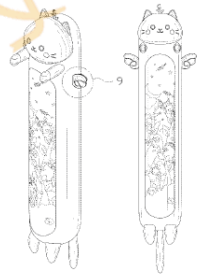

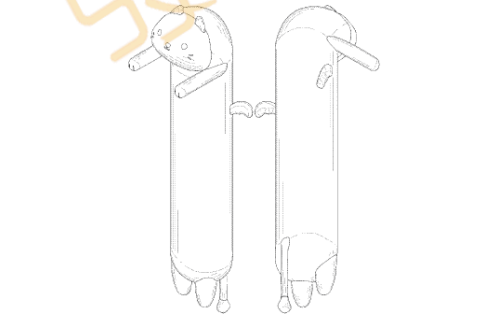

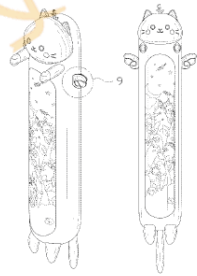

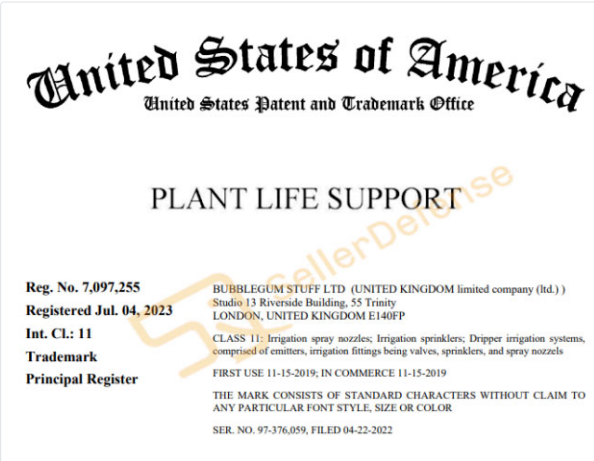
