Representative of community such as a resident living in 5th Ward at least 5 of the last 10 years or who is majority owner of a business with principal office in 5th Ward for at least 5 of the last 10 years.

Representative of a local community chamber of commerce operating in the 5th Ward and who is also (i) a resident of the 5th Ward or (ii) owns a business which has its principal office in the 5th Ward

Representative of a nonprofit organization that has been in operation for at least 10 years engaged in community development or real estate in the 5th Ward

The Administrator will evaluate each nomination and make recommendations to the Board for approval at the June Board meeting. Board approved representatives will be announced to the public via the TIRZ website and CBA listserv.
