State of Wisconsin – <u>LRB 2140 and LRB 2956</u> (bills before they are

assigned a bill number, which will be done later this month)

Prohibiting discrimination on the basis of vaccination status

This bill would amend current statutes in the following ways:

- Preventing discrimination based on vaccination status in the following categories:
 - o Employment
 - o Housing
 - o Equal enjoyment of public place of accommodation or amusement
- Preventing discrimination based on vaccination status by the following public educational organizations:
 - University of Wisconsin System
 - o Technical College System
 - o Public elementary and secondary schools
 - Charter Schools
- The UW System Board of Regents would be prohibited from investing gifts, grants, and bequests in companies that practice discrimination based on vaccination status
- Prohibiting exclusion from jury duty based on vaccination status
- Prohibiting discrimination against an otherwise qualified person based on vaccination status
- Require heads of departments and independent agencies in the executive branch of state government to determine whether there is arbitrary discrimination on the base of vaccination status and take remedial action if discrimination is found
- Prohibits discrimination against an employee, prospective employee, patient, or resident of an approved treatment facility providing treatment of alcoholic, drug dependent, mentally ill, or developmentally disabled persons on the basis of vaccination status
- Prohibits state agency rules from discriminating against a person on the basis of vaccination status
- Prohibits discrimination on the basis of vaccination status from receiving vocational rehabilitation or mental health services
- Prohibits an insurer, motor carrier, automobile insurer, transportation network company, real estate broker, and salespersons from discriminating against an individual on the basis of vaccination status
