ASSEMBLY BILL 429 / SENATE BILL 442 - relating to the **removal** of the personal conviction vaccine exemption for school and daycare children.

- Vaccines are liability-free pharmaceutical products.
- The ever-growing vaccine schedule has never been tested for safety.
- Vaccines, along with all pharmaceutical products, come with risks and CAN cause injury and death.

ASSEMBLY BILL 428 / SENATE BILL 428 - relating to vaccination of 16-17-year-old minors without parental consent. This bill seeks to eliminate the fundamental right of parents in Wisconsin to make medical decisions for their minor children.

- Minors may not have full knowledge of their medical history.
- Adolescents may be more likely to succumb to medical coercion by an authority figure.
- Teenagers may be particularly susceptible to pressure by means of incentivization (gift cards, vaccination kickbacks) as is regularly practiced in many retail settings.

ASSEMBLY BILL 427 / SENATE BILL 418 - relating to purchasing and distributing vaccines for children and making an appropriation.

- It is not fiscally responsible for the state to initiate a purchasing program.
- The implementation of one purchasing system for both public and private entities relative to vaccinations is undeniably another step toward employing a nationalized, single-payer healthcare system.
