Our family service staff and funeral directors provide personal services after the funeral, at no additional cost to the family.*

## *Itemized Prices*

The GOODS and SERVICES shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### *Professional Services*

<b>BASIC SERVICES OF FUNERAL DIRECTOR, STAFF and OVERHEAD .....</b>	<b>\$ 1595</b>
Availability of funeral director and staff to respond 24 hours a day; administrative services including preparation of death certificate, securing doctor's signature, and filing with proper authorities; securing burial or cremation authorization and/or transit permit locally; clerical administration and preparation of various forms of including Social Security and Veterans Administration; planning, supervision and follow-up on all details of arrangement conference with cemetery, crematory, clergy, or other third parties; and shelter of remains. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already in our charges for cremations, immediate burial, and forwarding or receiving remains.)	
<b>EMBALMING .....</b>	<b>\$ 795</b>
Except in certain special cases, embalming is not required by law. Embalming may be necessary; however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it such as direct cremation or immediate burial. (California state law requires embalming or refrigeration of deceased if held for more than 24 hours after time of death.)	
<b>REFRIGERATION/SHELTER OF REMAINS .....</b>	<b>\$ 250</b>
This is for a 3-day period, 65.00 for each day thereafter.	
<b>PREPARATION OF EMBALMED BODY .....</b>	<b>\$ 250</b>
This fee includes Cosmetology, Dressing and Casketing, Hairdressing.
