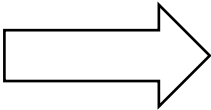

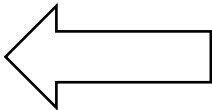

RULES & REGULATIONS

Eligibility: The Tournament is open to anyone with a valid Nebraska Fishing License, who have paid all entry fees and properly registered for the tournament by 6:00 pm on May 2, 2025. Nebraska park stickers are required on all vehicles entering the Lake McConaughy SRA. Anyone under the age of 16 must be accompanied by a licensed adult who is registered for the tournament.

Entry Fees: \$150.00 per team entry fee must accompany each entry form. Entry fee includes the Calcutta/Option Pot & Big Fish Pot. **As a bonus for registering early, the first ten teams registered will receive “One Free Pound” to their total catch.** All entries are final – no refunds unless the tournament is cancelled.

Permitted Fishing Locations: Fishing is permitted from the bank or from a boat. (Maximum 2 people per boat) – on Lake McConaughy from Kingsley Dam west up to the Lewellen River Bridge. Fishing is not allowed on private lakes or ponds.

Tackle and Equipment: Artificial and live bait may be used. Each contestant can use a maximum of two rods per NE Game & Parks regulations. All fish must be caught by rod & reel. **No set lines, trot lines, limb lines or snagging allowed.**

Launching Area: Contestants must leave from and return to – ***** Marina Landing *** 5051 Albees, Lewellen, NE 69147**

Fishing Hours: There will be a last-minute rules meeting a 6:45 am and a shotgun start at 7:00 am. **AT LEAST ONE TEAM MEMBER MUST BE AT THE MORNING MEETING AND SHOTGUN START!!!! IF YOU FAIL TO SHOW UP FOR THE MEETING AND SHOTGUN START YOUR TEAM WILL BE DISQUALIFIED!!!** All teams must check-in at or before **4:30 PM SHARP!! No excuses or exceptions!!**

*****NEW*** Fish Weighed:** Teams are allowed to **weigh ONLY 5 (five) fish per team.** ****Only 2 fish can be over 30 inches per team**** NGPC regulations. Be sure to read the 2025 Game & Parks Regulations on limits. This will be strictly enforced. Any violation will result in disqualification and may be subject to Game & Parks fines or penalties.

Prize Money: Prize money based on 90% of entry fees, paying six places. Calcutta/Option Pot paying four places. Big Fish pot pays one place for heaviest fish.

Ties: In the event of a tie, the winner will be determined by the clock. The team that checked in the earliest wins the tie.

Misc.: We would like to see as many fish as possible released back into the water. We ask that you take your fish afterwards and release them.

Protests: Any contestant wishing to protest the conduct or score of a fellow contestant must do so in writing and file the same with the tournament director within 30 minutes after weigh-ins. The tournament director may, at his own discretion decide questions relating to any contestants conduct and score. Tournament director’s decision is final.
