Exhibitor parking is located on the north side of the fair, with access through the National Guard parking lot. Setup is Tuesday, August 16. If you need to make other set-up arrangements, please contact the fair office. Take-down will begin Saturday, August 20 after 10:00 pm.

Wednesday, August 17 is family night. Following the 5:30 pm parade, the carnival will feature \$1 rides and vendors are encouraged to offer family discounts. Wednesday night will also be our first performance of the award-winning Gooding Pro Rodeo at 8:00 pm. The Commercial Building, Open Class, and 4-H Exhibit Halls will also open on Wednesday following the parade. Thursday, Friday and Saturday, public viewing of the Commercial Building and Exhibit Halls will be from 10:00 am to 10:00 pm.

We ask that food vendors be open by 6:30 pm at the latest on Wednesday and be open from 5:00pm to 10:00 pm (minimum) Thursday, Friday and Saturday.

Menu or Booth Description

Food vendors must include a complete menu with contract. Any changes must be cleared with the fair office prior to the fair. Vendors who make menu changes not approved by the fair office may be asked to cease selling the non-approved items immediately and subject to losing their vendor space in future years.

Non-food vendors must submit a complete list of products being promoted or sold. Vendors who make changes to their item list not approved by the fair office may be asked to cease selling the non-approved items immediately and subject to losing their vendor space in future years.

We appreciate everyone’s cooperation in this matter. We are a small fair and like to have as much variety and choice for our patron’s as possible, while still allowing our vendors to have a successful showing.

Contract, Insurance and Sales Tax

Enclosed is the 2022 Booth Space Contract. **Please return contract and let us know you plan to come to the Gooding County Fair NO LATER THAN May 2, 2022.** Payment is not due at this time. We will send invoices for payment around June 20. Payment must be made before set-up.

Insurance certificates must name Gooding County Fair as additionally insured and must be received at the Gooding County Fair Office prior to set-up.

The Idaho State Sales Tax declaration is now online. Event ID and instructions will be sent via your preferred contact method upon receipt of contract. The online tax declaration must also be completed before set-up.
