- Supervised the daily operation of all components of the Sheriff's Office which employed 335 employees and an annual budget of approximately \$42,000,000
- Conducted a comprehensive review of all components of the Sheriff's Office for functionality and sustainability with some of the major results of the study as follows:
 - Created the Public Information Officer and launched the Body Camera Program
 - Constructed a 100-yard, 14 lane indoor firing range with a construction cost of \$8,500,000.
 - Increased employee pay following the results of a pay and classification study
 - Reorganized the Command Staff that resulted in the addition of a Captain's position for the Indian Trail town contract and an additional Chief Deputy's position over Enforcement Operation
 - Initiated a facilities study that recognized the need for a new Administration Building
 - Obtained approximately \$32,000,000 for a new Administration Building, in collaboration with county staff and County Commissioners, through the passage of a bond that was successfully approved by Union County residents

 - Designed a five-year strategic growth analysis that projected fiscal budgeting and an increase in personnel
