### **Preparation Sheet for Roaches**

In order to give you the best possible service with the least inconvenience to you, we would appreciate your cooperation of these instructions before and after our technician treats you premises.

1. Remove all items from the kitchen cupboards (lower & upper): dishes, pot, pans, glassware, foods, cans etc. Place them on a table and cover with a sheet. Take all drawers out and turn them upside down on a countertop.
2. If any items are left on the kitchen floor or adjacent areas, keep them at least three (3) feet from the wall.
3. Empty medicine cabinets, counter tops & cabinets under bathroom sinks (towels, toilet paper, cleaners, etc.).
4. Any scrubbing or cleaning of cupboards, walls or shelves should be done BEFORE treating occurs.
5. NOTE: **HYDROGEN PEST CONTROL**, recommends for all persons they must vacate for 4 hours until treated areas are dried. Persons with ailing health or pregnancy must vacate for 24 hours and/or follow their doctor's advice. Remove all pets for at least a 4-hour period this include: birds, cats, dog, etc. must be removed.
6. Aquariums should be sealed off with plastic wrapping, and the filter turned off for 4 hours.
7. Owner or Tenant(s) needs to move refrigerator and stove 1 foot away from the wall.

\*Upon returning to the premises, open windows for 30 minutes. Thoroughly ventilating treated areas following application can reduce potential odors.
