

# Submitting a Religious Exemption Letter

There is NO FORM to fill out for a Religious Exemption. You must write a **personal letter** requesting a Religious Exemption and you need to be passionate about it!

Make sure to include in your introduction that these are your “Personal Religious Beliefs” ...

Put your contact information in the letter

Request a “Reply in a timely fashion”.

You do not need a “Religious Leader” or a “Church” to endorse your beliefs... If you are asked for one tell them that violates the “Personal” in personal beliefs.

Do not submit any request via a “portal” on a job... Submit a “Certified Letter” if necessary.

If your job is threatened, then you must make the choice between following your beliefs or being fired. DO NOT QUIT... Make them “Fire” you!

## Writing your Letter...

**Divide the Religious Exemption Letter into 3 parts.**

***Make sure to request that your letter remain “Confidential” when you submit it***

### 1. How you formed your belief in God – Be transparent...

- a. 2 or 3 pages... where you were born and what was your Church/Religious upbringing.
- b. Was someone in your family very faithful and that affected you?
- c. Did you go from a “Religious” situation such as a Catholic and become a Christian?
- d. What does God mean to you?
- e. Why do you believe what you do?
- f. Did you go to Parochial School, church School, Bible School, Bible Studies, Church Services that affected you personally?
- g. Have you done personal Bible Studies or a reading of The Bible that have helped shape your faith?
- h. Did you go to Pre-Cana or Pre-Marital classes, etc.

***(Part 2 is the most important part)***

### 2. \*\*\*\* Tell how and when you found out that vaccines go against your faith \*\*\*\*

- a. This did not come from a dream, etc. It must be prompted by someone or some event because vaccines are universally accepted...
- b. What happened to make you question vaccines?
  - i. Did someone tell you that vaccines have aborted fetal tissue?
  - ii. Example... Chiropractors kids never gave kids vaccines and they were never sick
  - iii. Our blood should be “Holy” and vaccines put “unholy” things in your body!

- iv. Be very clear about it!
- v. Something had to happen to get you started thinking about vaccines being wrong!
- vi. How did you get to the point where you took vaccinations in the past but not now?
- vii. Maybe your parents had you vaccinated and you never gave your consent!
- viii. What research did you use?
- ix. Use the links on the website... [www.mykidsmychoice.com](http://www.mykidsmychoice.com)
- x. These vaccines are tested on human embryonic cells on kidneys that were harvested while the “fetus” was alive!
- xi. Don’t go into vaccine injuries... keep it religious

### 3. Explain why vaccines go against your faith

- a. They violate the “Sanctity of Life” by using fetal tissue from abortions
  - i. Murder has been committed to create these vaccines and therefore they violate my Faith
- b. They violate the Sanctity of the Blood
  - i. Nothing “foreign” should enter my blood... The “Life” is in the blood
  - ii. Blood is Holy
  - iii. My blood is “Sacrosanct”
  - iv. Jesus’ Blood is Holy and we are Forgiven through it
  - v. Jesus’ Blood is Holy and I “Drink it” in Communion
  - vi. I cannot have “communion” with things that do not belong in my blood
  - vii. There is a synthetic genetic code in the mRNA vaccines that violates my unique genetic code that God gave me!
- c. Vaccines violate my Faith in God – He is my Healer and when I sin and sickness comes He is my Forgiver too
  - i. If I keep God’s rules He will keep me... Ex 15:26
  - ii. He is The Lord my Healer Exo 23:25
- d. Have your Children vaccinated?
  - i. We never knew about the Aborted fetal cells until...
  - ii. That makes me not want to have my kids vaccinated
  - iii. You cannot vaccinate your kids and expect a RE for yourself
  - iv. I didn’t know about the things in vaccines until (whenever) and now that I know I am against them
- e. I am not against modern medicine
  - i. No... I believe in what Jesus said: The sick need a physician Luke 5:31
- f. There is a major difference between Ingestion and Injection...
  - i. Ingestion goes in and out but Injection goes into my blood
- g. There are “foreign substances” in the vaccines
  - i. There are animal substances in vaccines
  - ii. There is Aborted fetal tissue in them
  - iii. I am against any “synthetic” substances in my body

- iv. I vaccinated my kid(s) because I didn't know what I know now. But now that I know it I can never allow it any longer
- v. Don't use words like "toxins" or "neuro toxins" ... say "foreign substances"

**Remember, once you submit this you are going to have to hold the line on all future vaccines too because all vaccines today are basically developed the same way... And, they violate your faith!**

### ***More Info***

#### **What if you're asked for a Religious Leaders endorsement or letter with your application?**

You don't have to be a member of any religious organization or have a letter from any religious leader to request an exemption. That would go against the "Establishment" clause in the Constitution that the Government cannot look at one religion differently than any other nor establish any laws of codes about religion.

Can a private entity require supporting documentation? Yes. The Establishment Clause doesn't apply to them

#### **What if employer says they will not accept RE?**

#### **You are protected under the Civil Rights Act**

##### **Title 7 Civil Rights Act Exemption**

The **Civil Rights Act of 1964** is known as a landmark piece of social justice legislation, most commonly associated with the removal of 'Jim Crow' laws which were responsible for racial segregation in parts of the United States. The language of the Act prohibits "discrimination on the basis of race, color, **religion**, sex or national origin."

Those seeking to use a religious exemption against a covid-19 vaccine mandate contend that employees are **discriminating against their religious beliefs** by requiring them to get vaccinated. Under Title VII of the Act, the Equal Employment Opportunity Commission has said that employers should accommodate workers' "**sincerely held**" beliefs, provided that doing so poses no undue hardship on the employer.

#### ***This is from the Civil Rights Act***

#### **UNLAWFUL EMPLOYMENT PRACTICES**

SEC. 2000e-2. [Section 703]

(a) Employer practices

It shall be an unlawful employment practice for an employer -

(1) to fail or refuse to hire or to discharge any individual, or otherwise to discriminate against any individual with respect to his compensation, terms, conditions, or privileges of employment, because of such individual's race, color, religion, sex, or national origin; or

(2) to limit, segregate, or classify his employees or applicants for employment in any way which would deprive or tend to deprive any individual of employment opportunities or otherwise adversely affect his status as an employee, because of such individual's race, color, religion, sex, or national origin.

### **You should submit your Religious Exemption and if it is denied then file a complaint with the EEOC**

### **Seeking an exemption for Testing**

You should be able to write a letter which includes some of the things in your RE letter

1. Putting a swab in my nose is against my beliefs...
2. It invades my blood and my person
3. I will not be tested because it would be a betrayal of my faith in God
4. I trust in Him and not in tests
5. It contains ethylene glycol (it's like rubbing alcohol?) That chemical should not go into my bloodstream.

If you get an approval for RE then this may be a simple 2<sup>nd</sup> step for people to request and get approved but don't lead with the testing exemption... The Religious Exemption is much more important for you.
