## **19 November 2020** **County Convention**

The meeting of the Montcalm County Republicans Convention was called to order by Chair, Judy Emmons, at 7:30 P.M. at the Montcalm County Administrative building. Marty Posekany moved to appoint Judy Emmons as temporary chair. Invocation by John Johansen followed by the Pledge of Allegiance.

Judy Emmons appointed Marty Posekany as temporary secretary.

Marty Posekany read the Call to Convention and explained the process and that only Precinct Delegates elected in the August, 2020 primary election or appointed at a county convention since that time, and at-large delegates who are current Republican nominees to offices, will be eligible to vote in the County Convention. Marty Posekany was elected as the permanent secretary.
