

# River Valley Cluster Reserved RV Parking

We have 3 categories of RV Parking:

1. Non-Electrical hookup or self-contained parking \$30/night
2. RV parking \$40/night
3. Premium RV Parking \$80/night

**No RV or trailer parking permitted on the Convention Center Parking lot. Vendors should coordinate trailer storage with Terry Naulty (812) 972-1457.**

All RVs and Box trucks with leveling jacks parked on any pavement, regardless of location, will require rigid mats under all jack and mats must be approved by convention center personnel prior to set up. RV parking in designated areas only.

## Hookups and grass lot sites

are available on a first come, first served basis by reservation. For reservation and questions, please contact Terry Naulty at [TerryNaulty@gmail.com](mailto:TerryNaulty@gmail.com)

RV Parking will be available beginning at 12:00 noon, Wednesday, August 22, 2018. You must be parked by a cluster member during the hours of 12:00 noon to 10:00pm, Wednesday, August 22, 2018 & 6:00am to 10:00pm daily, thereafter. Call 812-972-1457 upon arrival.

RV parking is available on a reservation only basis. There are 24 RV spaces on pavement with electrical hookups (30 and 50 Amp) available one block south of the Convention Center at \$40.00 per night, and 8 premium RV sites on concrete with electric (30 & 50 Amp) and water hookups located adjacent to the loading dock at a cost of \$80.00 per night. RV owners are encouraged to bring at least 100 feet of electric cable for the \$40.00/night sites. Non-electrical RV parking on a grass lot with plenty of shade is also available at the rate of \$30/night. RVs using generators will be permied to operate generators 24 hours a day.

**All RV parking spots require reservations and all electric RV spots are payable in advance by check or money order payable to River Valley Cluster.** After receiving confirmation of your reservation via email, send full payment to:

Handlers using a reservation agent must receive an email confirmation to be assured a site. Reservation payments must be received no later than August 15th or reservations will be forfeited. Fees for non-electric RV parking on grass lot are due at time of arrival. Contact Terry Naulty at 812-972-1457 upon arrival.

The sponsoring clubs will arrange for a holding tank cleaning service at a cost to be determined by the provider. RV owners are responsible for payment of pumping fees to the provider.

Personal vehicles (even if towed) and box trucks that are not electrically connected are prohibited from parking in the Premium RV Parking area during the period one hour prior to the show start time and one hour after best in show. Any violations will result in immediate towing, without notice, of the offending vehicle.
