Why does J Godfrey & Son Funeral Services Ltd need to collect and store personal data?

In any event, we are committed to ensuring that the information we collect and use is appropriate for this purpose, and does not constitute an invasion of your privacy.

Will Organisation Name share my personal data with anyone else?

We may pass your personal data on to third-party service providers contracted to J Godfrey & Son Funeral Services Ltd in the course of dealing with you. Any third parties that we may share your data with are obliged to keep your details securely, and to use them only to fulfil the service they provide on behalf of J Godfrey & Son Funeral Services Ltd. When they no longer need your data to fulfil this service, they will dispose of the details in line with J Godfrey & Son Funeral Services Ltd 's procedures. If we wish to pass your sensitive

personal data onto a third party we will only do so once we have obtained your consent, unless we are legally required to do otherwise.

How will J Godfrey & Son Funeral Services Ltd use the personal data it collects about me?

J Godfrey & Son Funeral Services Ltd will process (collect, store and use) the information you provide in a manner compatible with the EU's General Data Protection Regulation (GDPR). We will endeavour to keep your information accurate and up to date, and not keep it for longer than is necessary J Godfrey & Son Funeral Services Ltd. is required to retain information in accordance with the law, such as information needed for income tax and audit purposes. How long certain kinds of personal data should be kept may also be governed by specific business-sector requirements and agreed practices. Personal data may be held in addition to these periods depending on individual business needs.

Under what circumstances will J Godfrey & Son Funeral Services Ltd contact me?

Our aim is not to be intrusive, and we undertake not to ask irrelevant or unnecessary questions. Moreover, the information you provide will be subject to rigorous measures and procedures to minimise the risk of unauthorised access or disclosure.

Can I find out the personal data that the organisation holds about me?

How to lodge a complaint with the supervisory authority.

Whether the provision of personal data is a statutory or contractual requirement, or a requirement necessary to enter into a contract, as well as whether you are obliged to provide the personal data and the possible consequences of failing to provide such data.
