Eligibility: Sweepstakes is open only to individuals who are legal residents of Maine, Massachusetts, New Hampshire, Rhode Island, and Connecticut who have attained the age of majority in their jurisdiction of residence as of the date of entry into the Sweepstakes. Employees of Sponsor, Kure Creative, TD Garden, Delaware North Companies, Inc- Boston and each of their respective affiliates, officers, directors, employees, agents, advertising, public relations and promotion agencies, the judges, and members of each of their immediate families (i.e. spouses, parents, children and siblings, and their respective spouses) and those living in the same household of each are not eligible to enter.
