LOUISIANA ROOFING CONTRACTOR ASSOCIATION ORGANIZATIONAL GOVERNANCE

ARTICLE I: NAME & HEADQUARTERS

This shall be a non-profit trade association known as the Louisiana Roofing Contractor Association, hereinafter referred to as "LRCA". The principal place of business shall be the location of the registered agent.

ARTICLE II: PURPOSE

LRCA shall advocate for Louisiana roofing contractors and is dedicated to fostering strong relationships among roofing contractors, vendors and regulators while promoting industry integrity across Louisiana.

ARTICLE III: CONTRACTOR MEMBERSHIP

Any licensed and insured roofing contractor shall be eligible to apply for contractor membership in LRCA. Associate Membership is available for non-contractor roofing industry companies. All membership applications shall be reviewed by the Board of Directors to ensure the association's integrity policy criteria for members are met.

ARTICLE IV: BOARD EXECUTIVE COMMITTEE

Section A: Officers: President, Vice-President, Secretary-Treasurer

- 1. The President shall:
 - a. Call and preside over the meetings of the membership, the Executive Committee, and the Board,
 - b. Discharge such duties as may be required by these bylaws or as may be delegated by the membership.
- 2. The Vice-President shall:
 - a. Serve as President, in the event of the President's absence,
 - b. Assist the President with meetings and duties,
 - c. Handle correspondence as directed by the President.
 - d. Serve as President-Elect for the subsequent calendar year.
- 3. The Secretary-Treasurer shall:
 - a. Account for all receipts and disbursements of LRCA
 - b. Maintain a treasurer's report and meeting minutes,
 - c. Maintain a current mailing list of the members,
 - d. Serve as Vice-President-Elect for the subsequent year.

Section B: Term

- Officers shall be elected to one year terms, to begin the first day of January, by a
 majority of the Board members present and voting at the annual meeting of LRCA and
 may be reelected.
- 2. The President and Vice-President may not serve more than two consecutive terms in the same office.
- 3. A candidate for officer must have served at least one term on the Board.

ARTICLE V: BOARD OF DIRECTORS

Section A: Directors

1. The Board shall consist of at least five (5) members to include the Executive Committee.

Section B: Duties

- 1. The Board shall have the power and duty to develop and act on initiatives to support the purpose of the organization to the best of their abilities.
- 2. The Board shall approve an annual budget, presented by the Executive Committee, to fulfill the organization's development and its initiatives.

Section C: Term

- 1. The Board shall:
 - a. Be elected to one year terms, to begin the first day of January, by a majority of the Board present and voting at the annual meeting of LRCA.
 - b. Be eligible for election after two years of active contractor membership in LRCA,
 - c. Serve no more than two consecutive terms in the same office.
 - d. Not receive any stated salaries for their services.

Section D: Past Presidents

1. Past Presidents of LRCA may remain on the Board for three subsequent terms and serve on the Advisory Board thereafter.

Section E: Vacancy

- In the event of a vacancy on the Board, notwithstanding the provisions of Article V, Section C(1), the Board shall, by majority vote, name a successor to serve the remainder of a board member's term.
- 2. In the event of a vacancy on the Executive Committee, notwithstanding the provisions of Article IV, Section B(3), the Board may, by majority vote, name a successor to serve the remainder of an officer's term.

ARTICLE VI: ADVISORY BOARD

The Board may nominate and affirm industry and regulatory advisors. These advisors will serve without stated salaries and without a Board vote.

ARTICLE VII: MEETINGS

Meetings of the membership, the Executive Committee, and the Board shall be held at the call of the President. A quorum at any meeting shall consist of the members present.

ARTICLE VIII: INTEGRITY POLICY; REMOVALS

Section A: Member Integrity Policy

- 1. LRCA Members shall remain in good regulatory standings with the Louisiana State Licensing Board.
- 2. LRCA Members shall remain in good financial standings with material distributors.
- 3. LRCA Members must follow all state and local laws applicable to the industry in Louisiana.
- 4. LRCA members shall support the mission and purpose of the association to the best of their abilities.

Section B: Removal

- 1. Any member to be found in violation of the LRCA Integrity Policy may be removed from the LRCA until such time corrective action is shown.
- 2. Any applicant for membership, found in conflict with the LRCA Integrity Policy, may be denied membership until such time corrective action is shown.

ARTICLE IX: ELECTIONS

Section A: Nominating Committee

- 1. The President shall appoint a nominating committee of three to seven current members, including a past President of LRCA who will serve as Committee Chair.
- 2. The Nominating Committee will provide, to the President at least thirty (30) days prior to the annual meeting, a list of candidates for Board positions.

Section B: Nominations

- 1. The membership will be informed of the Nominating Committee's report by the President at the annual meeting, however, nominations will be accepted from the floor.
- 2. Election(s) will be determined by a majority vote of Board members present and voting.

ARTICLE X: DUES AND SPONSORSHIPS

Annual membership dues and sponsor participation will be set and approved by the Board.

ARTICLE XI: AMENDMENTS

Section A: Board Authority

 The Board shall have the authority to adopt and amend these governance procedures, at a meeting called by the President, by a two-thirds majority vote of Board members present and voting.

Section B: Annual Meeting

1. These governance procedures may be amended at the annual meeting of LRCA by a majority of members present and voting. Notice of proposed amendments must be provided to the Secretary-Treasurer no less than thirty (30) days prior to the meeting.

Section C: Adoption

1. These policies were duly amended and adopted at a meeting of the Board of Directors held in Baton Rouge, Louisiana December 17, 2025.
