Pro se Defendant Jason Goodman ("Goodman") respectfully moves the Court to find Plaintiffs Earth Intelligence Network, Kathy Steele, and non-parties Steven S. Biss and David George Sweigert in contempt of court and to stay proceedings pending an investigation of ECF No. 32. The Court has incorrectly found Plaintiffs filed a timely list of relevant statements. Plaintiffs have actually filed a clairvoyant list on September 6, 2022, nine days prior to the Order demanding a particularized list (ECF No. 33). Plaintiffs must be compelled to explain how they could so precisely anticipate the specific content of the Order before it was filed on the docket.

The list of URL links in Plaintiffs' premature filing refers to the same relevant statements cited in ECF No. 35. Plaintiffs' counsel has refused to discuss this highly suspicious anomaly as he attempts to deceive the Court by simply reformatting the same response and ignoring his own implausibly prescient previous filing. No reasonable explanation can exist outside the realm of inappropriate activity and Plaintiffs' refusal to communicate about this only increases suspicion.

PARTIES AND NON-PARTIES

1. Plaintiff – Earth Intelligence Network, INC (“EIN”) is a legally defective Virginia non-profit corporation that presently has no directors and is not in compliance with its own articles of incorporation or the Virginia Nonstock Corporations Act. Pursuant to Fed R Civ P Rule 17 (b)(2), EIN does not qualify as a plaintiff in its fatally defective state of corporate governance and cannot sue under the law by which it is organized.
2. Non-party Robert David Steele (“RDS”) is the now deceased progenitor of this instant legal action. While alive, RDS claimed to be a former employee of the Central Intelligence Agency (“CIA”) among other unverifiable things. RDS was the sole director of EIN at the time of his death. Pursuant to the Virginia Nonstock Corporations Act, EIN did not have any shareholders or owners. RDS did not own EIN and had no authority to bequeath it, or his directorship, to anyone upon his death.
3. Plaintiff – Kathy Steele (“Steele”) is the administrator of the estate of her deceased husband RDS. Steele resides in Oakton, Virginia. Steele also claims to be an employee of the CIA. Steele provided evidence stating RDS died August 28, 2021.
4. Defendant - Pro se Jason Goodman (“Goodman”) is a New York citizen and a documentary filmmaker, journalist and talk show host. In his personal capacity, Goodman is the sole owner of all Crowdsourcethe Truth (“CSTT”) branded intellectual property (“IP”).
5. Non-party Steven S. Biss (“Biss”) is a Virginia citizen, counsel for the Plaintiffs and alleged co-conspirator in a scheme to harass Goodman with sham litigation and extort money from him. Biss has been frequently sanctioned for multiple violations of the

6 refusing to schedule a call to discuss how he knew of the Court's detailed instructions
7 nine days prior to the Court's Order (ECF No. 33) appearing on the docket.
8

- 9 6. Non-party David George Sweigert aka Dave Acton ("David") is a professional
10 hacker, vexatious abuser of the U.S. District Court system, cyber stalker and serial
11 harasser who has attempted to intervene in this and approximately half a dozen other
12 lawsuits against Goodman and was denied intervention in every instance. Sweigert is
13 the author of the *Ethical Hacker's Field Operations Guide: Learning the Art of*
14 *Penetration Testing*. The subjectively ethical book describes a wide array of
15 techniques for penetrating secure systems, sending and receiving encrypted
16 clandestine communications, and various aspects of social engineering. Sweigert has
17 made public statements against his own interest about his family history of
18 schizophrenia and mental illness. (https://vk.com/video731682021_456239020)
19 (https://vk.com/video731682021_456239075). These statements, along with
20 Sweigert's five-year commitment to abusing U.S. District Courts in his maniacal,
21 vindictive, and obsessive pursuit of Goodman, cause Goodman to believe that he is
22 mentally ill, and a danger to Goodman's safety, himself, and the public around him.

- 1 7. Non-party George Webb Sweigert aka George Webb (“Webb”) is the brother of
2 David George Sweigert and alleged coconspirator to Plaintiffs. Webb is a video
3 journalist who voluntarily collaborated with Goodman in the production of YouTube
4 videos for approximately three months during 2017. Repeated incidents of acute
5 alcohol abuse, including his arrest in Zanesville, OH ended the collaboration.

- 10 8. Non-party Oakey Marshall Richards (“Richards”) is a retired FBI informant and
11 associate of Webb. Webb claims that Richards provided him with information about
12 the Maersk Memphis that gave rise to the June 2017 Port of Charleston incident, and
13 was the putative catalyst for the controversy in this case.
14
- 15 9. Non-party Patricia Negrón is believed to be an unemployed citizen of Massachusetts.
16 Negrón was an associate of Webb. Webb also introduced Negrón to Goodman in or
17 around June 2017. Negrón also voluntarily participated in YouTube broadcasts with
18 Goodman and Webb during the relevant timeframe in 2017.
- 19 10. Non-party Susan Holmes aka Susan Lutzke aka Queen Tut (“Holmes”) is a convicted
20 felon and political activist who voluntarily participated in YouTube broadcasts with
21 Goodman after the dispute with RDS began, during the relevant timeframe in 2017.
22 Holmes’ participation was terminated in or around October 2017 after she exhibited
23 behavior that caused Goodman to believe she was mentally ill.
24
- 25 11. Non-party Richard Louri (“Louri”) is the Pro Se Litigation manager and a Clerk of
26 the Court for the United States District Court in the Eastern District of Michigan.
27

1 12. Non-party Roy Warren Marshall aka Steve Quest aka Montagraph (“Roy”) is an
2 unemployed YouTube personality and longtime associate of David. Roy posted
3 multiple videos on YouTube in the days prior to June 14, 2017, that are likely to
4 prove that Roy and others had foreknowledge of a planned event involving a
5 container ship would be used to falsely incriminate Goodman.
6

7 13. Non-party Scott Anthony (“Anthony”) claims to be a former law enforcement
8 professional. He is a New Jersey citizen and longtime associate of Roy. Anthony
9 posted messages on YouTube and his own website prior to June 14, 2017, that are
10 likely to prove that Anthony and others had foreknowledge of a planned event that
11 would be used to falsely incriminate Goodman.
12

13 14. Non-party Manuel Chavez III aka Defango (“Chavez”) is an Information Technology
14 professional and a YouTube personality. Chavez was an associate of David and RDS
15 during 2017 and beyond. In the previous iteration of Steele v Goodman, email
16 evidence provided by Chavez of communications between Chavez, Biss and Steele,
17 were cited by the honorable M. Hannah Lauck in her decisions on the matter.
18

19 15. Non-party Tanya Cornwell (“Cornwell”) is Biss’ wife and paralegal. In the previous
20 iteration of Steele v Goodman, email evidence provided by Chavez showed that
21 Cornwell paid Chavez thousands of dollars while trying to coerce him into suing
22 Goodman in Arizona on the basis of frivolous claims.
23

24 **BACKGROUND**

25 In or around May 2017, Webb began voluntarily participating in video broadcasts
26 published by Goodman. In June of 2017, Webb introduced Goodman to now deceased previous
27

1 plaintiff RDS. One day after this introduction, Webb participated in a YouTube broadcast with
2 Goodman in which Webb claimed to have specific information regarding illegal transport of
3 radiological material on the cargo ship Maersk Memphis. Webb provided links to public
4 websites <https://www.fleetmon.com/> and <https://www.importgenius.com/> which allow real time
5 location tracking of seafaring vessels and give detailed information about their cargo. Webb
6 does not control the data on these websites to Defendant's knowledge. Real time corroboration
7 from third party public information, recent news stories based on similar allegations, and the
8 extreme danger associated with Webb's claims if proven true, provided sufficient context to
9 inform authorities out of an abundance of caution. Webb claims to have learned the information
10 from Oakey Marshall Richards ("Richards"). Richards is an individual Webb had introduced to
11 Goodman telephonically only weeks prior. Webb and Richards spent weeks, on numerous phone
12 calls with Goodman, independently verifying each other's claims. Richards claimed to be a
13 Vietnam War veteran and contractor to the FBI. Long after June 2017, Goodman would learn
14 the Washington Post refuted Richard's claims of military valor but confirmed that he had
15 infiltrated a West Virginia Militia in or around 1995 while working as an informant for the FBI.

18 convicted militia member Raymond Looker claimed he was entrapped by Richards.

1 During the June 14, 2017 broadcast, Webb told Goodman that failure to alert authorities
2 of the information supplied by Richards would be a crime in and of itself, misprision of a felony.
3 Webb did not explain why Goodman might be charged, but he would not. A reasonable observer
4 could conclude this was an effort to coerce Goodman into taking specific action.
5

6 Since June 2017, Webb's brother David has persistently cyberstalked, harassed, and
7 antagonized Goodman on a near daily basis. David has been involved in fomenting and or
8 disrupting at least seven lawsuits against Goodman, including vexatious attempts to intervene in
9 this instant action. Webb and David (collectively hereinafter "Sweigerts" or "Sweigert
10 brothers") together with Plaintiffs and attorney Biss, utilize multiple third-party apparatchiks to
11 carry out various functions including communication via clandestine encrypted means allowing
12 alleged co-conspirators to plausibly deny cooperation. In the interest of judicial efficiency those
13 individuals will remain non-parties to this action, but their involvement provides overwhelming
14 evidence of a conspiracy between the Plaintiffs, their counsel and the Sweigert brothers.
15
16

17 Goodman continues to allege this instant matter is baseless, vexatious, sham litigation,
18 brought to harass him, extort money from him and to prevent him from broadcasting evidence
19 that is likely to prove Plaintiffs have engaged in criminal activity. Their latest filing indicates
20 they are so desperate to gain any advantage in this case, they are willing to utilize some process
21 outside of normal court procedure. Plaintiffs must be compelled to explain how they obtained
22 specific knowledge of the order (ECF No. 36) prior to September 15, 2022, when there had been
23 no activity on the docket for nearly six months prior. Defendant was not aware of any Court
24 request as cited by Plaintiffs in ECF No 32. To resolve this confusion, on the morning of
25 September 15, 2022, Defendant called the clerk's office. The clerks were not aware of any

1 missing order or any other error on the docket and could not explain further. At or about 5 pm
2 that same day, a memorandum opinion (ECF No. 33) was issued seeking a particularized list of
3 videos containing relevant statements, making no reference to ECF No. 32. Failure to show
4 good cause for Plaintiffs' highly suspicious filing should result in a finding that Plaintiffs and the
5 Sweigert brothers are in contempt of court. Immediate sanctions should be applied, including
6 dismissal of all claims, a criminal referral, and any other sanctions as determined by the Court.
7

8 **CONSISTENT FOREKNOWLEDGE OF EVENTS ADVERSE TO DEFENDANT**

9 The Court should find Plaintiffs and their alleged coconspirators in contempt of court
10 because evidence is likely to prove they have attempted to obstruct the Court's administration of
11 justice by making a filing based on information gained through inappropriate or illegal means.
12 Plaintiffs sought to undermine the normal judicial process of this Honorable Court.
13

14 **I. Foreknowledge of Order ECF No. 33 Issued on September 15, 2022**

15 Goodman alleges Plaintiffs counsel Biss had prior knowledge of the contents of the
16 Court's forthcoming order when Plaintiffs filed ECF No. 32 on September 6, 2022. No logical
17 explanation has been offered and none apart from inappropriate action can explain the highly
18 unusual circumstance. Defendant has made numerous efforts to contact Biss seeking clarity.
19 Biss has dismissed Goodman's inquiry as "conspiracy theory" and stated his personal preference
20 to not communicate at all. This uncooperative behavior only furthers Defendant's belief that
21 something untoward has transpired. This is not the first time since Jun 14, 2017, that parties
22 adverse to Goodman, including those alleged to be Plaintiffs' coconspirators, have demonstrated
23 a likelihood of prior knowledge of events related to this litigation and specifically calculated to
24 harm Goodman.

II. Port of Charleston Incident That Gave Rise to Plaintiffs' Complaint

Defendant alleges that Plaintiffs, the Sweigert brothers and other non-parties had prior knowledge of the events of June 14, 2017. These parties had malicious intent and sought to use the incident to fuel false legal claims against Goodman for their own financial gain. On June 8, David participated in a broadcast with Chavez titled *#defango meltdown Talking with Action Dave*. The video is no longer available on YouTube but has been preserved by the Defendant. (https://vk.com/video/@id731682021?z=video731682021_456239071%2Fpl_731682021_-2) During the call, David and Chavez discuss Goodman's use of YouTube, claiming they had been YouTubers for years and Goodman had no right to show up and behave as they perceived. They speculated that some dramatic domestic terrorist event would be inspired by Goodman, and it was their moral duty to stop him. David told Chavez "I think there's going to be a false flag in New York. That's my prediction. It's going to be related to Webb." Chavez replied "Yeah, that's actually, you're not the first person that's actually delivered that information to my head." David goes on to mention "Montagraph" the internet pseudonym used by Roy, another of their alleged coconspirators. David boasted to Chavez of his past endeavors with Roy, telling him about their recent success against a Cobb County Georgia man, Justin Hess ("Hess"). When David, Roy and their associates failed to convince law enforcement to arrest Hess, they resorted to their own brand of vigilante justice, cyberstalking and harassing his mother, Carol Ann Hess. By their own admission, they repeatedly telephoned her, warning her of their concerns about her live-in adult son. The phone calls created a dispute that culminated in Hess murdering his mother and another person. (<https://www.ajc.com/news/crime--law/east-cobb-man-accused-killing-mom-thanks-judge-first-court-appearance/zVn8xqjDQhj0DM07D8dCAJ/>). Hess was indicted in March

1 2017, perhaps emboldened the group or sending a signal that their brand of internet vigilantism
2 was effective if not appropriate, illegal or unconstitutional..

3 On June 11, 2017, Roy posted a video on YouTube titled *Tiger's Eye - Professional*
4 *Warfare* (<https://youtu.be/KysTO2GoRB0>). The video displays a succession of images including
5 the text, "*George Webb & Jason Goodman, are inches away, from being SUPER STARS, for all*
6 *the wrong reasons:.) YOU CLOWNS, GEORGE & JASON WANT TO PLAY WITH THE*
7 *PUBLIC? THEN, WE ARE GONNA PLAY WITH YOU*" (**EXHIBIT A**). Another image depicts a
8 sinking cargo ship (**EXHIBIT B**). This remarkably coincidental creative decision appears to
9 foretell events that would transpire only days later. In a separate video published June 9, 2017,
10 Roy states "*Jason is going to have a VERY BAD DAY, today*" (<https://youtu.be/dPocusUAFRQ>).
11 There is a reply from the YouTube account Radar Ops, that says "*It's being pushed out now*".
12 The Radar Ops account was previously named "Scott Anthony" and is controlled by Anthony.
13 Roy replied, "*Scotty, That is great to know.*" (**EXHIBIT C**). At the time, Anthony published a
14 website called www.Scottanthonyarchives.com. The site has been deactivated, but defendant has
15 preserved an op-ed opinion piece published by Anthony on June 11, 2017. (**EXHIBIT D**)

16 Goodman alleges it is this June 11, 2017 op-ed that Anthony is referring to with his "it's
17 being pushed out now" comment. In his editorial, Anthony reiterates the sentiment expressed by
18 David and Chavez, that Goodman as an inexperienced newcomer who had no right to exercise
19 the first amendment, but rather must be prosecuted like a criminal suspect by their collective of
20 experienced YouTube users who dole out their own home brew of vigilante justice. Goodman
21 was unaware of these videos and their related comments prior to June 2022. Upon discovering
22 this evidence, Goodman contacted Anthony. He did not deny writing the comments but did not

1 offer any insight into what he may have known or what he was thinking at the time. Anthony
2 ended the phone call abruptly after behaving in a way that caused Goodman to believe he was
3 not being truthful. Goodman also contacted Roy and asked about the nature of his relationship
4 with David Sweigert and what he may have known prior to June 14, 2017. The questions altered
5 Roy's demeanor dramatically, almost as if he experienced some kind of emotional break. He
6 claimed the meaning of the video was "your ship is sinking" as he became increasingly agitated.
7 Roy threatened and insulted Goodman using foul language. After the phone call, Roy began
8 publicly threatening Goodman and posted additional videos containing false claims, statements
9 that constitute extortion as defined by the Code of Virginia § 18.2-59. Roy warned that further
10 efforts by Goodman to alert authorities of accusations against him would result in some
11 unspecified action that would terminate Goodman's credit card payment processor. In a video
12 posted July 8, 2022, CrowdsourcetheTroof Patreon Parody (<https://youtu.be/um1JAebqHBI>).
13 Roy admits to having taken some unspecified action that destroyed a personal phone number that
14 had been in Goodman's possession for more than ten years. No charge of harassment was
15 reported to authorities or adjudicated by a court of law. Acting as judge jury and executioner as
16 far as Goodman's long time phone number causing considerable harm. Approximately six
17 minutes into his new video threat against Goodman, Roy asks "And how'd that recording go for
18 you. Oh, you didn't get it. Uh, see how that works?" This refers to Goodman's failed attempt to
19 record their telephone conversation. Goodman regularly records telephone interviews and it is
20 extremely rare for recordings to fail. It is unclear how Roy would have known that particular
21 recording had failed. The taunting nature of Roy's statements indicates he may have cause the
22 failure. His threats, coupled with the demonstrated ability to destroy Goodman's phone, suggests

1 that Roy may be involved in hacking, computer intrusion, wire fraud or other activities outside
2 the bounds of the law. The destruction of the phone and further threats indicate a willingness to
3 harm Goodman in a similar manner Goodman alleges Plaintiffs and their coconspirators have.

4 III. District Court Filings That Defy the Laws of Time and Space

5
6 On October 31, 2020, Webb brought action against Cable News Network
7 (“CNN”) alleging defamation and other things. Biss has represented former congressman Devin
8 Nunes in several frivolous suits against CNN ([https://www.reuters.com/world/us/trump-ally-](https://www.reuters.com/world/us/trump-ally-devin-nunes-loses-cnn-defamation-appeal-2022-04-14/)
9 [devin-nunes-loses-cnn-defamation-appeal-2022-04-14/](https://www.reuters.com/world/us/trump-ally-devin-nunes-loses-cnn-defamation-appeal-2022-04-14/)) and he boasts on Truthsocial.com “*I*
10 *litigate defamation cases against the animals at CNN.*” Despite the Sweigert brothers’ claims
11 that they are estranged and have virtually no contact, David was aware the lawsuit was filed and
12 prepared and filed a twelve-page motion to intervene less than one week later. (*See* Sweigert v
13 Cable News Network Case 2:20-cv-12933-GAD-KGA MIED). David alleged the defective
14 complaint was related to his case against Goodman in the Southern District of New York (*See*
15 Sweigert v Goodman Case 1:18-cv-08653-VEC-SDA SDNY) and attempted a change of venue.
16 Judge Gershwin Drain dismissed the case on March 21, 2022, but prior to that, a filing was made
17 that Goodman alleged to be fraudulent (**EXHIBIT E**). The document is still on the MIED
18 Court’s docket (*See* Case 2:20-cv-12933-GAD-KGA ECF No. 12). The document properties
19 inspector within Adobe’s Acrobat Reader reveals that the document was created at 9:05 AM on
20 June 21, 2021. The clerk’s stamp however indicates this document was filed on June 18, 2021,
21 fully three days before it existed. Although the document purports to be electronically filed, no
22 e-filing receipt from the Temporary Pro Se filing web page has been presented by Webb. In the
23 same space–time and logic defying manner as Plaintiffs’ filing of ECF No. 32 in this action,

1 Webb's response to judge Drain's show cause order was magically filed on time three days
2 before it was created. No logical, or any other alternate explanation has been offered. Goodman
3 also identified a network of Twitter accounts, including one with the screen name "Richard"
4 (https://twitter.com/Richaf_loury28) that Goodman alleges was used by Loury and other
5 coconspirators to exchange clandestine communications.

8 **CONCLUSION**

9 Defendant cannot explain how Plaintiffs could so precisely anticipate the detailed
10 instructions of the Court's order days in advance of its appearance on the docket. Plaintiffs have
11 refused to communicate about it or provide any clarity. Absent some heretofore unknown
12 explanation, Plaintiffs should be held in contempt of court or otherwise compelled to show cause
13 as to why they should not be. Defendant prays the Court will stay these proceedings pending a
14 proper resolution of this troubling issue.

Researchers Being Attacked By Crowdsourced The Truth Member Jason Goodman: Credibility Called Into Question

Good morning,

Today is Sunday, June 11, 2017.

I am providing this video and a written response as a matter of public record, in response to a video uploaded and broadcast on the social media platform YouTube on this date approximately four and a half hours ago, entitled "Deep State Attack on George Webb & Crowdsourced the Truth".

Like almost all of you watching this video, and indeed, the ones uploaded by either George Webb or Jason Goodman and any subsequent livestreams either individually or collectively (also known as "Crowdsourced the Truth" hereinafter referred to as CTT), I believe that we all would like to see the rapid apprehension and prosecution for the persons responsible for either the murder or disappearance of the individual we have come to know as "Seth Rich". For many, the story of Seth Rich and his alleged homicide evokes a visceral reaction for justice. I concur with the need for justice in the case of any unsolved homicide, abduction, or any other capital offense or felony. After all, we are a "nation of laws" in the United States of America, and it is woven within our founding father's words of wisdom that all people shall enjoy "Life, Liberty and the Pursuit of Happiness".

Disturbingly, on this date, and prior to this date, a trend had been developing on both Mr. Webb's and Mr. Goodman's channels and the videos they have been uploading: what had at first seemed like a novel idea to "storyboard" and "crowdsourced" an open investigation into potential crimes committed against innocent Americans by a host of entities and individuals that have been named by Mr. Webb and Mr. Goodman within their video content, has crossed into the realm of what I consider highly unethical, dangerous, and potentially illegal behavior. It is for these reasons that I can no longer sit idly by as Mr. Webb and Mr. Goodman utilize various psychological tactics to illicit responses from their viewers.

While Americans enjoy a "Free Press" and the right to ensure that those who have committed crimes are held accountable, there are well established methods and processes to ensure that information is accurately reported, and those accused of potential crimes are afforded due process. In America, we are free to say what we like, without fear or prejudice, as long as the safety of others or their civil rights is not violated. Regarding the Rule of Law however, there are a host of safeguards in place to ensure that the right person is tried for the right crime and is judged by a jury of their peers utilizing constitutional protections. For this reason, and almost this reason alone, America has been one of the beacons of liberty around the globe since our nation was founded.

In the video broadcast earlier today, Jason Goodman issued what I believe was designed to be a "call-to-action" video: that is, he created it with the intent to utilize psychological tactics to illicit a response. The average person may not be aware such tactics are being utilized. This is understandable as they are very subtle by design. I believe the purpose of Jason's video was to encourage others to start investigating a person known on YouTube as "Defango", also known as Manuel Chavez. However, there are implied messages as well, as you will see throughout this call-to-action video. This is how I perceived the messaging in the above named video, and while it is impossible for me to state with certainty that was Mr. Goodman's intent, perception is reality in many instances. Thus, a reasonable person may likely draw the same conclusions I have regarding the intent of his video.

It should be noted that while Mr. Goodman has made it clear that his relevant employment history and experience is comprised of the creation of 3D Stereoscopic cameras and/or other inventions for Hollywood filmmaking, Mr. Goodman has never indicated former employment or experience in the fields of journalism, law enforcement, or the legal profession at large. This is an important distinction because he very likely lacks the fundamental and basic education required to conduct a large-scale investigation into criminal activities as the CTT library entails. It should also be noted that at no time have I witnessed Mr. Webb state that he possesses the requisite professional training to conduct criminal investigations in the same manner.

In reviewing the library and archived video evidence that both Mr. Webb and Mr. Goodman have catalogued on their channels, there is ample evidence that lack of appropriate training in investigations and law enforcement easily places the public at risk. In no particular order, and by no means a comprehensive list, some of the more obvious issues may be:

1. Implicating or accusing an innocent person of wrong-doing, including being part of a criminal conspiracy;
2. Revealing the identity of an otherwise private individual with no knowledge of the investigation to the Crowdsourced audience;
3. The potential for over-eager and inexperienced "researchers" to commit acts of harassment towards innocent persons;
4. The potential for large numbers of viewers to contact family, friends, co-workers of the stated victims (which would fall under the aforementioned harassment section).

5. The potential for inexperienced investigators to place themselves into dangerous scenarios during the canvassing and interviewing of potential witnesses;
6. Exposing actual witnesses of a criminal investigation where their protection might otherwise be afforded by law;
7. The inherent lack of ability to control the direction of the investigation, all of which could compromise or undermine actual investigations currently underway.

...individuals who have been employed as a law enforcement

official, although it is not my current profession. Currently, I am licensed and Board Certified healthcare practitioner able to assess and treat conditions, injuries, and illnesses across the age spectrum, including mental health. It is both my prior and current occupations that afford me the insight, formal training, and ability to detect even subtle nuances in the human condition the average person might overlook.

I understand that my assessment will be met with resistance from many. I accept that many of you will continue to follow Mr. Goodman and Mr. Webb regardless of the information I provide. However, it is my hope that those who may feel compelled to take any actions against any individuals named within this video, or any prior or subsequent videos that Mr. Webb, Mr. Goodman, or their "Associates" produce and publish, will pause and think through the ramifications if the actions taken are based off of faulty investigative techniques, lack of appropriate citations, sources and methods during their investigation, and not least of all, the potential criminal and civil rights violations that might incur as a result of actions taken simply because Mr. Goodman has created a sense of urgency. The case of Seth Rich is nearing the one-year mark since the alleged crime has occurred. Urgency has long since passed, and this investigation is now in the long-haul phase where accurate and methodical law enforcement tactics should be used to bring those who committed the crimes against Seth Rich to justice.

Based on viewer reactions to the George Webb / Jason Goodman video series, and based on a variety of videos now being published, many of which touch upon the topic of what appears to be a somewhat reckless and potentially dangerous crowdsourced investigation process, it is my opinion that other individuals are detecting something amiss with the ethics of CTT's crowdsourced investigation.

Chairmen Burr, Ranking Member Warner, Members of the Committee:
Thank you for inviting me to appear before you today. I was asked to testify today to describe for you my interactions with President-Elect and President Trump on subjects that I understand are of interest to you. I have not included every detail from my conversations with the President, but, to the best of my recollection, I have tried to include information that may be relevant to the Committee.

January 6 Briefing

I first met then-President-Elect Trump on Friday, January 6 in a conference room at Trump Tower in New York. I was there with other Intelligence Community (IC) leaders to brief him and his new national security team on the findings of an IC assessment concerning Russian efforts to interfere in the election. At the conclusion of that briefing, I remained alone with the President-Elect to brief him on some personally sensitive aspects of the information assembled during the assessment.

The IC leadership thought it important, for a variety of reasons, to alert the incoming President to the existence of this material, even though it was salacious and unverified. Among those reasons were: (1) we knew the media was about to publicly report the material and we believed the IC should not keep knowledge of the material and its imminent release from the President-Elect; and (2) to the extent there was some effort to compromise an incoming President, we could blunt any such effort with a defensive briefing.

The Director of National Intelligence asked that I personally do this portion of the briefing because I was staying in my position and because the material implicated the FBI's counter-intelligence responsibilities. We also agreed I would do it alone to minimize potential embarrassment to the President-Elect. Although we agreed it made sense for me to do the briefing, the FBI's leadership and I were concerned that the briefing might create a situation where a new President came into office uncertain about whether the FBI was conducting a counter-intelligence investigation of his personal conduct.
